(57) **CLAIM**

The ornamental design for a hard hat, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a hard hat showing my new design;

FIG. 2 is a right side elevation view thereof, the left side being a mirror image;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a rear perspective view of a second embodiment thereof;

FIG. 7 is a right side elevation view of FIG. 6; the left side being a mirror image;



FIG. 8 is a rear elevation view of FIG. 6;




















