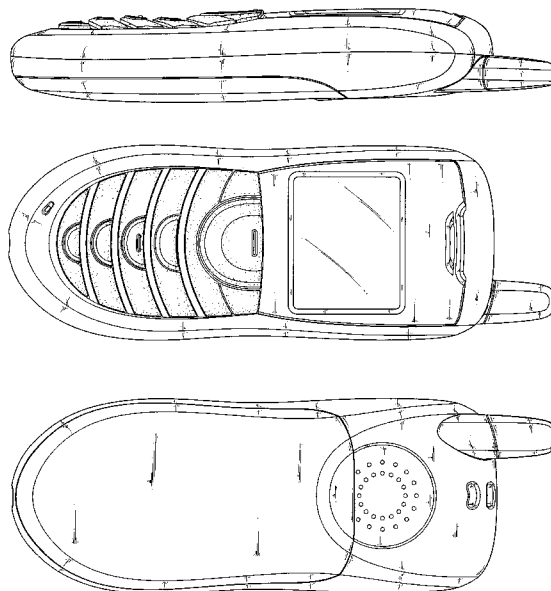
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a mobile phone showing our new design;
FIG. 2 is a right side elevational view thereof;

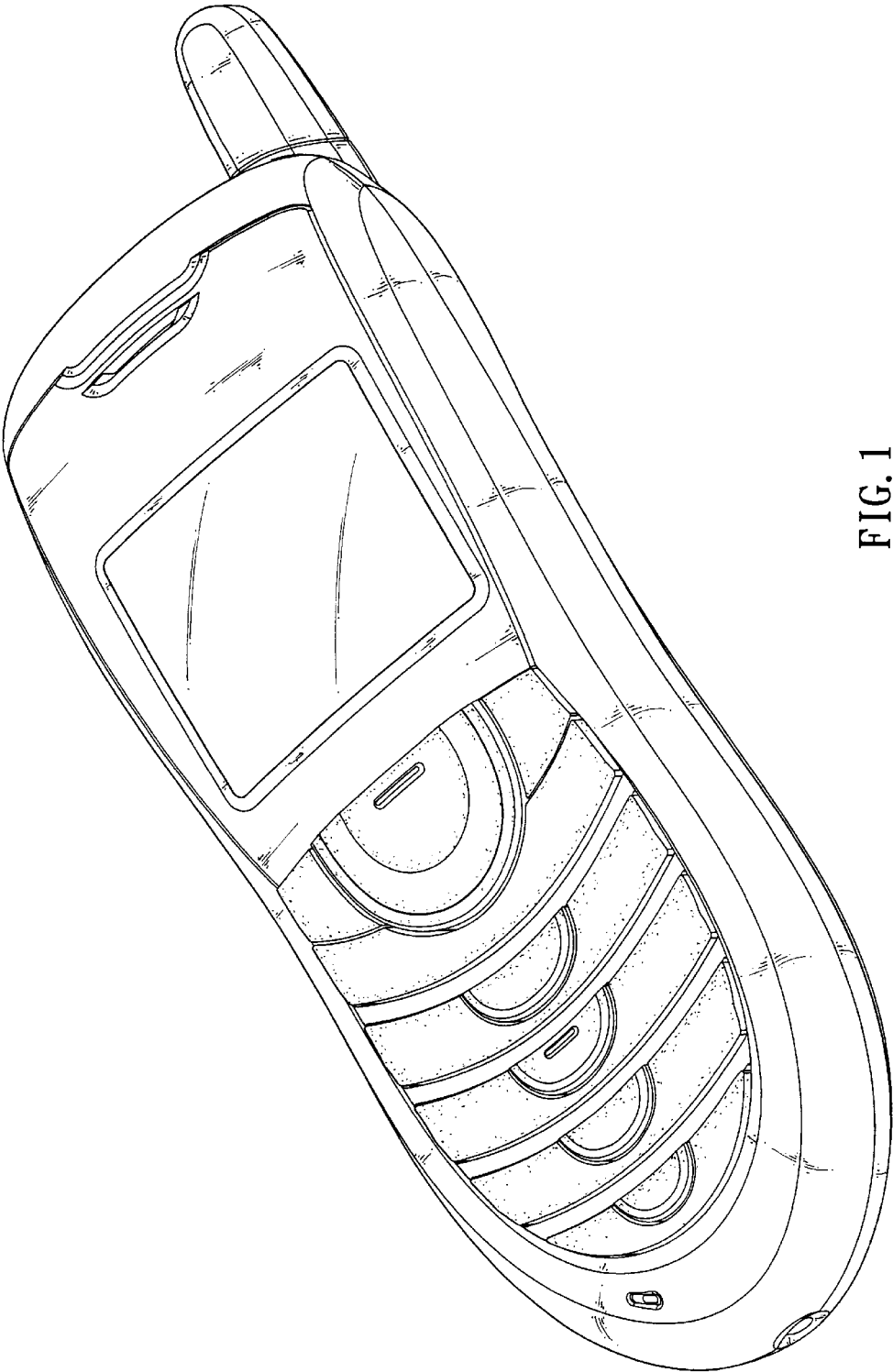

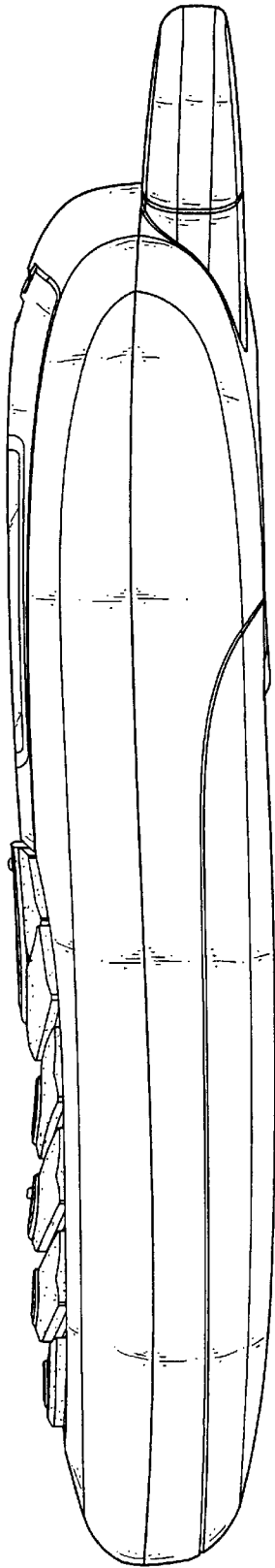

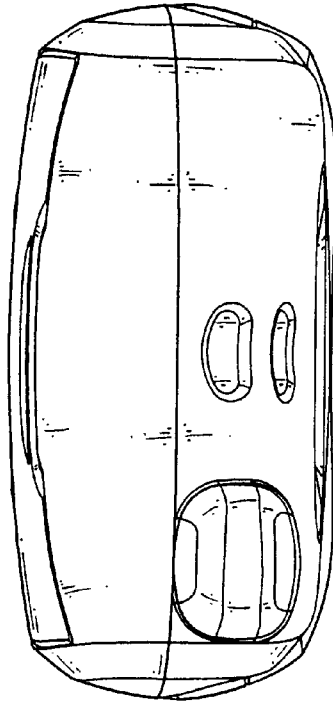

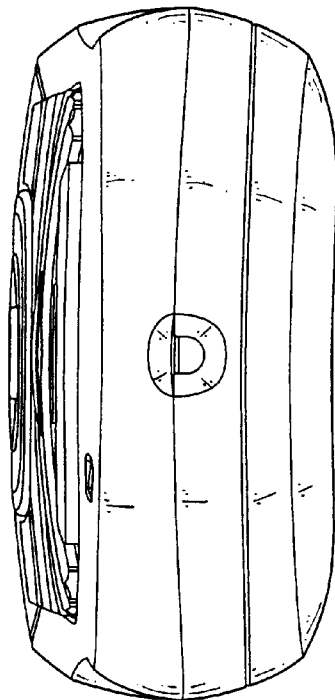

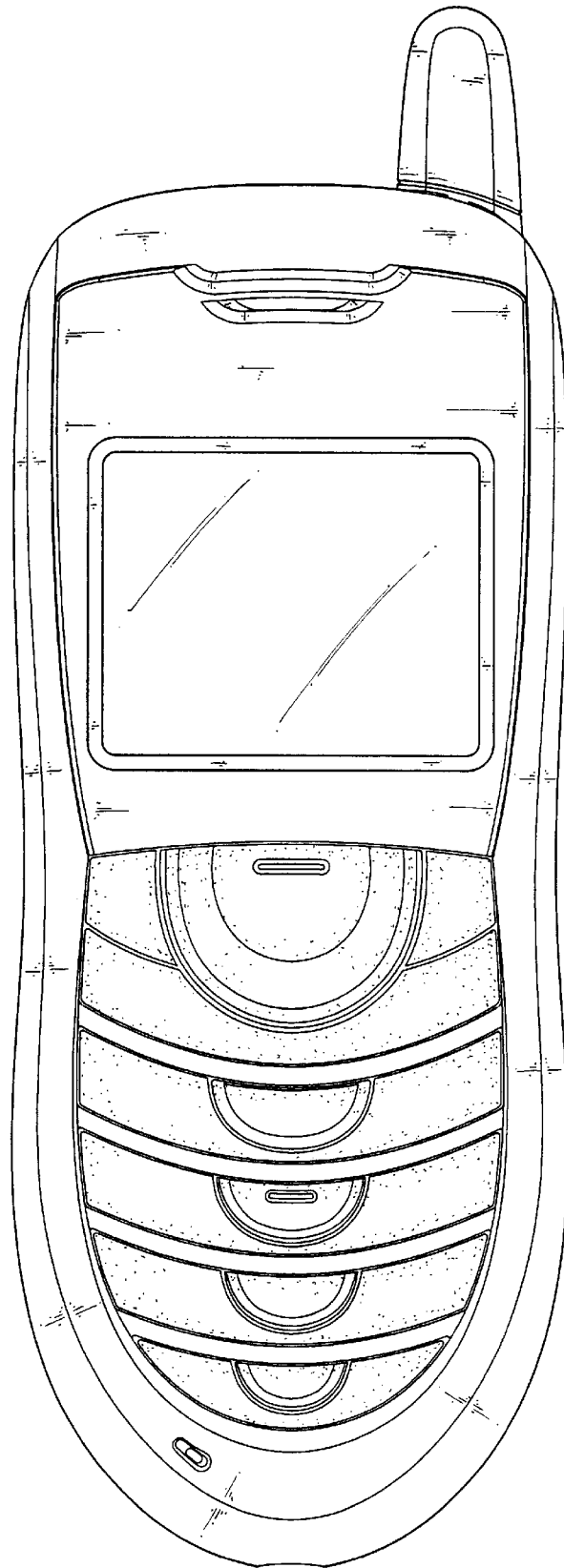

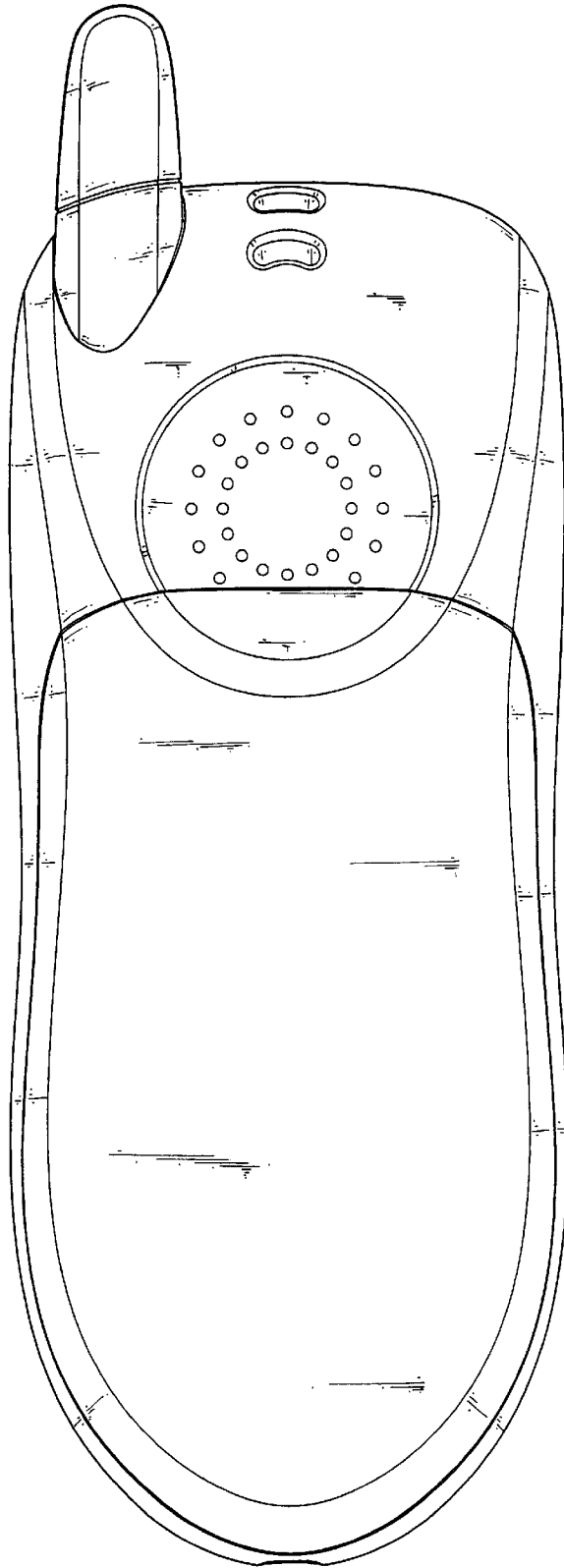
