(57) **CLAIM**

The ornamental design for a sanding tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sanding tool showing the new design;

FIG. 2 is a perspective view thereof with one of the ends shown in its open position;

FIG. 3 is a left side view thereof, the right side view thereof being a mirror image of the left side view shown;

FIG. 4 is a top view thereof;


FIG. 5 is a front view thereof;

FIG. 7 is a bottom view thereof.














