
(57) **CLAIM**

The ornamental design for a surveillance system enclosure, as shown and described.

DESCRIPTION

FIG. 1 is an angled right bottom perspective view of an surveillance system enclosure;
FIG. 2 is an angled top right perspective view of the variation of the enclosure shown in FIG. 1;
FIG. 3 is an angled left bottom perspective view of the variation of the enclosure shown in FIG. 1;
FIG. 4 is an angled top left perspective view of the variation of the enclosure shown in FIG. 1;
FIG. 5 is a bottom view of the variation of the enclosure shown in FIG. 1;
FIG. 6 is a top view of the variation of the enclosure shown in FIG. 1; and,
FIG. 7 is a left side view of the variation of the enclosure shown in FIG. 1.














