(57) **CLAIM**

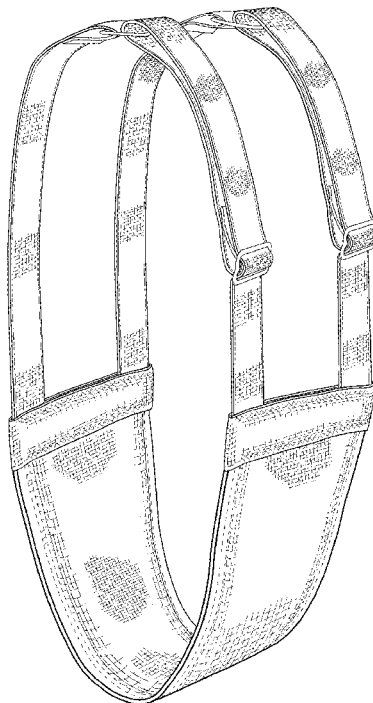
The ornamental design for a prolapse support garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a prolapse support garment in accordance with the present invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The evenly dashed broken lines on the prolapse support garment are for the purpose of illustrating stitching and form no part of the claim.

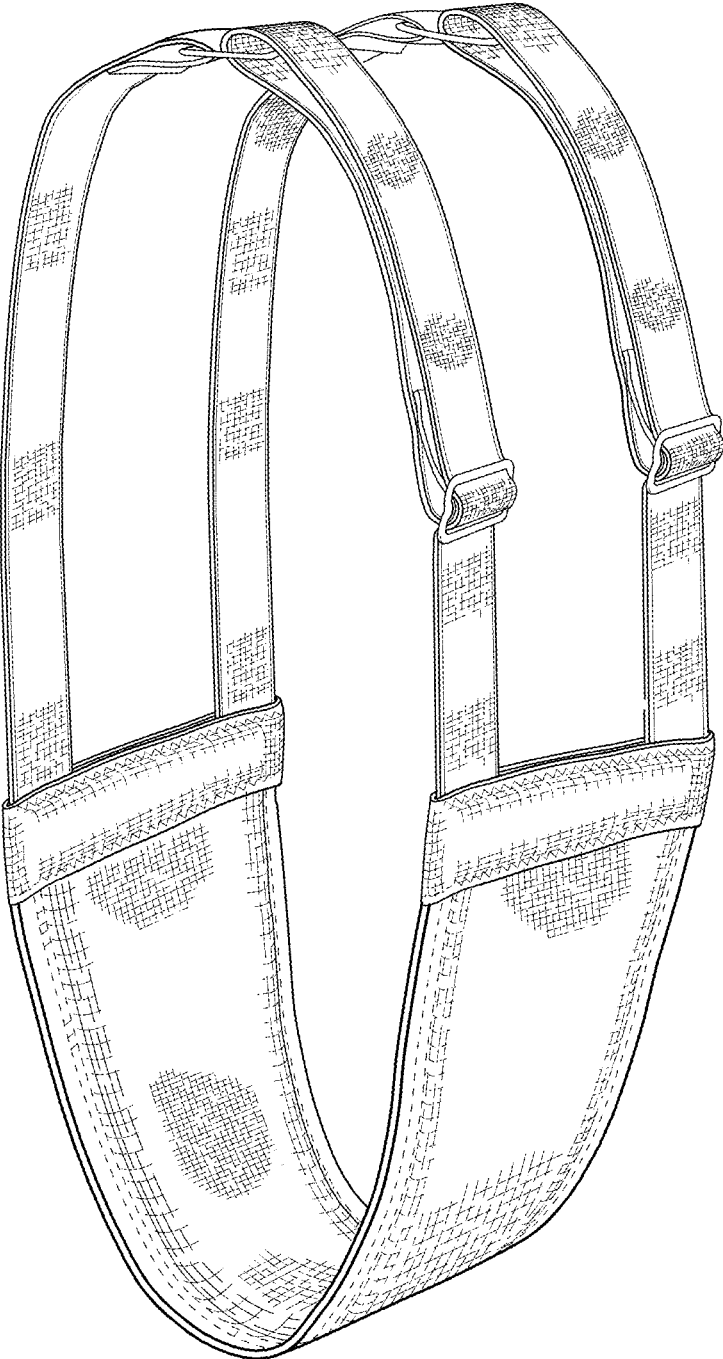

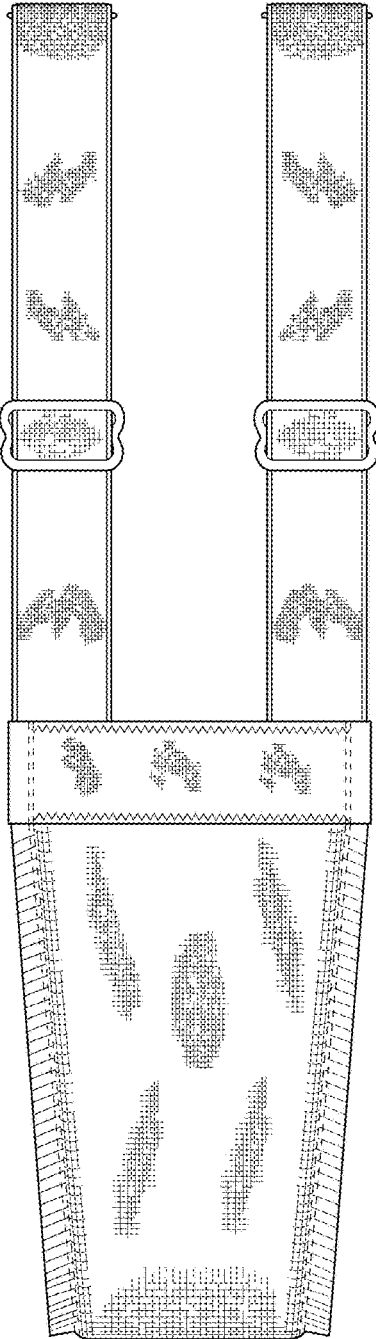

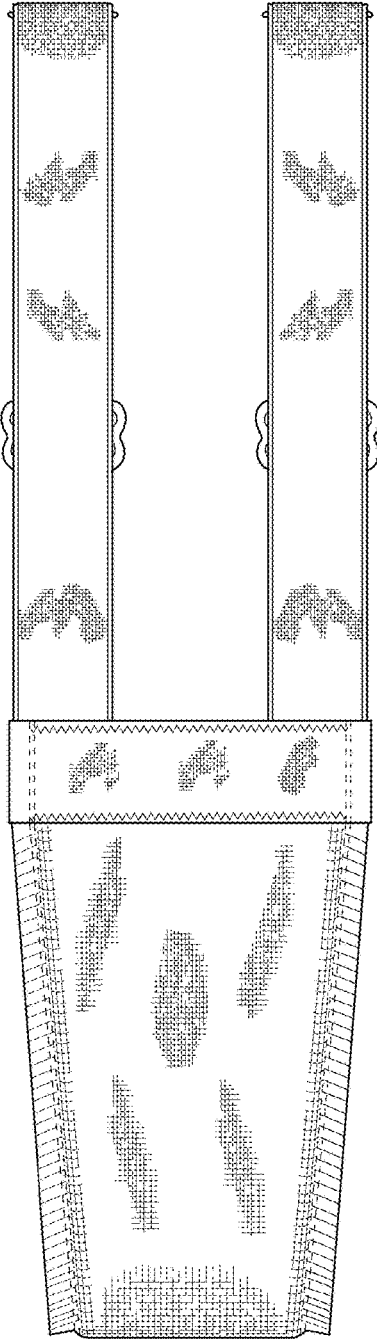

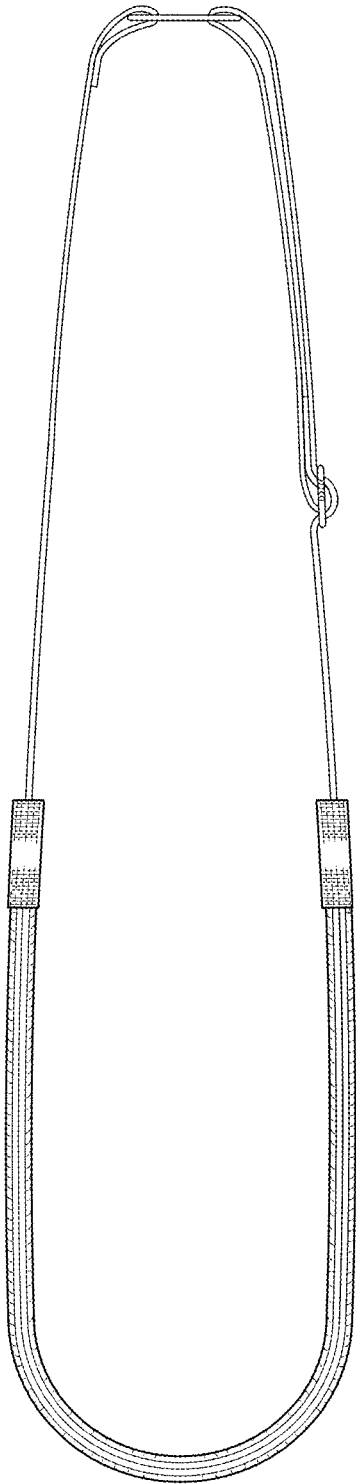

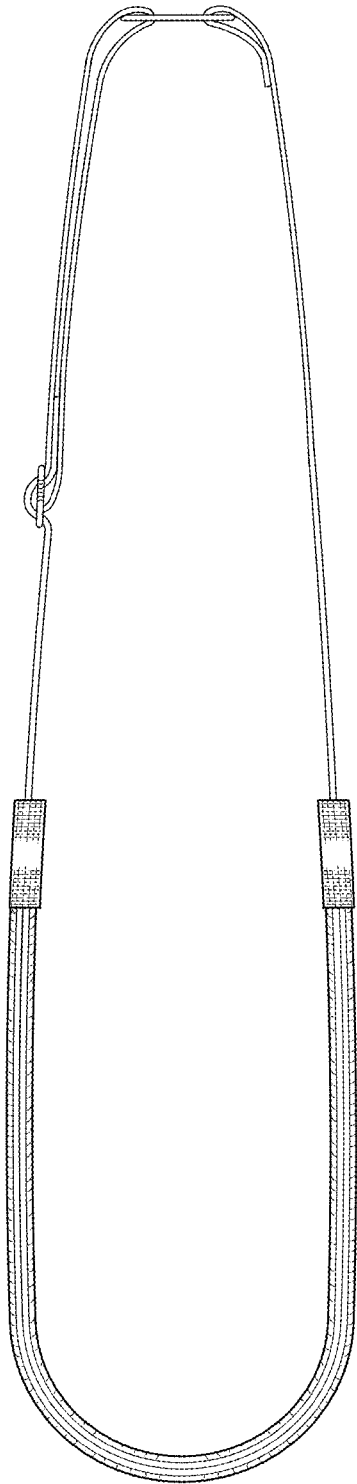

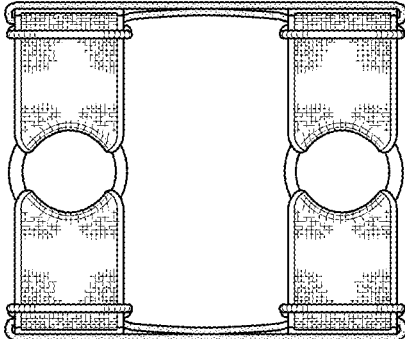

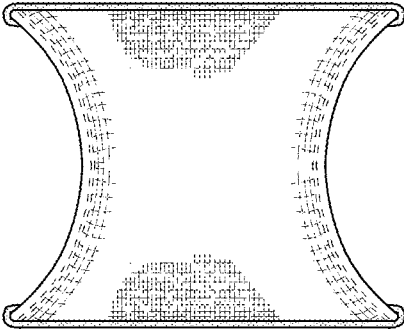
