
**CLAIM**

The ornamental design for a single ray bone plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a single ray bone plate comprising the new design; FIG. 2 is a right elevational view of the design of FIG. 1; FIG. 3 is a left elevational view of the design of FIG. 1; FIG. 4 is a top view of the design of FIG. 1; FIG. 5 is a bottom view of the design of FIG. 1; FIG. 6 is a front elevational view of the design of FIG. 1; and, FIG. 7 is a rear elevational view of the design of FIG. 1. 








