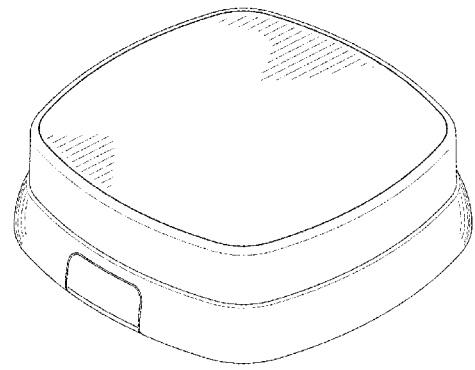

(57) **CLAIM**
The ornamental design for a cosmetic compact, as shown and described.

DESCRIPTION
FIG. 1 is a top, front and right side perspective view of my new design for a cosmetic compact, shown in the closed position;
FIG. 2 is a front elevation view of the cosmetic compact, shown in FIG. 1;
FIG. 3 is a rear elevation view of the cosmetic compact, shown in FIG. 1;
FIG. 4 is a left side elevation view of the cosmetic compact, shown in FIG. 1;
FIG. 5 is a right side elevation view of the cosmetic compact, shown in FIG. 1;
FIG. 6 is a top plan view of the cosmetic compact, shown in FIG. 1;
FIG. 7 is a bottom plan view of the cosmetic compact, shown in FIG. 1;
FIG. 8 is a right side perspective view of the cosmetic compact, shown in FIG. 1, in a first open position;
FIG. 9 is a right side perspective view of the cosmetic compact, shown in FIG. 1, in a second open position; and, FIG. 10 is an enlarged view of the encircled portion shown in FIG. 3.
The broken lines, shown in the FIGS. 7 and 9, depict portions of the cosmetic compact which form no part of the claimed design.

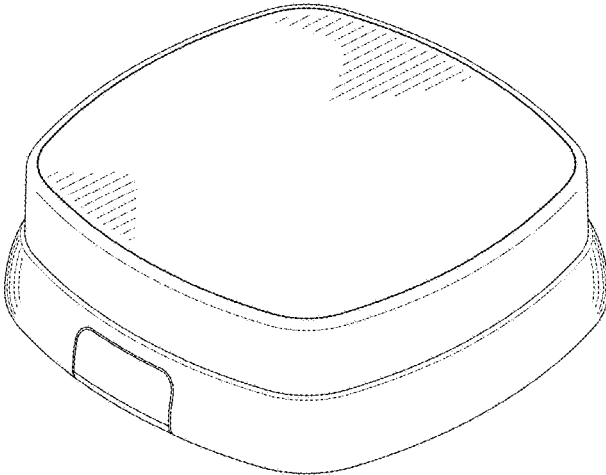

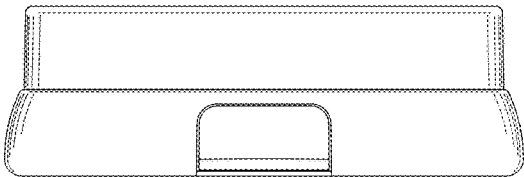

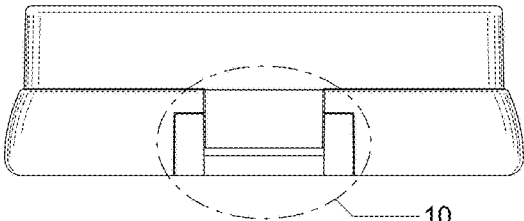

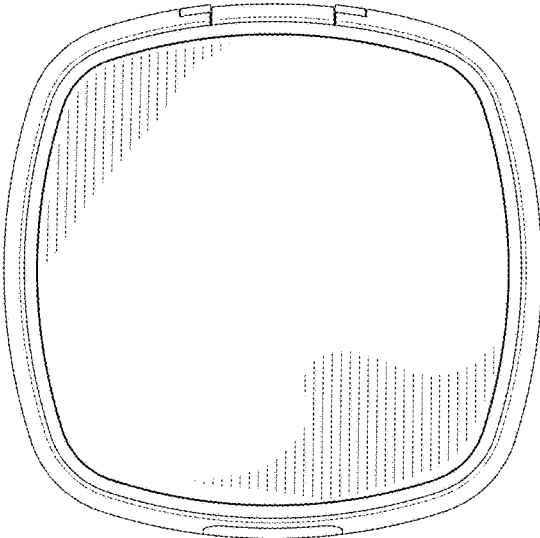

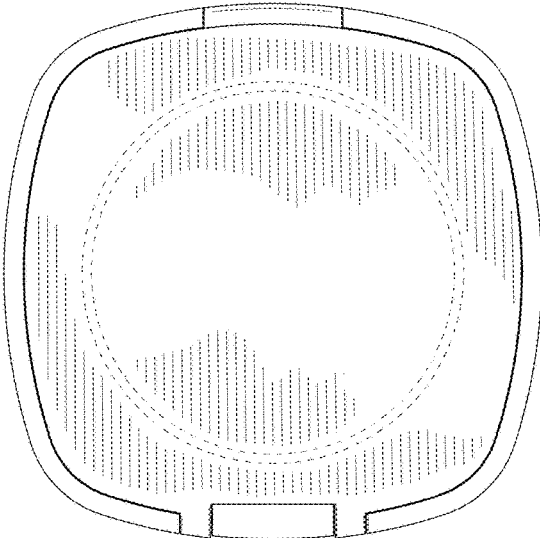

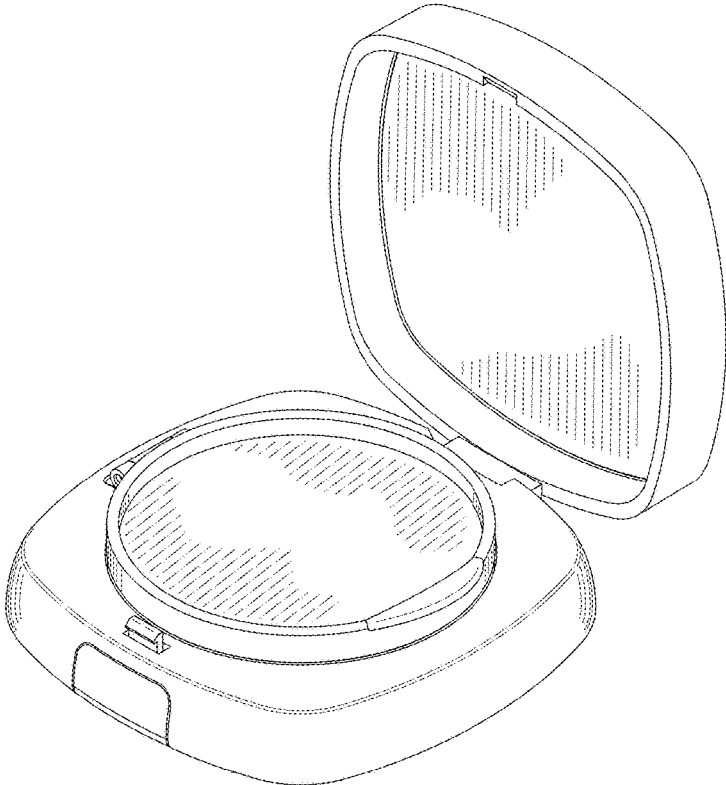

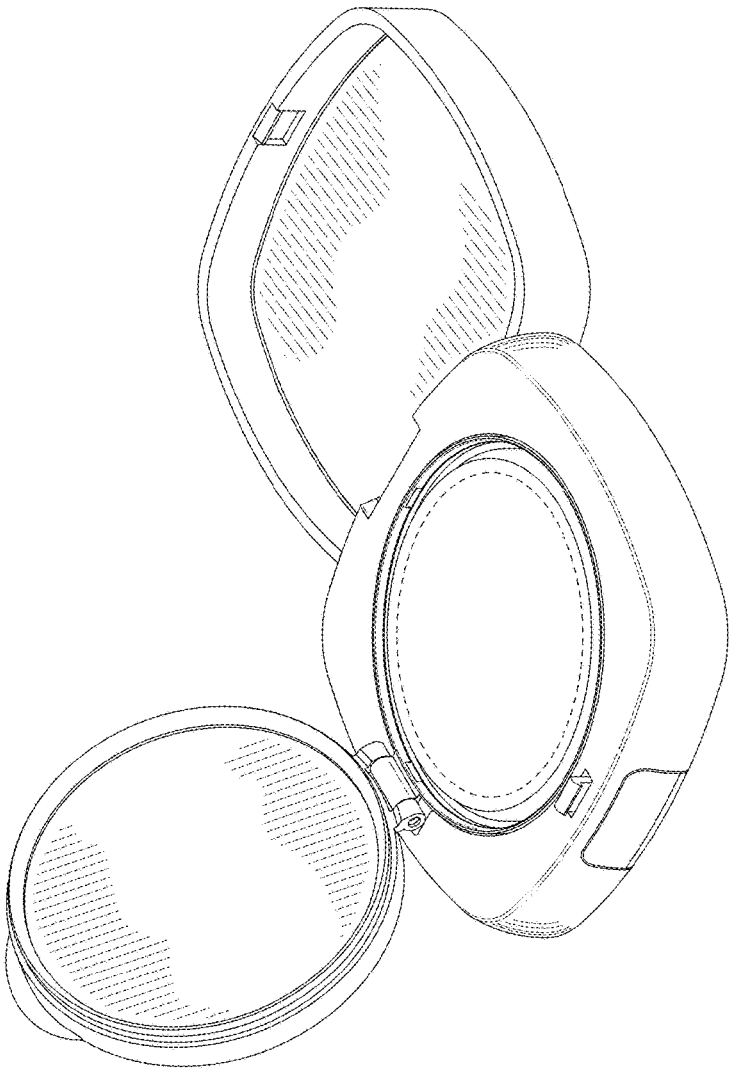

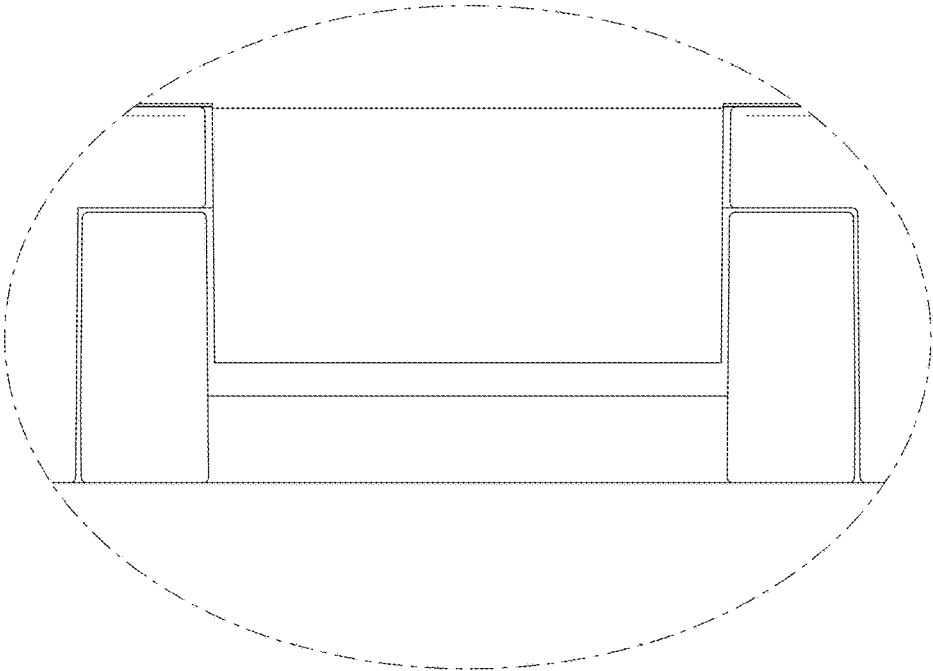
