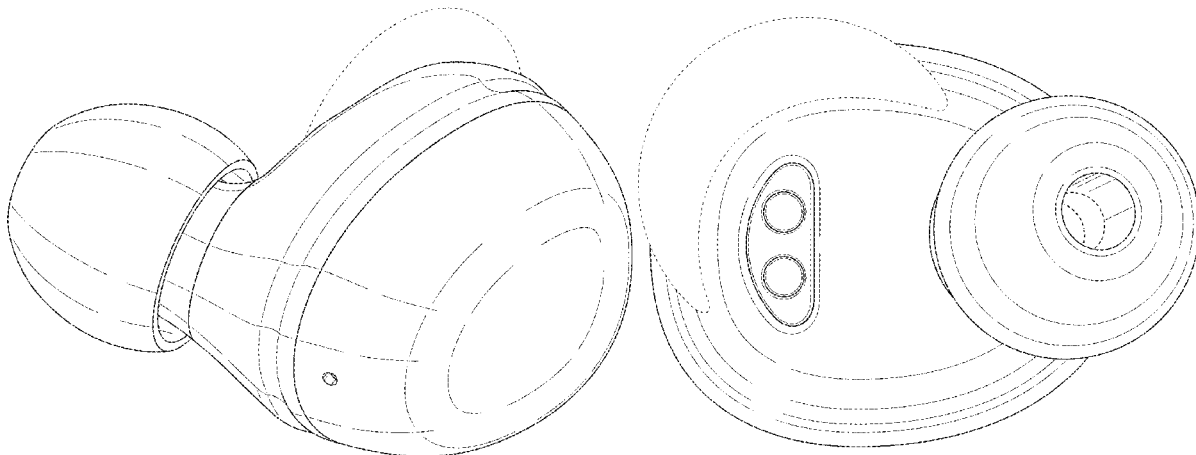
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front, top and left side of an earphone showing our new design;
FIG. 2 is a front view thereof;

FIG. 5 is a right side view thereof;

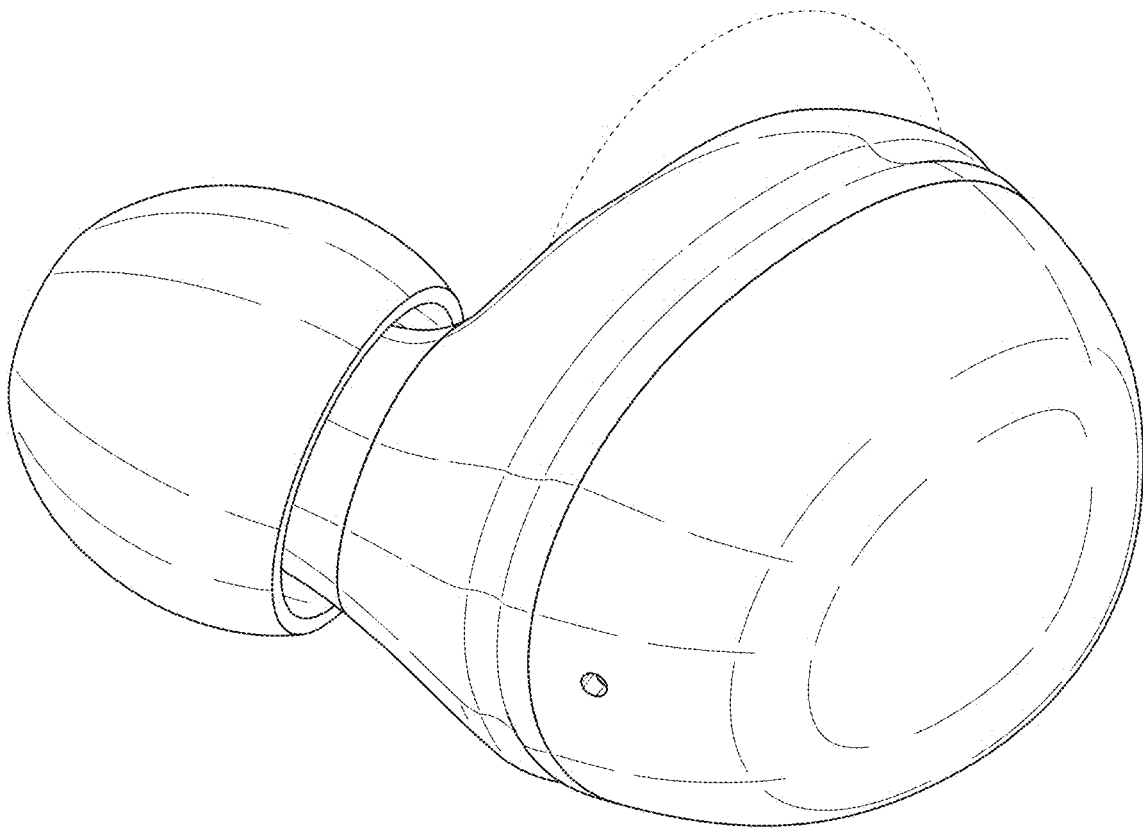

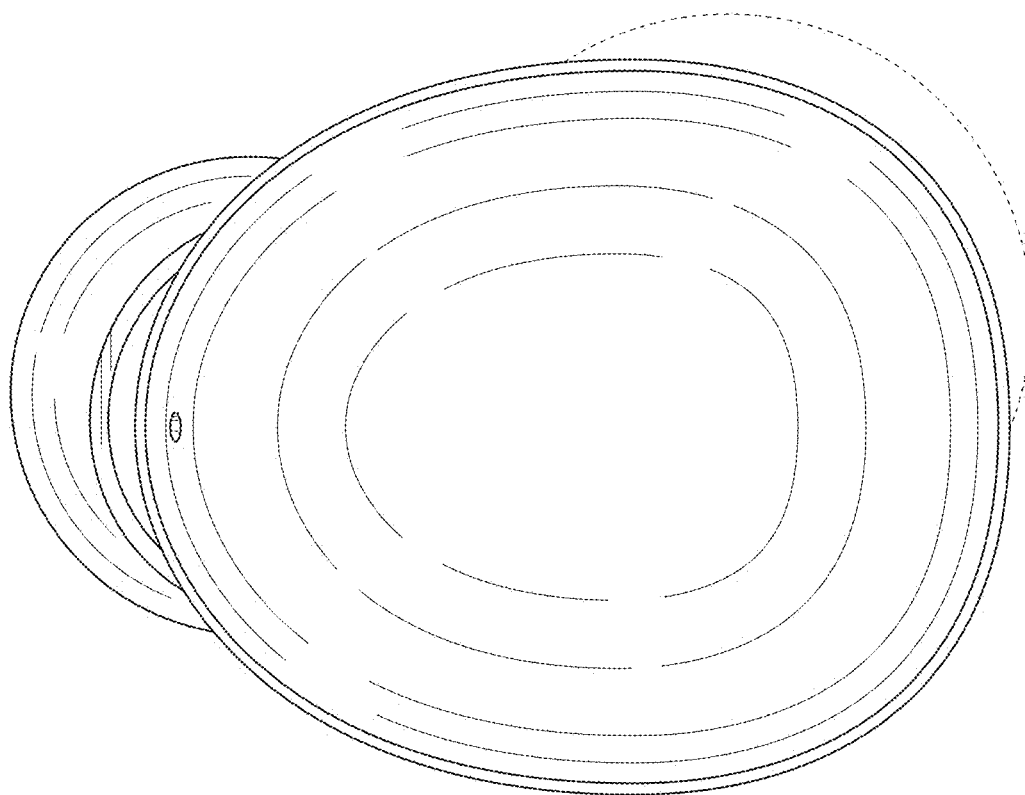

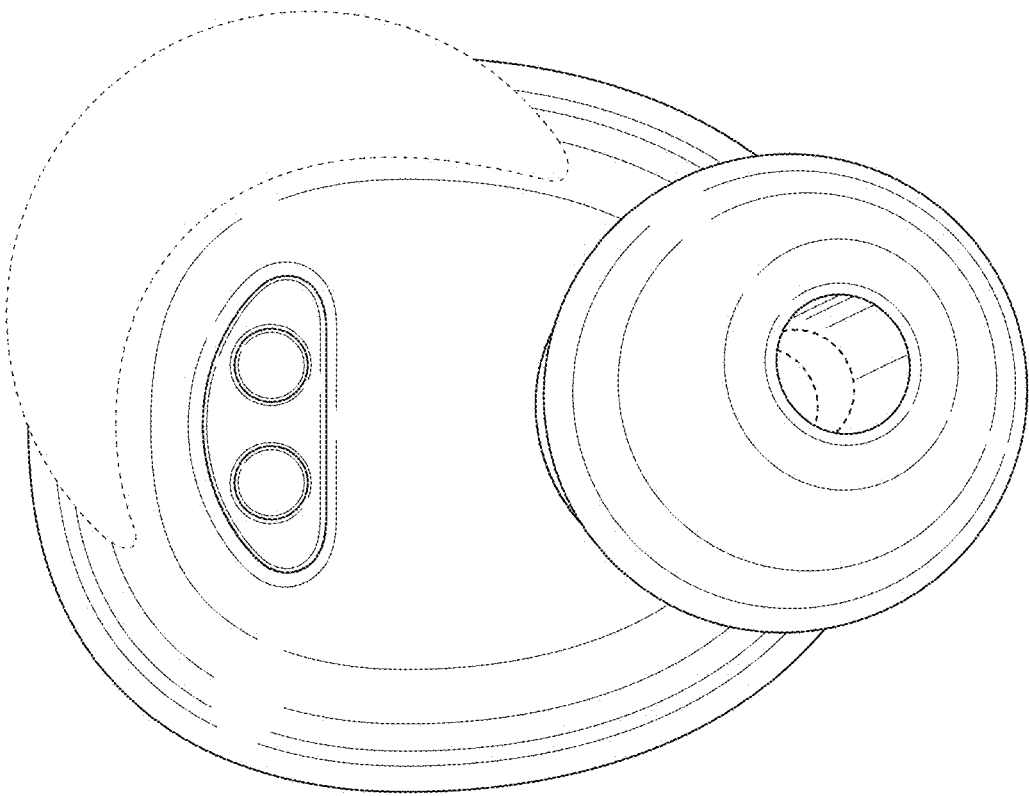

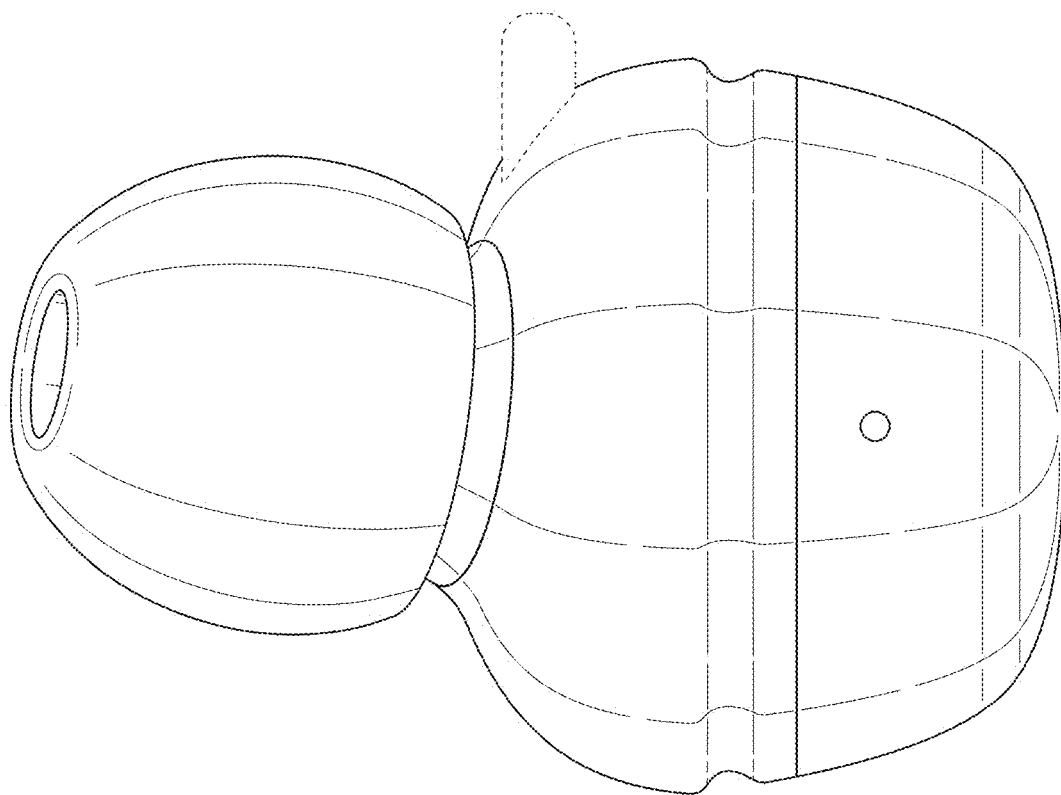

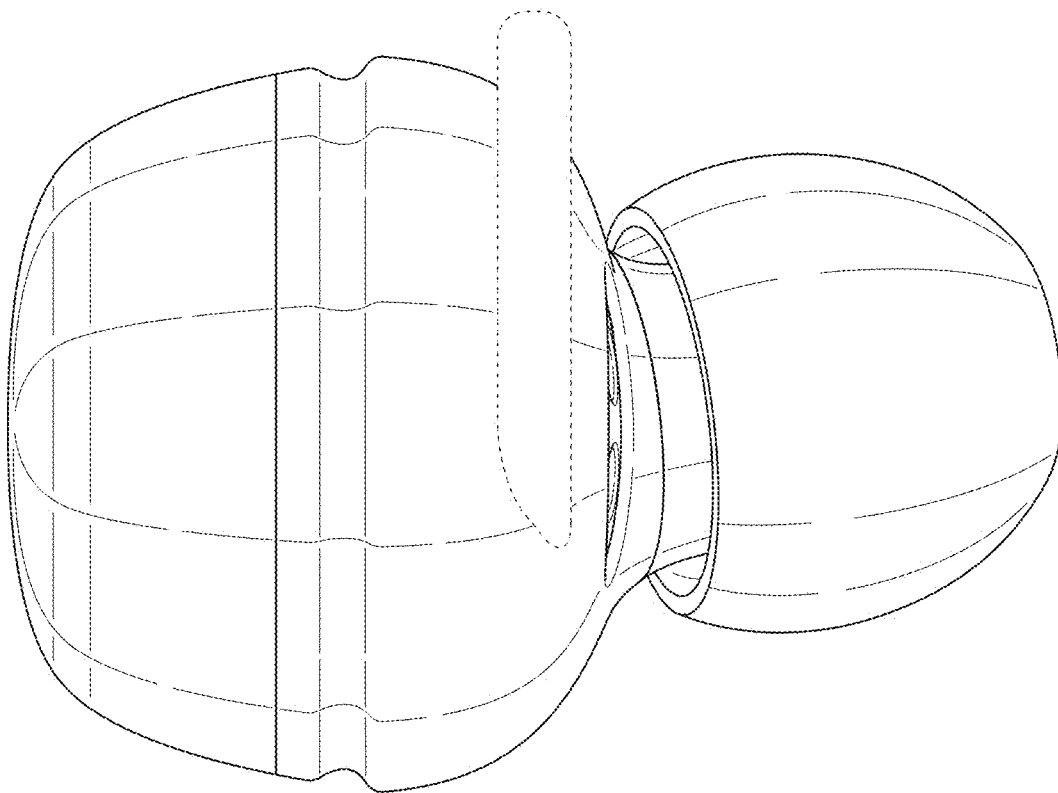

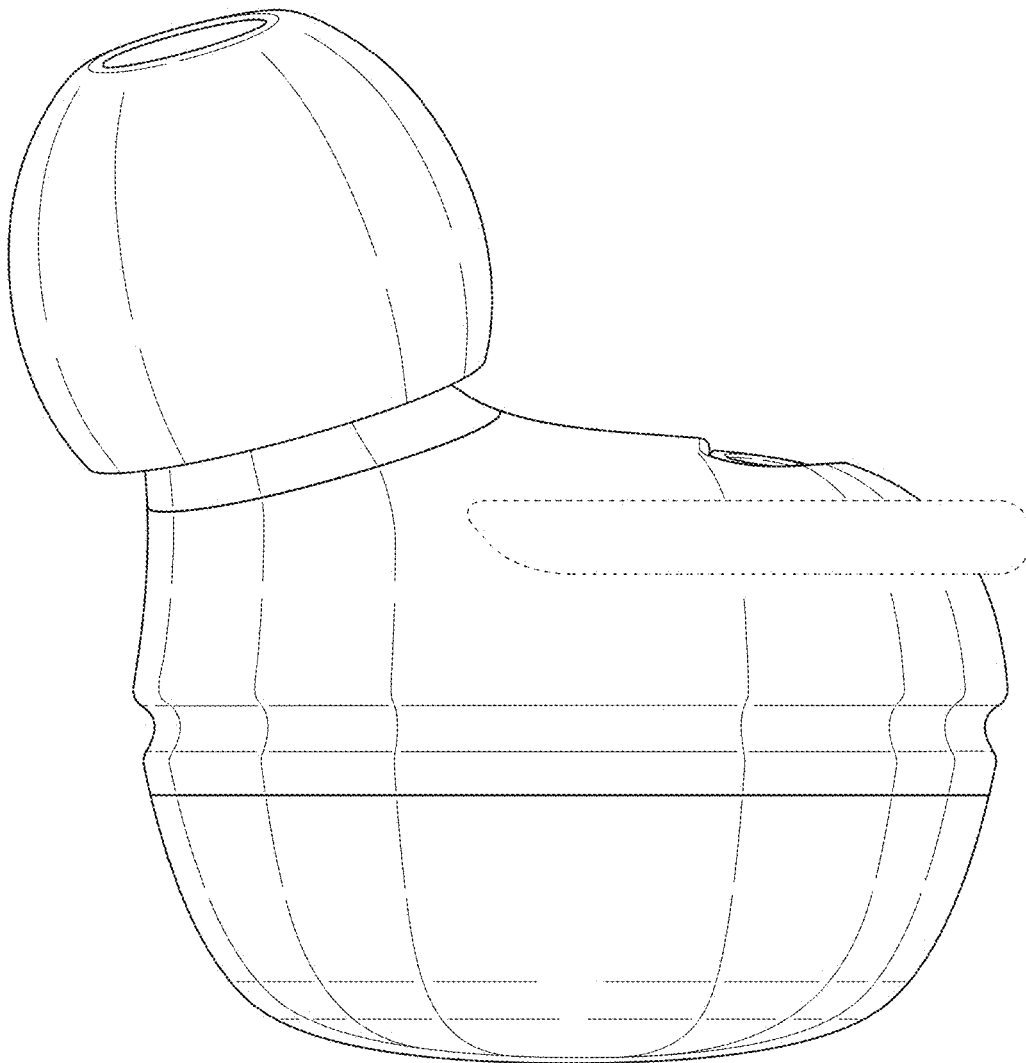
