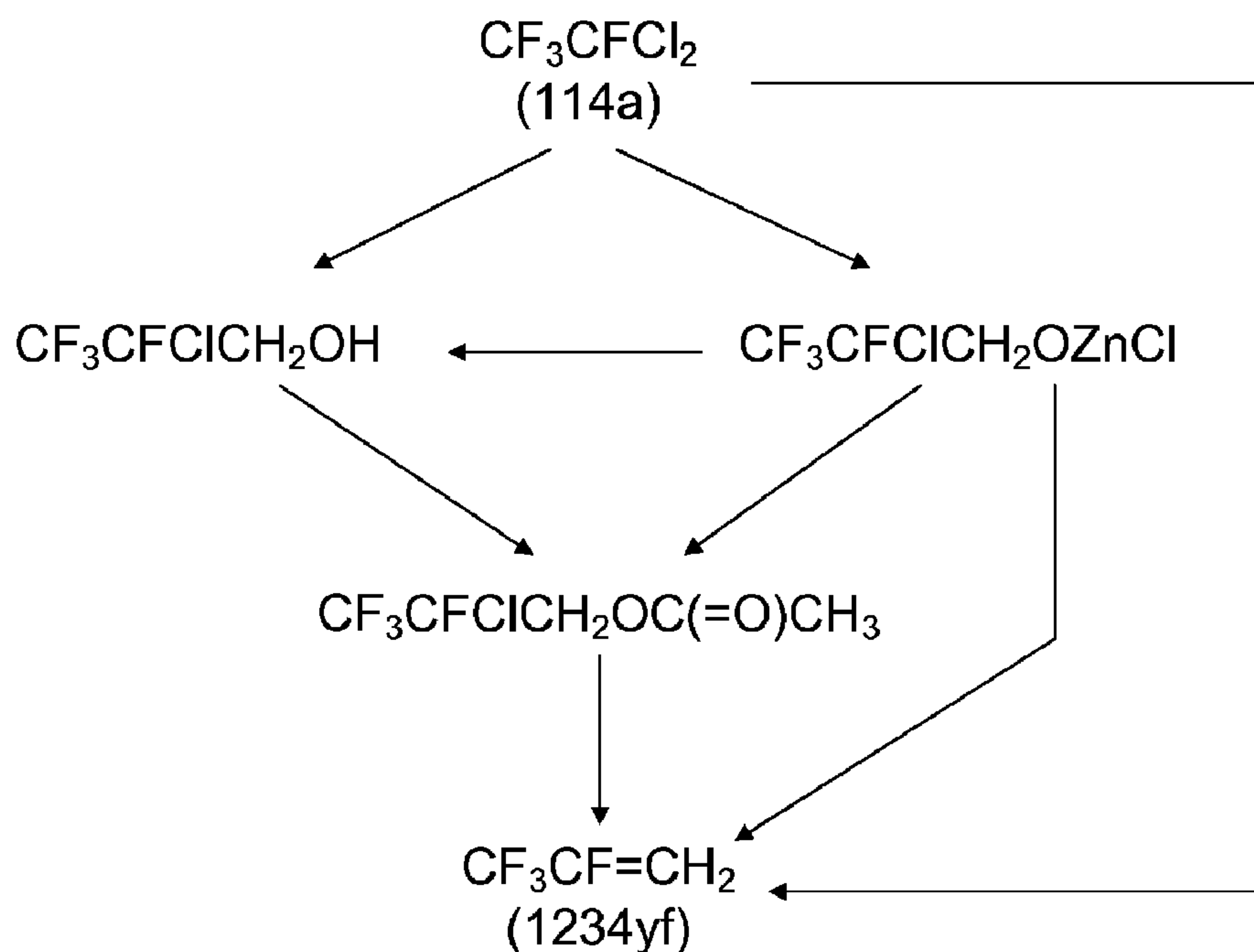

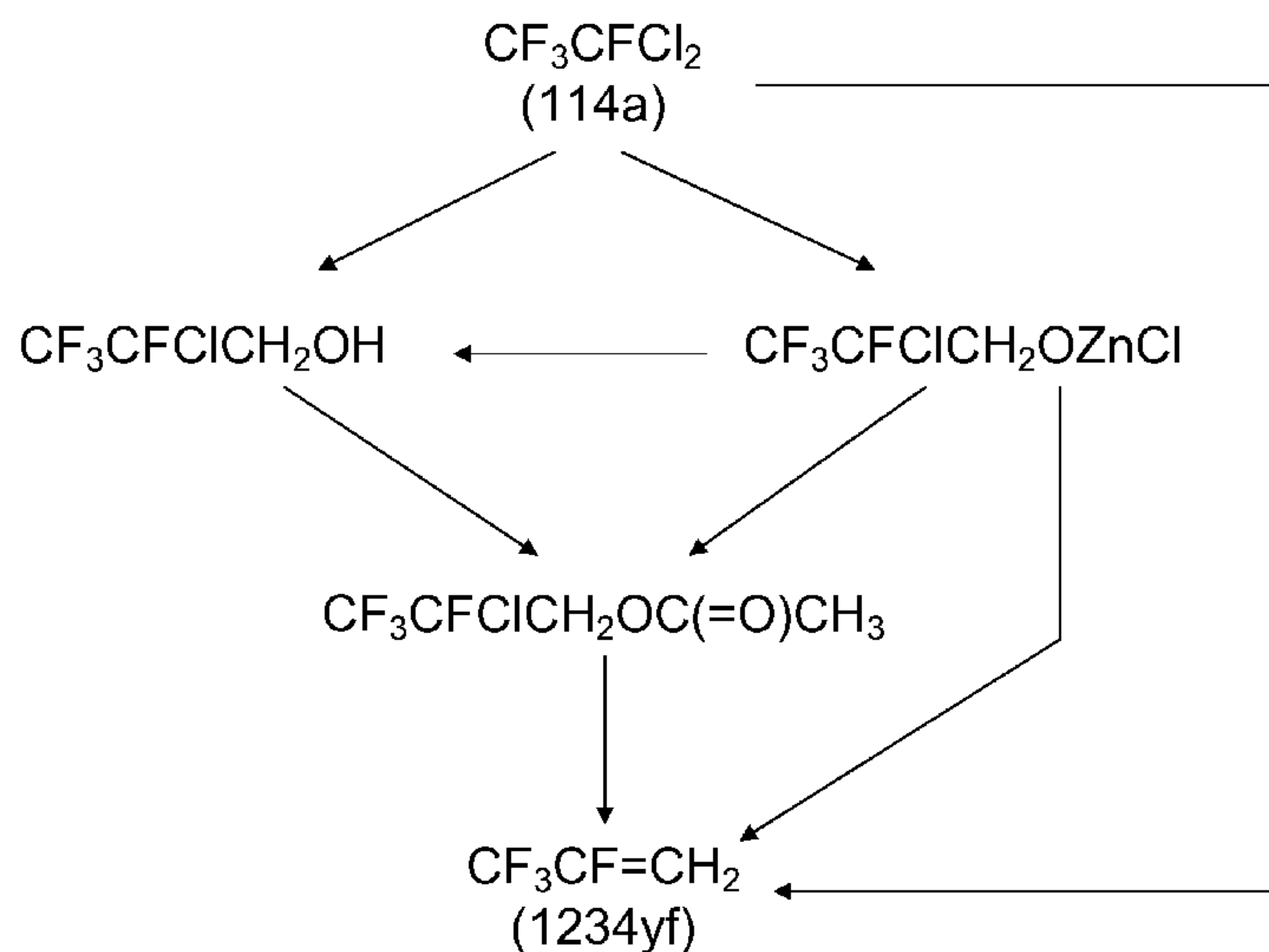

**BACKGROUND**

1. Field of the Disclosure.

The present disclosure relates to the field of compositions which  
may be useful as heat transfer compositions, aerosol propellants, foaming  
15 agents, blowing agents, solvents, cleaning agents, carrier fluids,  
displacement drying agents, buffing abrasion agents, polymerization  
media, expansion agents for polyolefins and polyurethane, gaseous  
dielectrics, extinguishing agents, and fire suppression agents, all of which  
may be in liquid or gaseous form. In particular, the present disclosure  
20 relates to compositions that may be useful as heat transfer compositions,  
such as 2,3,3,3-tetrafluoropropene (HFO-1234yf, or 1234yf). Additionally,  
the present disclosure relates to compositions comprising 2-chloro-2,3,3,3-  
tetrafluoropropanol, 2-chloro-2,3,3,3-tetrafluoropropyl acetate or zinc (2-  
chloro-2,3,3,3-tetrafluoropropoxy) chloride.

25 These additional compositions are useful in processes to make  
HFO-1234yf.

2. Description of Related Art.

New environmental regulations have led to the need for new  
compositions for use in refrigeration, air-conditioning and heat pump  
30 apparatus. Low global warming potential compounds are of particular  
interest.

**SUMMARY OF THE INVENTION**

Applicants have found that in preparing such new low global warming potential compounds, such as HFO-1234yf, that certain additional compounds are present in small amounts.

Therefore, in accordance with the present invention, in one embodiment there is provided a composition comprising HFO-1234yf and at least one additional compound selected from the group consisting of CFC-114a (2-dichloro-1,1,1,2-tetrafluoroethane,  $\text{CCl}_2\text{FCF}_3$ ), HCFC-124 (2-chloro-1,1,1,2-tetrafluoroethane,  $\text{CF}_3\text{CHFCl}$ ), HFC-143a (1,1,1-trifluoroethane,  $\text{CF}_3\text{CH}_3$ ), CFO-1113 (2-chloro-1,1,2-trifluoroethene,  $\text{CClF}=\text{CF}_2$ ), HFO-1123 (1,1,2-trifluoroethene,  $\text{CHF}=\text{CF}_2$ ), HFO-1132a (1,1-difluoroethene,  $\text{CH}_2=\text{CF}_2$ ), TFE (tetrafluoroethene,  $\text{CF}_2=\text{CF}_2$ ), HCFO-1122 (2-chloro-1,1-difluoroethene,  $\text{CHCl}=\text{CF}_2$ ), 3,4,4,4-tetrafluoro-2-butanone ( $\text{CH}_3\text{C}(=\text{O})\text{CHF}\text{CF}_3$ ), acetyl fluoride ( $\text{CH}_3\text{C}(=\text{O})\text{F}$ ), 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ), 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate ( $\text{CF}_3\text{CFClCH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), 1,3-bistrifluoromethyl-1,3-difluorocyclobutane ( $\text{C}_6\text{H}_4\text{F}_8$ ), 2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CHFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), dimethylformamide (DMF,  $\text{HCON}(\text{CH}_3)_2$ ), pyridine ( $\text{C}_5\text{H}_5\text{N}$ ), ethyl acetate, ( $\text{CHClF}\text{CF}_3$ ), acetic acid ( $\text{CH}_3\text{C}(=\text{O})\text{OH}$ ), diethyl ether ( $\text{CH}_3\text{CH}_2\text{OCH}_2\text{CH}_3$ ), acetic anhydride ( $\text{CH}_3\text{C}(=\text{O})\text{OC}(=\text{O})\text{CH}_3$ ), methyl acetate ( $\text{CH}_3\text{C}(=\text{O})\text{OCH}_3$ ), dimethylacetamide ( $\text{CH}_3\text{C}(=\text{O})\text{N}(\text{CH}_3)_2$ ), methanol ( $\text{CH}_3\text{OH}$ ), ethanol ( $\text{CH}_3\text{CH}_2\text{OH}$ ), methyl formate ( $\text{HC}(=\text{O})\text{OCH}_3$ ), pyrazine, pyrimidine, N-methylpyrrolidine, N-methylpiperidine, hexamethylphosphoramide, tetrahydrofuran, 1,4-dioxane, N-methyl pyrrolidinone, dimethyl sulfoxide, acetonitrile, benzonitrile, and mixtures thereof, meaning mixtures of any of the foregoing additional compounds listed in this paragraph.

In another embodiment is provided a composition comprising 2-chloro-3,3,3-trifluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), at least one solvent, and optionally at least one additional compound.

In another embodiment is provided a composition comprising 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent, and optionally at least one additional compound.



In another embodiment, is provided a composition comprising zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ), at least one solvent, and optionally at least one additional compound.

### **BRIEF DESCRIPTION OF THE DRAWINGS**

FIG. 1 is a schematic drawing showing different reactions for producing HFO-1234yf from CFC-114a.

### **DETAILED DESCRIPTION**

#### 10 **Compositions**

A process for making 2,3,3,3-tetrafluoropropene (HFO-1234yf,  $\text{CF}_3\text{CF}=\text{CH}_2$ ) from CFC-114a (or just 114a or  $\text{CF}_3\text{CFCl}_2$ ) is shown in FIG. 1. As can be seen from FIG. 1,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  and  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  are intermediate  
15 compounds which may be formed in this process.

Referring to FIG. 1, in one embodiment, CFC-114a may be reacted to form  $\text{CF}_3\text{CFClCH}_2\text{OH}$ , by treatment with activated zinc powder and paraformaldehyde. This reaction may be carried out in the liquid phase in the presence of a solvent.  $\text{CF}_3\text{CFClCH}_2\text{OH}$  may be reacted with a  
20 carboxylic acid anhydride (e.g. acetic anhydride) and a reactive metal (e.g. zinc) to form  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , which may further be reacted in solvent with a reactive metal, such as zinc, to produce HFO-1234yf. In one particular embodiment, the solvent may be a mixed solvent, such as DMF (dimethylformamide) and pyridine. However, it should be noted that  
25 the present invention is not limited to the use of these particular solvents, and a variety of solvents, such as those listed below, *infra*, will work with the present invention.

Alternatively, in another embodiment, as shown in FIG. 1, CFC-114a may be reacted with a reactive metal and an aldehyde to form  
30  $\text{CF}_3\text{CFClCH}_2\text{OZnCl}$ . This reaction may also be carried out in the liquid phase in the presence of a solvent. Again, in one particular embodiment, the solvent may be a mixed solvent, such as DMF (dimethylformamide) and pyridine, it being noted that a variety of solvents, such as those listed below, *infra*, will work with the present invention.  $\text{CF}_3\text{CFClCH}_2\text{OZnCl}$  may

be further reacted with a carboxylic acid anhydride (e.g. acetic anhydride) and a reactive metal (e.g., zinc) to form  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , which may further be reacted in solvent with a reactive metal, such as zinc, to produce HFO-1234yf. In yet another embodiment, all of the above  
 5 mentioned reactions may be carried out in multiple steps in a single reaction vessel wherein none of the intermediate compounds are isolated. This is indicated in FIG. 1 as a single arrow from CFC-114a to HFO-1234yf.

2,3,3,3-tetrafluoropropene (HFO-1234yf,  $\text{CF}_3\text{CF}=\text{CH}_2$ ), 2-chloro-  
 10 2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), and zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) may be prepared as described herein.

In one embodiment, the composition of the present invention  
 15 comprises HFO-1234yf and at least one additional compound selected from the group consisting of CFC-114a (2-dichloro-1,1,1,2-tetrafluoroethane,  $\text{CCl}_2\text{FCF}_3$ ), shown in Fig. 1, HCFC-124 (2-chloro-1,1,1,2-tetrafluoroethane,  $\text{CF}_3\text{CHFCl}$ ), HFC-143a (1,1,1-trifluoroethane,  $\text{CF}_3\text{CH}_3$ ), CFO-1113 (2-chloro-1,1,2-trifluoroethene,  $\text{CClF}=\text{CF}_2$ ), HFO-  
 20 1123 (1,1,2-trifluoroethene,  $\text{CHF}=\text{CF}_2$ ), HFO-1132a (1,1-difluoroethene,  $\text{CH}_2=\text{CF}_2$ ), TFE (tetrafluoroethene,  $\text{CF}_2=\text{CF}_2$ ), HCFO-1122 (2-chloro-1,1-difluoroethene,  $\text{CHCl}=\text{CF}_2$ ), 3,4,4,4-tetrafluoro-2-butanone ( $\text{CH}_3\text{C}(=\text{O})\text{CHFCH}_2\text{F}$ ), acetyl fluoride ( $\text{CH}_3\text{C}(=\text{O})\text{F}$ ), 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), shown in Fig. 1, 2-chloro-2,3,3,3-  
 25 tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), shown in Fig. 1, zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ), shown in Fig. 1, 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), 1,3-bistrifluoromethyl-1,3-difluorocyclobutane ( $\text{C}_4\text{H}_2\text{F}_6$ ), 2,3,3,3-tetrafluoropropyl acetate  
 30 ( $\text{CF}_3\text{CHFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), dimethylformamide (DMF,  $\text{HCON}(\text{CH}_3)_2$ ), pyridine ( $\text{C}_5\text{H}_5\text{N}$ ), ethyl acetate, ( $\text{CH}_3\text{COCH}_2\text{CH}_3$ ), acetic acid ( $\text{CH}_3\text{COOH}$ ), diethyl ether ( $\text{CH}_3\text{CH}_2\text{OCH}_2\text{CH}_3$ ), acetic anhydride ( $(\text{CH}_3\text{CO})_2\text{O}$ ), methyl acetate ( $\text{CH}_3\text{COOCH}_3$ ), dimethylacetamide ( $\text{CH}_3\text{CON}(\text{CH}_3)_2$ ), methanol ( $\text{CH}_3\text{OH}$ ), ethanol



CH<sub>3</sub>CH<sub>2</sub>OH), methyl formate (HC(=O)OCH<sub>3</sub>), pyrazine, pyrimidine, N-methylpyrrolidine, N-methylpiperidine, hexamethylphosphoramide, tetrahydrofuran, 1,4-dioxane, N-methyl pyrrolidinone, dimethyl sulfoxide, acetonitrile, benzonitrile, and mixtures thereof, meaning mixtures of any of  
5 the foregoing additional compounds listed in this paragraph. Any of the compositions of this embodiment as set forth in this paragraph will be referred to hereinafter as Composition A. These compositions can be either vapor phase or liquid phase compositions.

FIG. 1 is a representative illustration of the process for making the  
10 compositions of the present invention, and not all of the additional compounds listed in the paragraph above are shown in FIG. 1, it being understood that the composition of the present invention may include all of these additional compounds. The additional compounds listed here as potentially being in the composition comprising HFO-1234yf may be  
15 present in the starting materials or the solvent, or these additional compounds may be the reaction products of such additional compounds which are present in the starting materials, produced under the conditions of the reactions to make the HFO-1234yf.

The reaction chemistry described herein and illustrated in FIG. 1  
20 produces HFO-1234yf containing no detectable HFO-1234ze (1,3,3,3-tetrafluoropropene), i.e., it is “essentially free” of HFO-1234ze. By “essentially free of” is meant that the amount of HFO-1234ze present is essentially zero. The ability to detect the presence of any component depends upon the analytical method used and various other factors. In  
25 one embodiment, essentially free of HFO-1234ze means that the composition contains less than 10 parts per million (ppm) by weight HFO-1234ze. In another embodiment, essentially free of HFO-1234ze means that the composition contains less than 5 ppm by weight HFO-1234ze. In another embodiment, essentially free of HFO-1234ze means that the  
30 composition contains less than 1 ppm by weight HFO-1234ze.

In one embodiment, the total amount of additional compound(s) in the vapor phase of the composition comprising HFO-1234yf ranges from greater than zero weight percent to about 30 weight percent. In another embodiment, the total amount of additional compounds ranges from

greater than zero weight percent to about 20 weight percent. In another embodiment, the total amount of additional compound(s) ranges from greater than zero weight percent to about 10 weight percent. In another embodiment, the total amount of additional compound(s) ranges from  
5 greater than zero weight percent to about 5 weight percent.

In one embodiment, the total amount of additional compound(s) in the composition comprising HFO-1234yf ranges from greater than zero weight percent to less than 1 weight percent.

In some embodiments, certain precursor compounds to HFO-  
10 1234yf contain impurities that appear as the additional compounds in the HFO-1234yf compositions. In other embodiments, the additional compounds are formed by reaction of these precursor impurities. In other embodiments, the reaction conditions under which the HFO-1234yf is produced also produce by-products that then appear as the additional  
15 compounds in the HFO-1234yf compositions, by which is meant alternative reaction pathways may produce additional compounds depending upon the particular conditions under which the HFO-1234yf is produced.

In another particular embodiment, the composition of the present  
20 invention comprises HFO-1234yf and the following additional compounds: tetrafluoroethene, 1,1-difluoroethene, trifluoroethene, and 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124). A representative amount of impurities for this embodiment is about 80 weight % 1234yf, about 10 weight % HCFC-124 and the remainder being the tetrafluoroethene, 1,1-difluoroethene,  
25 trifluoroethene.

In another particular embodiment, the composition of the present invention comprises HFO-1234yf and the following additional compounds: 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), acetic anhydride, methyl acetate, DMF, and pyridine. In this embodiment, there is greater  
30 than 90 weight % 1234yf, about 2 weight % pyridine, and about 1 weight % or less of the remaining additional compounds.

In another particular embodiment, the composition of the present invention comprises HFO-1234yf and the following additional compounds: tetrafluoroethene (TFE), HFO-1123, 1,1,1-trifluoroethane (HFC-143a),



CFO-1113, HCFC-124, CFC-114a, 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane, methyl formate, acetic acid, and 2,3,3,3-tetrafluoropropyl acetate. In this embodiment, a representative amount of impurities is about 10 weight % or less of HFO-1123, HCFC-124, and 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane; and less than about 1 weight % of the remainder.

In another particular embodiment, the composition of the present invention comprises HFO-1234yf and the following additional compounds: HFO-1123, water, CFO-1113, 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane, methyl formate, and methyl acetate. In this embodiment, a representative amount of impurities is about 1 weight % or less of HFO-1123, water, CFO-1113, 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane, methyl formate, and methyl acetate.

In another embodiment, the present disclosure provides a composition comprising either 1) 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), or 2)  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ; or 3)  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ , and each including at least one solvent. The composition comprising 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) and at least one solvent shall be referred to hereinafter as Composition B. The composition comprising 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ) and at least one solvent shall be referred to hereinafter as Composition C. The composition comprising zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) and at least one solvent shall be referred to hereinafter as Composition D.

In one embodiment, the total amount of additional compound(s) in the compositions comprising  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , or  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  and at least one solvent ranges from greater than zero weight percent to about 50 weight percent based upon the total composition. In another embodiment, the total amount of additional compounds ranges from greater than zero weight percent to about 30 weight percent. In another embodiment, the total amount of additional compound(s) ranges from greater than zero weight percent to about 10 weight percent. In another embodiment, the total amount of additional



compound(s) ranges from greater than zero weight percent to about 5 weight percent. In another embodiment, the total amount of additional compound(s) ranges from greater than zero weight percent to about 1 weight percent.

5 In some embodiments, certain precursor compounds to  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , or  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  contain impurities that appear in the  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , or  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ . In other embodiments, the additional compounds are formed by reaction of these precursor impurities. In other embodiments,  
10 the reaction conditions under which the  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , or  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  is produced also produce by-products, by which is meant alternative reaction pathways may produce additional compounds depending upon the particular conditions under which the  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , or  
15  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  is produced. For these products as produced by the processes described herein, certain other compounds introduced by way of the solvent used to carry out the chemistry may be present in the compositions or may react to form other compounds that may be present in the compositions as well.

20 In one embodiment, the solvent is selected from the group consisting of alkyl, dialkyl, and trialkyl linear or cyclic amines, N-methylpyrrolidine, N-methylpiperidine, sulfoxides, ethers, pyridine or alkyl-substituted pyridines, pyrazine or pyrimidine, alkyl and aromatic nitriles, hexamethylphosphoramide, and mixtures thereof. In another  
25 embodiment, the solvent is selected from the group consisting of trialkylamines, N-methylpyrrolidine, N-methylpiperidine, pyridine, alkyl-substituted pyridines, dimethylformamide, pyrazine or pyrimidine, and mixtures thereof. In another embodiment, the reaction solvent is selected from the group consisting of dimethylformamide, tetrahydrofuran, pyridine,  
30 dimethylacetamide, 1,4-dioxane, N-methyl pyrrolidone, diethyl ether and mixtures thereof. In another embodiment, the solvent is pyridine or alkyl-substituted pyridines or mixtures thereof. In another embodiment, the solvent is selected from the group consisting of alcohols, esters, and mixtures thereof. In another embodiment, the solvent is selected from the

group consisting of methanol, ethanol, methyl formate, dimethyl sulfoxide, acetonitrile, benzonitrile and mixtures thereof, or mixtures of these with any of the aforementioned other solvents.

In one embodiment, the total amount of solvent present in the compositions comprising any of  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ , or  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , will vary depending upon various factors. If not enough solvent is provided not all of the reactant and/or product compounds will stay in solution. Additionally, if too much solvent is used, the rate of reaction will be slow. In one embodiment, the solvent will be present in an amount of at least about 90 weight percent of the composition. In another embodiment, the solvent will be present in the compositions in an amount of at least 50 weight percent of the composition. In another embodiment, the solvent will be present in the compositions in an amount of at least about 30 weight percent of the composition. In yet another embodiment the solvent will be present in an amount of at least about 20 weight percent.

In another embodiment, the composition comprising  $\text{CF}_3\text{CClFCH}_2\text{OH}$  and at least one solvent may further comprise at least one additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, dimethylacetamide, methanol, methyl acetate, methyl formate, dimethylformamide, pyridine, ethyl acetate, acetic acid, diethyl ether,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate, and mixtures thereof meaning mixtures of any of the foregoing additional compounds listed in this paragraph. It is noted that not all of the compounds listed here are shown in FIG. 1, since FIG. 1 is meant to be a representative illustration of the processes to make the compositions of the present invention. It is believed that these compounds arise as impurities in the starting materials, impurities in the solvent, or either of these types of impurities that have reacted to form other compounds under the reaction conditions used to produce the  $\text{CF}_3\text{CClFCH}_2\text{OH}$ . The compositions of this embodiment as described in this paragraph will be referred to hereinafter as Compositions B(1).



In one particular embodiment, the composition comprises 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) and at least one solvent comprising dimethylformamide and further comprises HCFC-124 and methanol as the additional compounds. In this embodiment, the solvent,  
 5 DMF, may be present at about 80 weight % or higher. The HCFC-124 may be at about 8 weight % or less and the methanol maybe less than about 1 weight %.

In another particular embodiment, the composition comprising 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) and at least one  
 10 solvent comprising pyridine, and further comprises 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124), methyl formate, chlorotrifluoroethene (CFO-1113), trifluoroethene (HFO-1123) and methanol as the additional compounds. In this embodiment, the pyridine solvent is present at about 80 weight % or more, HCFC-124 is present at about 3 weight % or less  
 15 and the other additional compounds are each at about 1 weight % or less.

In another particular embodiment, the composition comprising 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) and at least one solvent comprising dimethylacetamide and further comprises 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124), methyl formate,  
 20 chlorotrifluoroethene (CFO-1113), and trifluoroethene (HFO-1123), and methanol as the additional compounds. A representative amount of the additional compounds for this embodiment is about 2-3 weight % each of HCFC-124 and CFO-1113 and about 1 weight % or less of the remaining compounds.

25 In another embodiment, the composition comprising  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  and at least one solvent may further comprise at least one additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, methanol, methyl acetate, methyl formate,  
 30 dimethylacetamide, dimethylformamide, pyridine, ethyl acetate, acetic acid, diethyl ether, acetic anhydride, formaldehyde, 3-chloro-3,4,4,4-trifluoro-2-butanone, 2,3,3,3-tetrafluoropropyl acetate,  $\text{CF}_3\text{CClFCH}_2\text{OCH}(=\text{O})$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ , and mixtures thereof, meaning



mixtures of any of the foregoing additional compounds listed in this paragraph. The composition of the present invention as described in this paragraph will be referred to hereinafter as Composition C(1). Again, it is noted that not all of the compounds listed here are shown in FIG. 1. It is  
5 believed that these compounds arise as impurities in the starting materials, impurities in the solvent, or either of these types of impurities that have reacted to form other compounds under the reaction conditions used to produce the  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ .

In one particular embodiment where the composition of the present  
10 invention comprises 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent comprising diethyl ether and additional compounds, the additional compounds comprise 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), ethyl acetate, and acetic acid. A representative amount of the additional compounds for this  
15 embodiment is about 17 weight % acetic acid, about 3 weight % ethyl acetate, and less than about 1 weight % 2-chloro-2,3,3,3-tetrafluoropropanol, all of which are relative to the amount of the 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ) in the composition.

20 In one other particular embodiment where the composition of the present invention comprises 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent which is DMF and pyridine and additional compounds, the additional compounds comprise 2-chloro-2,3,3,3-tetrafluoropropyl formate ( $\text{CF}_3\text{CClFCH}_2\text{OCH}(=\text{O})$ ), 2-chloro-  
25 2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) acetic anhydride and acetic acid. In this embodiment, the solvent is a mixture of and DMF and pyridine. A representative amount of the additional compounds for this embodiment is about 3 weight % or less for all the additional compounds.

In one particular embodiment where the composition of the present  
30 invention comprises 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent, which is DMF and pyridine, and additional compounds, the additional compounds comprise TFE, HCFC-124, 3-chloro-3,4,4,4-trifluoro-2-butanone ( $\text{CF}_3\text{CClFCH}_2\text{C}(=\text{O})\text{CH}_3$ ), ethyl methyl ether, and methyl acetate, all in the

liquid phase. In this embodiment, the solvent is a mixture of DMF and pyridine. A representative amount of the additional compounds for this embodiment is about 85 weight % 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), about 6 weight % of 2-chloro-1,1,1,2-tetrafluoro ethane (HCFC-124), about 2.5 weight % 3-chloro-3,4,4,4-trifluoro-2-butanone ( $\text{CF}_3\text{CClFCH}_2\text{C}(=\text{O})\text{CH}_3$ ), about 2.5 weight % unknowns, and less than 1 weight % each of TFE, ethyl methyl ether and methyl acetate.

In another particular embodiment, where the composition of the present invention comprises 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent, which in this case is a mixture of DMF and pyridine, and additional compounds, the additional compounds comprise HFO-1123, HFO-1234yf, water, formaldehyde, HCFC-124, CFC-114a, methyl acetate, methyl formate, 3-chloro-3,4,4,4-tetrafluoro-2-butanone, 2,3,3,3-tetrafluoropropyl acetate, 2-chloro-2,3,3,3-tetrafluoropropanol, acetic anhydride, and 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate. A representative amount of the additional compounds for this embodiment is about 6-8 weight % each of HCFC-124, and 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate: about 1-4 weight % each of water, CFC-114a, 3-chloro-3,4,4,4-tetrafluoro-2-butanone, 2-chloro-2,3,3,3-tetrafluoropropanol, and acetic anyhydride; and less than about 1 weight % of the remainder.

In another particular embodiment, where the composition of the present invention comprises 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), at least one solvent, which is DMF and pyridine, and additional compounds, the additional compounds comprise HCFC-124, CFC-114a, methyl acetate, ethyl formate, methyl formate, acetic acid, 3-chloro-3,4,4,4-tetrafluoro-2-butanone, 2-chloro-2,3,3,3-tetrafluoropropanol, acetic anyhydride, and 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate. A representative amount of the additional compounds for this embodiment is about 7-8 weight % of 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate; about 3 weight % of HCFC-124; and less than about 2 weight % of the remainder.



In another embodiment, the composition comprising  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  and at least one solvent may further comprise at least one additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, methanol, methyl acetate, methyl formate, dimethylacetamide, dimethylformamide, pyridine, ethyl acetate, acetic acid, diethyl ether, formaldehyde, trifluoroacetaldehyde,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate ( $\text{CF}_3\text{CFCICH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), and mixtures thereof, meaning mixtures of any of the foregoing additional compounds listed in this paragraph. The composition of the present invention as described in this paragraph will be referred to hereinafter as Composition D(1). Again, it is noted that not all of the compounds listed here are shown in FIG. 1. It is believed that these compounds arise as impurities in the starting materials, impurities in the solvent, or either of these types of impurities that have reacted to form other compounds under the reaction conditions used to produce the  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ .

In one particular embodiment, the composition comprising zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) and at least one solvent comprising pyridine further comprises 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124), methyl formate, methanol and trifluoroethene (HFO-1123) as the additional compounds. In this embodiment, the solvent is pyridine. In this particular embodiment, the composition comprises about 80 weight % or more of solvent, that being pyridine, about 12 weight % or more zinc (2-chloro-2,3,3,3-tetrafluoropropoxide) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) about 3 weight % HCFC-124, and 1 weight % or less of the remaining components, those being methyl formate, methanol, and HFO-1123.

In another particular embodiment, the composition comprising zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) and at least one solvent comprising a mixture of DMF and pyridine further comprises tetrafluoroethene, acetic acid, methyl formate, methyl acetate, HCFC-124, HFO-1234yf, and 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ) as additional compounds. In this particular



embodiment, the HCFC-124,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , and the HFO-1234yf are each present at about 3-5 weight % relative to the  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ .

In another particular embodiment, the composition comprising zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) and at least one solvent comprising a mixture of DMF and pyridine further comprises HFO-1123, trifluoroacetaldehyde, formaldehyde, HCFC-124, CFC-114a, methanol, methyl formate, and 2-chloro-2,3,3,3-tetrafluoropropyl acetate as additional compounds. In this embodiment, the HCFC-124 is present at about 13 weight % or less relative to the amount of zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ), and the remaining additional compounds are present at 1 weight % or less.

In another particular embodiment, the composition comprising zinc(2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) and at least one solvent comprising a mixture of DMF and pyridine further comprises HFO-1123, trifluoroacetaldehyde, HFO-1234yf, formaldehyde, HCFC-124, CFC-114a, methanol, dimethyl ether, methyl formate, ethyl formate, 2-chloro-2,3,3,3-tetrafluoropropyl acetate, and acetic anhydride as additional compounds. In this embodiment, the HCFC-124 was present at about 8 weight %, and the other additional compounds were each present at about 2 weight % or less.

Certain components of the disclosed compositions are commercially available, such as for instance the solvents. Other components may be prepared by methods known in the art. HFO-1234yf,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  and  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  may be prepared as described herein below.

The compositions as disclosed herein may be prepared by the reaction chemistry described below.

### Reaction chemistry

Before addressing details of embodiments described below, some terms are defined or clarified.

As used herein, formaldehyde refers to the compound having the structure  $\text{H}_2\text{C}=\text{O}$ , which is also known to occur in the form of a cyclic trimer 1,3,5-trioxane, and also as paraformaldehyde or polyoxymethylene (sometimes shown as  $(\text{H}_2\text{C}=\text{O})_n$ ).

5 As used herein, reactive metal refers to reactive metals such as magnesium turnings, activated zinc powder, aluminum, and a powder of any of the following metals: magnesium, calcium, titanium, iron, cobalt, nickel, copper, zinc and indium, and also zinc(II) salts. Magnesium turnings are pieces of magnesium which are cut to produce small pieces  
10 with higher surface areas and generally low amounts of surface oxides (which reduce reactivity). The reactive metal powders of magnesium, calcium, titanium, iron, cobalt, nickel, copper, zinc and indium are Rieke metals, which are prepared by a specific procedure which produces high surface area metal powders which are very reactive in reactions such as  
15 those of the present invention. Without wishing to be bound by any particular theory, Rieke metals are thought to be highly reactive because they have high surface areas and lack passivating surface oxides.

As used herein, a dehydrating agent is a gas or gaseous mixture containing at least one gas selected from the group consisting of:  
20 methane, ethane, propane, butane, natural gas, alcohols, aldehydes, and carbon monoxide. As used herein, natural gas refers to a gaseous mixture having methane as the major component, but also comprising quantities of ethane, butane, propane, carbon dioxide, nitrogen.

As used herein dehydroxychlorinating refers to removing a hydroxyl  
25 group and a chlorine atom from adjacent carbon atoms of a hydrofluoroalkanol to form a hydrofluoroalkene.

In one embodiment, 2-chloro-1,1,1,2-tetrafluoro-propanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) may be prepared by reaction of a CFC-114a with an aldehyde, and a reactive metal in a reaction solvent, thus producing 2-  
30 chloro-1,1,1,2-tetrafluoro-propanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) and a solvent. The method as described in this paragraph produces Composition B as described above.

Alternatively, CFC-114a is reacted with an aldehyde, and a reactive metal in a reaction solvent to generate a composition a metal



hydrofluoroalkoxide,  $\text{CF}_3\text{CFCICH}_2\text{OZnCl}$  and a solvent. The method as described in this paragraph produces Composition D as described above.

The metal hydrofluoroalkoxide may be neutralized to provide a hydrofluoroalkanol,  $\text{CF}_3\text{CCIFCH}_2\text{OH}$ , which can be isolated. The  
5 neutralization may comprise dilution with an organic solvent, and reaction with a dilute aqueous solution of an acid, including without limitation dilute aqueous hydrochloric acid or dilute aqueous sulfuric acid. Upon separation of the organic solvent phase from the aqueous phase, the organic solvent phase is washed further with an aqueous salt solution.  
10 The organic solvent phase is then dried and the solvent removed by evaporation or distillation to provide the hydrofluoroalkanol product.

Additionally, the metal hydrofluoroalkoxide,  $\text{CF}_3\text{CCIFCH}_2\text{OZnCl}$ , may be used in further reactions as described later to produce a hydrofluoroalkene, HFO-1234yf, without neutralization. The method as  
15 described in this paragraph produces Composition A as described above.

In addition to the reactive metal, (i.e., just the zinc), a metal salt may be added to the mixture comprising the reaction of the CFC-114a. Suitable zinc salts include zinc acetate, zinc bromide, zinc chloride, zinc citrate, zinc sulfate and mixtures thereof. In one embodiment, the zinc salt  
20 is zinc acetate. The amount of zinc salt added may be from 0.1 to 1.0 mole per mole of CFC-114a. The aldehyde for reaction with CFC-114a may be selected from the group consisting of formaldehyde, acetaldehyde, propionaldehyde, butyraldehyde and isobutyraldehyde. The mole ratio of reactive metal to CFC-114a is from about 1:1 to about 2.5:1. The mole  
25 ratio of aldehyde to CFC-114a is from about 1:1 to about 3:1.

In some embodiments, wherein paraformaldehyde is used as the aldehyde, a quaternary ammonium salt is added to the reaction. In one embodiment, the quaternary ammonium salt is a bis-alkyldimethyl ammonium acetate. Without wishing to be bound by any particular theory,  
30 such quaternary ammonium salts are believed to promote the decomposition of paraformaldehyde to formaldehyde. In some embodiments the amount of quaternary ammonium salt added is from about 1 weight % to about 20 weight % by weight of the amount of paraformaldehyde. In other embodiments, the amount of quaternary



ammonium salt added is from about 5 weight % to about 10 weight % by weight of the amount of paraformaldehyde.

The reaction of CFC-114a with an aldehyde and reactive metal is conducted in a reaction solvent. The reaction solvent may be selected from the group consisting of alkyl, dialkyl, and trialkyl linear or cyclic amines, N-methylpyrrolidine, N-methylpiperidine, sulfoxides, ethers, pyridine or alkyl-substituted pyridines, pyrazine or pyrimidine, alkyl and aromatic nitriles, hexamethylphosphoramide, and mixtures thereof. In another embodiment, the solvent is selected from the group consisting of trialkylamines, N-methylpyrrolidine, N-methylpiperidine, pyridine, alkyl-substituted pyridines, dimethylformamide, pyrazine or pyrimidine, and mixtures thereof. In another embodiment, the reaction solvent is selected from the group consisting of dimethylformamide, tetrahydrofuran, pyridine, dimethylacetamide, 1,4-dioxane, N-methyl pyrrolidone, diethyl ether and mixtures thereof. In another embodiment, the solvent is pyridine or alkyl-substituted pyridines or mixtures thereof. In another embodiment, the solvent is selected from the group consisting of alcohols, esters, and mixtures thereof. In another embodiment, the solvent is selected from the group consisting of methanol, ethanol, methyl formate, dimethyl sulfoxide, acetonitrile, benzonitrile and mixtures thereof, or mixtures of these with any of the aforementioned other solvents.

The amount of water present in the reaction of CFC-114a with an aldehyde and reactive metal may be less than 1000 ppm. The reaction of CFC-114a with an aldehyde and reactive metal is performed at a temperature of from about 30°C to about 100°C, and the reaction is conducted for from about 3 to about 10 hours. The aldehyde may be pre-treated with the reaction solvent for a period of time before the reaction. For instance, paraformaldehyde is pre-treated in pyridine for four hours at 60°C prior to reaction with CFC-114a and reactive metal. The pre-treatment may occur for two to six hours or there may be no pre-treatment, and the reaction may be commenced upon charging all of the reactants and reaction solvent to the reaction vessel sequentially.

The reaction of CFC-114a with an aldehyde and reactive metal may be performed in a closed vessel or other reactor. The reaction may be

performed under autogenous pressure. Alternatively, the reaction of CFC-114a with an aldehyde and reactive metal may be performed in an open vessel or reactor, equipped with a suitable condenser to prevent escape of unreacted CFC-114a.

5           Another process for the manufacture of HFO-1234yf comprises reacting CFC-114a with an aldehyde and zinc metal to generate  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  and then reductively dehydrochlorinating  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  in a second step to produce HFO-1234yf. The process for producing HFO-1234yf may comprise neutralizing  
10  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  to produce  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ; mixing a dehydrating agent with  $\text{CF}_3\text{CClFCH}_2\text{OH}$ , thereby forming a gaseous mixture; and contacting a catalyst with the gaseous mixture, thereby forming HFO-1234yf. The gaseous mixture is a mixture of the dehydrating agent and hydrofluoroalkanol, mixed in the gas phase.

15           The reaction product of CFC-114a, an aldehyde and a reactive metal may be neutralized by diluting the reaction product mixture with a mixture of a solvent, ice, and an aqueous solution of an acid. The solvent can be any commonly used organic solvent, such as diethyl ether. The aqueous solution of an acid may be an aqueous solution of a common  
20 mineral acid, such as hydrochloric acid. After stirring the resulting mixture for a period of time, the layer comprising the organic solvent is separated. The organic solvent layer can be subsequently washed with a dilute aqueous solution of an acid, followed by a brine solution. The organic layer is then dried. The drying is accomplished by stirring the organic  
25 layer over an anhydrous salt, such as anhydrous magnesium sulfate or anhydrous sodium sulfate. The organic solvent may then be evaporated to afford  $\text{CF}_3\text{CClFCH}_2\text{OH}$ .

          The catalyst is at least one transition metal. The metal is selected from the group consisting of: Ni, Pd, and Pt. In one embodiment, the  
30 catalyst is a supported catalyst which comprises a transition metal and a support material. The support material is at least one selected from the group consisting of activated carbon and  $\gamma$ -alumina.



The dehydrating agent is at least one gas selected from the group consisting of: methane, ethane, propane, butane, natural gas, alcohols, aldehydes, and carbon monoxide.

5 The mixing step takes place at a temperature in the range between about 65-80°C.

The gaseous mixture may be preheated prior to the contacting step. The preheating takes place at a temperature in the range between about 250 to about 450°C.

10 The contacting step preferably takes place at a temperature in the range between about 400 to about 700°C. The contacting step also preferably takes place for between about 20 to about 25 seconds.

Residual HF contained in the HFO-1234yf product may then be neutralized, wherein the HF is neutralized by passing the HFO-1234yf product through a KOH solution. Alternatively, HF may be removed from  
15 the HFO-1234yf product by some other method known in the art, including for instance azeotropic distillation.

The gaseous mixture may further comprise at least one diluent inert gas selected from the group consisting of: nitrogen, helium, and argon.

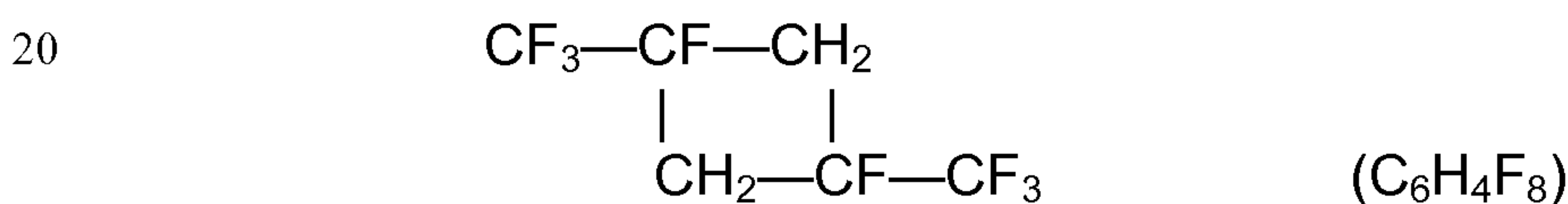
20 The conversion of the  $\text{CF}_3\text{CClFCH}_2\text{OH}$  to HFO-1234yf is in the range between about 50 to about 100%. The selectivity of  $\text{CF}_3\text{CClFCH}_2\text{OH}$  to HFO-1234yf is in the range between about 29 to about 100%.

The pressure during the contacting step is in the range between about 1 to about 100 psig.

25 The reductive dehydroxychlorination may be carried out by reacting the  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ , described earlier as Composition D, or  $\text{CF}_3\text{CClFCH}_2\text{OH}$ , described earlier as Composition B, with a carboxylic acid anhydride and a reactive metal in a reaction solvent to form a hydrofluoroalkene. Either of  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  or  $\text{CF}_3\text{CClFCH}_2\text{OH}$  will  
30 react with the acid anhydride to produce an ester,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , which is then reduced by the reactive metal to produce HFO-1234yf. This 1234yf composition contains additional compounds as described earlier as Composition A.

This reaction may be run as described with addition of both reagents in the same reaction vessel or the acid anhydride may be added alone to produce  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , which may be isolated. And then the reactive metal may be added to the  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  to produce the HFO-1234yf. In this process the carboxylic acid anhydride is selected from the group consisting of acetic anhydride, propionic anhydride, butyric anhydride, succinic anhydride, glutaric anhydride, and adipic anhydride. The reactive metal powder is as described previously herein. The reductive dehydroxychlorination can be done without neutralizing the product mixture from the reaction of CFC-114a with zinc and an aldehyde. Or the reductive dehydroxychlorination may be done after first isolating the  $\text{CF}_3\text{CClFCH}_2\text{OH}$ , and then esterification by reaction with a carboxylic acid anhydride and a reactive metal to form  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ . Any of these dehydroxychlorinations produce Composition C as described above.

In some embodiments, the product of the reductive dehydroxychlorination is HFO-1234yf as described above, which further comprises 1,3-bistrifluoromethyl-1,3-difluorocyclobutane, a substituted cyclobutane of the formula:



This compounds may also be represented by the formula:  
 cyclo-(-CH<sub>2</sub>(CF<sub>3</sub>)CFCH<sub>2</sub>(CF<sub>3</sub>)CF-)-.

The carboxylic acid anhydride may be acetic anhydride. The mole ratio of acetic anhydride to  $\text{CF}_3\text{CClFCH}_2\text{OH}$  is from about 1:1 to about 2:1. The mole ratio of reactive metal to  $\text{CF}_3\text{CClFCH}_2\text{OH}$  is from about 1:1 to about 2.5:1. The reductive dehydroxychlorination may be conducted in a reaction solvent which is the same solvent that the reaction of CFC-114a with reactive metal and an aldehyde is conducted in or a different solvent.

The reaction chemistry disclosed herein that produces the compositions disclosed herein is particularly useful in producing HFO-1234yf without producing HFO-1234ze (1,3,3,3-tetrafluoropropene, E- or Z- isomer). This results in a product, HFO-1234yf, which is essentially



free of HFO-1234ze, as described above. Other common processes known for production of HFO-1234yf involve dehydrofluorination of saturated compounds such as 1,1,1,2,2-pentafluoropropane (HFC-245cb) and/or 1,1,1,2,3-pentafluoropropane (HFC-245eb). This  
5 dehydrofluorination chemistry regardless of whether accomplished liquid phase by reaction with caustic or vapor phase by a thermal and/or catalytic process produces percent quantities of HFO-1234ze. The presence of this compound has not been acceptable to the refrigerants industry as it causes decreasing performance in refrigeration and air  
10 conditioning systems of all types. Therefore, extensive distillation processes must be added to the back end of any commercial manufacturing facility utilizing this chemistry to allow the removal of HFO-1234ze from the product HFO-1234yf. Therefore any chemistry that can produce HFO-1234yf essentially free of HFO-1234ze has a great  
15 advantage in the industry.

### Utility

The compositions disclosed herein comprising HFO-1234yf are useful as low global warming potential (GWP) heat transfer compositions, aerosol propellant, foam expansion agents (also known as foaming agents  
20 or blowing agents), solvents, cleaning agents, carrier fluids, displacement drying agents, buffing abrasion agents, polymerization media, expansion agents for polyolefins and polyurethane, gaseous dielectrics, extinguishing agents, and fire suppression agents in liquid or gaseous form. The  
25 disclosed compositions can act as a working fluid used to carry heat from a heat source to a heat sink. Such heat transfer compositions may also be useful as a refrigerant in a cycle wherein the fluid undergoes a phase change; that is, from a liquid to a gas and back or vice versa.

Examples of heat transfer systems include but are not limited to air  
30 conditioners, freezers, refrigerators, heat pumps, water chillers, flooded evaporator chillers, direct expansion chillers, walk-in coolers, heat pumps, mobile refrigerators, mobile air conditioning units and combinations thereof.

In one embodiment, the compositions comprising HFO-1234yf are useful in mobile heat transfer systems, including refrigeration, air conditioning, or heat pump systems or apparatus. In another embodiment, the compositions are useful in stationary heat transfer systems, including refrigeration, air conditioning, or heat pump systems or apparatus.

As used herein, mobile heat transfer systems refers to any refrigeration, air conditioner, or heating apparatus incorporated into a transportation unit for the road, rail, sea or air. In addition, mobile refrigeration or air conditioner units, include those apparatus that are independent of any moving carrier and are known as "intermodal" systems. Such intermodal systems include "containers" (combined sea/land transport) as well as "swap bodies" (combined road/rail transport).

As used herein, stationary heat transfer systems are systems that are fixed in place during operation. A stationary heat transfer system may be associated within or attached to buildings of any variety or may be stand alone devices located out of doors, such as a soft drink vending machine. These stationary applications may be stationary air conditioning and heat pumps (including but not limited to chillers, high temperature heat pumps, residential, commercial or industrial air conditioning systems, and including window, ductless, ducted, packaged terminal, chillers, and those exterior but connected to the building such as rooftop systems). In stationary refrigeration applications, the disclosed compositions may be useful in equipment including commercial, industrial or residential refrigerators and freezers, ice machines, self-contained coolers and freezers, flooded evaporator chillers, direct expansion chillers, walk-in and reach-in coolers and freezers, and combination systems. In some embodiments, the disclosed compositions may be used in supermarket refrigerator systems.

The compositions disclosed herein comprising  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ; and at least one solvent, are useful in methods to prepare HFO-1234yf as described previously herein.



The compositions disclosed herein comprising  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ; and at least one solvent are useful in methods to prepare HFO-1234yf as described previously herein.

5 The compositions disclosed herein comprising  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ; and at least one solvent are useful in methods to prepare HFO-1234yf as described previously herein.

Without further elaboration, it is believed that one skilled in the art can, using the description herein, utilize the present invention to its fullest extent. The following specific embodiments are, therefore, to be  
10 construed as merely illustrative, and do not constrain the remainder of the disclosure in any way whatsoever.

### **EXAMPLES**

15 The concepts described herein will be further described in the following examples, which do not limit the scope of the invention described in the claims. The results as given in GC or GC-MS area percent are thought to approximate weight percent.

#### 20 **Example 1**

Example 1 demonstrates the preparation of 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) from 1,1,1,2-tetrafluoro-2,2-dichloroethane (CFC-114a), and the particular reaction products obtained from this preparation.

25 A 400 ml Hastelloy<sup>TM</sup> C shaker tube was charged with 32.8 grams (0.5 mole) of activated Zinc powder, 12 grams (0.5 mole) of paraformaldehyde and 180 ml anhydrous dimethylformamide (DMF) under  $\text{N}_2$ . The tube was cooled down to  $-15^\circ\text{C}$  and 64.4 grams (0.2 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) was added. Then the  
30 reaction mixture was stirred at  $50^\circ\text{C}$  for 6 hours. The results of gas chromatographic analysis of the reaction products are summarized in Table 1. The reaction mixture was cooled to room temperature and then

poured into a 200 mL mixture of ice, 10% aqueous HCl and 200 mL diethyl ether. The solution was stirred for 30 min and the organic layer was separated and washed with 100 mL of 2% aqueous HCl and then 100 mL brine. The organic layer was dried with  $\text{MgSO}_4$ , and diethyl ether was removed by vacuum to afford 13.36 grams of product 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), thus obtaining an 8% yield.

Example 2

Example 2 demonstrates the synthesis of 2,3,3,3-tetrafluoropropene from 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a), and the particular reaction products obtained from this synthesis.

A 400 ml Hastelloy<sup>TM</sup> C shaker tube was charged with 20 grams (0.315 mole) of activated zinc powder, 7.5 grams (0.25 mole) of paraformaldehyde and 130 mL anhydrous DMF under  $\text{N}_2$ . The tube was cooled to  $-15^\circ\text{C}$ , and 43 grams (0.25 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) were added. The reaction mixture was stirred at  $60^\circ\text{C}$  for 6 hours and then cooled to room temperature. 30 grams (0.46 mole) of activated zinc powder, and 50 grams (0.5 mole) of acetic anhydride were added to the reactor. The reaction mixture was stirred at  $50^\circ\text{C}$  for 6 hr and then cooled to room temperature. The gas phase and the liquid phase were analyzed by gas chromatography-mass spectrometry (GC-MS) Results are summarized in Table 2. The 1234yf



composition is demonstrated in the gas phase portion of Table 2 below, and the liquid phase portion of Table 2 is what is left in the reactor when the gas sample comes off. Note that the gas phase sample corresponds to the compositions comprising HFO-1234yf and additional compounds.

10 Example 3

Example 3 demonstrates the synthesis of 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) from CFC-114a in pyridine and the particular reaction products obtained from this synthesis.

An 80 mL Fisher Porter tube was charged with 2.24 grams (0.034 mole) of activated zinc powder, 1.24 grams (0.041 mole) of paraformaldehyde and 30 mL anhydrous pyridine under N<sub>2</sub>. The tube was cooled to -15° C, and 5 grams (0.029 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) were added and the reaction mixture was stirred at 50° C for 8 hours. The reactor pressure dropped from 25 psig to 8 psig at the end of the reaction. The reaction mixture was cooled to room temperature and analyzed by GC-MS. For GC-MS analysis, a portion of the reaction mixture was acidified with a 10% solution of HCl in acetone. The data is reported by area percent of GC-MS in Table 3.

#### Example 4

Example 4 demonstrates the synthesis of 2-chloro-2,3,3,3-tetrafluoropropanol (CF<sub>3</sub>CClFCH<sub>2</sub>OH) in dimethylacetamide, and the particular reaction products obtained from this synthesis.

An 80 mL Fisher Porter tube was charged with 2.23 grams (0.034 mole) of activated zinc powder, 1.21 grams (0.040 mole) of paraformaldehyde and 30 mL anhydrous dimethylacetamide under N<sub>2</sub>.



The tube was cooled to -15° C, and 5.2 grams (0.030 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) were added. The reaction mixture was stirred at 60° C for 4.5 hours. The pressure of the reactor dropped from 30 psig to 9 psig at the end of the reaction. The reaction mixture was cooled to room temperature, and it was analyzed by GC-MS. For GC-MS analysis, a portion of the reaction mixture was acidified with a 10% solution of HCl in acetone. The data is reported by area percent of GC-MS in Table 4.

#### Example 5

Example 5 demonstrates the synthesis of CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl in pyridine, with pre-treatment of formaldehyde, and the particular reaction products obtained from this synthesis.

An 80 ml Fisher Porter tube was charged with 1.82 grams (0.06 mole) of paraformaldehyde and 30 ml anhydrous pyridine under N<sub>2</sub>. The tube was heated to 60°C and stirred for 4 hours. The tube was cooled to room temperature, and 2.24 grams (0.034 mole) of activated zinc powder were added. After purging with N<sub>2</sub> for 15 minutes, the tube was cooled to -15° C and 5 grams (0.029 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) were added. Then the reaction mixture was stirred at 50° C

for 8 hours. The pressure of the reactor dropped from 25 psig to 9 psig at the end of the reaction. The reaction mixture was cooled to room temperature and analyzed by GC-MS. For GC-MS analysis, a portion of the reaction mixture was acidified with a 10% solution of HCl in acetone.

- 5 The data is reported by area percent of GC-MS in Table 5. The selectivity of 114a to  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  (analyzed as  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) increased to 78.7%.

### Example 6

- Example 6 illustrates the esterification of 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ) with acetic anhydride to produce  
 15  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  and the reaction products obtained from this esterification.

- An 80 ml Fisher Porter tube was charged with 2 grams (0.012 mole) of  $\text{CF}_3\text{CClFCH}_2\text{OH}$  (which contains ~15% diethyl ether), 1.35 grams  
 20 (0.0132 mole) of acetic anhydride and 0.25 grams of concentrated sulfuric acid. The mixture was stirred at 60°C for 6 hours. The reaction mixture was cooled to room temperature and analyzed by GC-MS. The data is



reported by area percent of GC-MS in Table 6. These results show that more than 99% of  $\text{CF}_3\text{CClFCH}_2\text{OH}$  has been converted to  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ .

Example 7

Example 7 illustrates the direct esterification of  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  to  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , and the reaction products obtained from this direct esterification.

10 ml of a pyridine solution containing about 14%  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  was vacuum evaporated at room temperature to remove the majority of the pyridine. Then 2.0 grams acetic anhydride and 1 mL DMF were added to the resultant solid. The mixture was stirred at 60°C for 7 hours. The reaction mixture was cooled to room temperature and analyzed by GC-MS. The data is reported by area percent of GC-MS in Table 7.

### Example 8

Example 8 illustrates the conversion of 2-chloro-2,3,3,3-tetrafluoropropyl acetate (CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub>) to 2,3,3,3-tetrafluoropropene (HFO-1234yf).

The reaction mixture from Example 7, above, was stirred with 1 gram of Na<sub>2</sub>CO<sub>3</sub> to remove the acid generated in the esterification step. Then 3 moles of DMF and 1.3 grams of Zn were added. The reaction was run in an 80 mL Fisher Porter tube at 50°C for 2 hours and 60°C for another 2 hours with stirring. The pressure of the reactor increased from 0 psig to 13 psig. The reaction mixture was cooled to room temperature and analyzed by GC-MS. The data is reported by area percent of GC-MS in Table 8. CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub> became non-detectable in the liquid phase of the reactor. This result shows that CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub> has been quantitatively converted to 2,3,3,3-tetrafluoropropene (HFO-1234yf) under the conditions above. Note that the vapor phase sample corresponds to the compositions comprising HFO-1234yf and additional compounds.

Example 9

Example 9 demonstrates the reaction of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) with paraformaldehyde to form zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ) in a mixed solvent of dimethylformamide and pyridine.

An 80 mL Fisher Porter tube was charged with 2.2 grams Zn (0.037 mole), 0.3 grams zinc acetate (0.0016 mole), 2 grams (0.067 mole) of paraformaldehyde, 15 grams of anhydrous pyridine and 15 grams of dimethylformamide under  $\text{N}_2$ . After  $\text{N}_2$  purge for 15 min, the tube was cooled to  $-15^\circ\text{C}$  and 5 grams (0.029 mole) of 1,1-dichloro-1,2,2,2-tetrafluoroethane (CFC-114a) was added and the reaction mixture was stirred at  $50^\circ\text{C}$  for 2 hours. The pressure of the reactor dropped from 25 psig to 5 psig at the end of the reaction. The reaction mixture cooled to room temperature and analyzed by GC-MS. For GC-MS analysis, a portion of the reaction mixture was acidified with a 10% solution of HCl in acetone. The data is reported by area percent from GC-MS in Table 9 (DMF and pyridine peaks are excluded from the integration, i.e., are present in the sample). The selectivity of CFC-114a to  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  (analyzed as 2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ )) was 83% based on GC-MS analysis.

### Example 10

Example 10 illustrates esterification of CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl directly to CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub> with acetic anhydride in a solvent mixture, and the reaction products obtained from this esterification. °

Excess Zn was filtered from the reaction mixture obtained in Example 9, then the filtrate was charged to an 80 mL Fisher Porter tube, and 4.4 grams of acetic anhydride (0.043 mole) were added. The mixture was stirred at 60°C for 6 hours. The reaction mixture cooled to room temperature and was analyzed by GC-MS. The data is reported by area percent of GC-MS in Table 10 (DMF, pyridine and acetic anhydride were excluded from integration), i.e., they were present in the final composition. This result shows that more than 94% of CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl has been converted to CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub> at these reaction conditions.

### Example 11

Example 11 illustrates the synthesis of 2,3,3,3- tetrafluoropropene (HFO-1234yf) from 1,1,1,2-tetrafluoro-2,2-dichloroethane (CFC-114a) in  
5 3:1 pyridine: DMF solvent.

An 80 mL Fisher Porter tube was charged with 2.1 grams zinc metal (0.032 mole), 0.3 grams zinc acetate (0.0016 mole), 2 grams (0.067 moles) of paraformaldehyde, 30 grams anhydrous pyridine under N<sub>2</sub>. After N<sub>2</sub> purge for 15 minutes, the tube was cooled to -15 °C and 5 grams  
10 (0.029 moles) of 1,1-dichlorotetrafluoroethane (CFC-114a) were added. Then the reaction mixture was stirred at 50 °C for 3 hours. The pressure of the reactor dropped from 25 psig to 5.5 psig at the end of the reaction. After the reaction mixture cooled to room temperature, it was analyzed by GC-MS. For GC-MS analysis, a portion of the reaction mixture was  
15 acidified with a 10% solution of HCl in acetone. The solvent (pyridine) peak was excluded from the integration. The data is reported in Table 11 by area percent of GC-MS. The selectivity of 1,1-dichlorotetrafluoroethane to CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl (analyzed as CF<sub>3</sub>CClFCH<sub>2</sub>OH) is 81% based on GC-MS analysis.

The excess zinc was filtered off from the reaction mixture and it was charged to an 80 mL Fisher Porter tube. 10 mL of anhydrous DMF and 3.5 grams of acetic anhydride (0.034 moles) were also added to the reactor. The mixture was stirred at 60°C for 4 hours. The reaction mixture

was cooled to room temperature and analyzed by GC-MS. The data is reported in Table 12 by area percent of GC-MS. The solvent (DMF and pyridine) peak were excluded from the integration. This result shows that more than 98% of  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$  has been converted, and selectivity to  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  and  $\text{CF}_3\text{CFCICH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$  are 89%.

10 mL of the reaction mixture above was left in an 80 mL Fisher Porter tube and activated zinc powder (1 gram, 0.015 moles) was added. The reaction was run at 60 °C for 4 hours with stirring. The pressure of the reactor increased from 6 psig to 15.5 psig. The reaction mixture was cooled to room temperature and the vapor phase and liquid phase were analyzed by GC-MS. The data is reported by area percent of GC-MS. The vapor phase (product 2,3,3,3-tetrafluoropropene) data is listed in Table 13 and the liquid phase (remaining after reaction) data is listed in Table 14 (the solvent peaks for DMF and pyridine were excluded from the integration).  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  became non-detectable in the liquid phase of the reactor. Analysis shows that selectivity to 2,3,3,3-tetrafluoro-1-propene (HFO-1234yf) was about 94%, and selectivity to 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane ( $\text{C}_6\text{H}_4\text{F}_8$ ) was about 5%.

### Example 12

Example 12 illustrates the synthesis of 2,3,3,3-tetrafluoropropene (HFO-1234yf) from 1,1,1,2-tetrafluoro-2,2-dichloroethane (CFC-114a) in  
5 1:1 pyridine: DMF solvent.

A 80 mL Fisher Porter tube was charged with 2.1 grams of zinc metal (0.032 moles), 0.3 grams zinc acetate (0.0016 moles), 2 grams (0.067 moles) of paraformaldehyde, 0.2 grams of bis(hydrogenated alkyl) dimethyl ammonium acetate and 30 grams of anhydrous pyridine under  
10 N<sub>2</sub>. After N<sub>2</sub> purge for 15 minutes, the tube was cooled to -15° C and 5 grams (0.029 moles) of 1,1-dichlorotetrafluoroethane (CFC-114a) were added. Then the reaction mixture was stirred at 50° C for 3 hours. The pressure of the reactor dropped from 23 psig to 5.5 psig at the end of the reaction. The reaction mixture cooled to room temperature and analyzed  
15 by GC-MS. For GC-MS analysis, a portion of the reaction mixture was acidified with a 10% solution of HCl in acetone. The solvent for DMF and pyridine were excluded from the integration. The data is reported in Table 15 as area percent from GC-MS data. The selectivity for CFC-114a to CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl (analyzed as CF<sub>3</sub>CClFCH<sub>2</sub>OH) was about 85% based  
20 on GC-MS analysis.

10 mL of the reaction mixture was filtered and charged into an 80 mL Fisher Porter tube. 10 mL of anhydrous DMF and 3.5 grams of acetic anhydride (0.034 moles) were also added to the reactor. The mixture was  
25 stirred at 60°C for 4 hours. The reaction mixture was cooled to room temperature and analyzed by GC-MS. The data is reported in Table 16 as area percent from GC-MS data. The solvent peaks for DMF and pyridine were excluded from the integration. This result shows that more than 98% of CF<sub>3</sub>CClFCH<sub>2</sub>OZnCl was converted, and selectivity for  
30 CF<sub>3</sub>CClFCH<sub>2</sub>OC(=O)CH<sub>3</sub> and CF<sub>3</sub>CFCICH<sub>2</sub>OCH<sub>2</sub>OC(=O)CH<sub>3</sub> are about 95%.

The reaction mix above was treated with 2 grams of Na<sub>2</sub>CO<sub>3</sub> in an 80 mL Fisher Porter tube. After Na<sub>2</sub>CO<sub>3</sub> was filtered off, activated zinc

powder (1 gram, 0.015 moles) was added. The reaction was run in 80 mL Fisher Porter tube at 60°C for 4 hour with stirring. The pressure of the reactor increased from 5 psig to 18 psig. The reaction mixture was cooled to room temperature and the liquid and vapor phases were analyzed by GC-MS. The data is reported by area percent of GC-MS. The results for the vapor phase (product 2,3,3,3-tetrafluoropropene) are listed in Table 17 and the results for the liquid phase (remaining after reaction) are reported in Table 18 (solvent peaks for DMF and pyridine were excluded from the integration). More than 99%  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$  and more than 95%  $\text{CF}_3\text{CFCICH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$  were converted. Analysis shows that selectivity for HFO-1234yf was about 98%, and selectivity for 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane ( $\text{C}_6\text{H}_4\text{F}_8$ ) was about 0.1%.

**CLAIMS**What is claimed is:

1. A composition comprising HFO-1234yf and at least one additional  
5 compound selected from the group consisting of CFC-114a (2-dichloro-1,1,1,2-tetrafluoroethane,  $\text{CCl}_2\text{FCF}_3$ ), HCFC-124 (2-chloro-1,1,1,2-tetrafluoroethane,  $\text{CF}_3\text{CHFCl}$ ), HFC-143a (1,1,1-trifluoroethane,  $\text{CF}_3\text{CH}_3$ ), CFO-1113 (2-chloro-1,1,2-trifluoroethene,  $\text{CClF}=\text{CF}_2$ ), HFO-1123 (1,1,2-trifluoroethene,  $\text{CHF}=\text{CF}_2$ ), HFO-1132a (1,1-difluoroethene,  $\text{CH}_2=\text{CF}_2$ ),  
10 TFE (tetrafluoroethene,  $\text{CF}_2=\text{CF}_2$ ), HCFO-1122 (2-chloro-1,1-difluoroethene,  $\text{CHCl}=\text{CF}_2$ ), 3,4,4,4-tetrafluoro-2-butanone ( $\text{CH}_3\text{C}(=\text{O})\text{CHFCH}_2\text{F}$ ), acetyl fluoride ( $\text{CH}_3\text{C}(=\text{O})\text{F}$ ), 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), 2-chloro-2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), Zinc (2-chloro-2,3,3,3-tetrafluoropropoxy) chloride ( $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ), 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate ( $\text{CF}_3\text{CFClCH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), 1,3-bistrifluoromethyl-1,3-difluorocyclobutane ( $\text{C}_4\text{H}_2\text{F}_8$ ), 2,3,3,3-tetrafluoropropyl acetate ( $\text{CF}_3\text{CHFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), dimethylformamide (DMF,  $\text{HCON}(\text{CH}_3)_2$ ), pyridine ( $\text{C}_5\text{H}_5\text{N}$ ), ethyl acetate, ( $\text{CH}_3\text{COCH}_2\text{CH}_3$ ), acetic  
20 acid ( $\text{CH}_3\text{COOH}$ ), diethyl ether ( $\text{CH}_3\text{CH}_2\text{OCH}_2\text{CH}_3$ ), acetic anhydride ( $(\text{CH}_3\text{CO})_2\text{O}$ ), methyl acetate ( $\text{CH}_3\text{COOCH}_3$ ), dimethylacetamide ( $\text{CH}_3\text{CON}(\text{CH}_3)_2$ ), methanol ( $\text{CH}_3\text{OH}$ ), ethanol ( $\text{CH}_3\text{CH}_2\text{OH}$ ), methyl formate ( $\text{HCOOCH}_3$ ), pyrazine, pyrimidine, N-methylpyrrolidine, N-methylpiperidine, hexamethylphosphoramide, tetrahydrofuran, 1,4-dioxane, N-methyl pyrrolidinone, dimethyl sulfoxide, acetonitrile, benzonitrile, and mixtures thereof.

2. The composition of claim 1, wherein the additional compounds comprise tetrafluoroethene, 1,1-difluoroethene, trifluoroethene and 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124).  
30

3. The composition of claim 1, wherein the additional compounds comprise 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), acetic anhydride, methyl acetate, DMF, and pyridine.

5 4. The composition of claim 1, wherein the additional compounds comprise TFE, HFO-1123, HFC-143a, CFO-1113, HCFC-124, CFC-114a, 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane, methyl formate, acetic acid, and 2,3,3,3-tetrafluoropropyl acetate.

10 5. The composition of claim 1, wherein the additional compounds comprise HFO-1123, water, CFO-1113, 1,3-bis-trifluoromethyl-1,3-difluorocyclobutane, methyl formate, and methyl acetate.

6. A composition comprising:

- 15 a.  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ; and  
b. at least one solvent.

7. The composition of claim 6 further comprising at least one additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, dimethylacetamide, methanol, methyl acetate, methyl formate, DMF, pyridine, ethyl acetate, acetic acid, diethyl ether,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate, and mixtures thereof.

25

8. The composition of claim 7, wherein the additional compound comprises HCFC-124, and methanol.

9. The composition of claim 7, wherein the additional compound comprises 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124), methyl formate, chlorotrifluoroethene (CFO-1113), trifluoroethene (HFO-1123) and methanol.

30



10. The composition of claim 7, wherein the additional compound comprise 2-chloro-1,1,1,2-tetrafluoroethane (HCFC-124), methyl formate, chlorotrifluoroethene (CFO-1113), and trifluoroethene (HFO-1123).

5 11. A composition comprising:

- a.  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ; and
- b. at least one solvent.

12. The composition of claim 11, further comprising at least one  
 10 additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, methanol, methyl acetate, methyl formate, dimethylacetamide, dimethylformamide, pyridine, ethyl acetate, acetic acid, diethyl ether, acetic anhydride, formaldehyde, 3-chloro-3,4,4,4-trifluoro-2-butanone,  
 15 2,3,3,3-tetrafluoropropyl acetate,  $\text{CF}_3\text{CClFCH}_2\text{OCH}(=\text{O})$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ , and mixtures thereof.

13. The composition of claim 12, wherein the additional compound  
 20 comprises 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), ethyl acetate, acetic acid and diethyl ether.

14. The composition of claim 12, wherein the additional compound comprises 2-chloro-2,3,3,3-tetrafluoropropyl formate  
 25 ( $\text{CF}_3\text{CClFCH}_2\text{OCH}(=\text{O})$ ), 2-chloro-2,3,3,3-tetrafluoropropanol ( $\text{CF}_3\text{CClFCH}_2\text{OH}$ ), acetic anhydride and acetic acid.

15. The composition of claim 12, wherein the additional compound comprises TFE, HCFC-124, 3-chloro-3,4,4,4-trifluoro-2-butanone, ethyl  
 30 methyl ether, and methyl acetate.

16. The composition of claim 12, wherein the additional compound comprises HFO-1123, HFO-1234yf, water, formaldehyde, HCFC-124, CFC-114a, methyl acetate, methyl formate, 3-chloro-3,4,4,4-tetrafluoro-2-

butanone, 2,3,3,3-tetrafluoropropyl acetate, 2-chloro-2,3,3,3-tetrafluoropropanol, acetic anhydride, and 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate.

- 5 17. The composition of claim 12, wherein the additional compound comprises HCFC-124, CFC-114a, methyl acetate, ethyl formate, methyl formate, acetic acid, 3-chloro-3,4,4,4-tetrafluoro-2-butanone, 2-chloro-2,3,3,3-tetrafluoropropanol, acetic anyhydride, and 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate.

18. A composition comprising:
- a.  $\text{CF}_3\text{CClFCH}_2\text{OZnCl}$ ; and
  - b. at least one solvent.

- 15 19. The composition of claim 18, further comprising at least one additional compound selected from the group consisting of HFO-1234yf, CFC-114a, HCFC-124, CFO-1113, HFO-1123, HFO-1132a, TFE, HCFO-1122, methanol, methyl acetate, methyl formate, dimethylacetamide, dimethylformamide, pyridine, ethyl acetate, acetic acid, diethyl ether,
- 20 formaldehyde, trifluoroacetaldehyde,  $\text{CF}_3\text{CClFCH}_2\text{OH}$ ,  $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ , 2-chloro-2,3,3,3-tetrafluoropropoxy methyl acetate ( $\text{CF}_3\text{CFCICH}_2\text{OCH}_2\text{OC}(=\text{O})\text{CH}_3$ ), and mixtures thereof.

20. The composition of claim 19, wherein said the additional compound
- 25 comprises HCFC-124, methyl formate, methanol and HFO-1123.

21. The composition of claim 19, wherein the additional compound comprises TFE, acetic acid, methyl formate, methyl acetate, HCFC-124, HFO-1234yf, and 2-chloro-2,3,3,3-tetrafluoropropyl acetate
- 30 ( $\text{CF}_3\text{CClFCH}_2\text{OC}(=\text{O})\text{CH}_3$ ).

22. The composition of claim 19, wherein the additional compound comprises HFO-1123, trifluoroacetaldehyde, formaldehyde, HCFC-124,

CFC-114a, methanol, methyl formate, and 2-chloro-2,3,3,3-tetrafluoropropyl acetate.

23. The composition of claim 19, wherein the additional compound  
5 comprises HFO-1123, trifluoroacetaldehyde, HFO-1234yf, formaldehyde, HCFC-124, CFC-114a, methanol, dimethyl ether, methyl formate, ethyl formate, 2-chloro-2,3,3,3-tetrafluoropropyl acetate, and acetic anhydride.

24. The composition of claim 1 containing greater than zero weight  
10 percent to less than 1 weight percent of the at least one additional compound.

25. The composition of claims 6, 11 or 18 wherein said solvent is  
selected from the group consisting of alkyl, dialkyl, or trialkyl linear or cyclic  
15 amines; pyridine or alkyl-substituted pyridines, pyrazine, pyrimidine; sulfoxides, ethers, alkyl or aromatic nitriles, hexamethylphosphoramide; alcohols; esters, dimethylformamide, tetrahydrofuran, dimethylacetamide, 1,4-dioxane, and N-methyl pyrrolidone, and mixtures thereof.

20 26. The composition of claim 25 wherein said solvent is selected from the group consisting of methanol, ethanol, methyl formate, DMSO, acetonitrile, benzonitrile, and mixtures thereof.

27. The composition of claim 25 wherein said solvent is selected from  
25 the group consisting of dimethylacetamide, dimethylformamide, pyridine, and mixtures thereof.



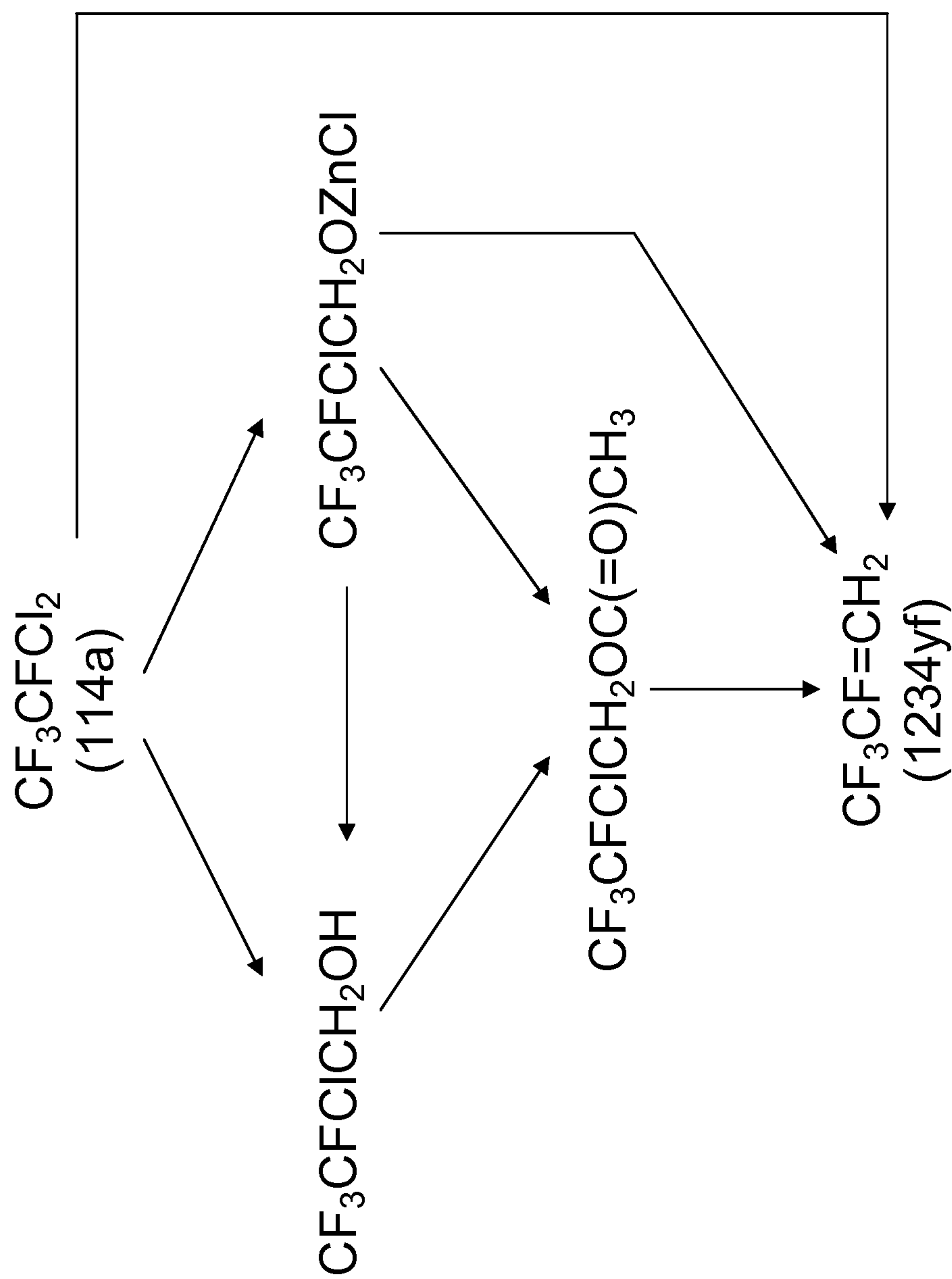

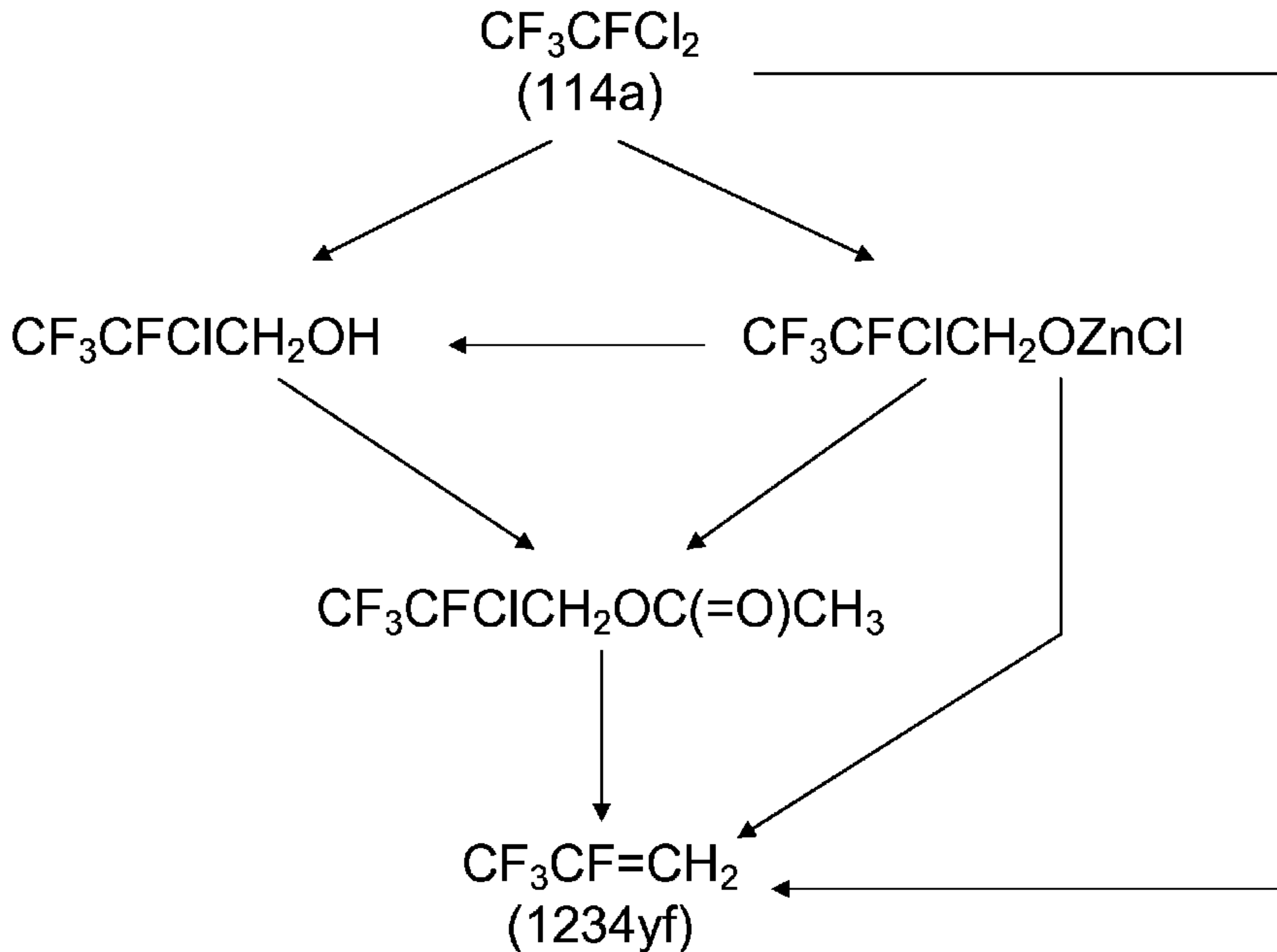
