(57) **CLAIM**

The ornamental design for an armrest for a wheelchair, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an armrest for a wheel chair
showing an embodiment of the new design;

FIG. 2 is a right side view of the armrest for a wheel chair
design shown in FIG. 1;

FIG. 3 is a left side view of the armrest for a wheel chair
design shown in FIG. 1;

FIG. 4 is a front view of the armrest for a wheel chair design
shown in FIG. 1;

FIG. 5 is a back view of the armrest for a wheel chair design
shown in FIG. 1;

FIG. 6 is a top view of the armrest for a wheel chair of design
shown in FIG. 1; and,

FIG. 7 is a bottom view of the armrest for a wheel chair design
shown in FIG. 1.

illustrative texture or gloss.
















