FIG. 4 is a top plan view of the chair.

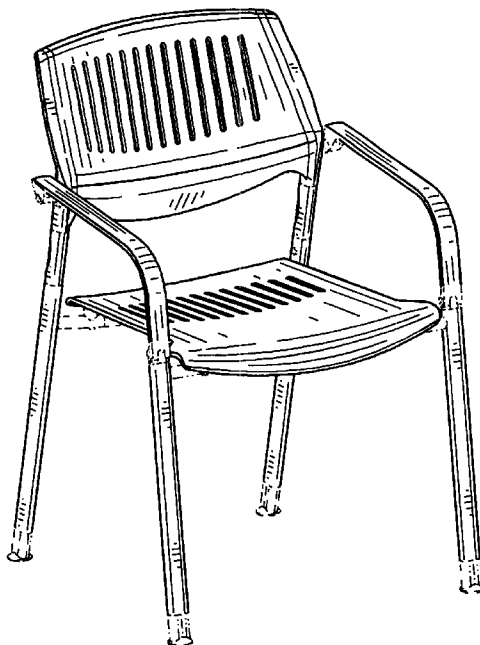
FIG. 5 is a rear elevation view of the chair.

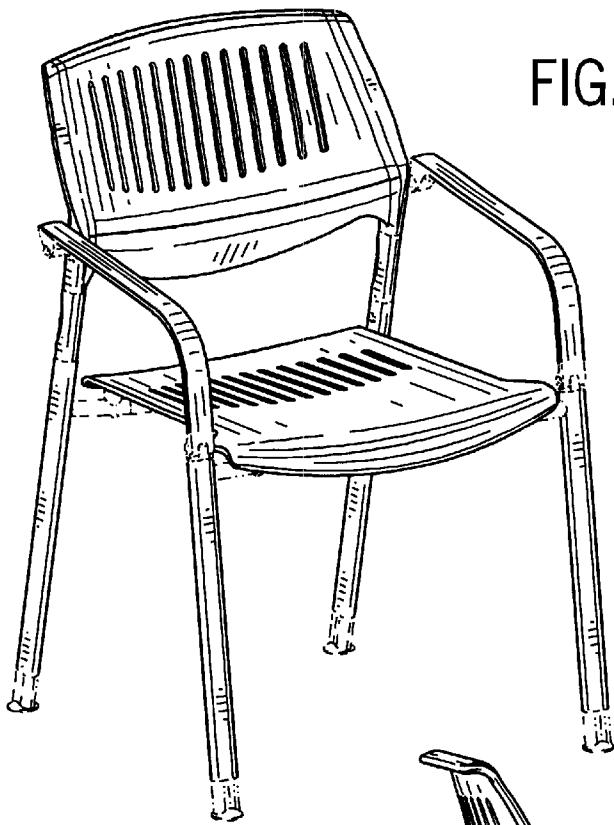

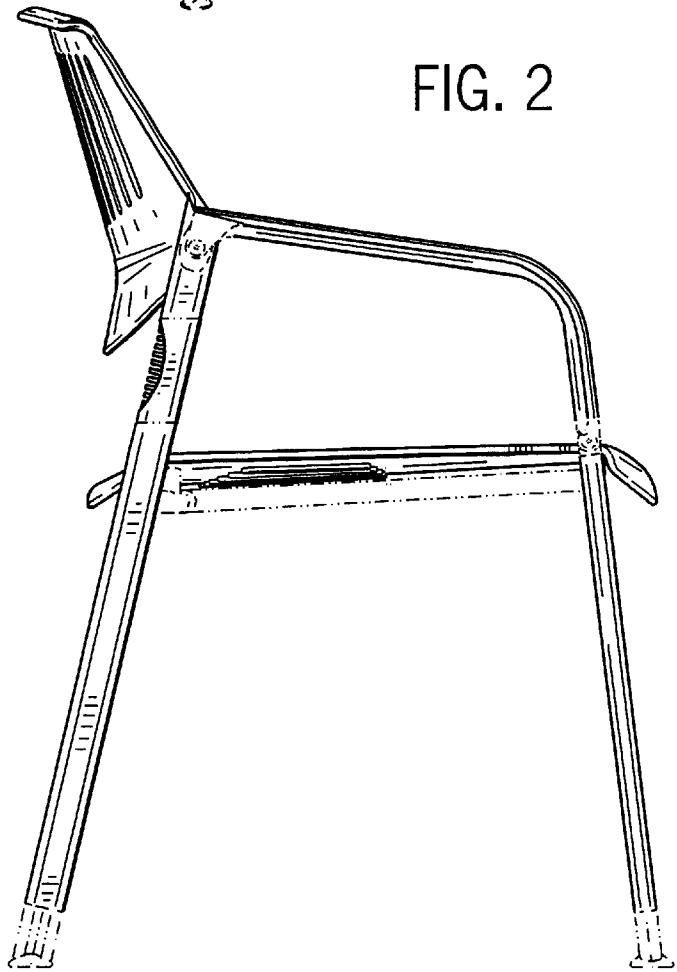

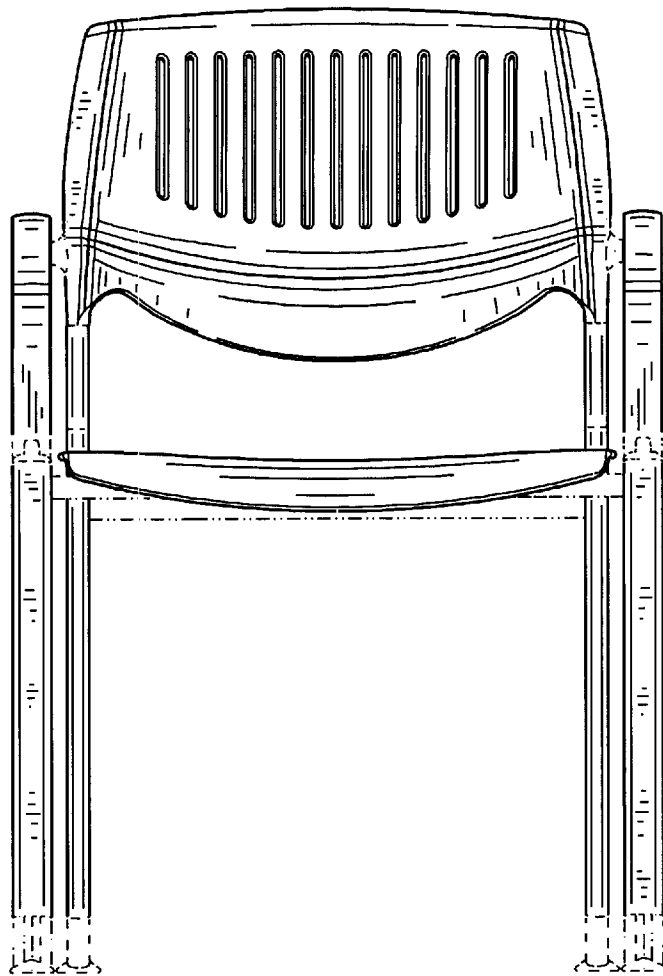

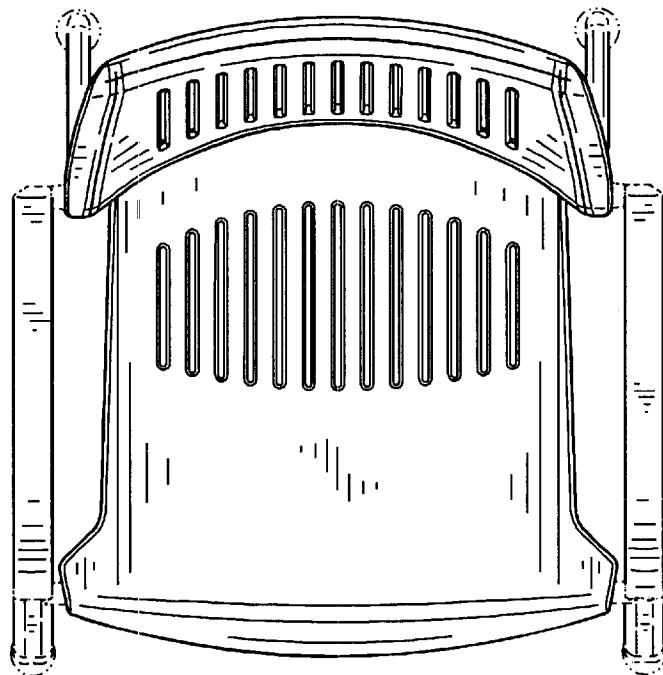

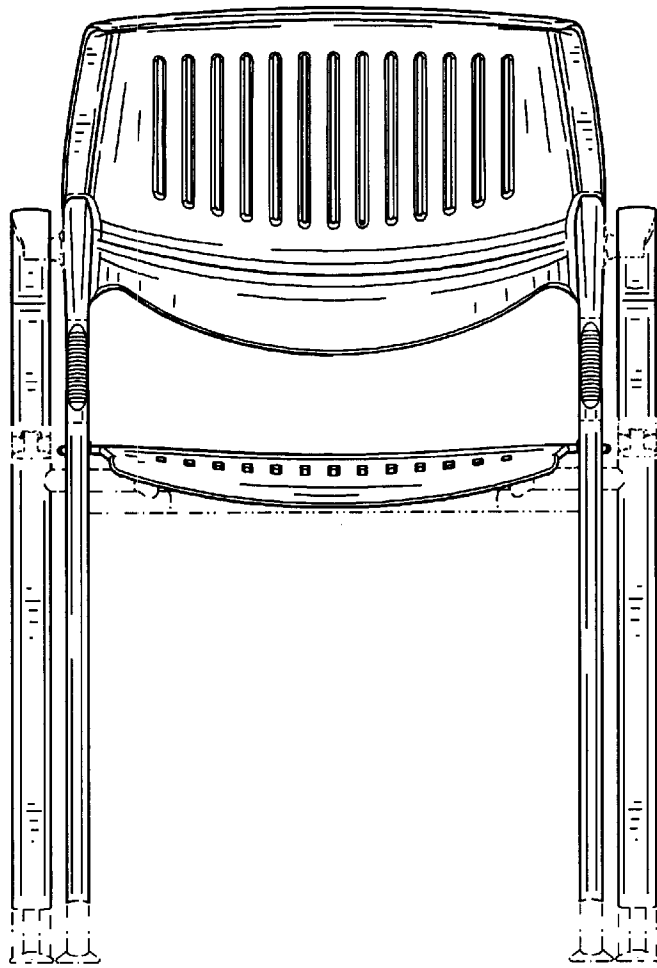

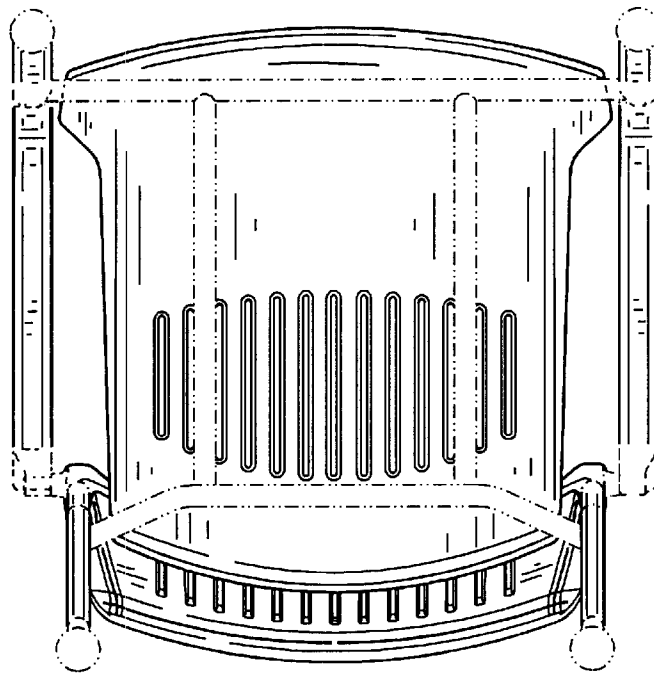
