DESCRIPTION

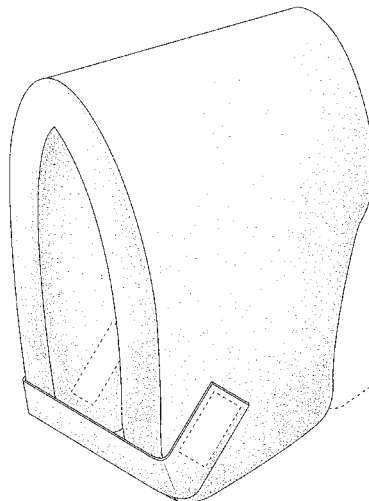
FIG. 1 is a perspective view of a heel positioner embodying the new design;

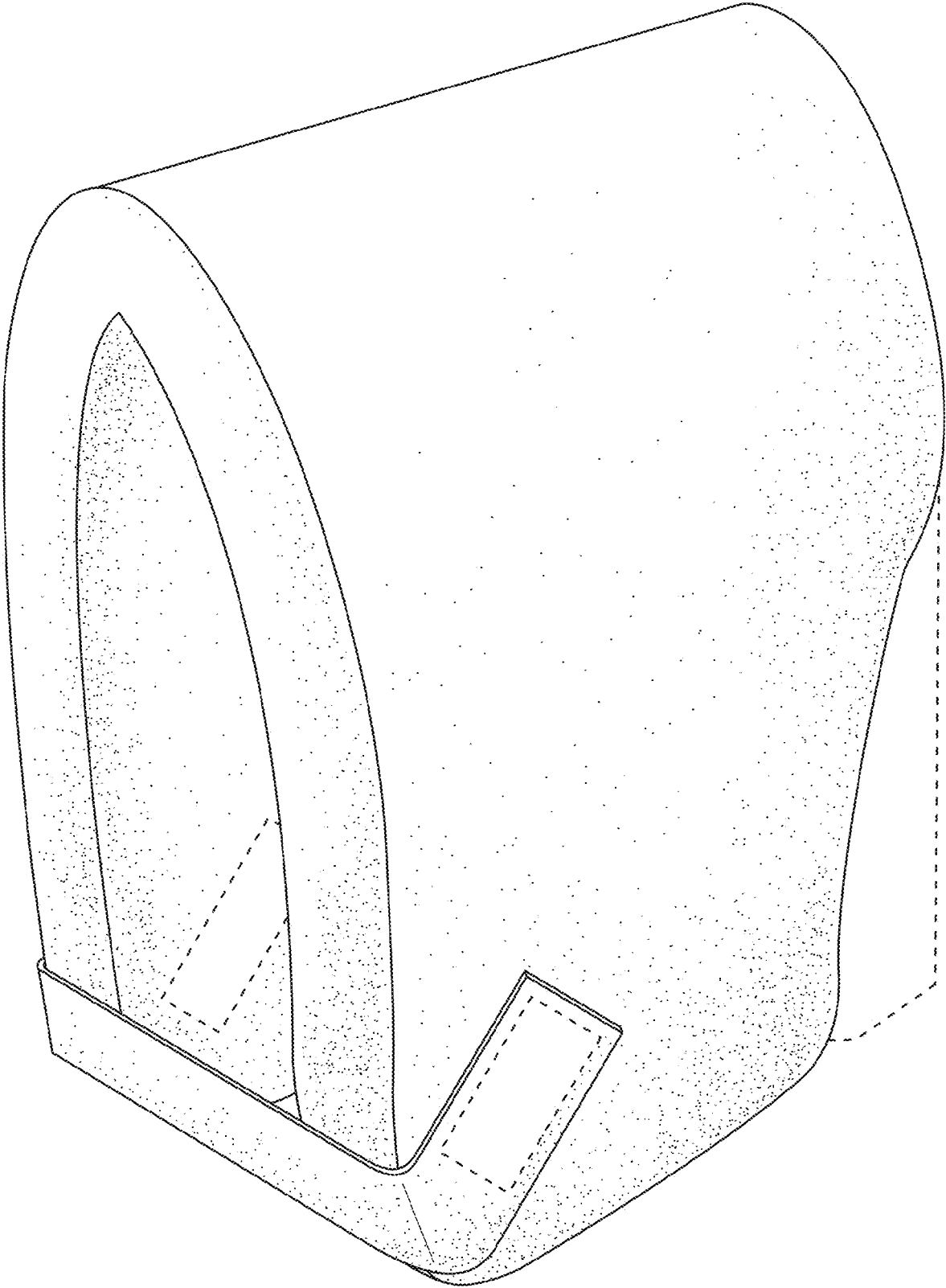

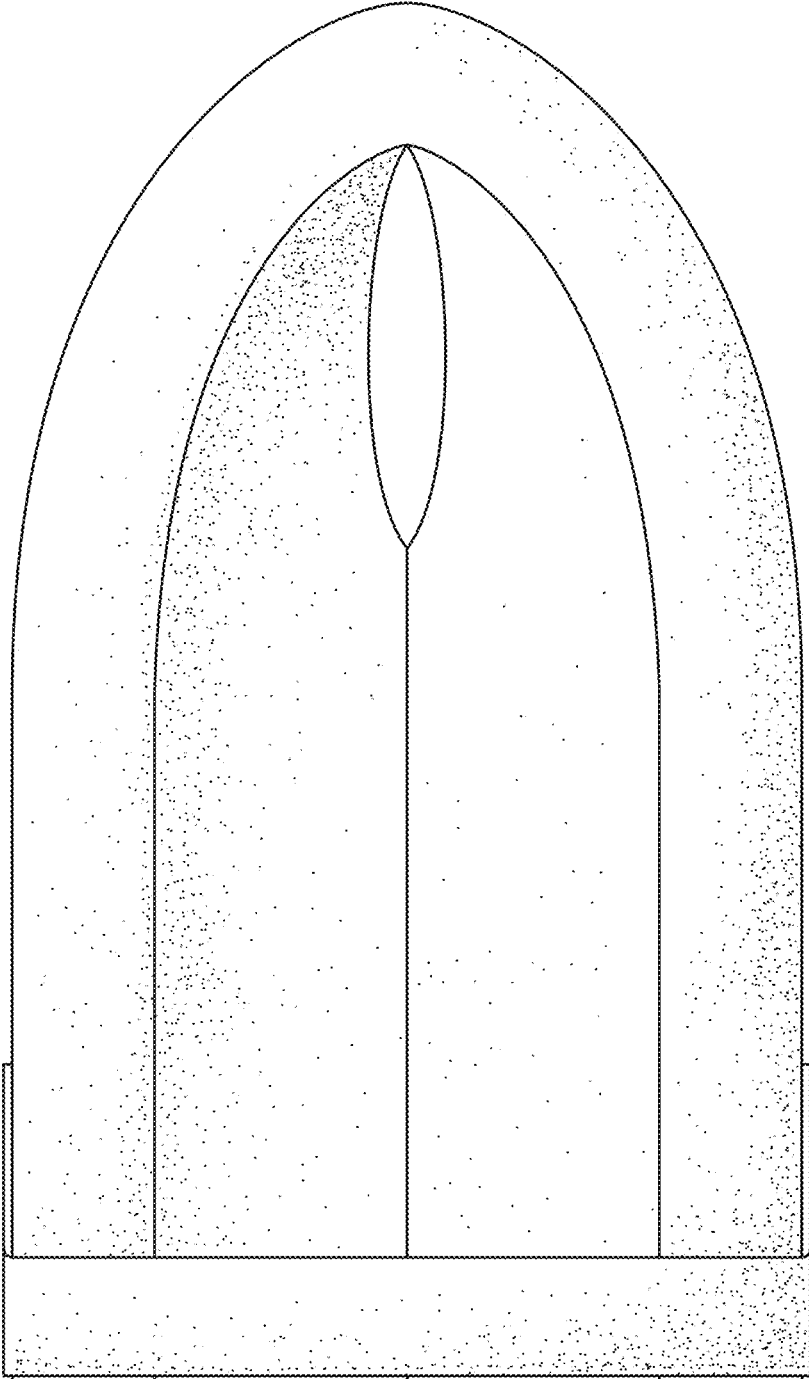

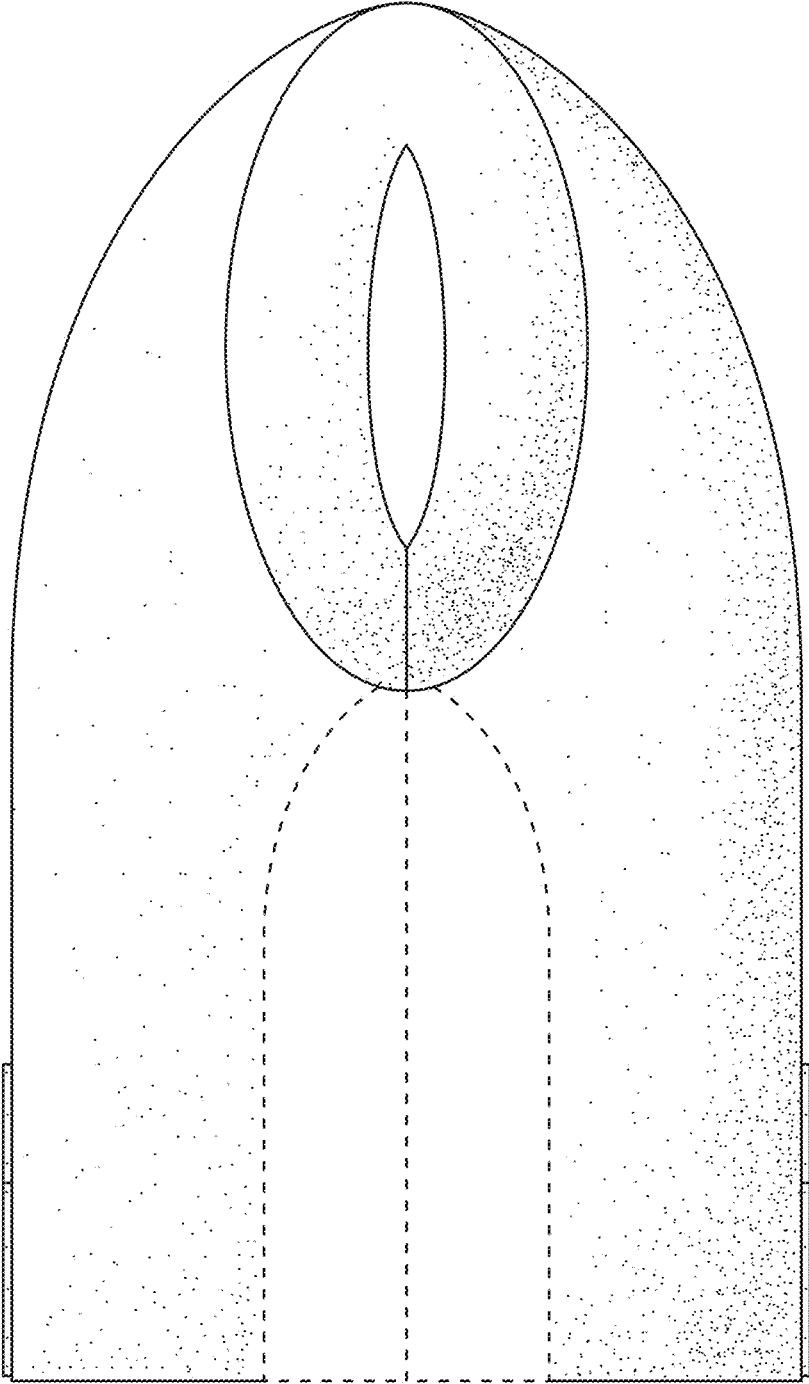

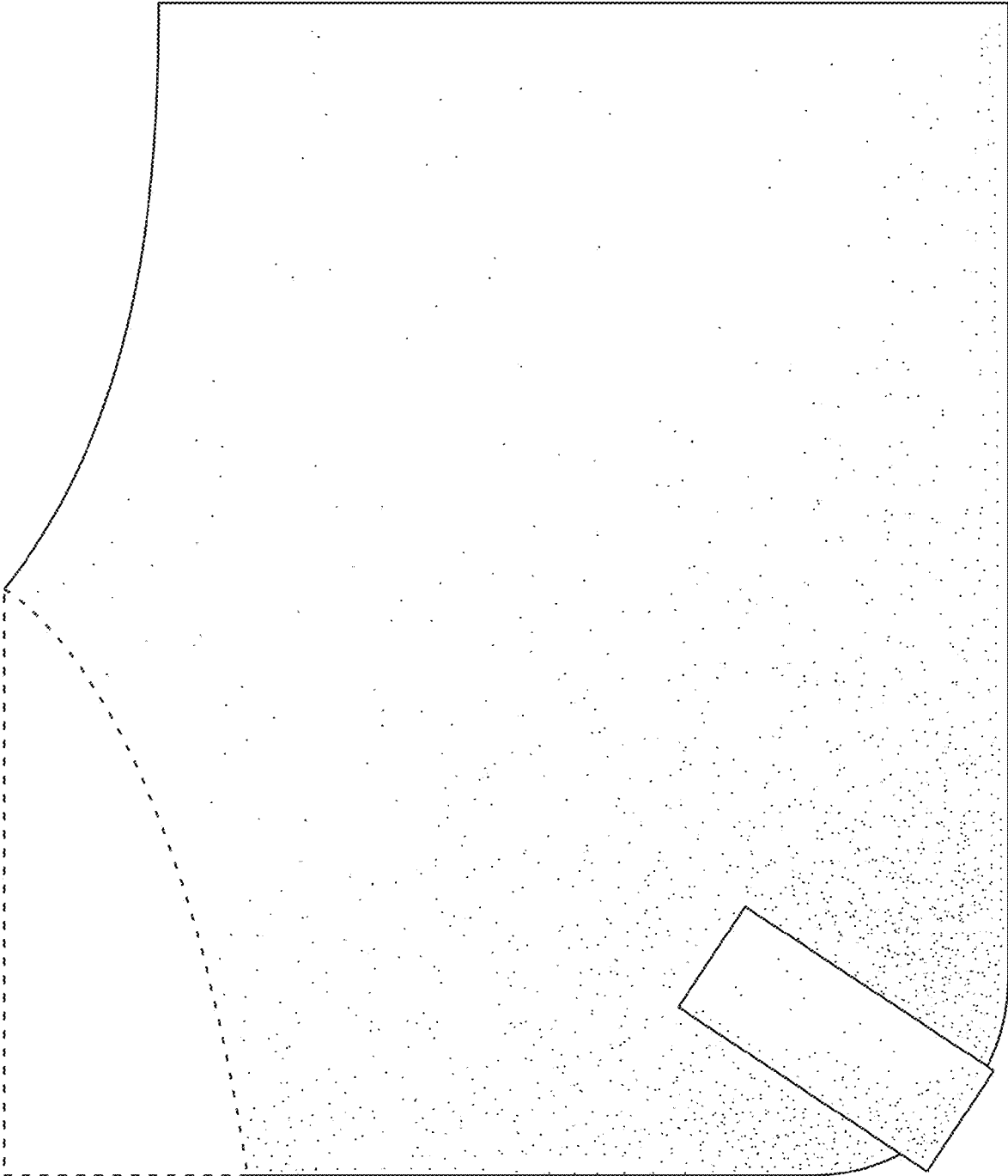

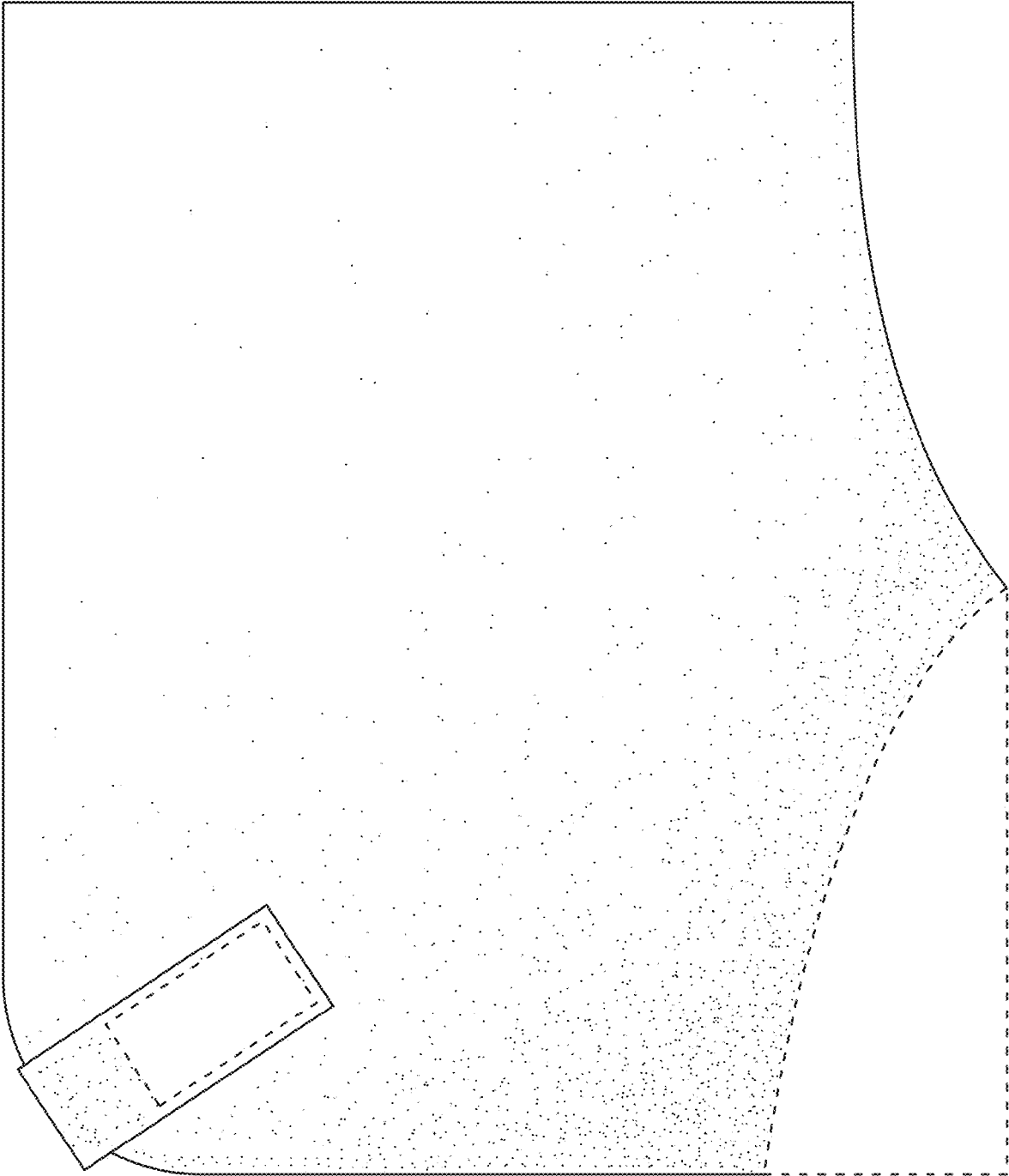

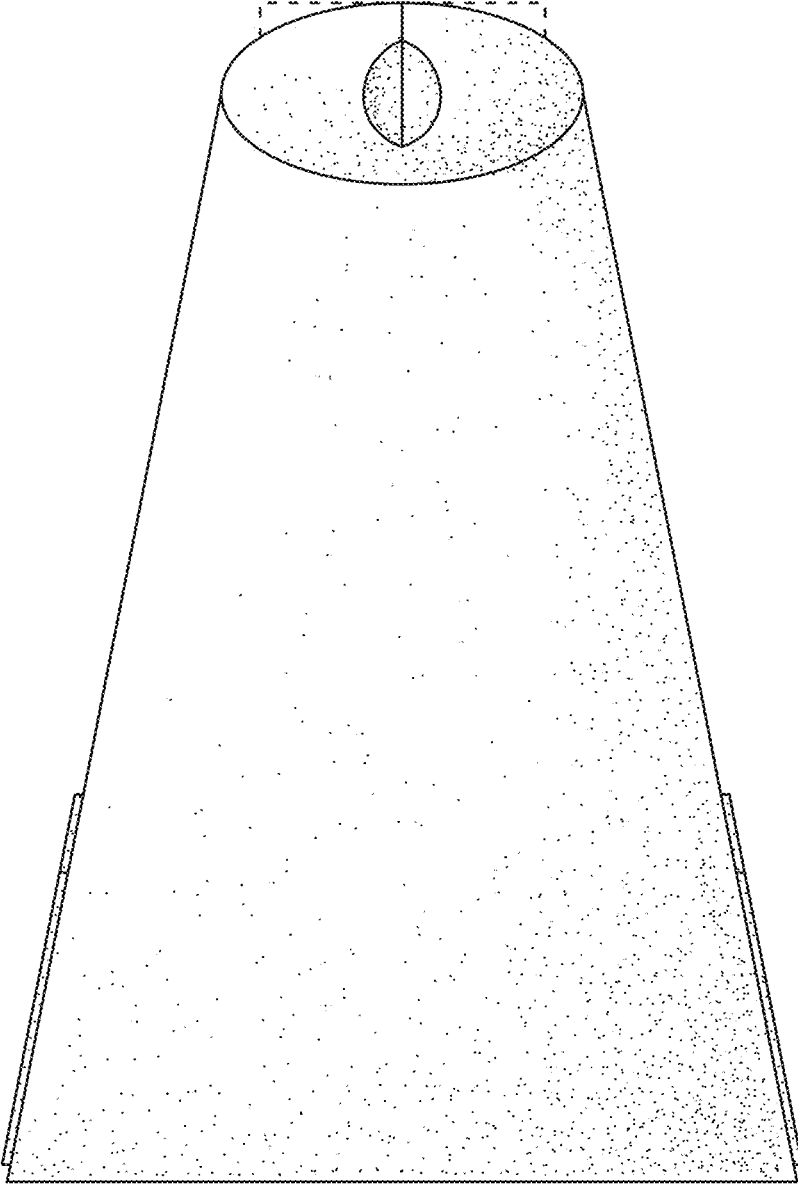

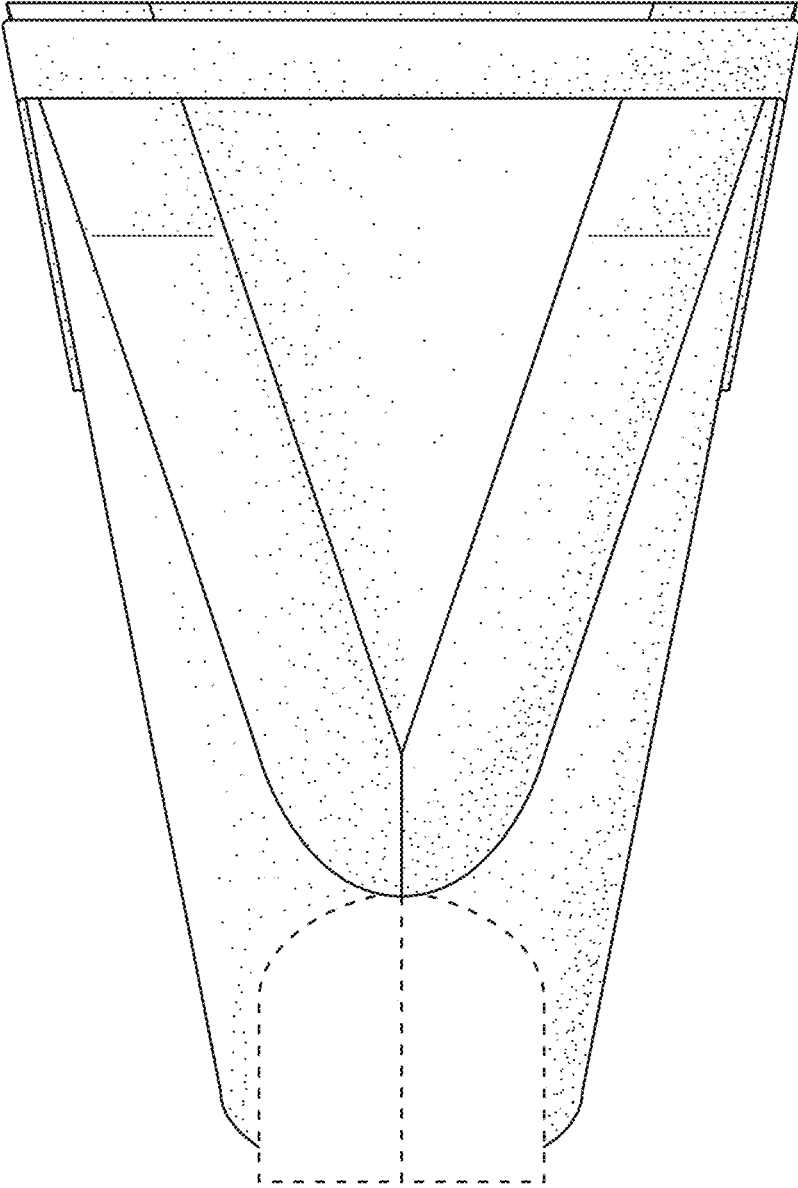
