
The ornamental design for a package for skin care products as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the package for skin care products showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;

FIG. 6 is a top plan view thereof; and,








