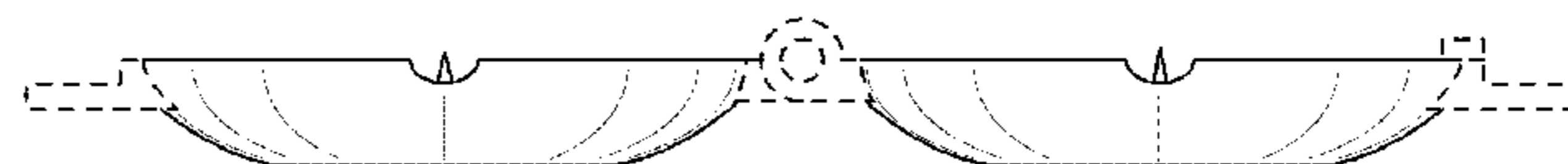
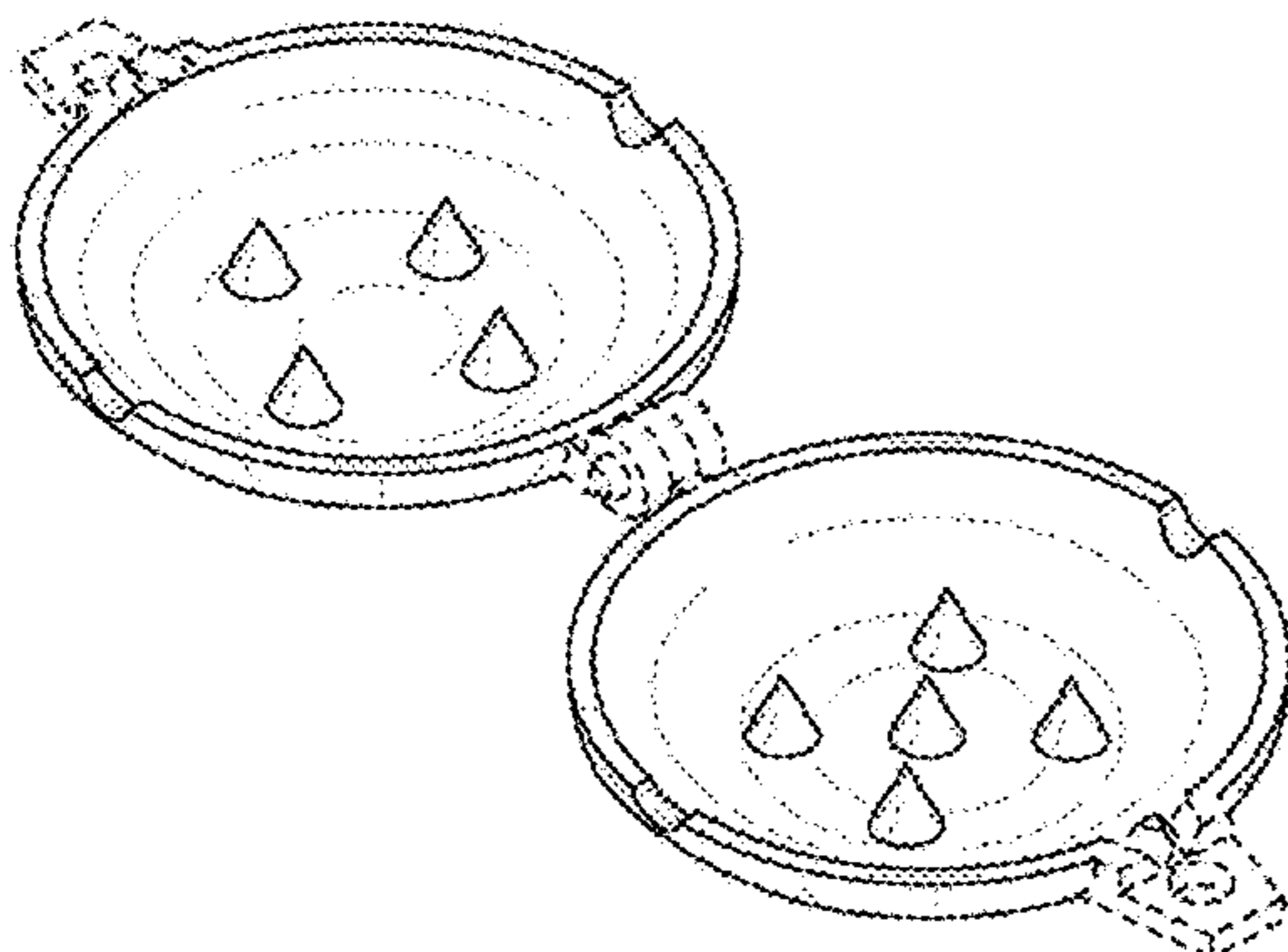
(57) **CLAIM**

The ornamental design for a cookware, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cookware in an open configuration according to the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is bottom plan view thereof;
FIG. 4 is a right side view the cookware in a closed configuration, of which the left side view is a mirror image;
FIG. 5 is a top plan view thereof, of which the bottom view is identical thereto;
FIG. 6 is a front view thereof;
FIG. 7 is a rear view thereof; and,
FIG. 8 is a left side view of the cookware in an open configuration, of which the right side view is a mirror image.
The broken lines in the drawings illustrate portions of the cookware that form no part of the claimed design.

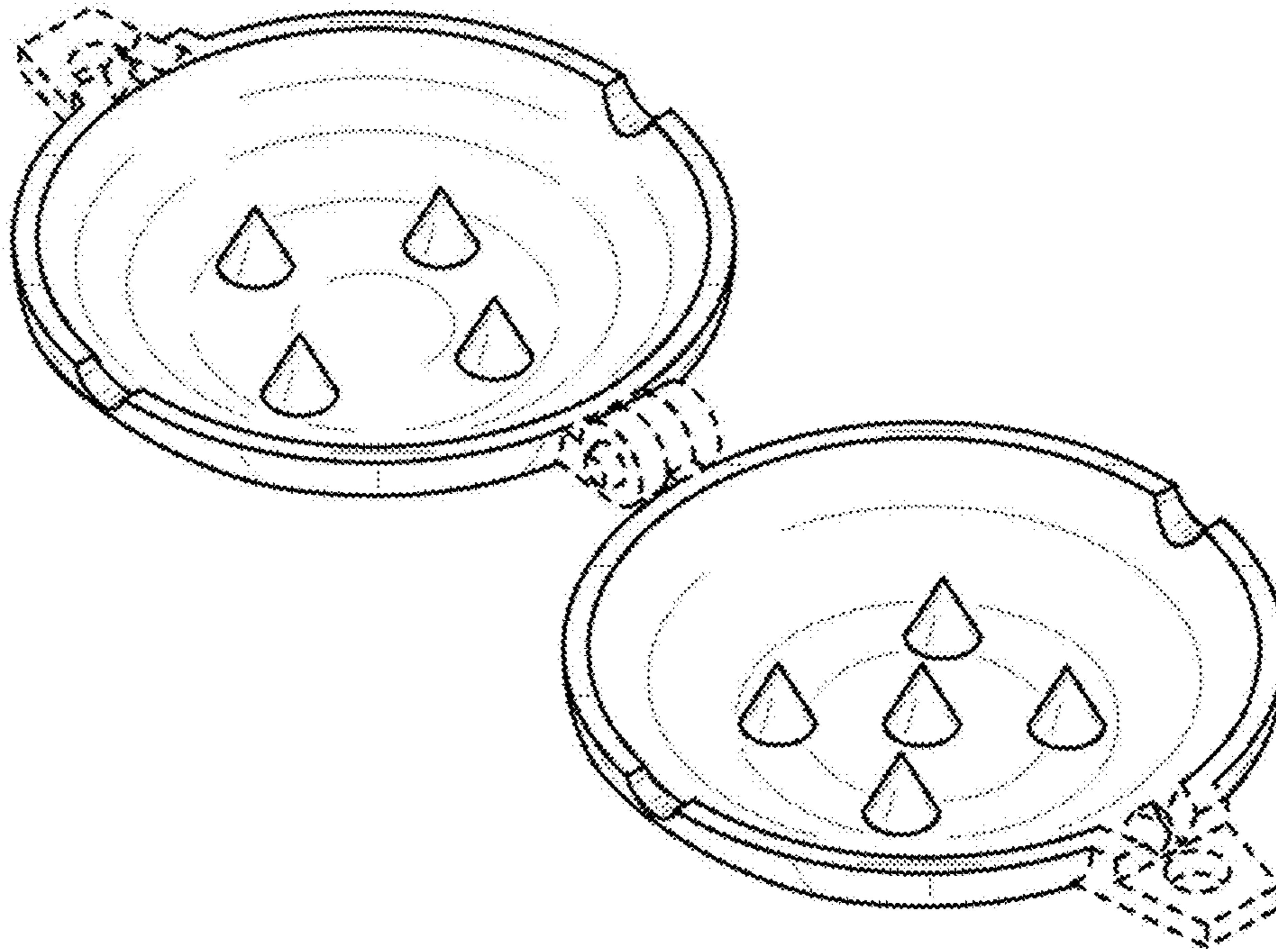

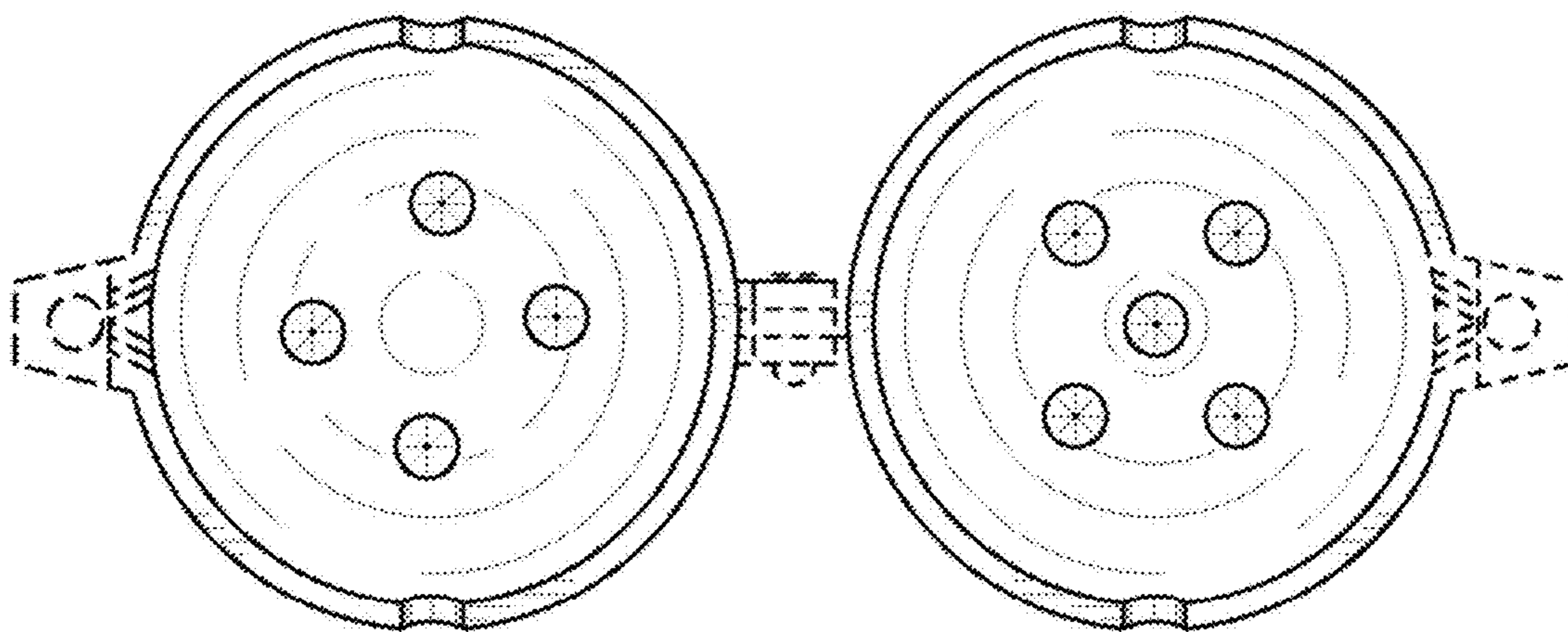

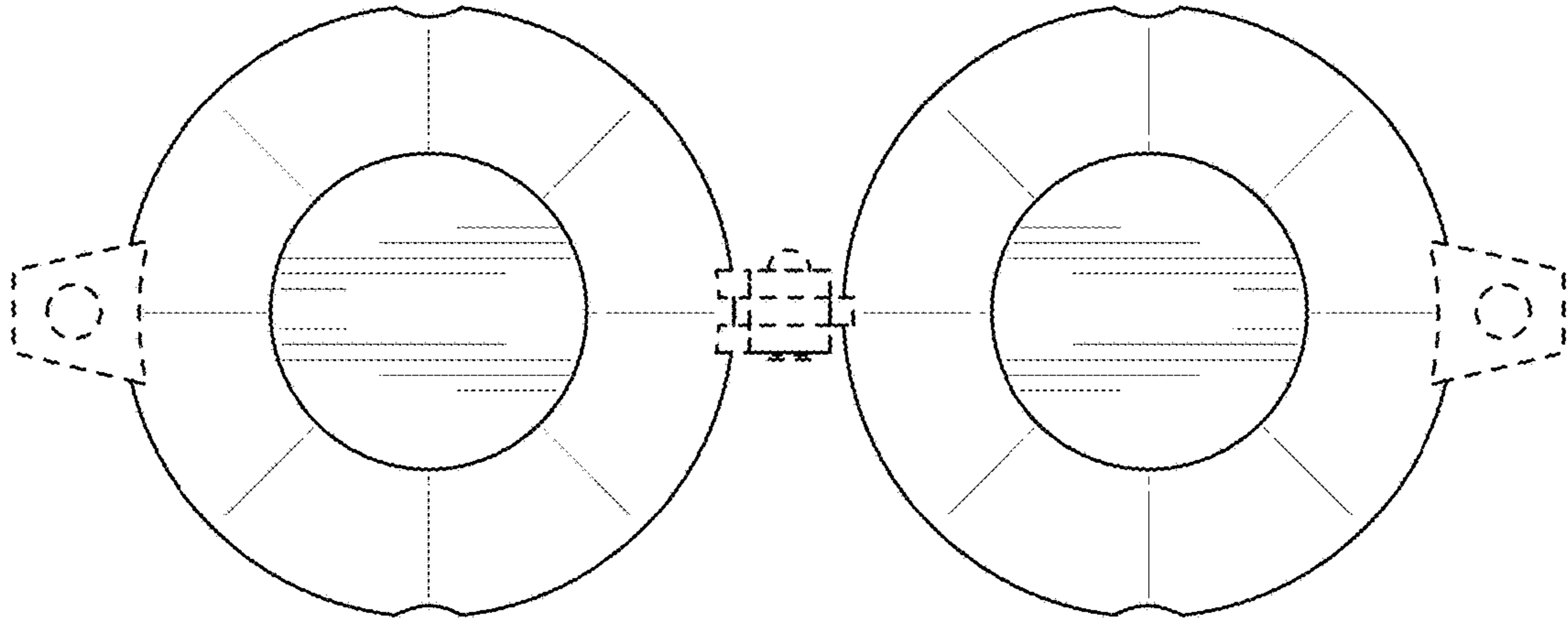

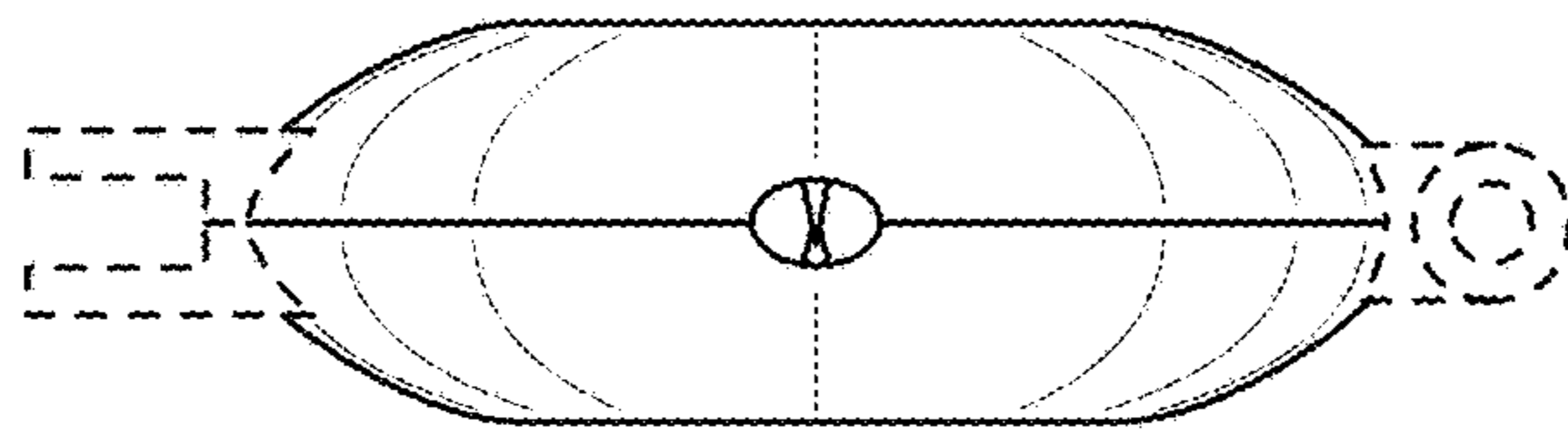

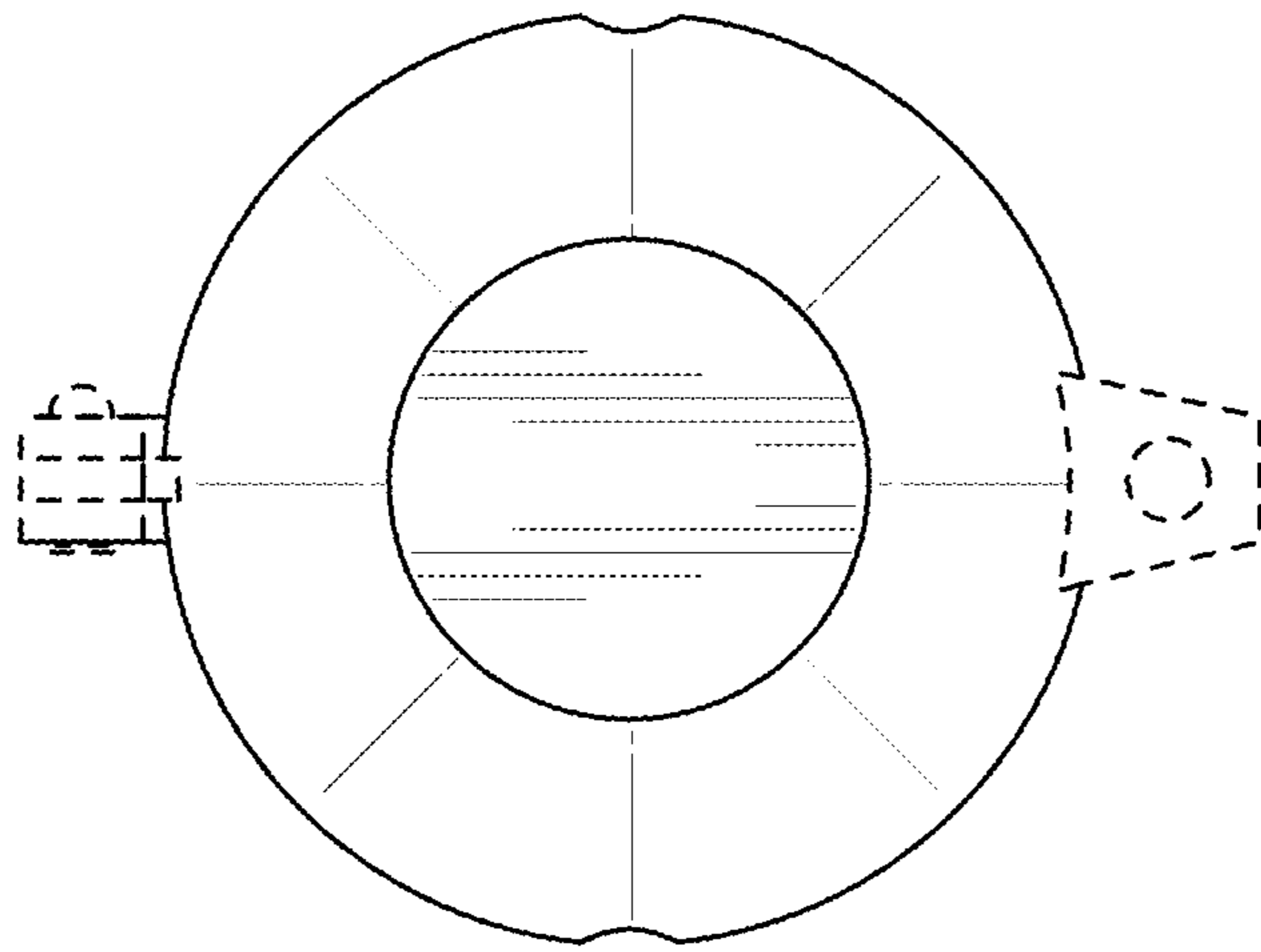

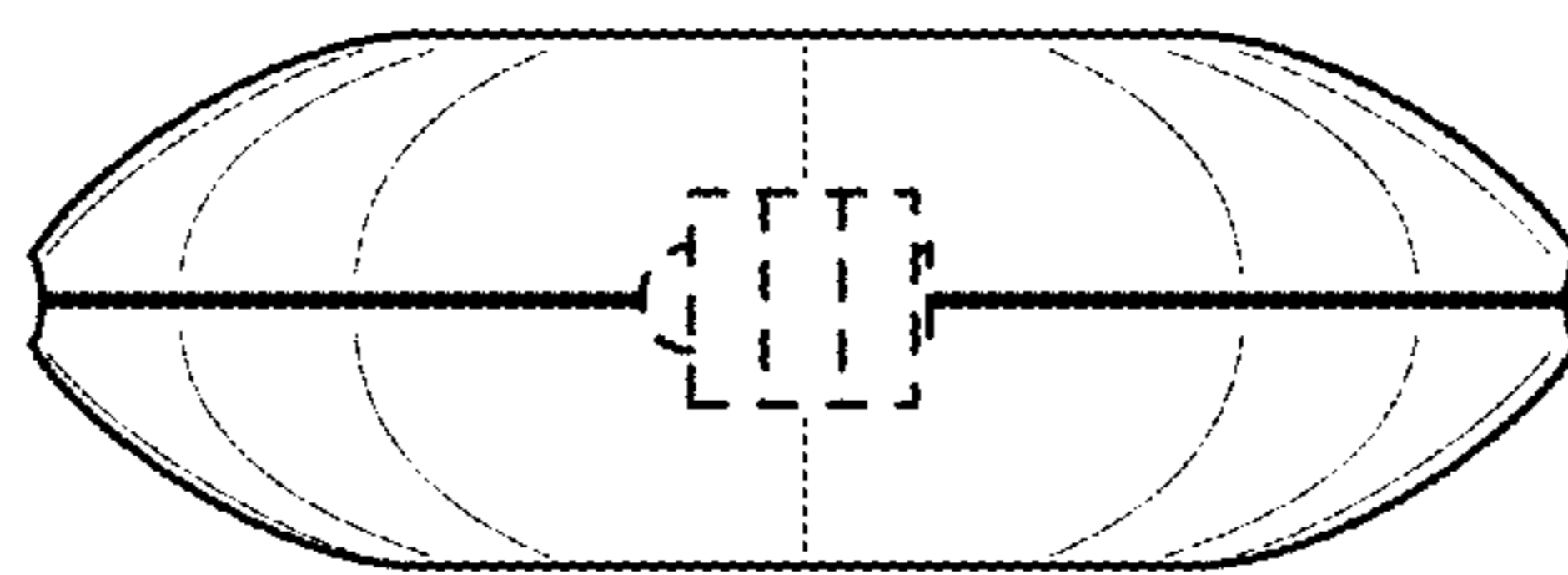

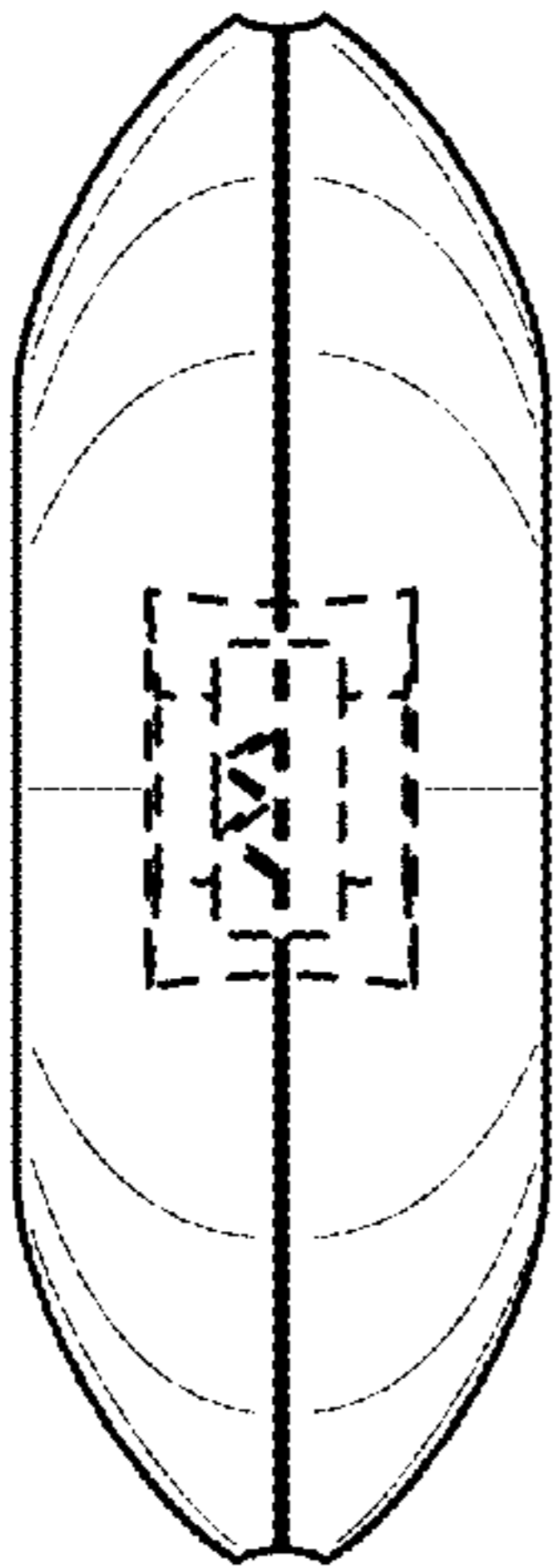

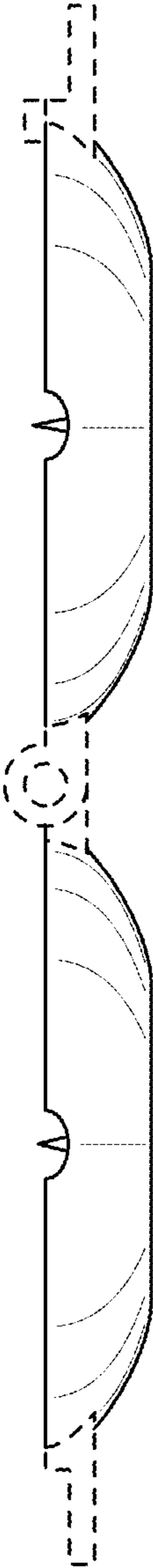
