DESCRIPTION

FIG. 3 is a right side view of the triangular toy street sign of FIG. 1;

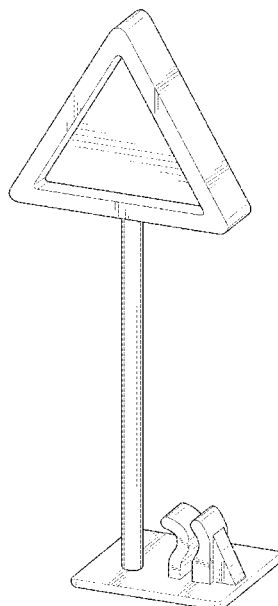
FIG. 4 is a left side view of the triangular toy street sign of FIG. 1;

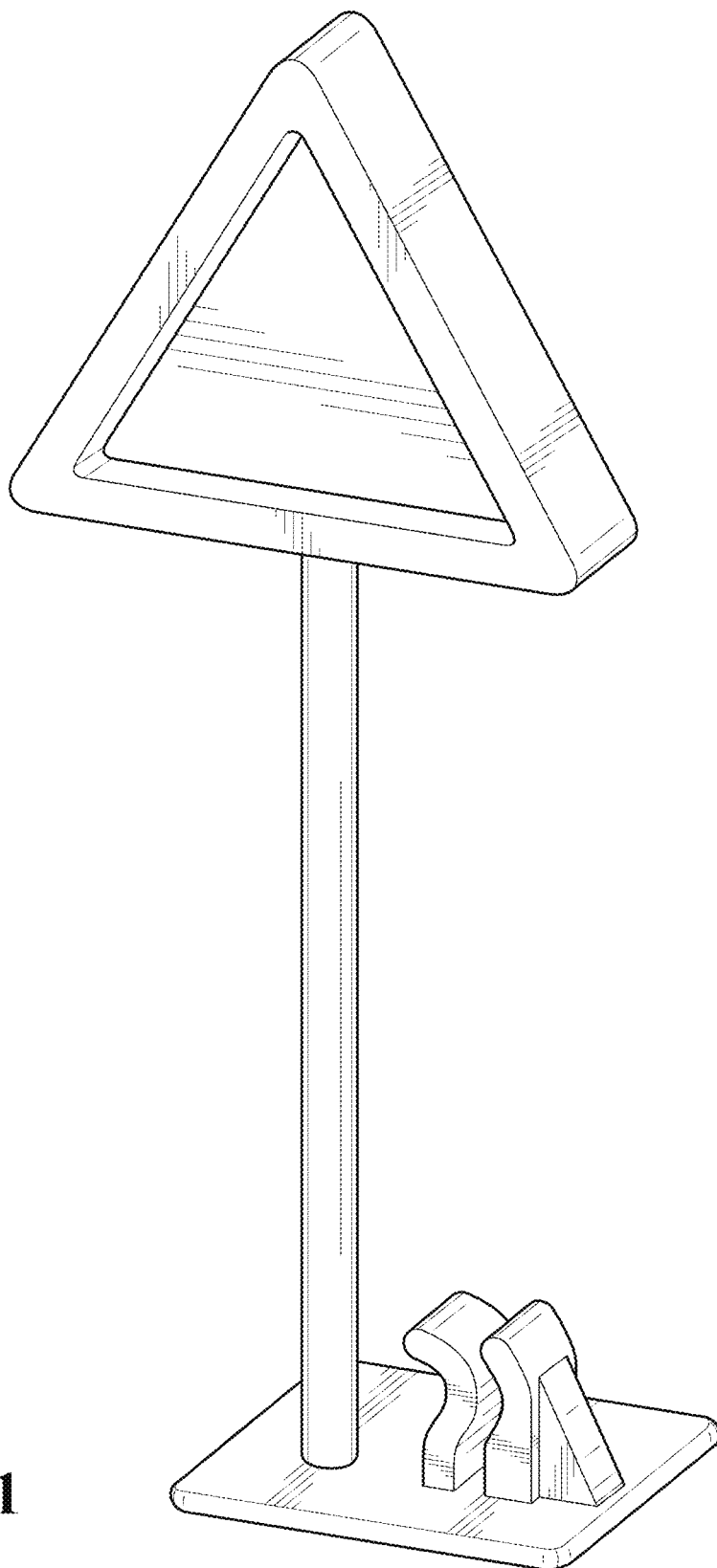

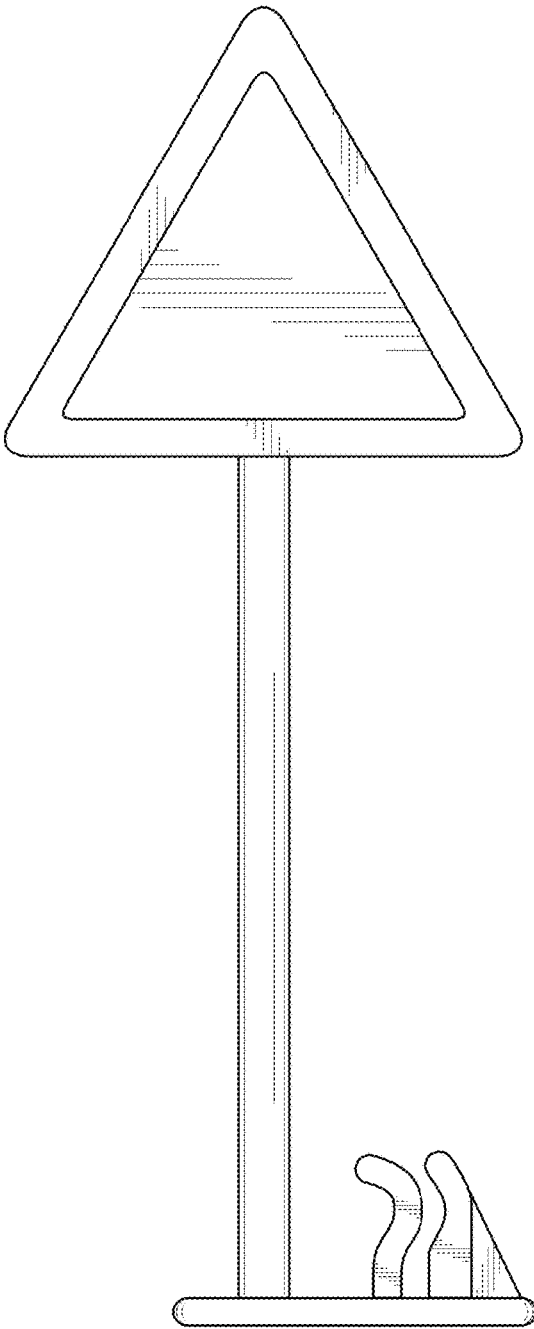

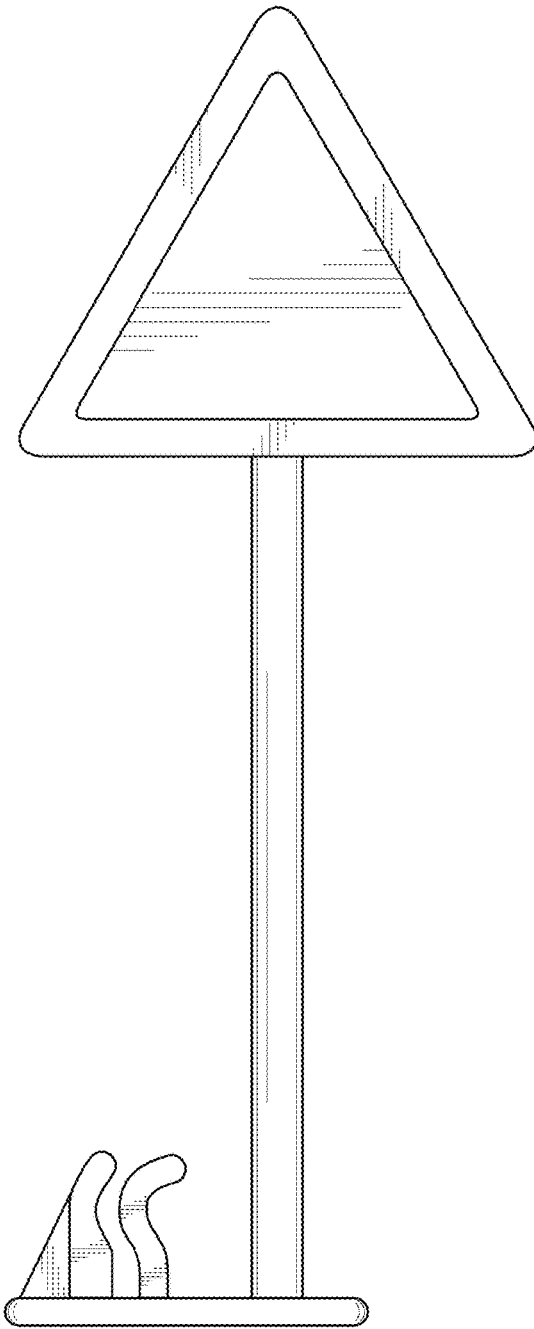

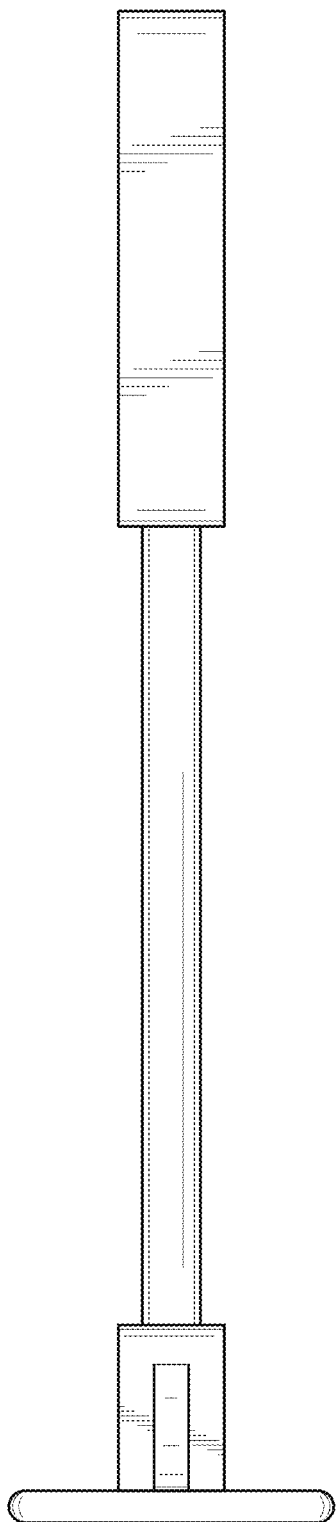

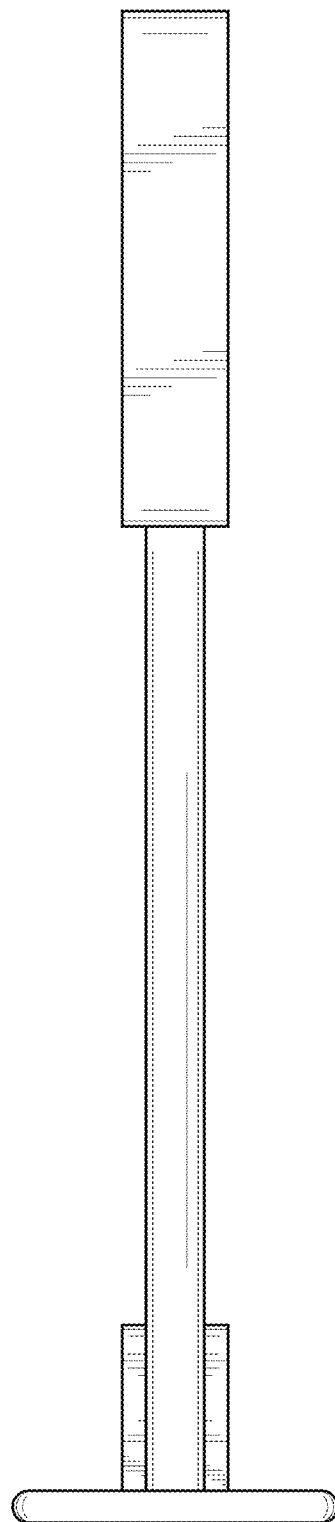

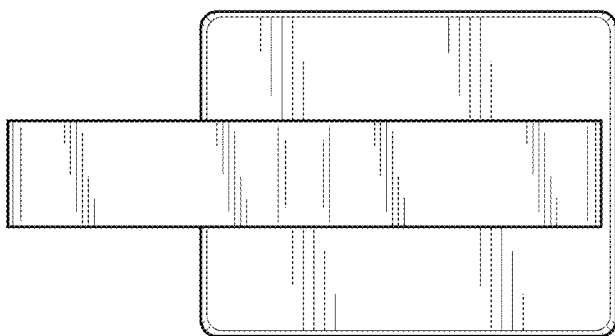

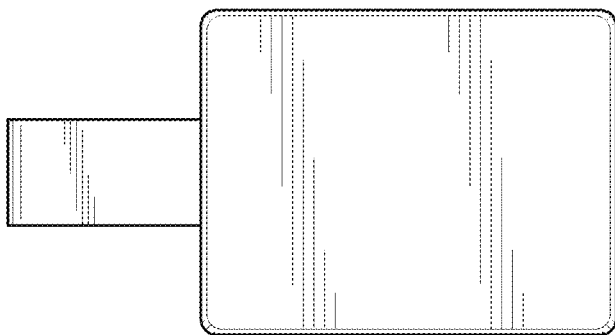
