
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a funnel showing my new design;  
FIG. 2 is a left side elevation view thereof; the right side  
elevation view being an identical mirror image thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a top, left perspective view thereof.












