(57) **CLAIM**

The ornamental design of an extra large truck mirror, as shown and described.

DESCRIPTION


FIG. 1 is a perspective view taken from the front, top, right side of the extra large truck mirror showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a back elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view taken from the back, top right side of the extra large truck mirror of FIG. 1; and, FIG. 9 is a perspective view of a second embodiment of the extra large truck mirror taken from the front, top, left side, the second embodiment being substantially a mirror image of the first embodiment, further views of the second embodiment not being shown as the further views are mirror images of the corresponding views of FIGS. 1 through 8. Portions shown in broken lines are for illustrative purposes only and form no part of the claimed design.

















