DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a headphone showing my new design;

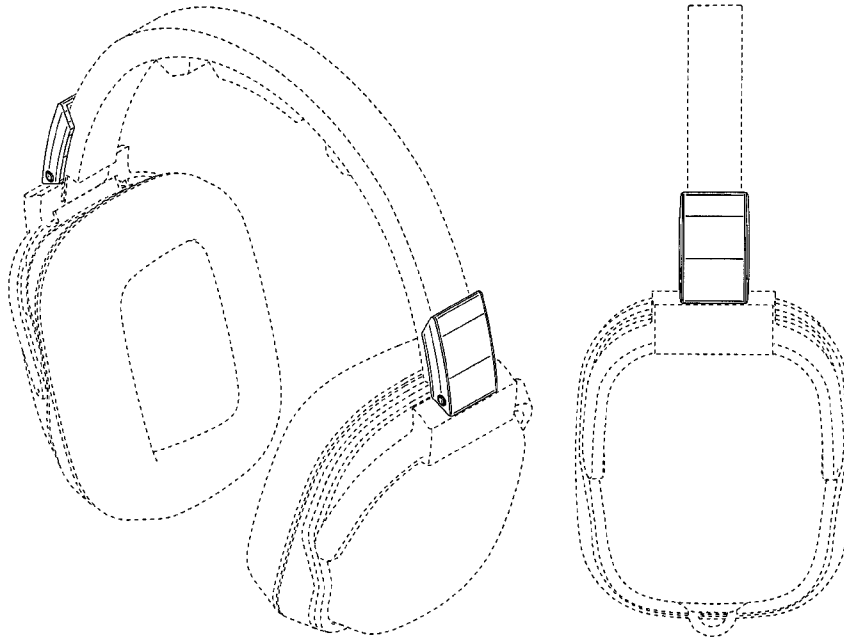

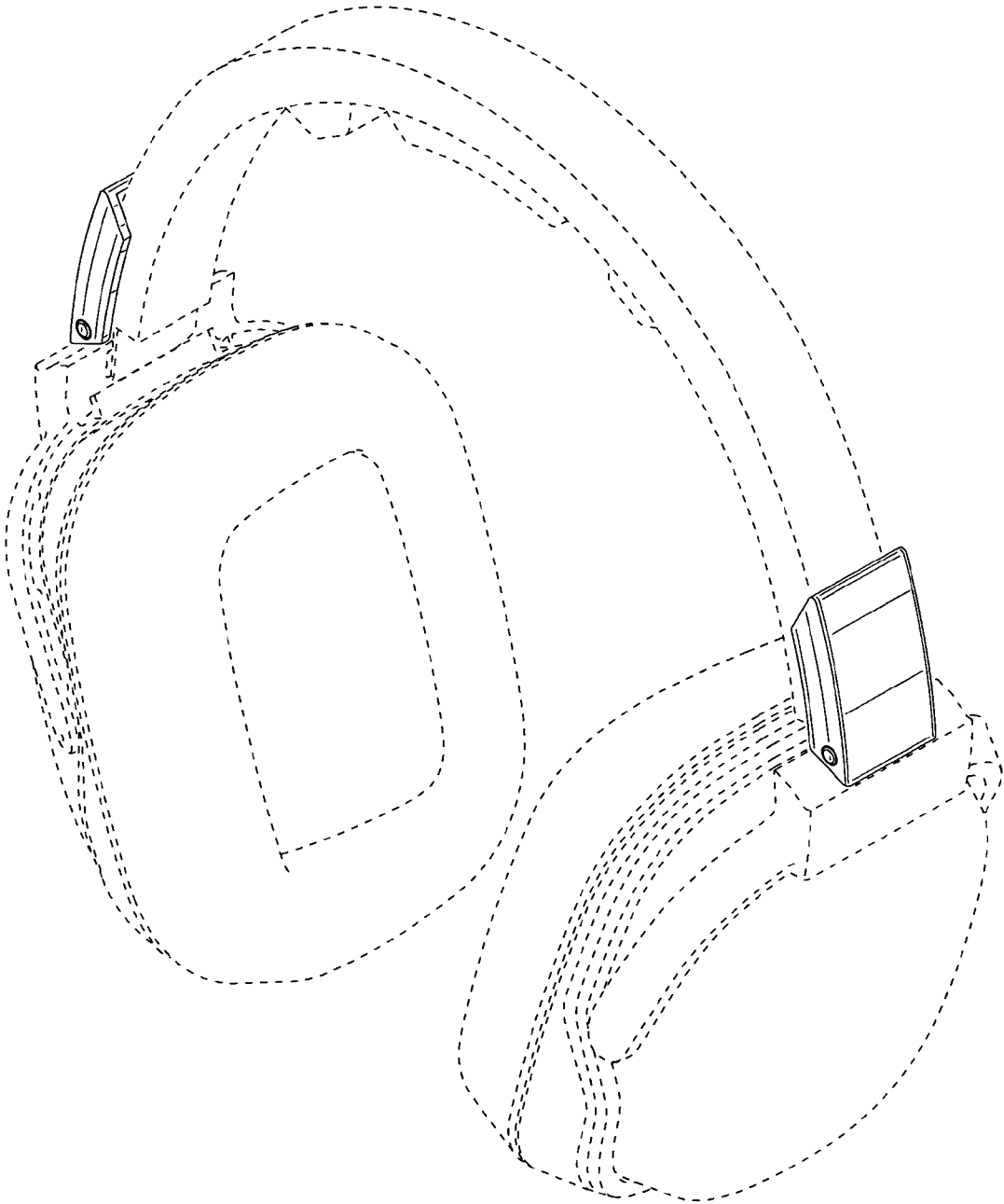

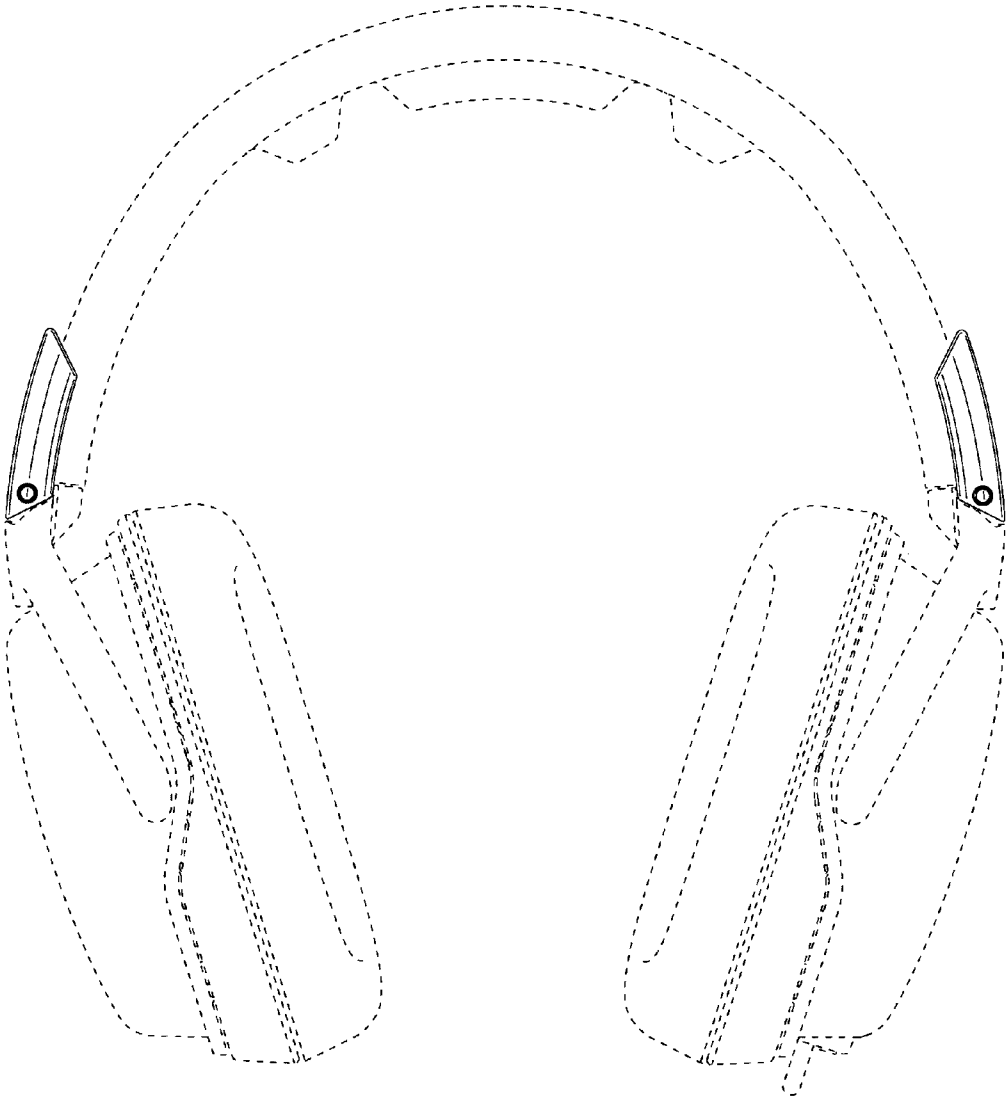

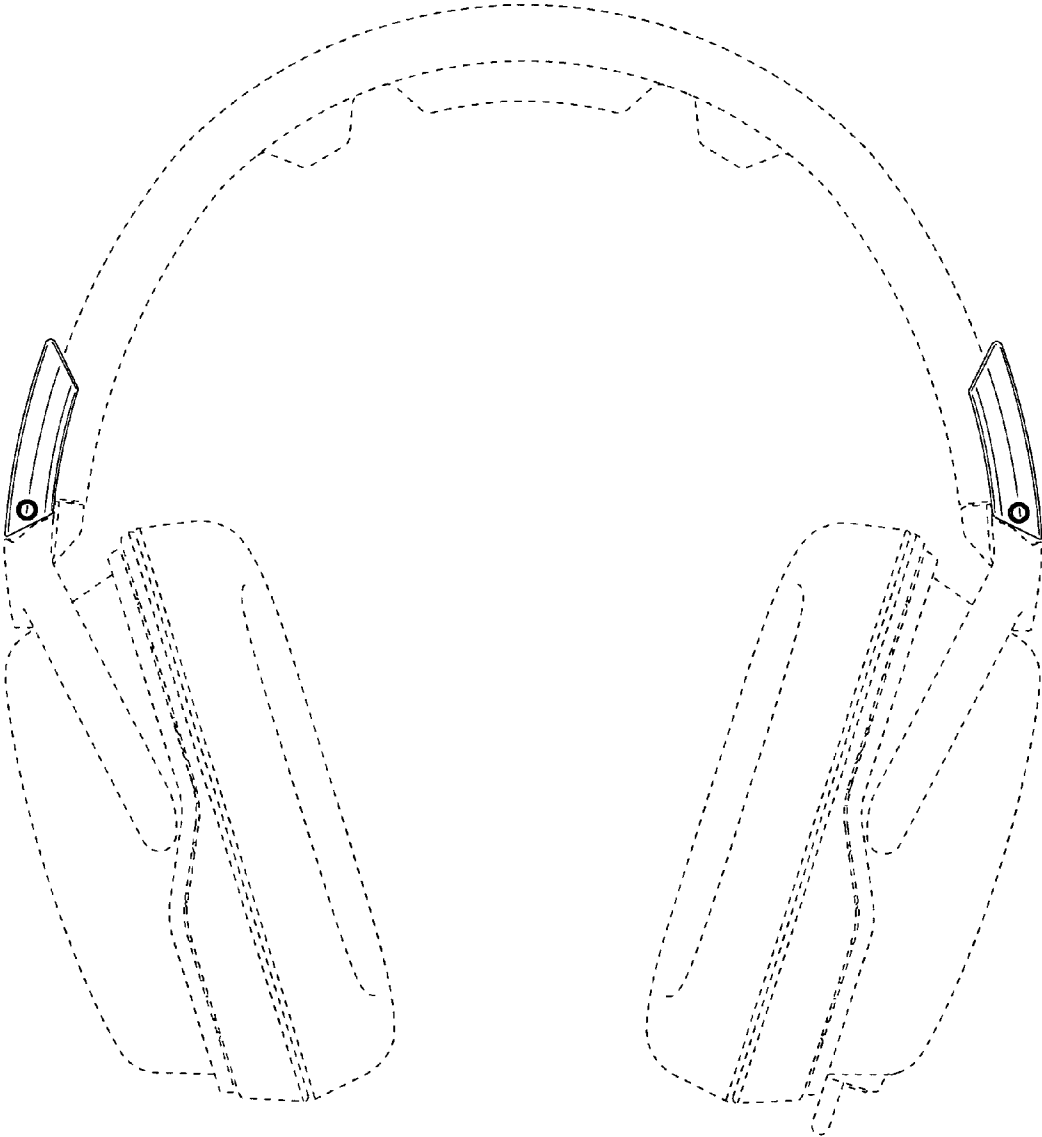

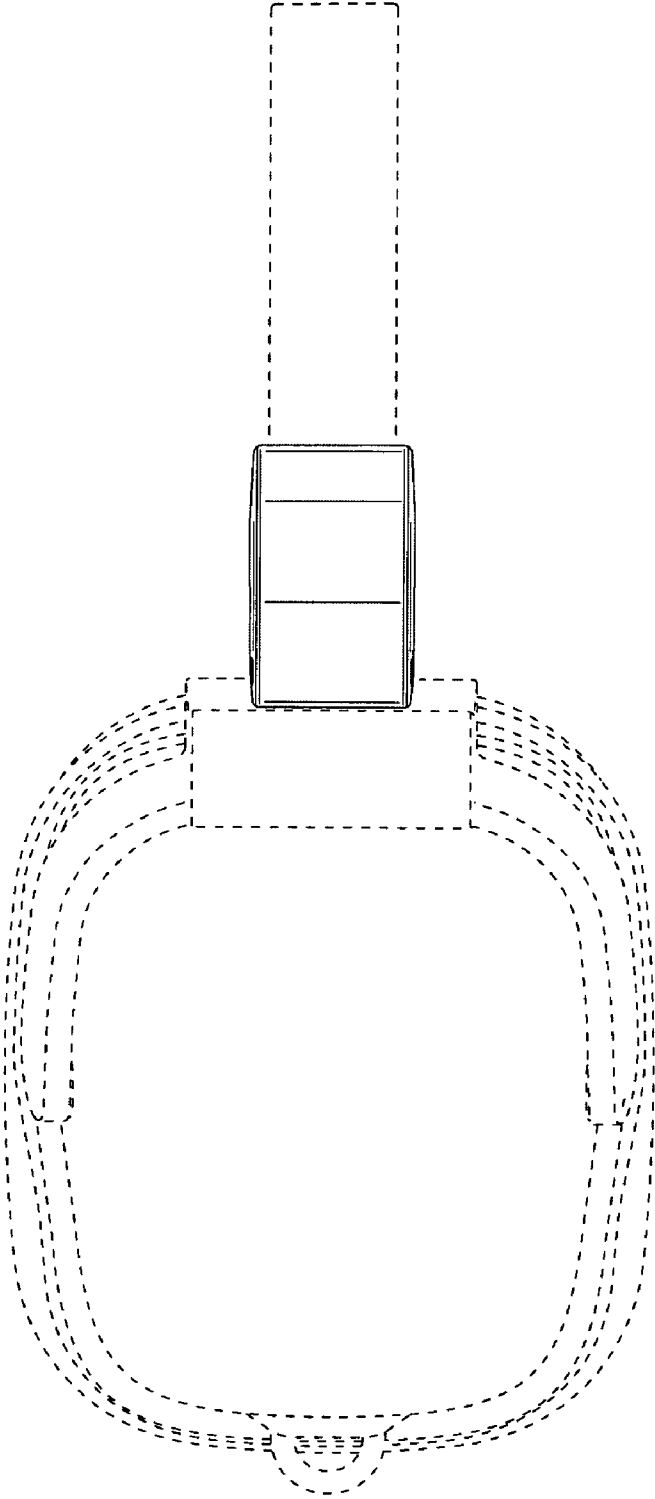

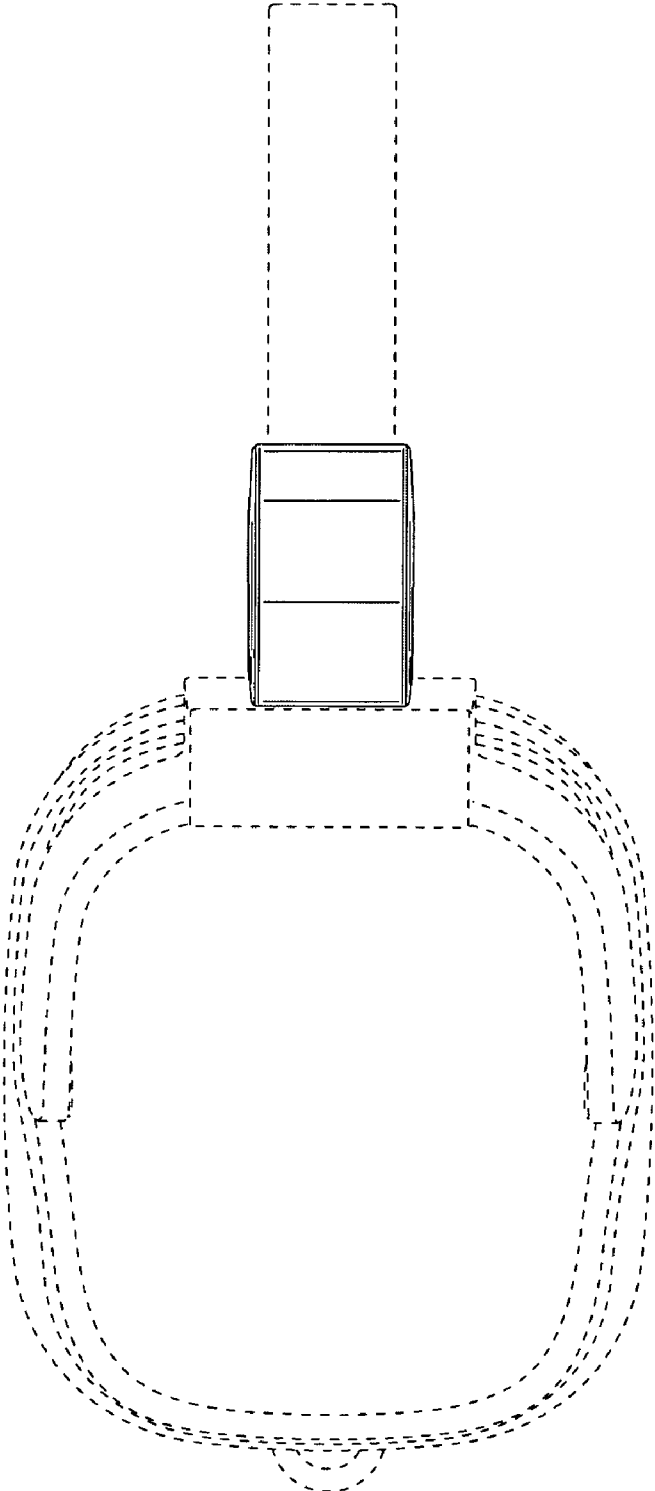
