(57) **CLAIM**

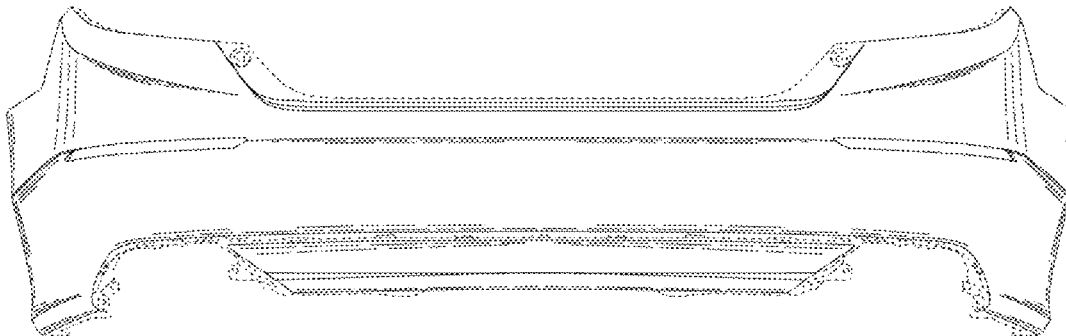
The ornamental design for a rear bumper for an automobile,

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a rear bumper for an automobile showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

The broken lines in the drawings illustrate portions of the rear bumper for an automobile that form no part of the claimed design.

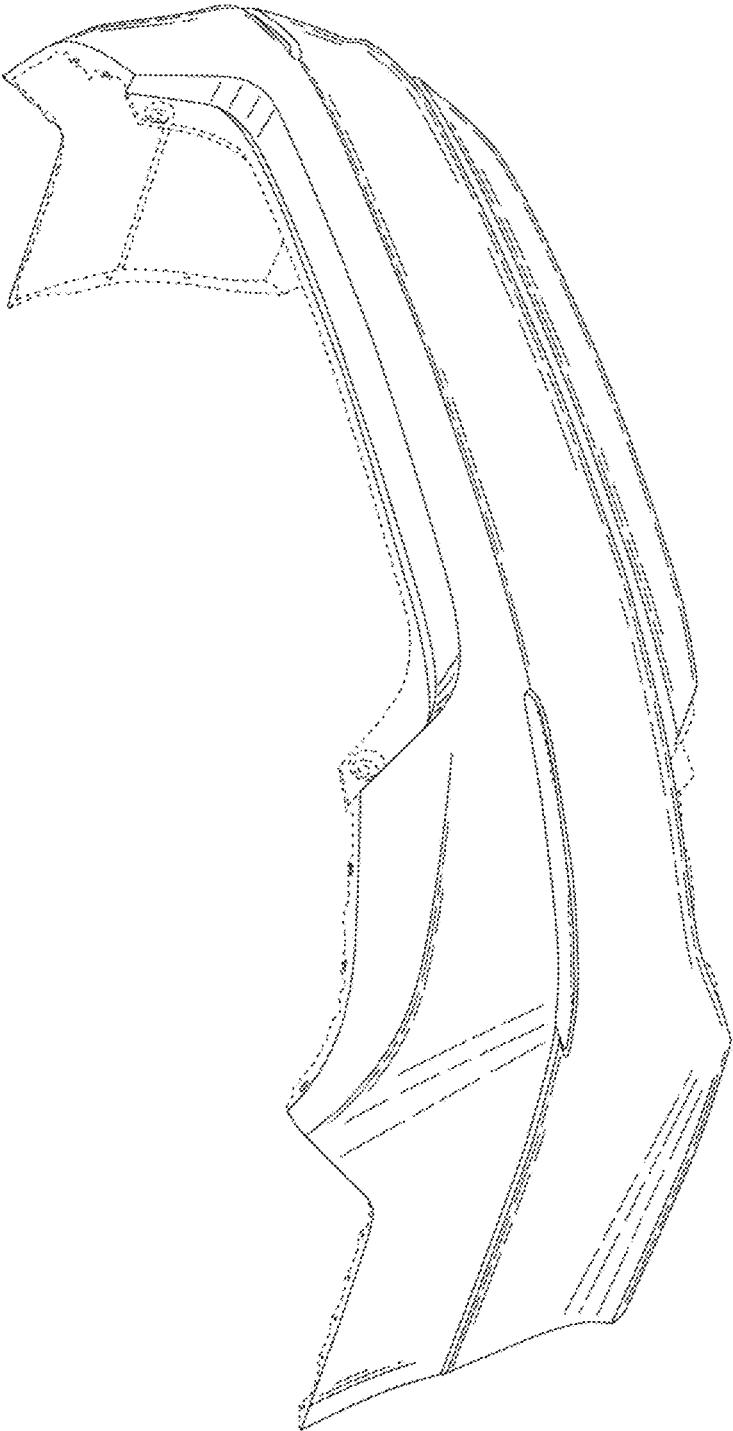

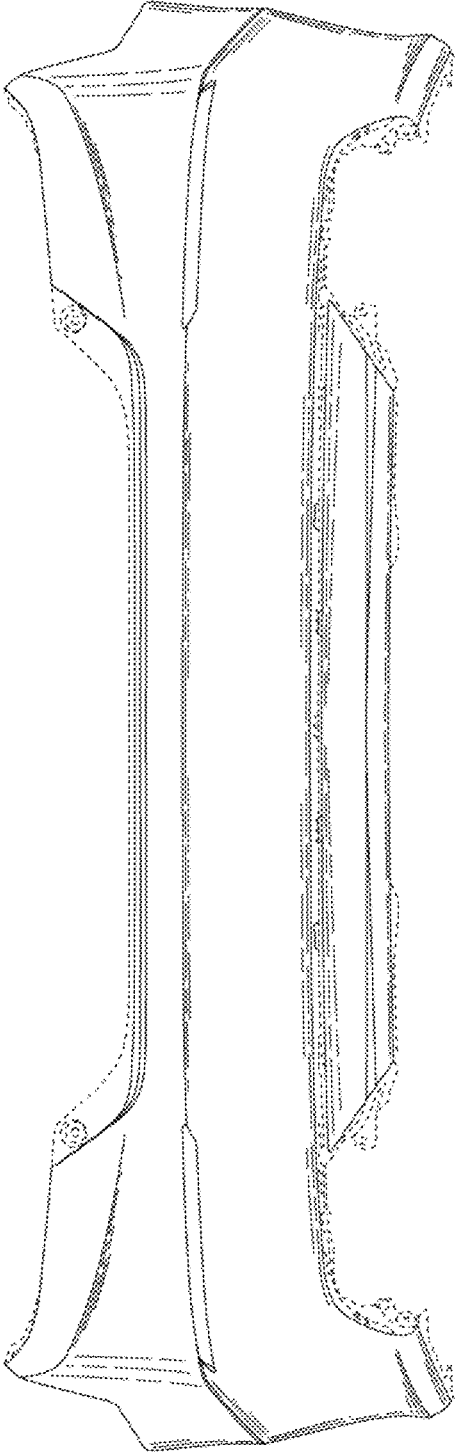

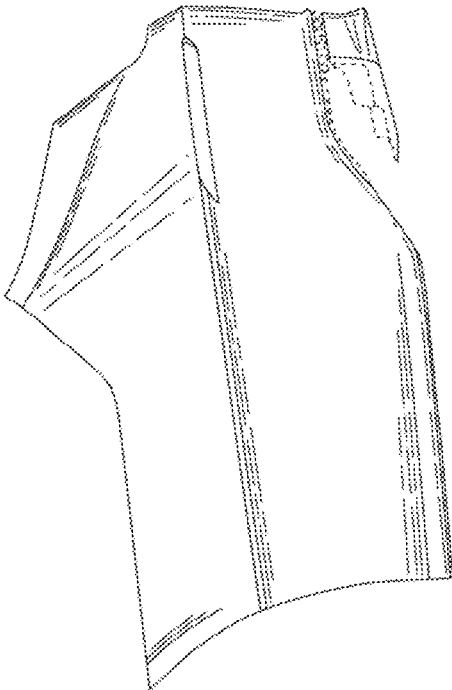

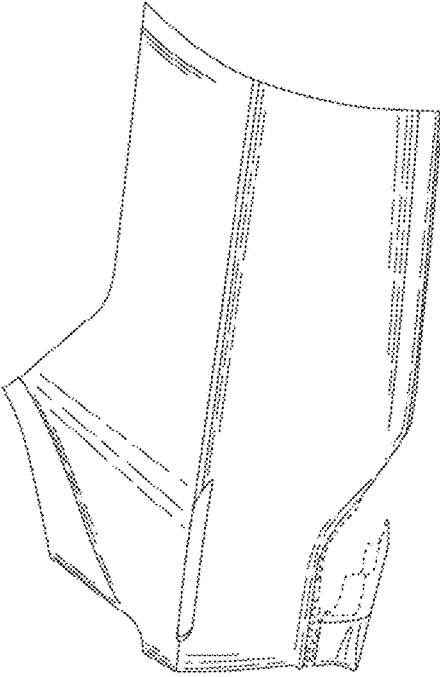

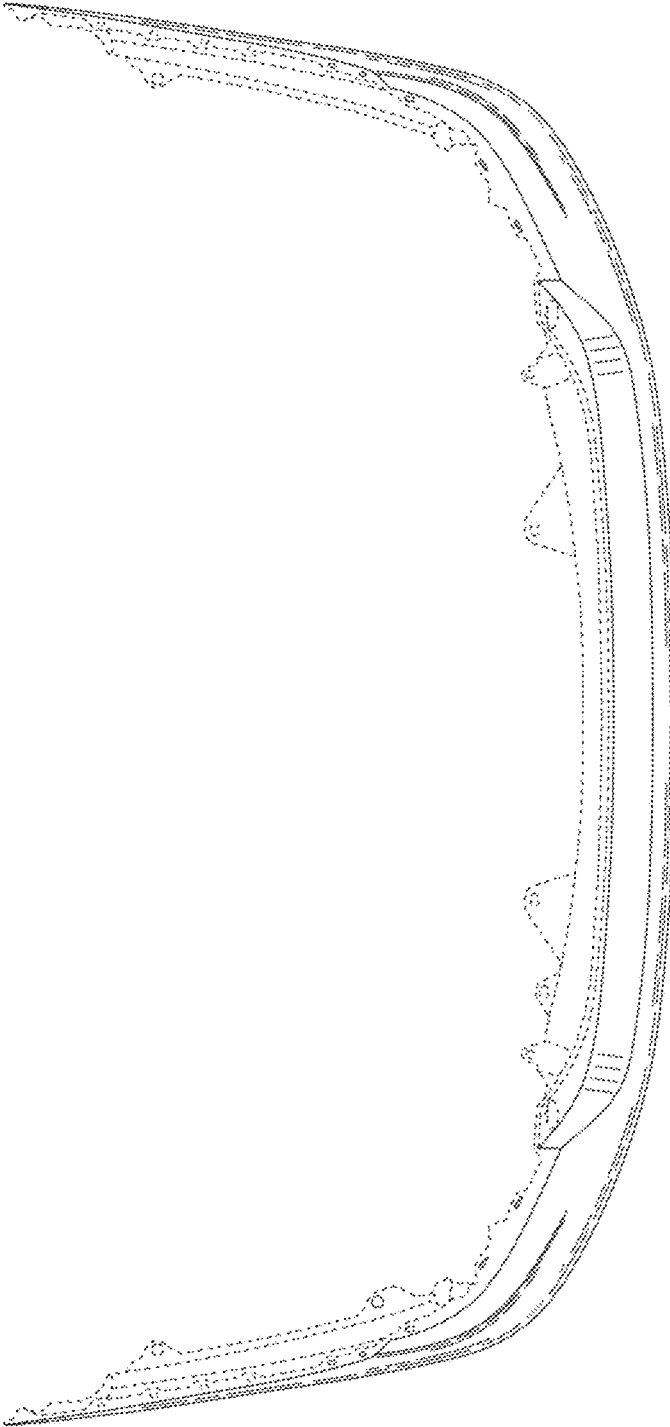

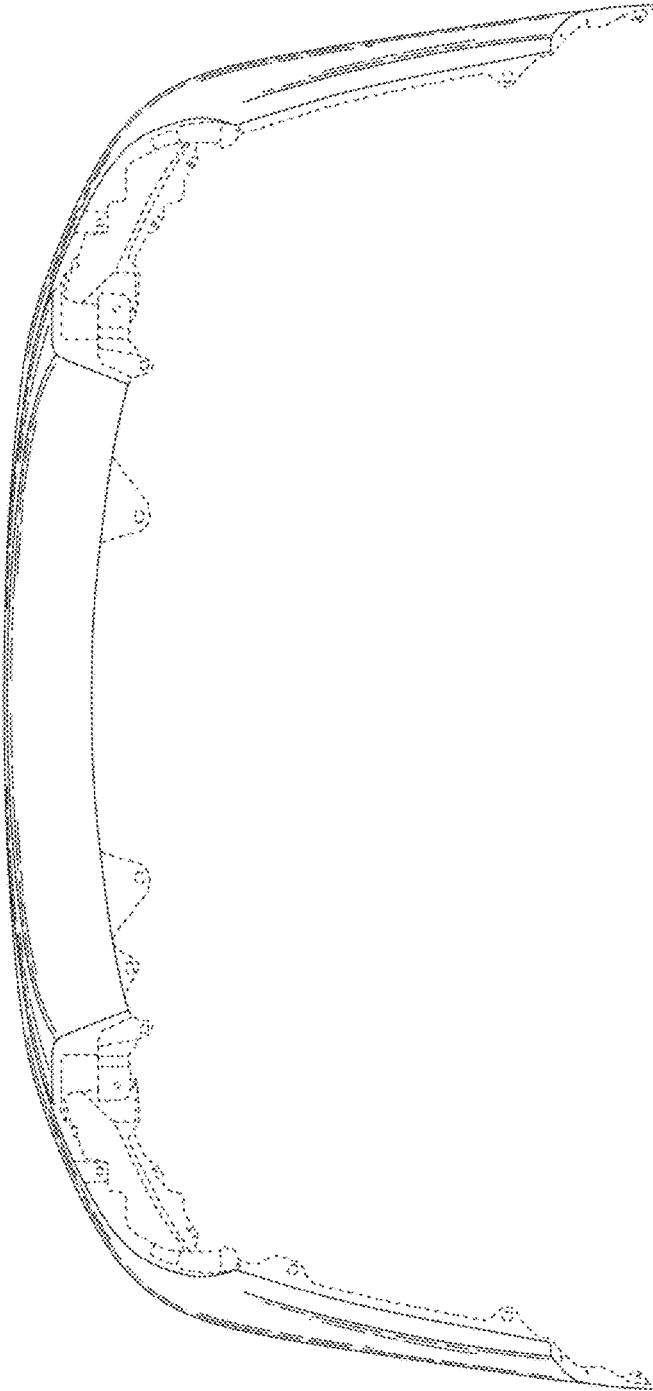
