
(57) **CLAIM**

The ornamental design for the pathway luminaire, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a right side elevation view thereof, showing the lamp pivoted to an alternate position; and, FIG. 9 is a left side elevation view thereof, showing the lamp pivoted to another alternate position.


















