#### (57) **CLAIM**

The ornamental design for a portion of a palm side of a glove, as shown and described.

### DESCRIPTION

FIG. 1 is a plan view of a portion of a palm side of a glove showing my new design;

FIG. 2 is a first perspective view thereof; and,

FIG. 3 is second perspective view thereof.

The uneven broken line immediately adjacent to the shaded area represents an unclaimed boundary of the design. The uneven broken line showing of the remainder of the glove is for illustrative purposes only and forms no part of the claimed design.
