(57) **CLAIM**

The ornamental design for a faucet stream straightener, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a faucet stream straightener in accordance with my design; FIG. 2 is a top, front perspective view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a bottom, rear perspective view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a rear elevational view thereof; and FIG. 8 is a right side elevational view thereof; FIG. 9 is a top plan view of a second embodiment of a faucet stream straightener in accordance with my design; FIG. 10 is a top, front perspective view thereof; FIG. 11 is a bottom plan view thereof; FIG. 12 is a bottom, rear perspective view thereof; FIG. 13 is a front elevational view thereof; FIG. 14 is a left side elevational view thereof; FIG. 15 is a rear elevational view thereof; and, FIG. 16 is a right side elevational view thereof.

The broken lines represent portions of the faucet stream straightener in which the design is embodied that form no part of the claimed design.

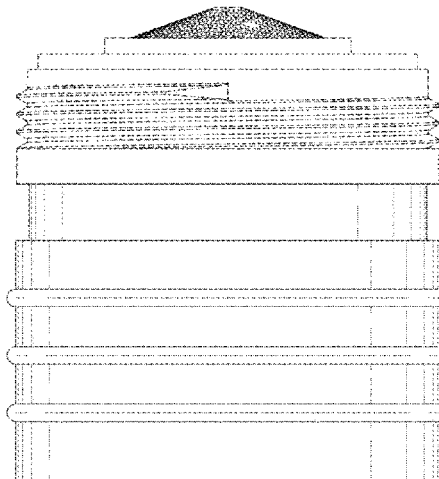
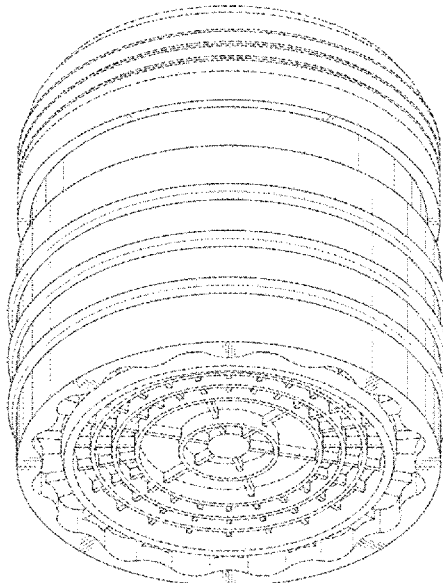

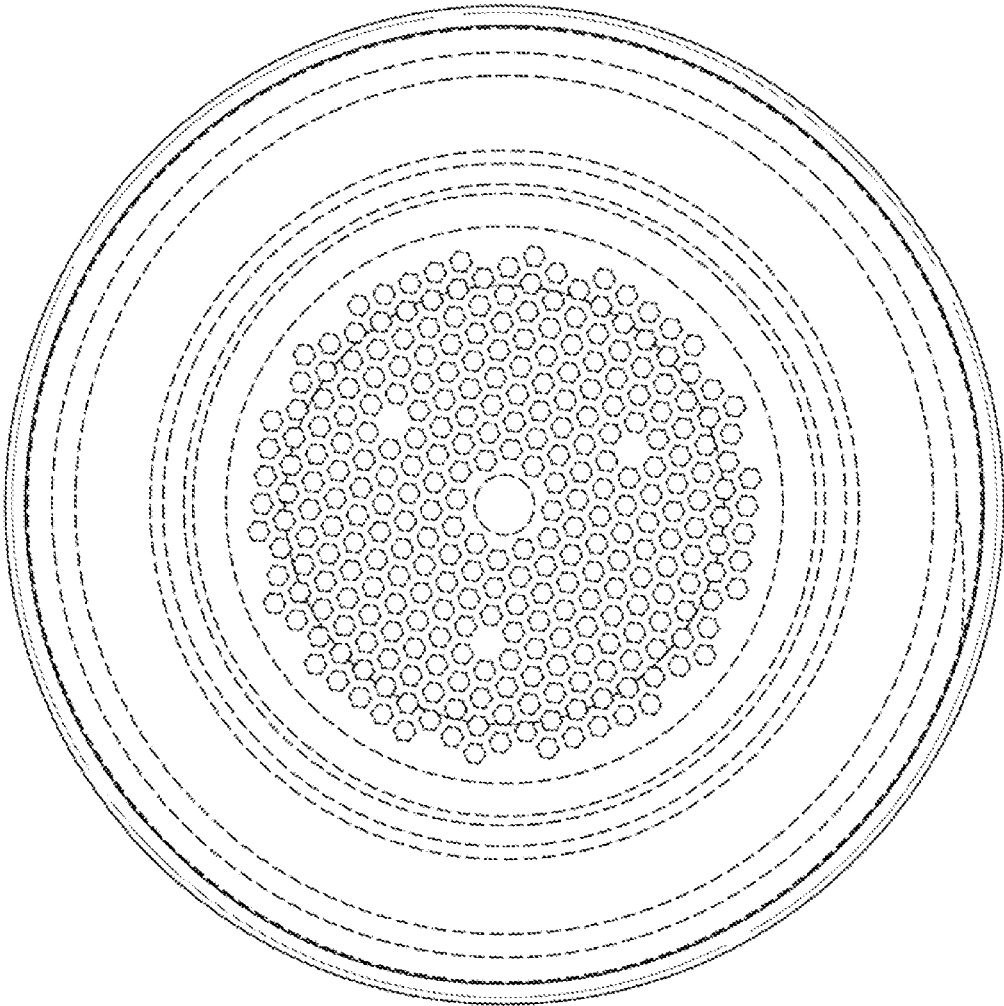

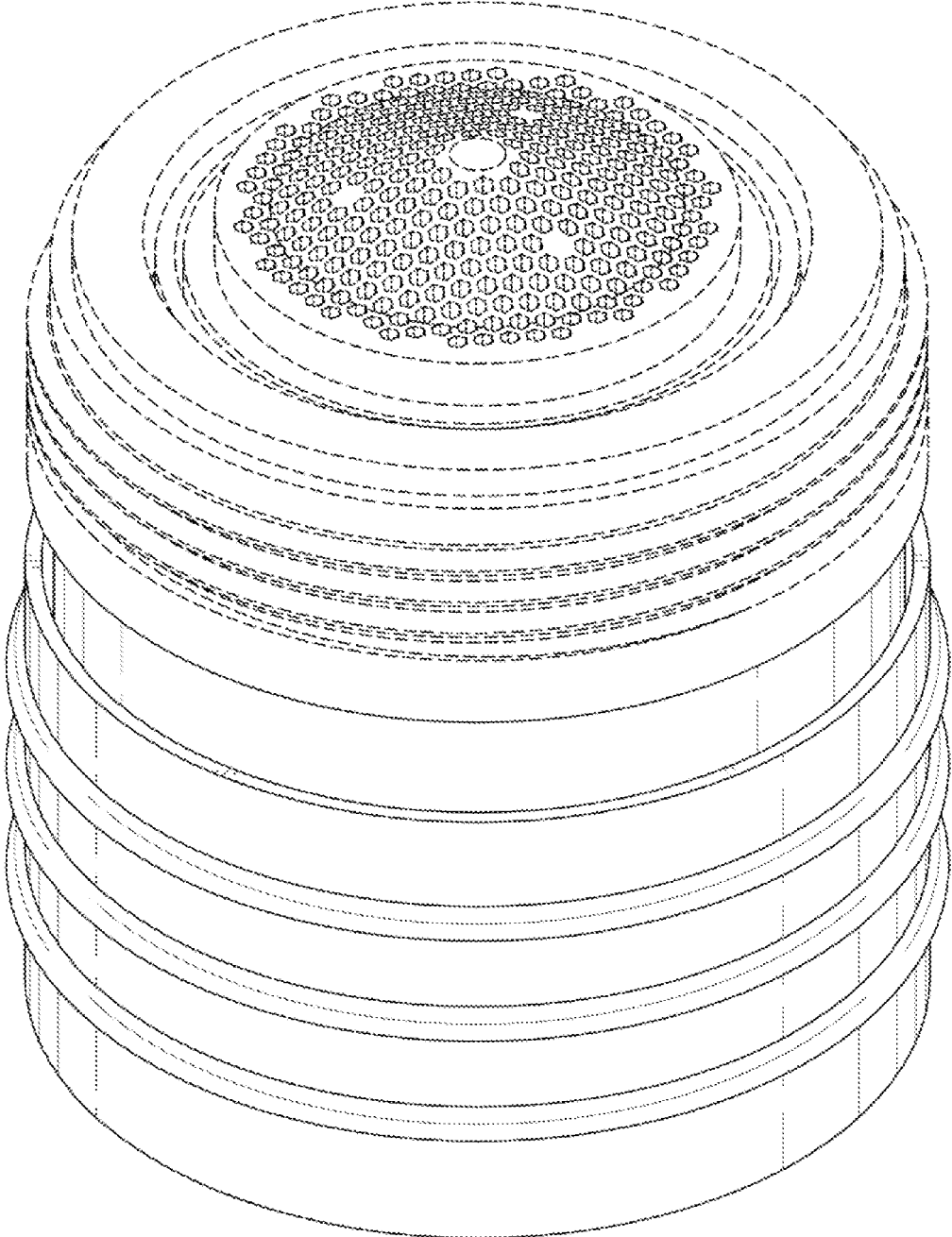

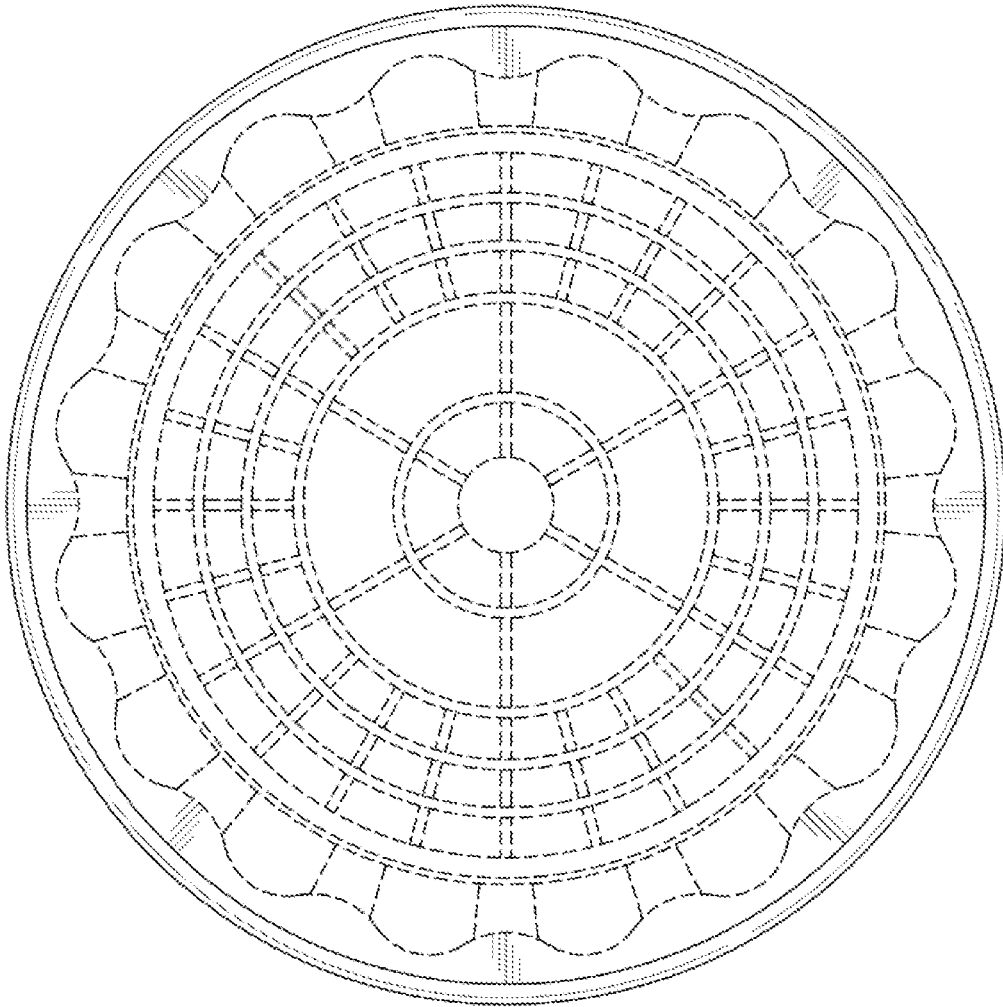

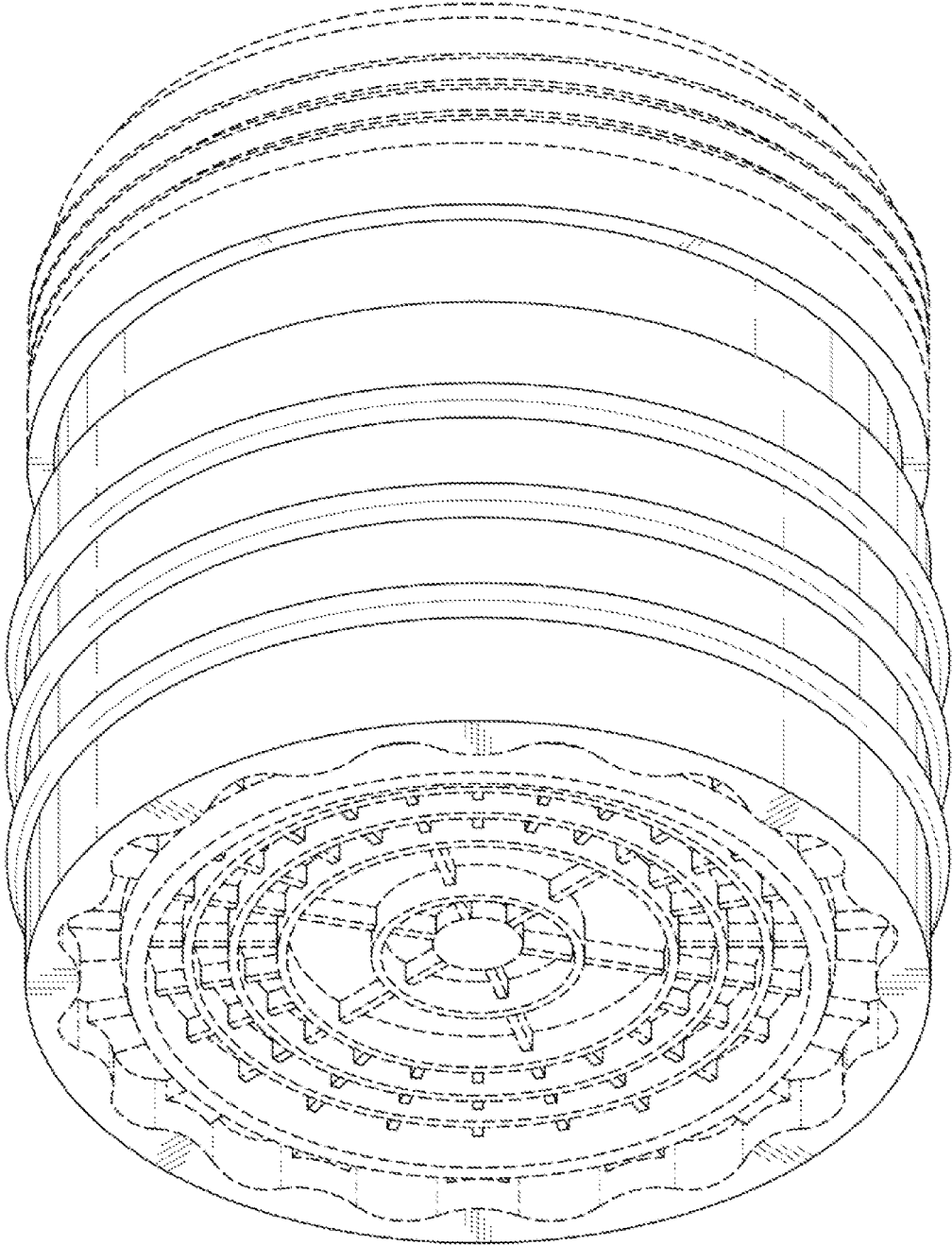

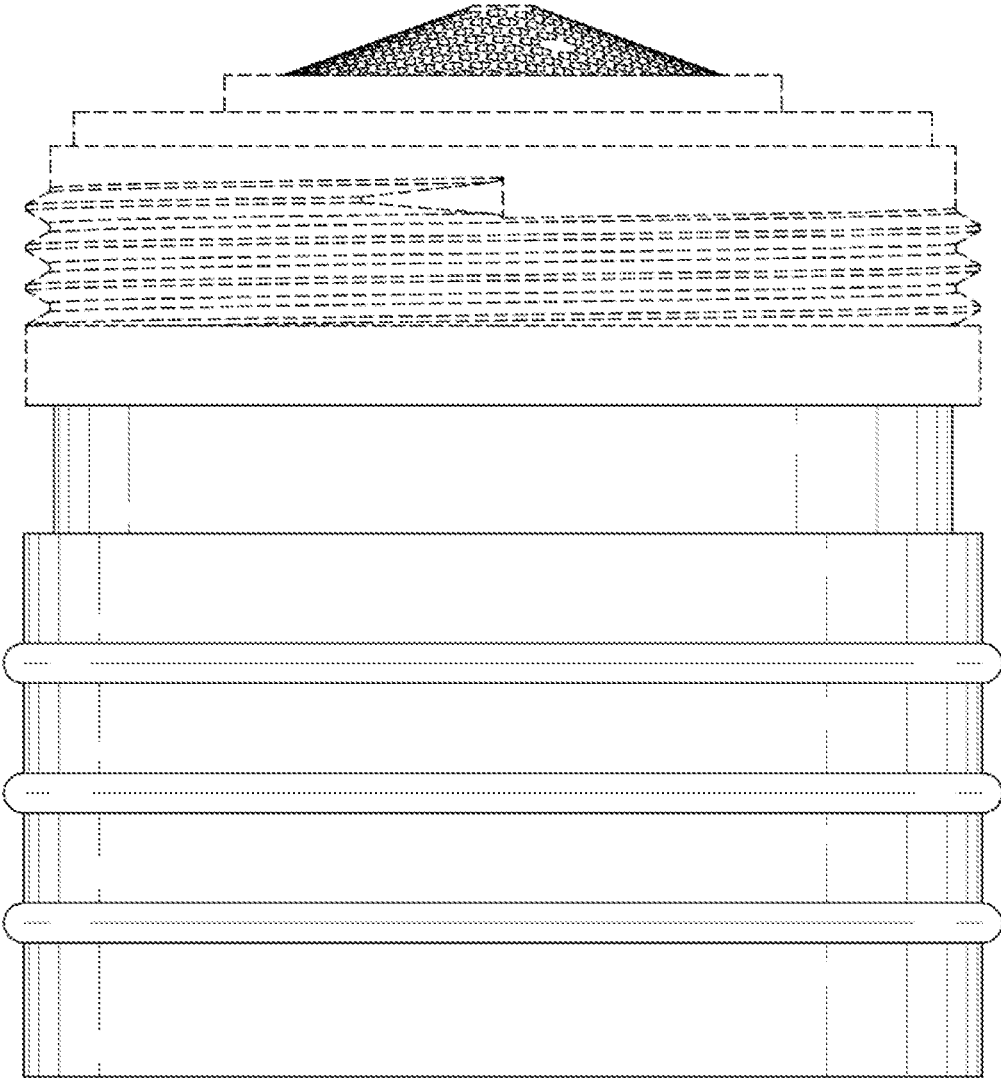

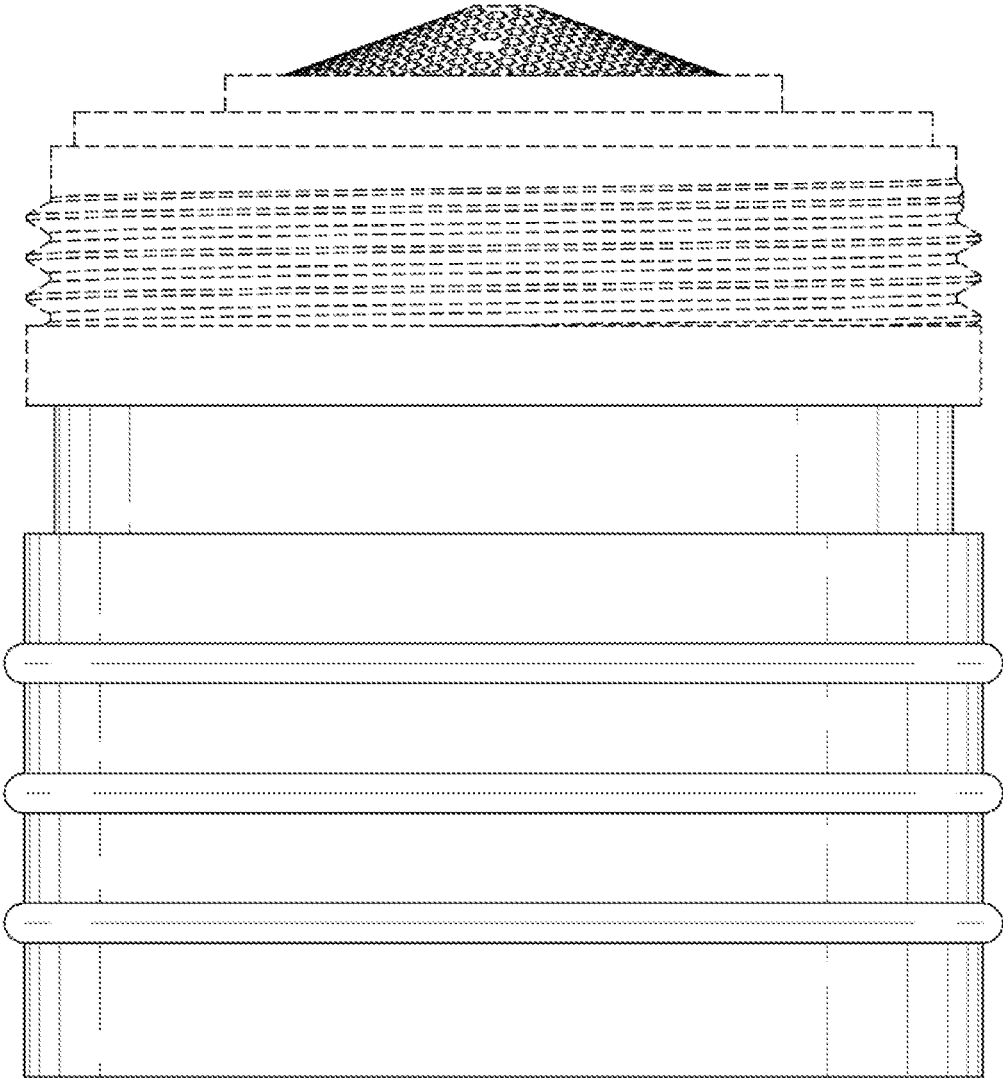

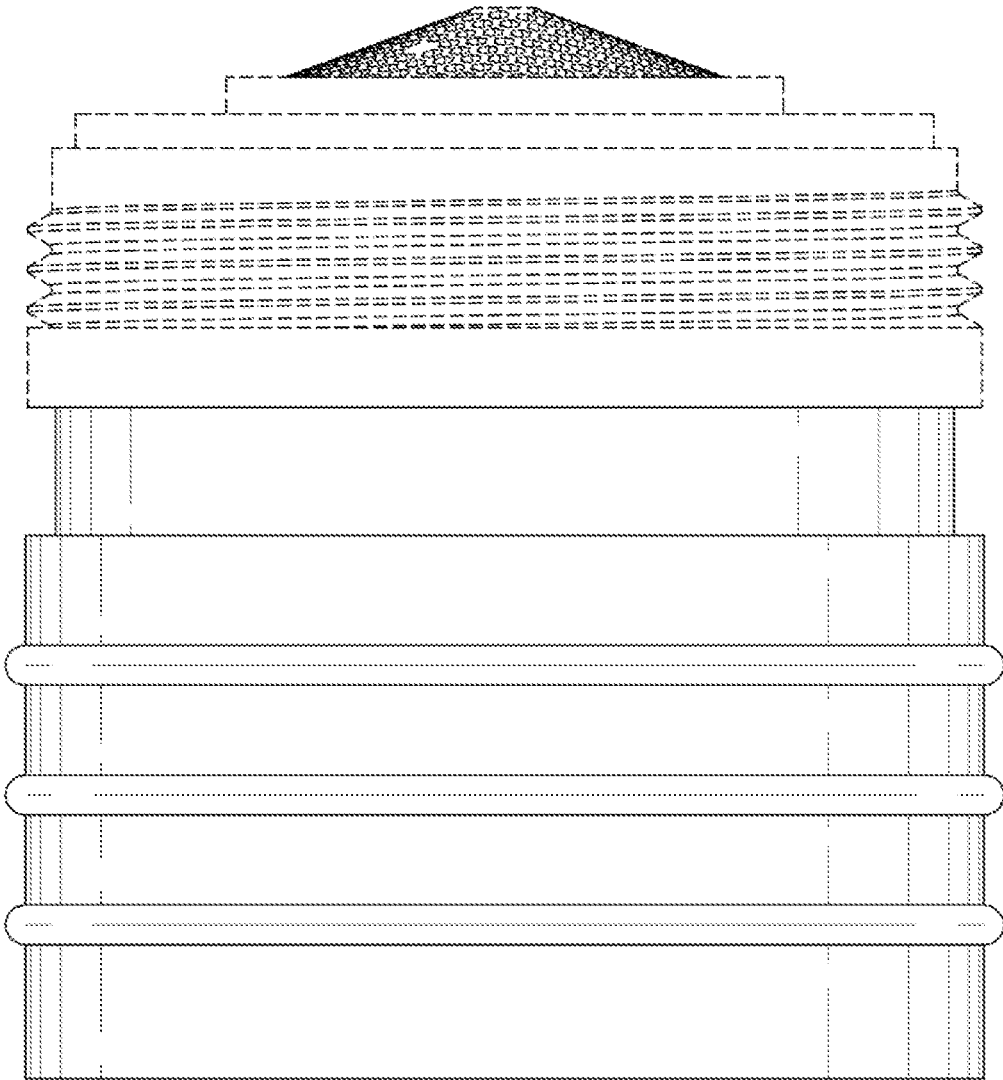

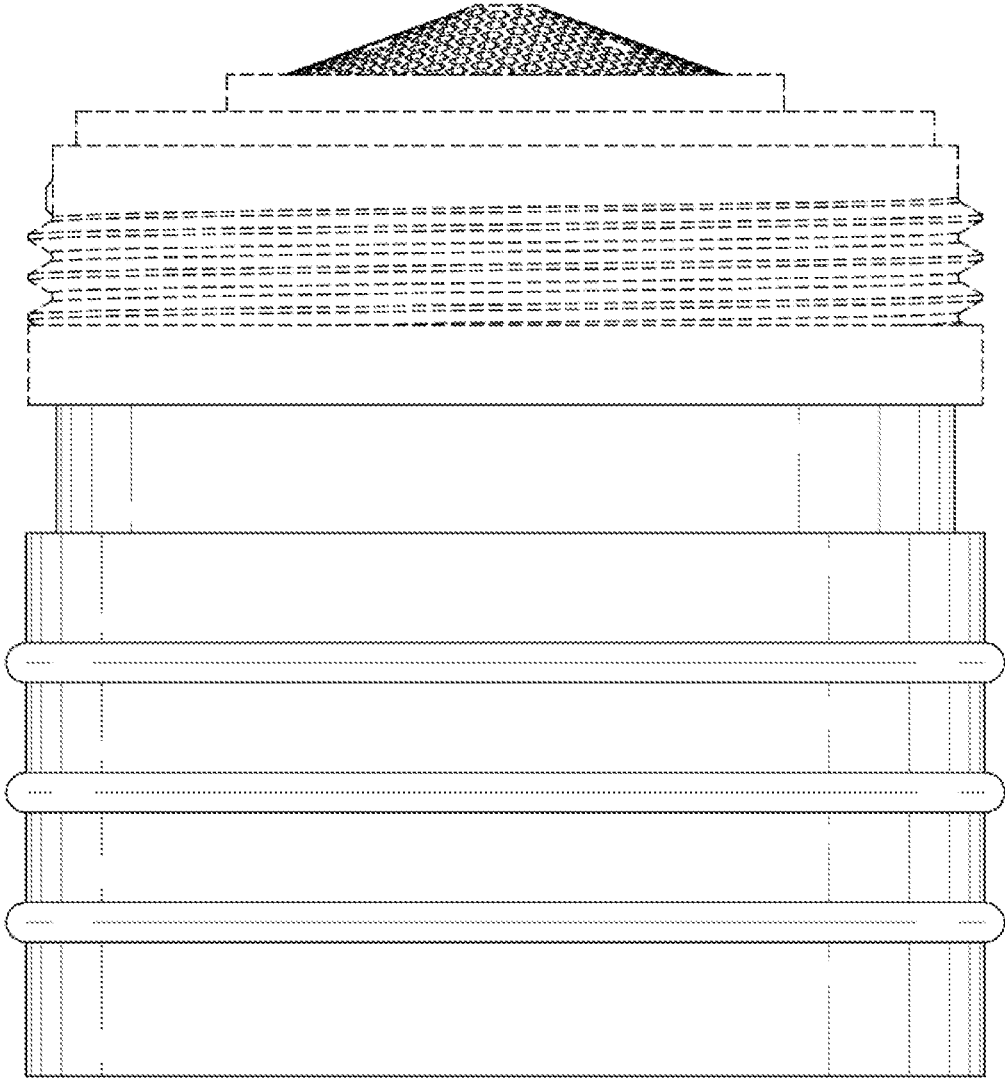

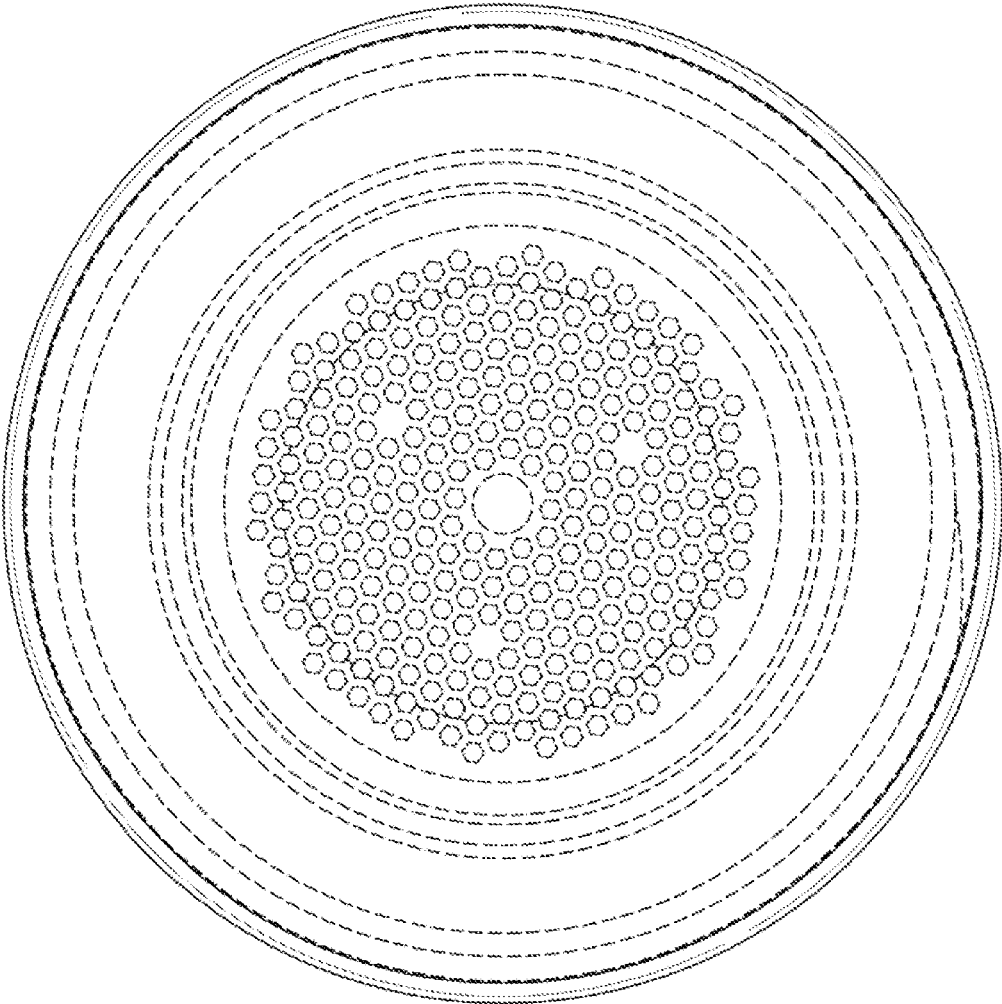

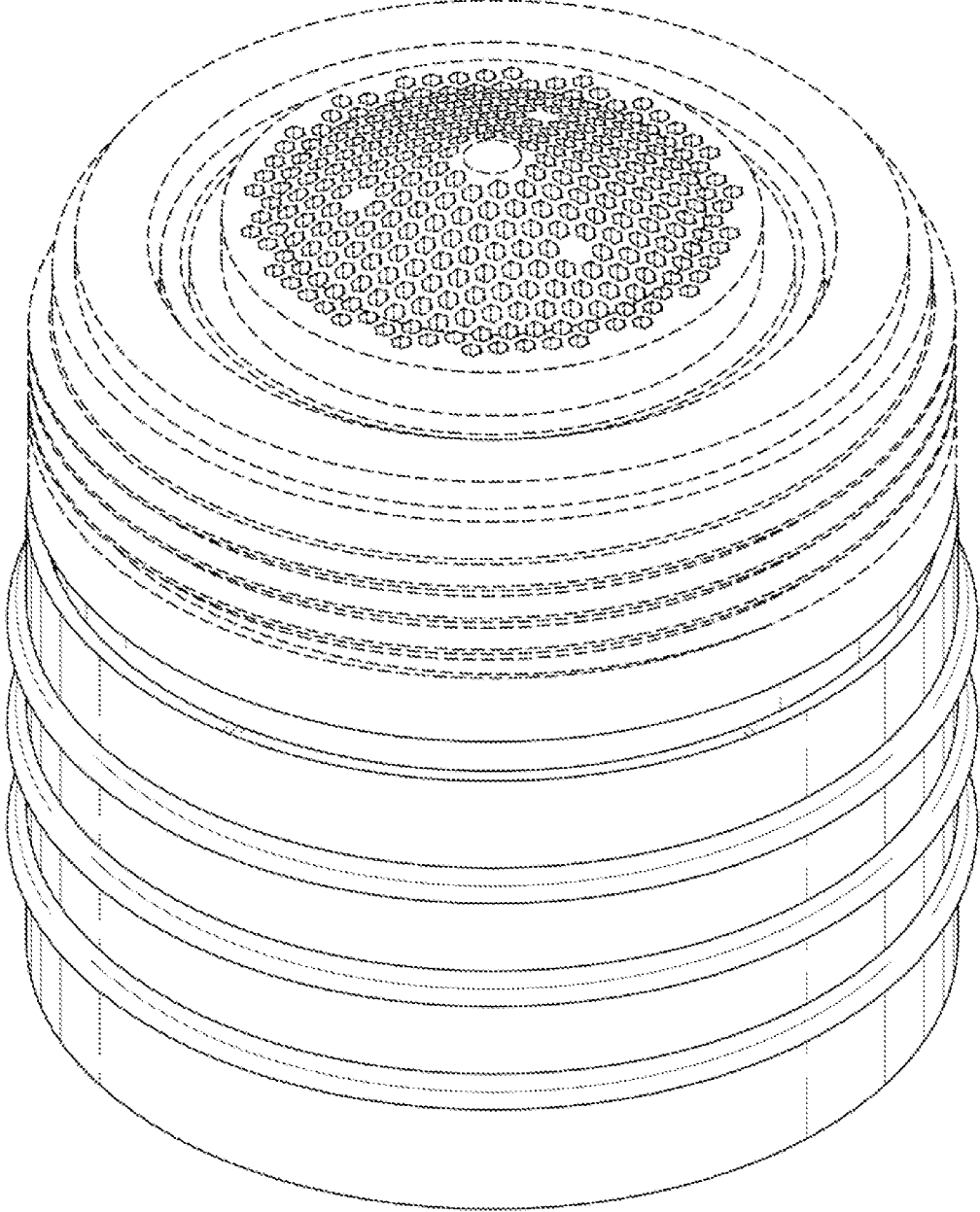

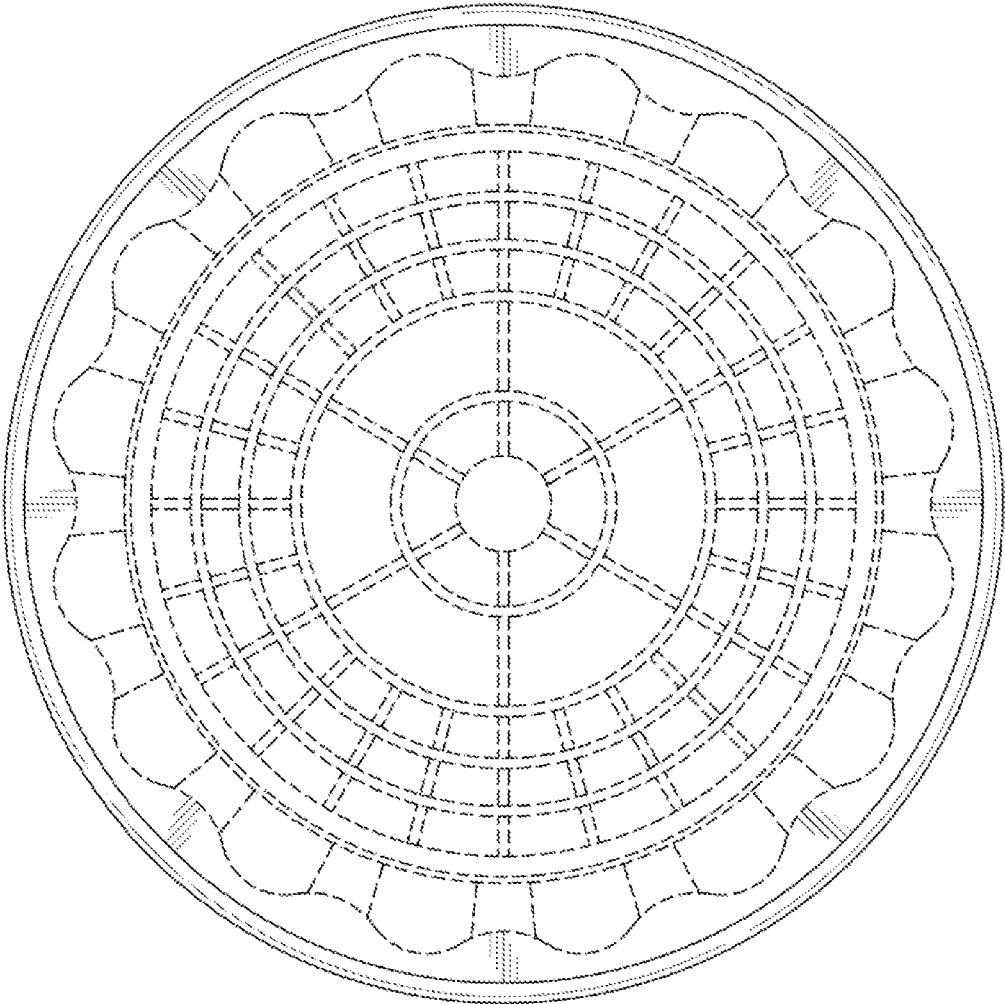

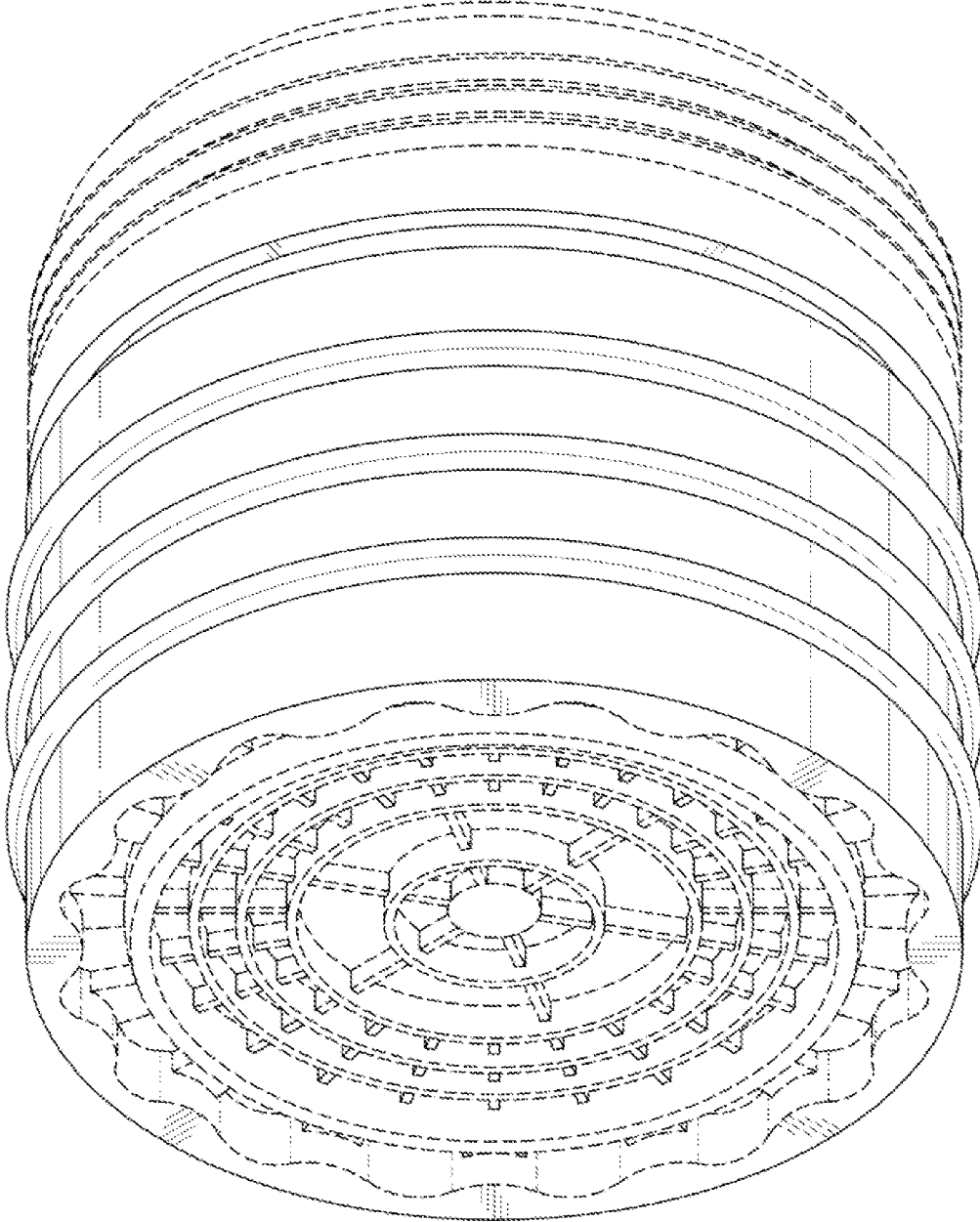

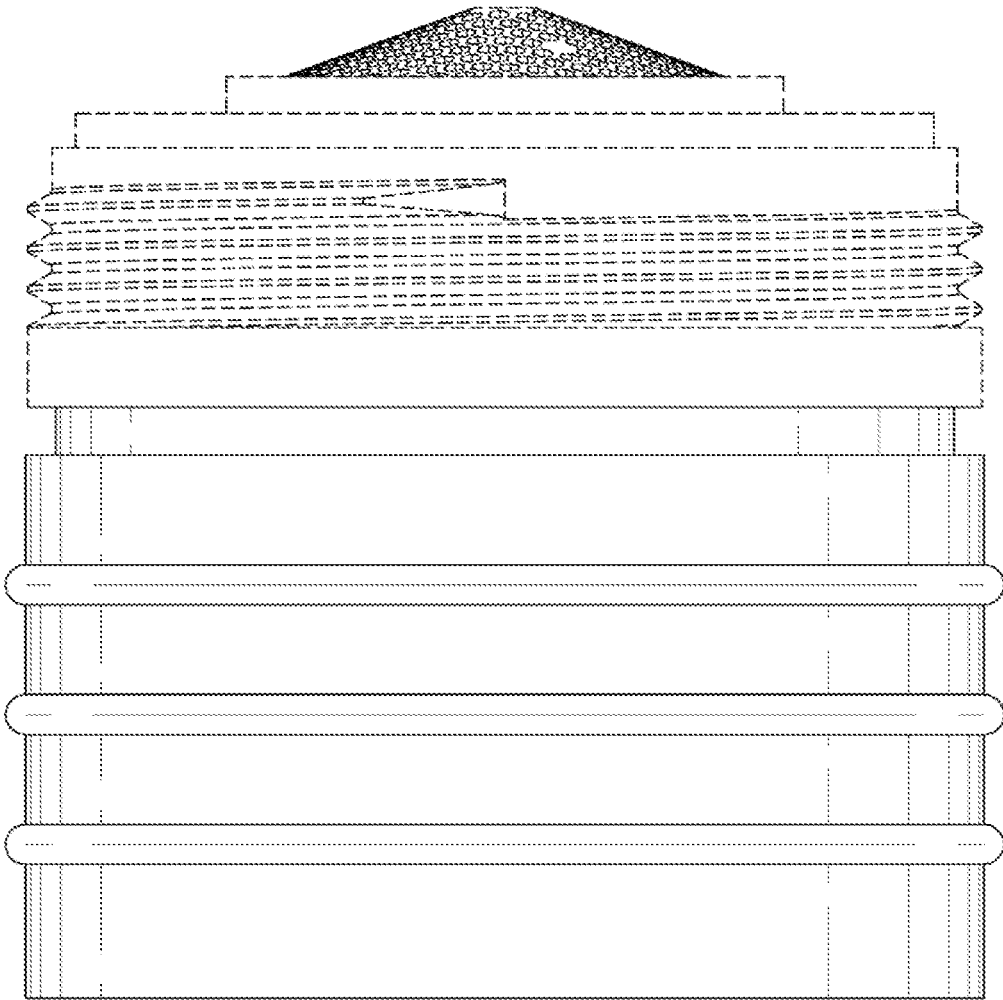

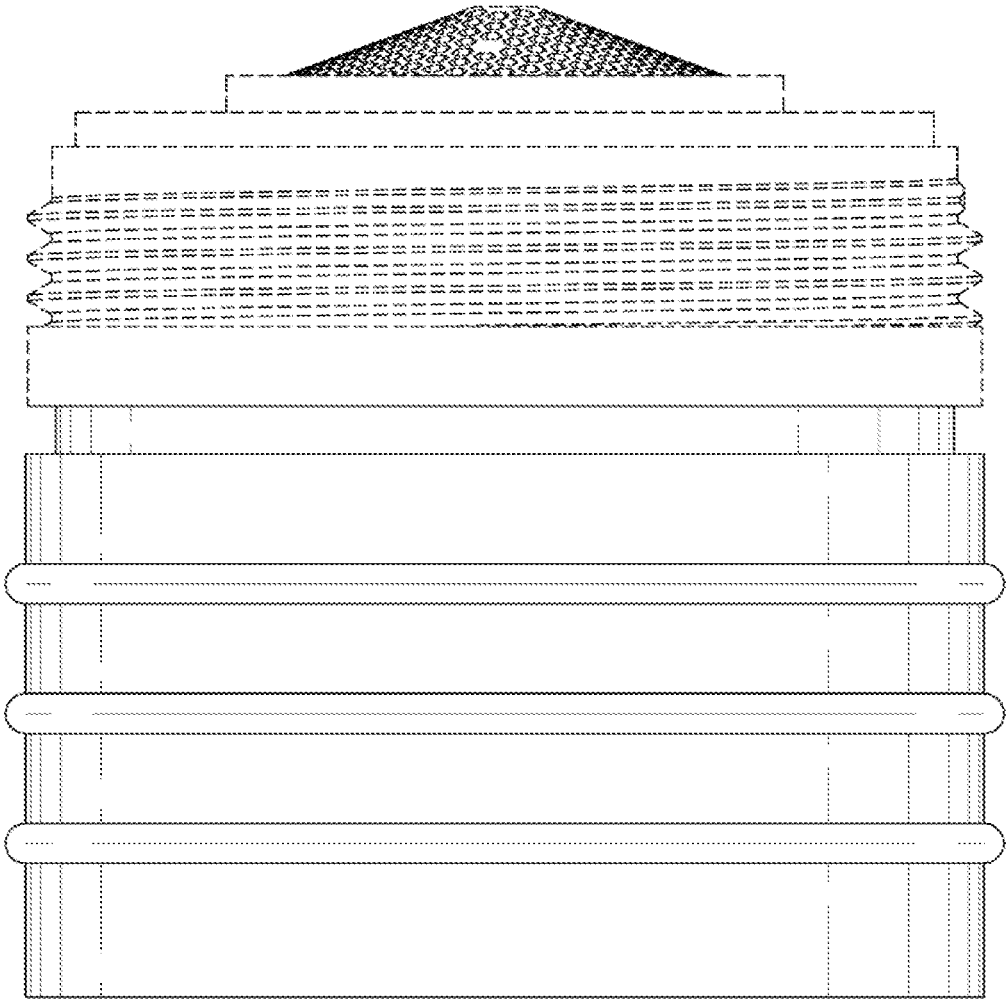

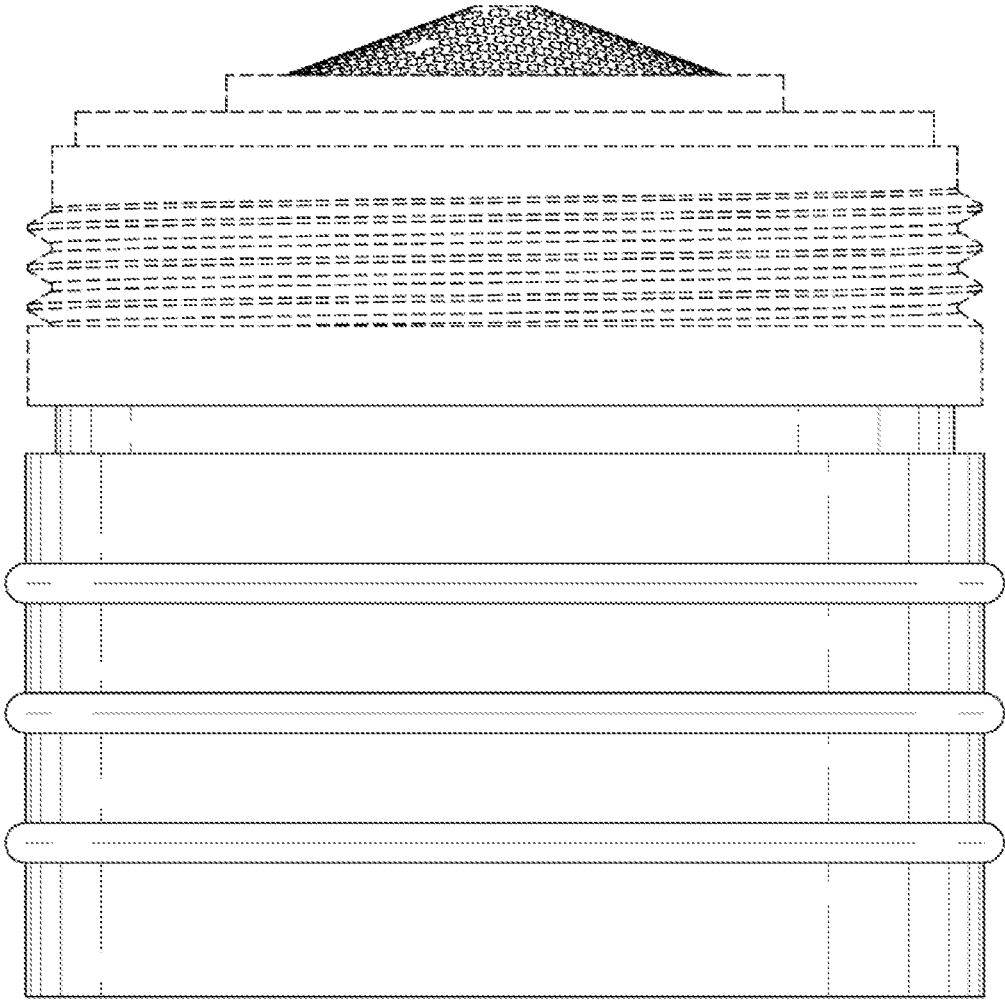
