(57) **CLAIM**

The ornamental design for a combined wet and dry vacuum appliance, as shown and described.

DESCRIPTION

FIG. 1 is an isometric perspective view of the combined wet and dry vacuum appliance;

FIG. 2 is a front elevational view of the combined wet and dry vacuum appliance;

FIG. 3 is a back elevational view of the combined wet and dry vacuum appliance;

FIG. 4 is a side view of the combined wet and dry vacuum appliance;


FIG. 5 is a side view of the combined wet and dry vacuum appliance, showing the side opposite that shown in FIG. 4;

FIG. 6 is a top plan view of the combined wet and dry vacuum appliance; and,














