(57) **CLAIM**

I claim the ornamental design for a scalloped deep food service dish, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of the scalloped deep food service dish.

FIG. 2 is a plan view looking downwardly into the scalloped deep food service dish from the top.

FIG. 3 is a side elevation view of the scalloped deep food service dish.

FIG. 4 is a front elevation view of the scalloped deep food service dish.

FIG. 5 is a bottom plan view of the scalloped deep food service dish.

FIG. 6 is a bottom perspective view thereof; and,

FIG. 7 is a bottom perspective view of a second embodiment of a scalloped deep food service dish showing my new design.

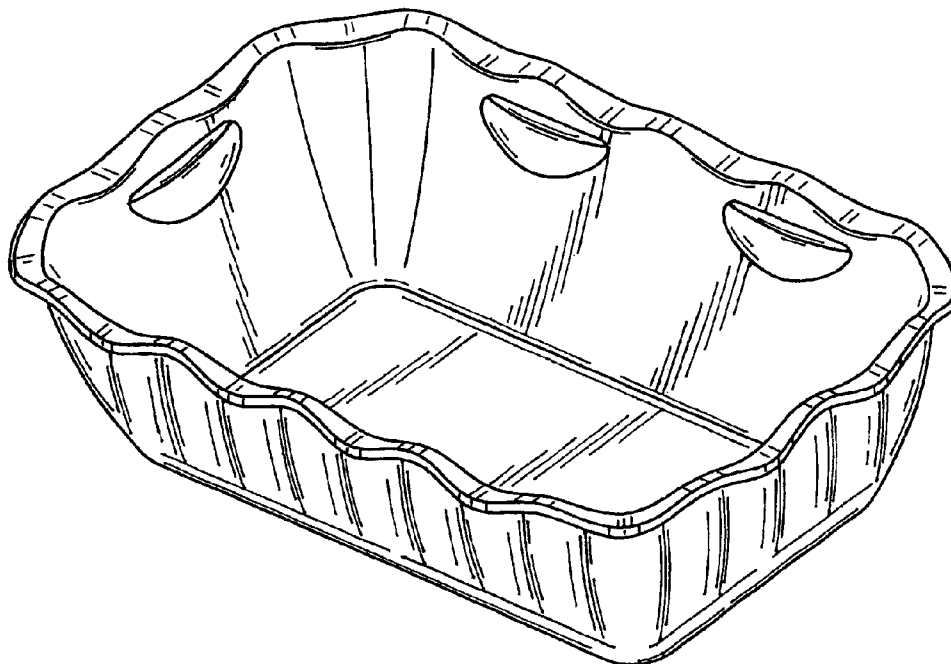
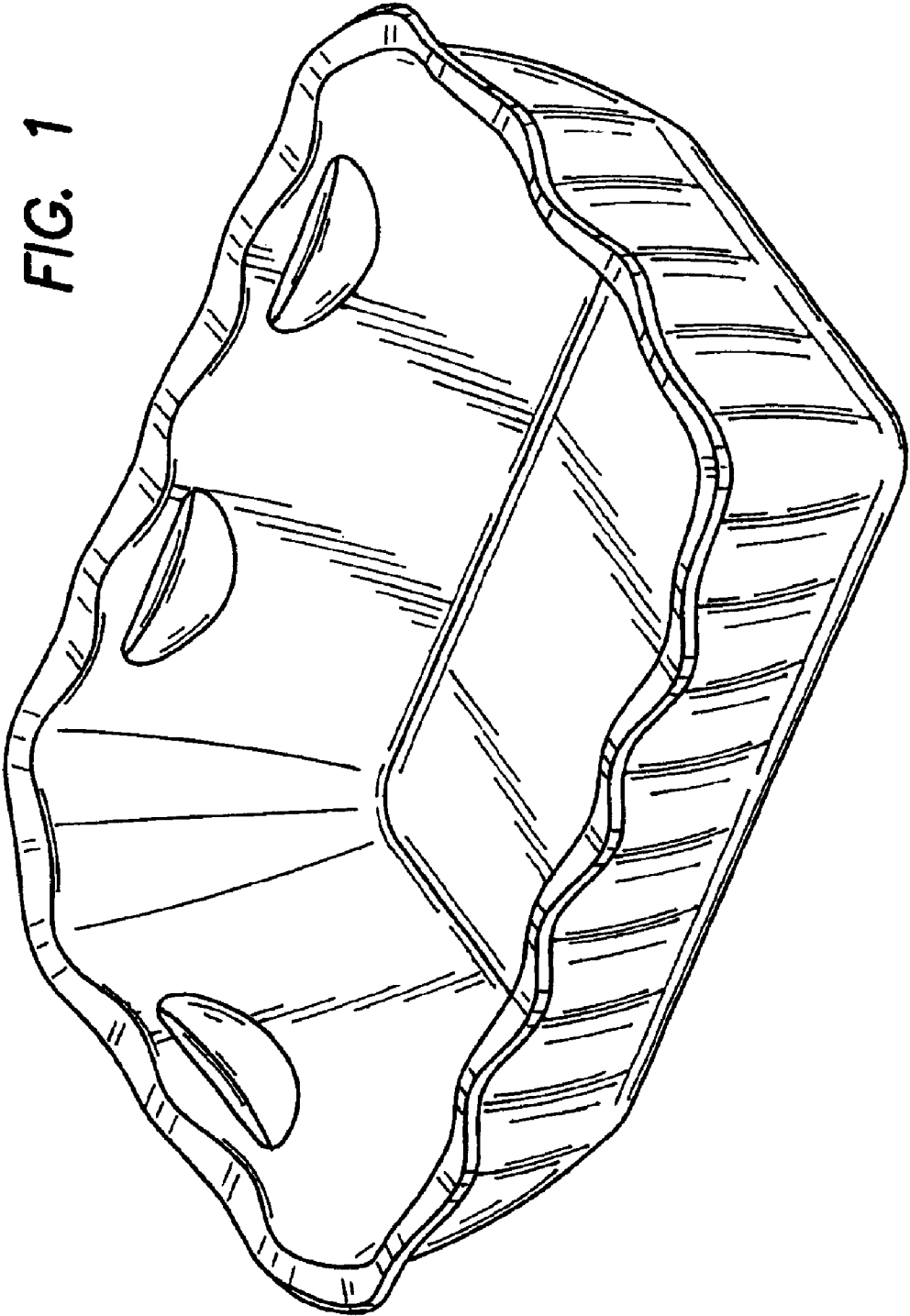

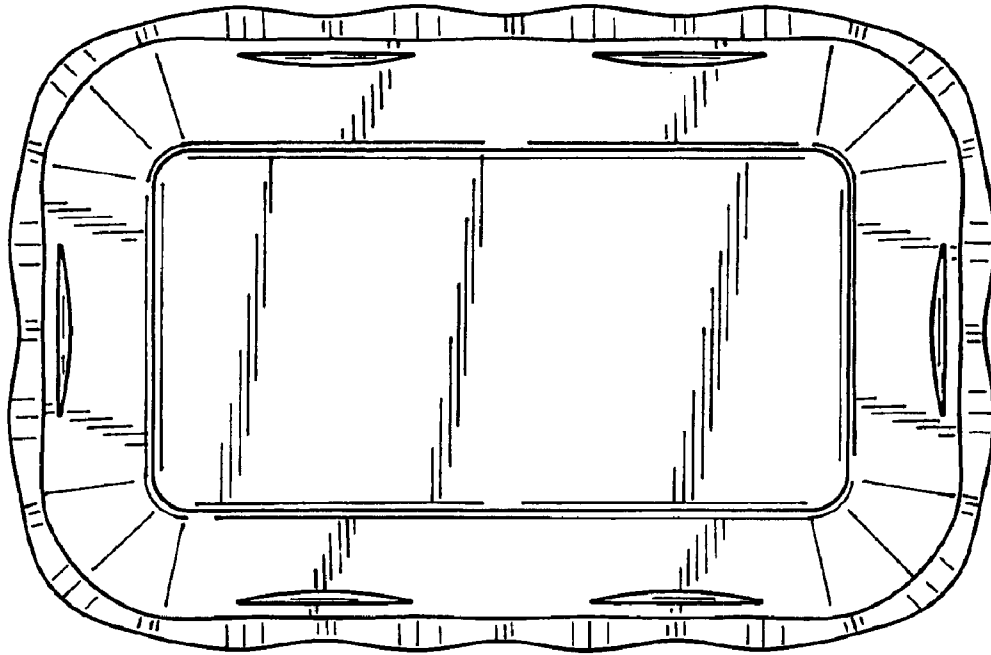

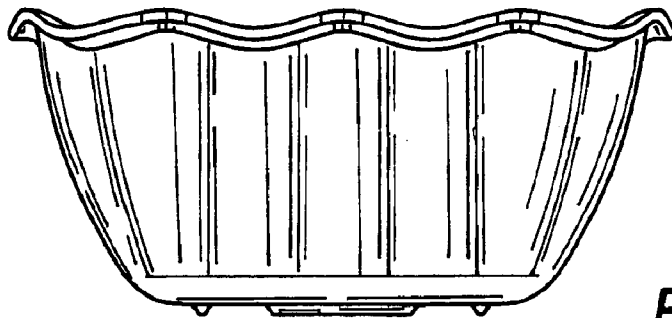

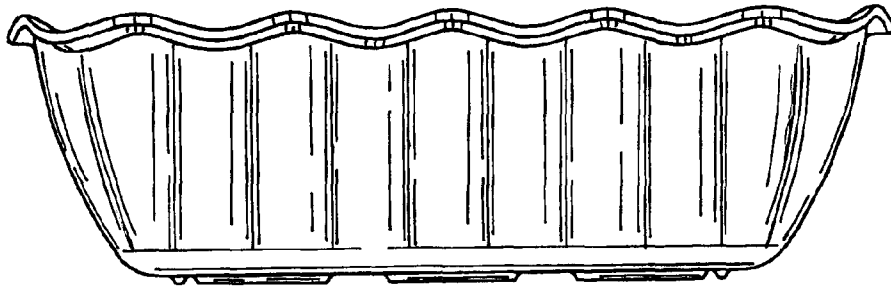
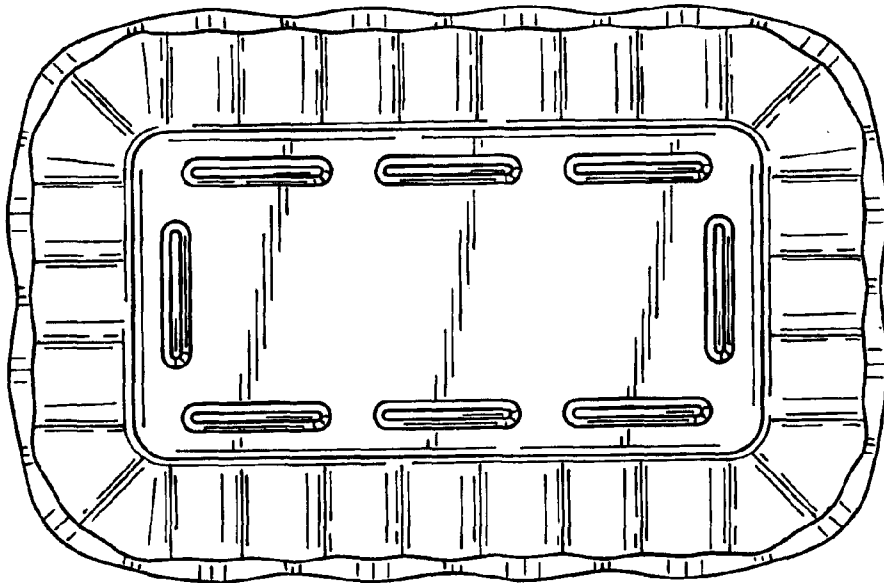

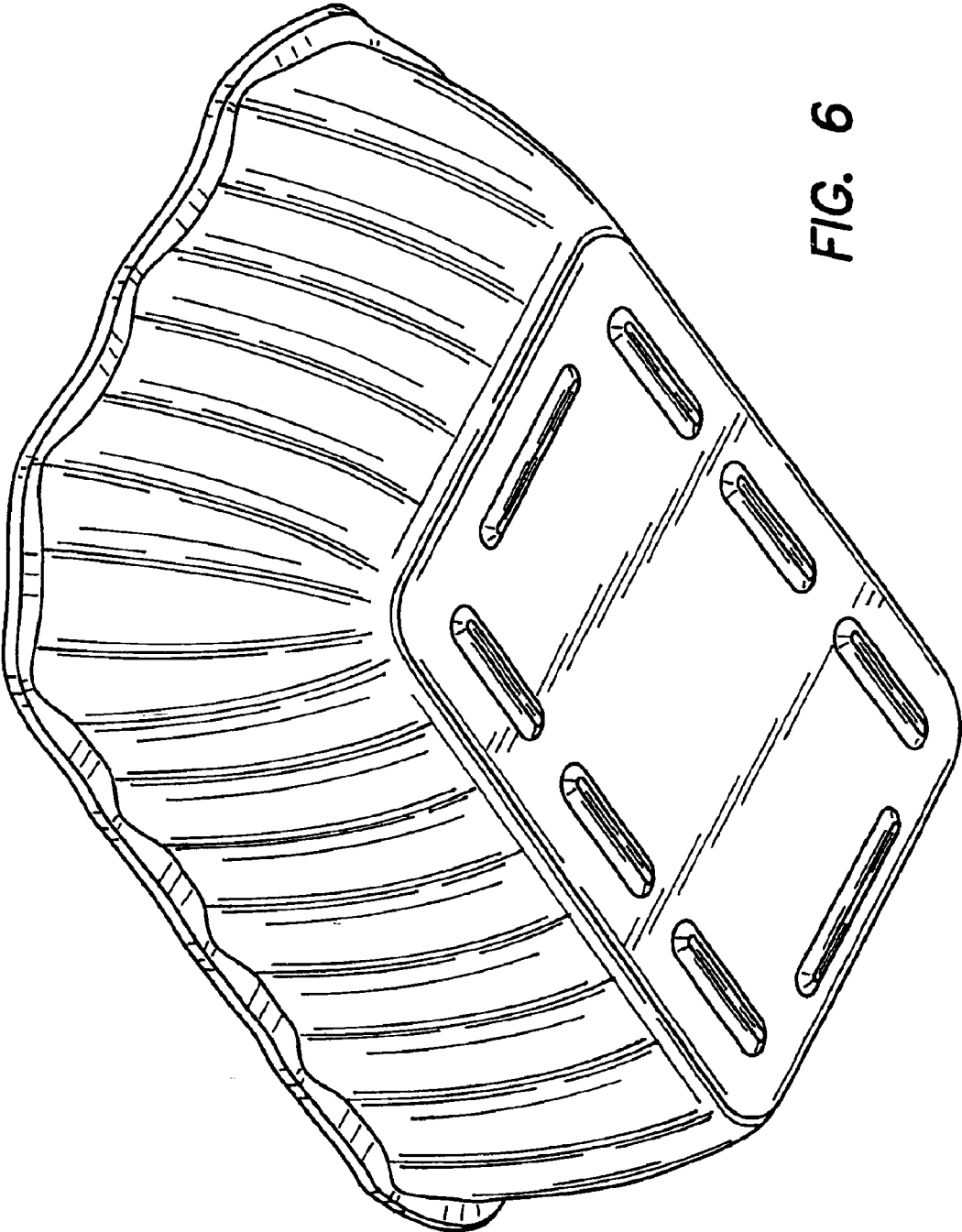

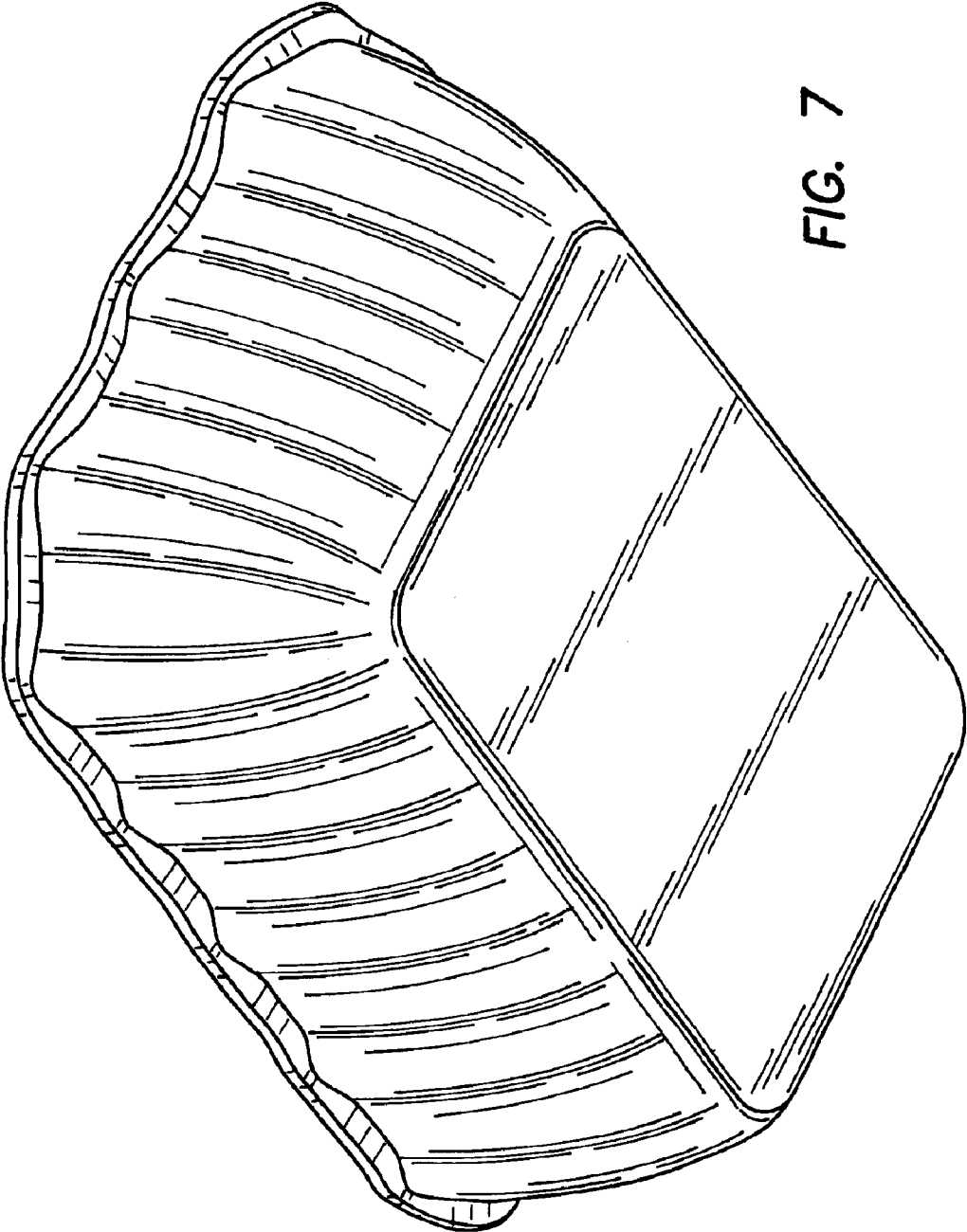
