FIG. 9 is a rear elevational view thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof;

FIG. 12 is a left-hand side elevational view thereof;

FIG. 13 is a right-hand side elevational view thereof;

FIG. 14 is a front elevational view of a further embodiment of the invention having three modular units;

FIG. 15 is a rear elevational view thereof;

FIG. 16 is a top plan view thereof; (a bottom plan view is a mirror image of FIG. 16);

FIG. 17 is a left-hand side elevational view thereof;

FIG. 18 is a right-hand side elevational view thereof;

FIG. 19 is a front elevational view showing still another embodiment of the invention having four modular units;

FIG. 20 is a rear elevational view thereof;

FIG. 21 is a top plan view thereof; (a bottom plan view thereof is a mirror image of the view shown in FIG. 21);

FIG. 22 is a left-hand side elevational view thereof; and,

FIG. 23 is a right-hand side elevational view thereof.

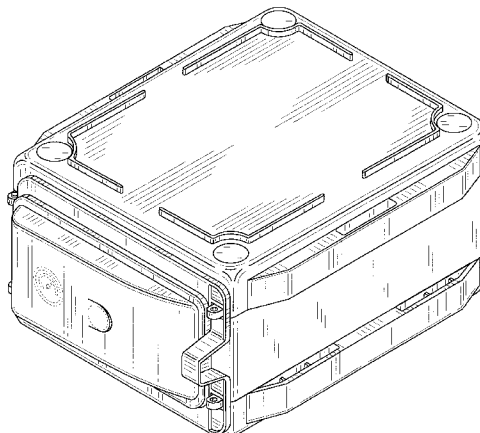

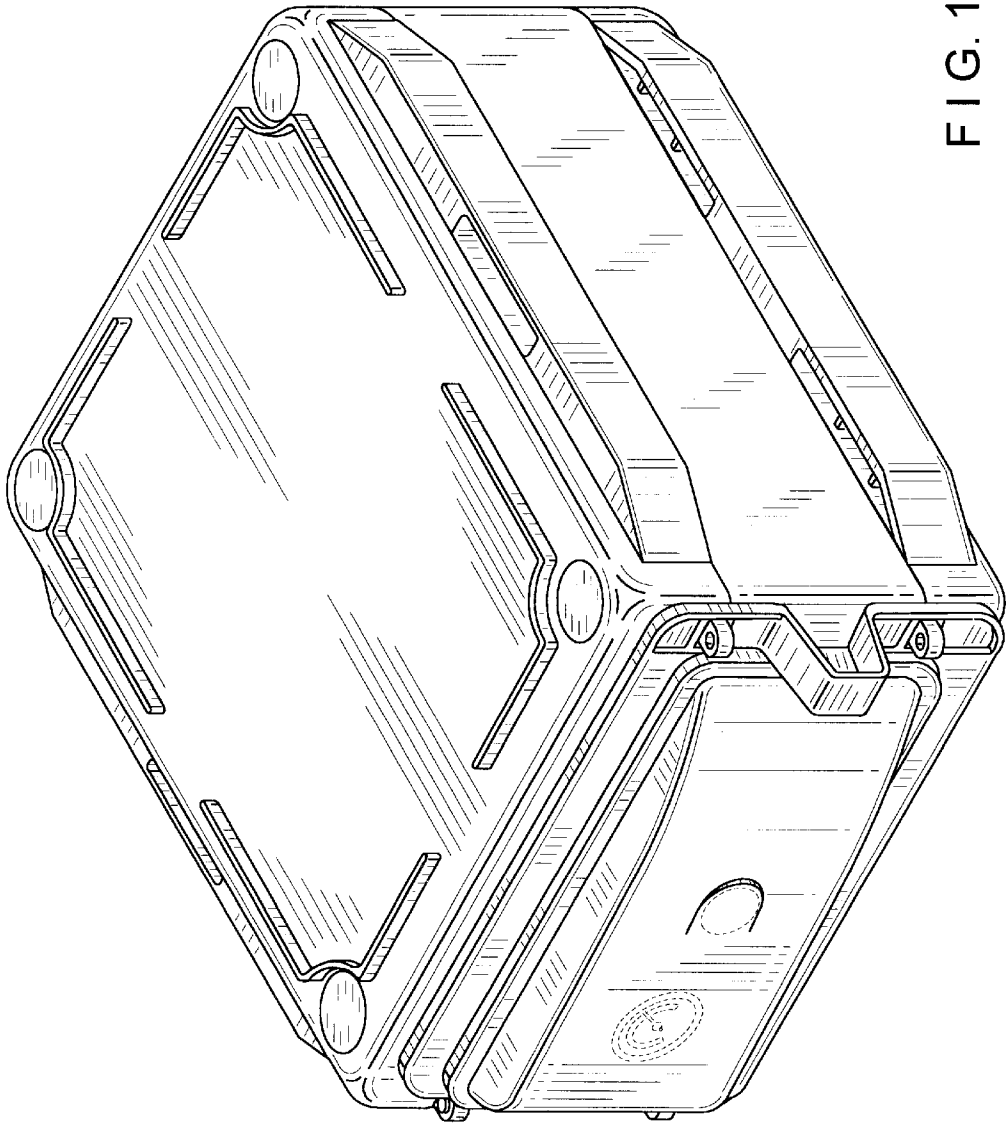

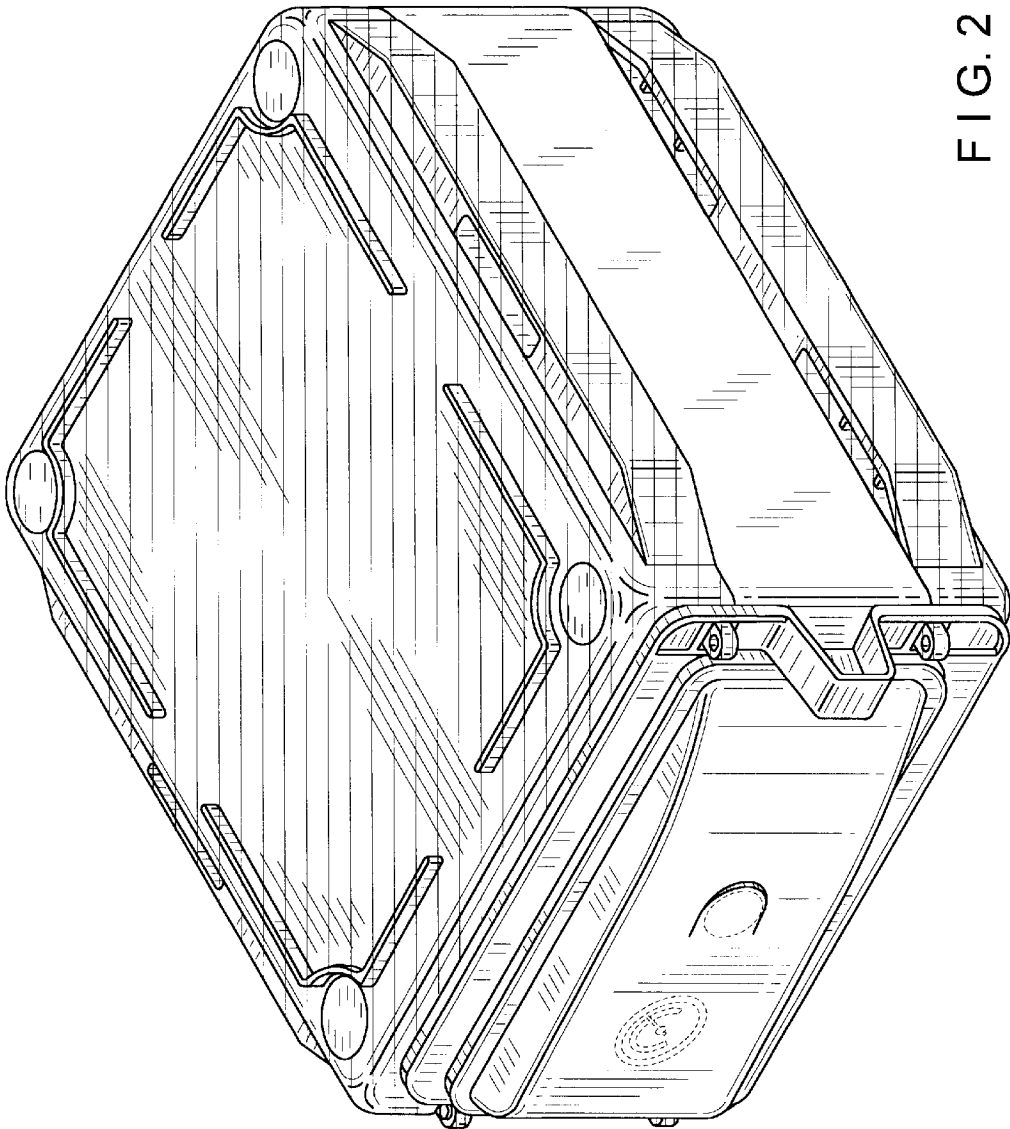

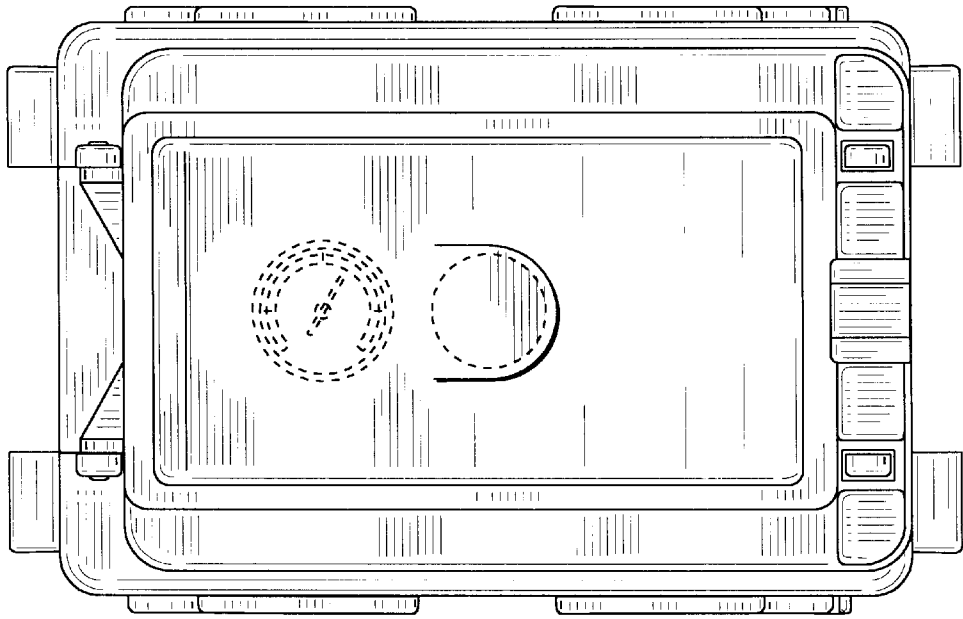

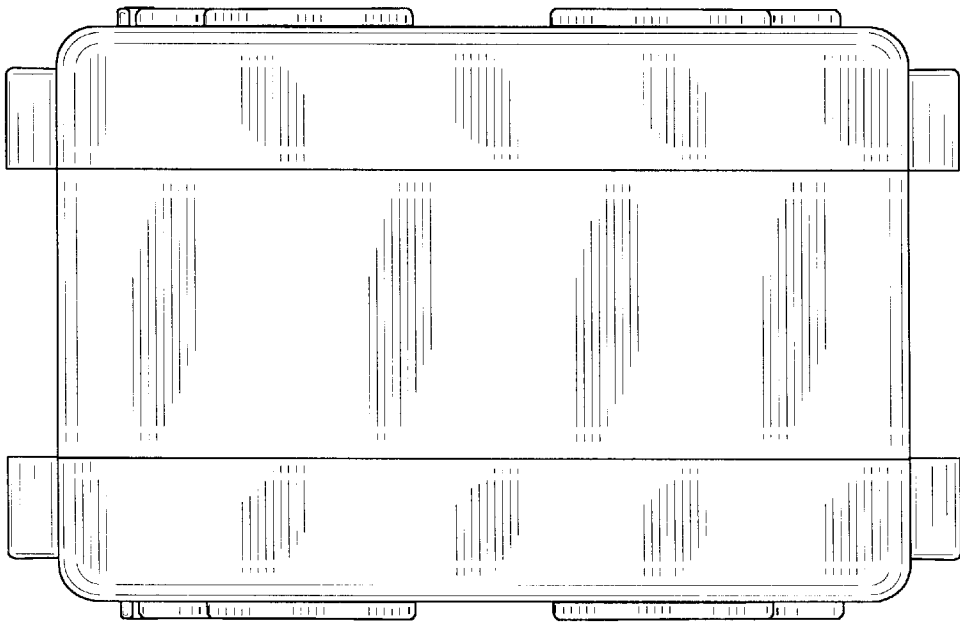

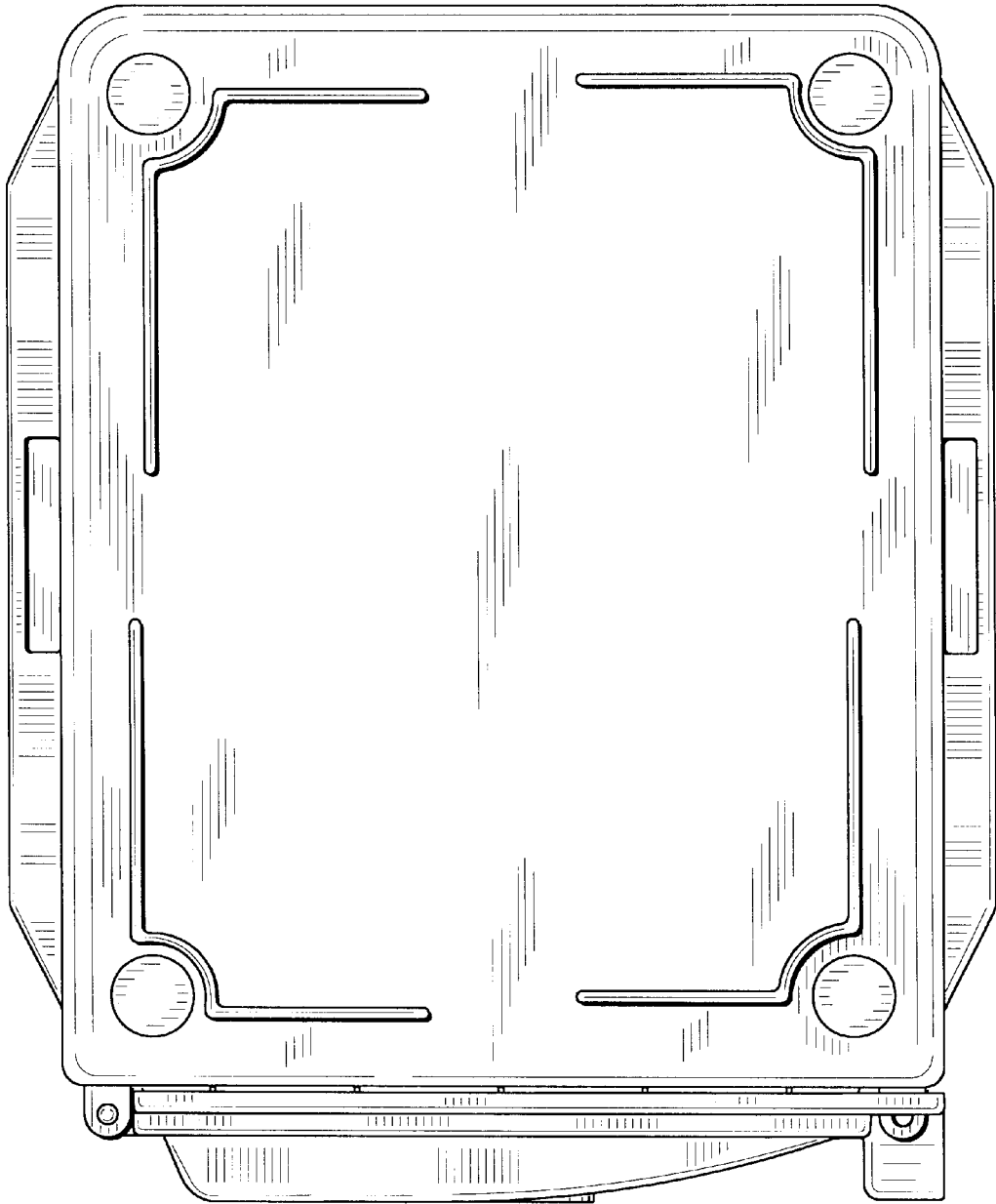

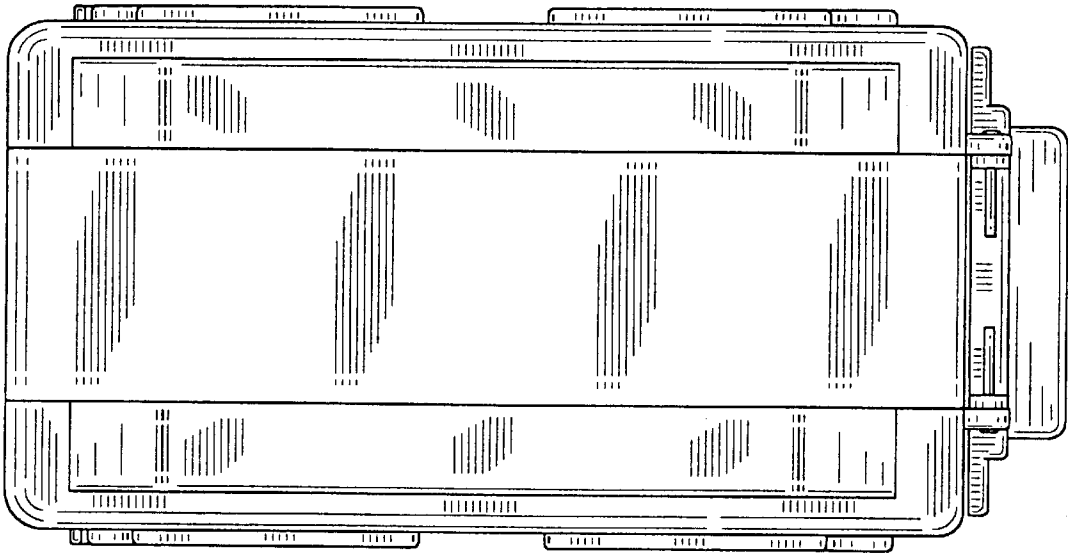

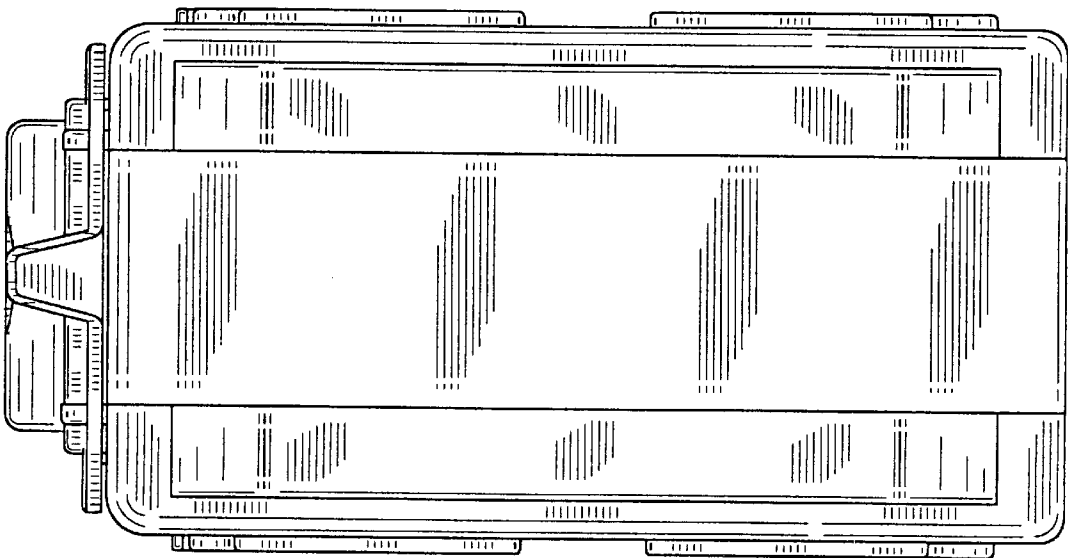

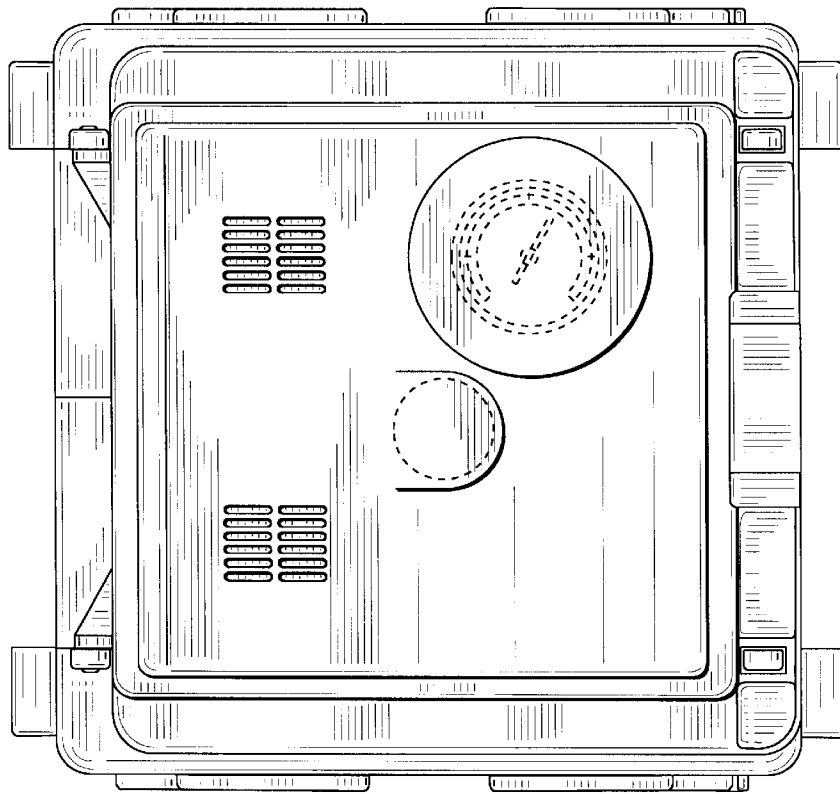

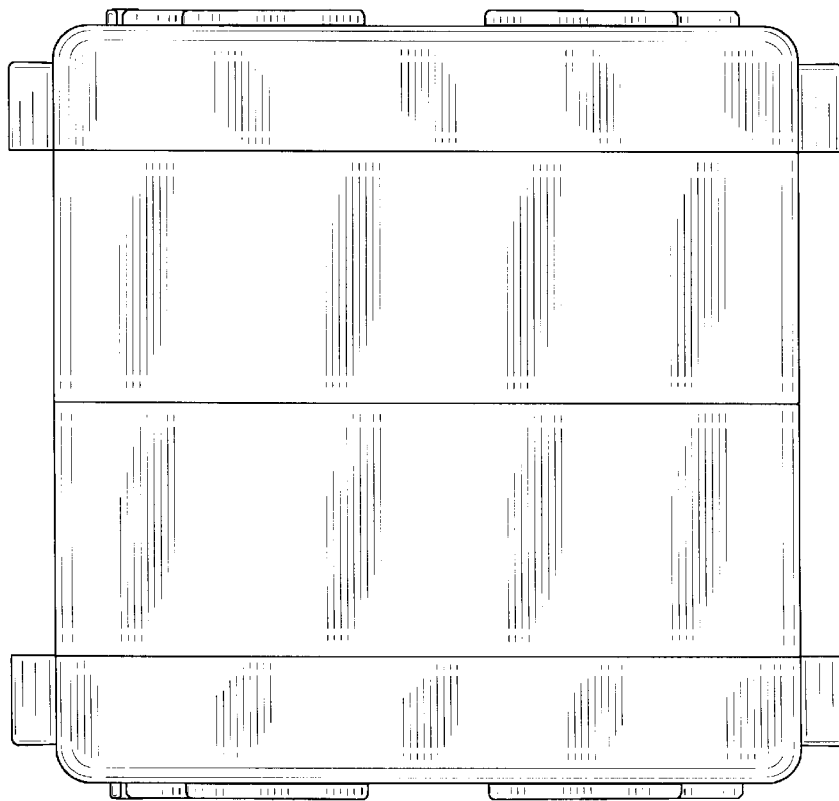

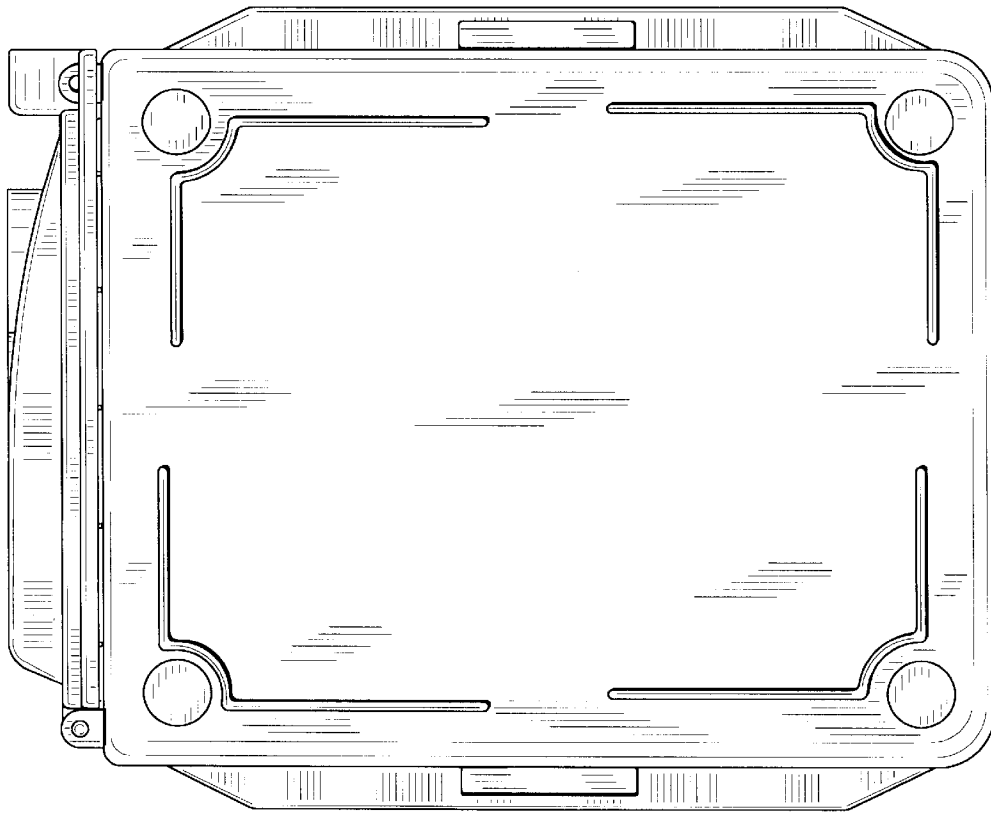

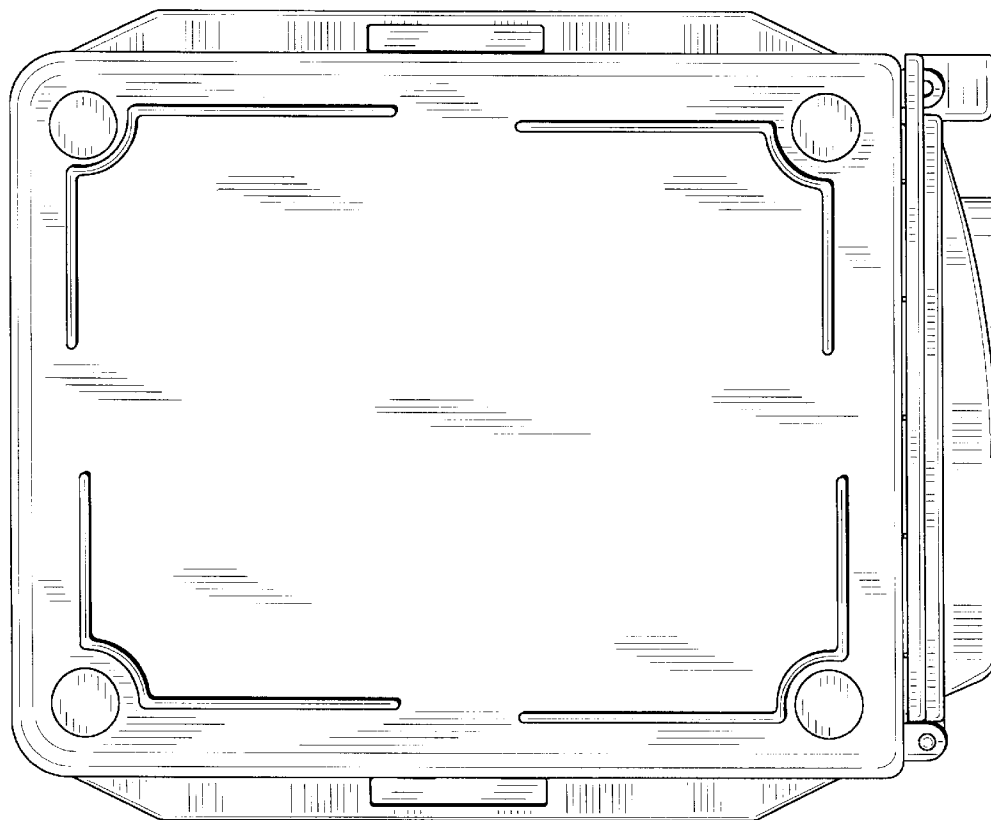

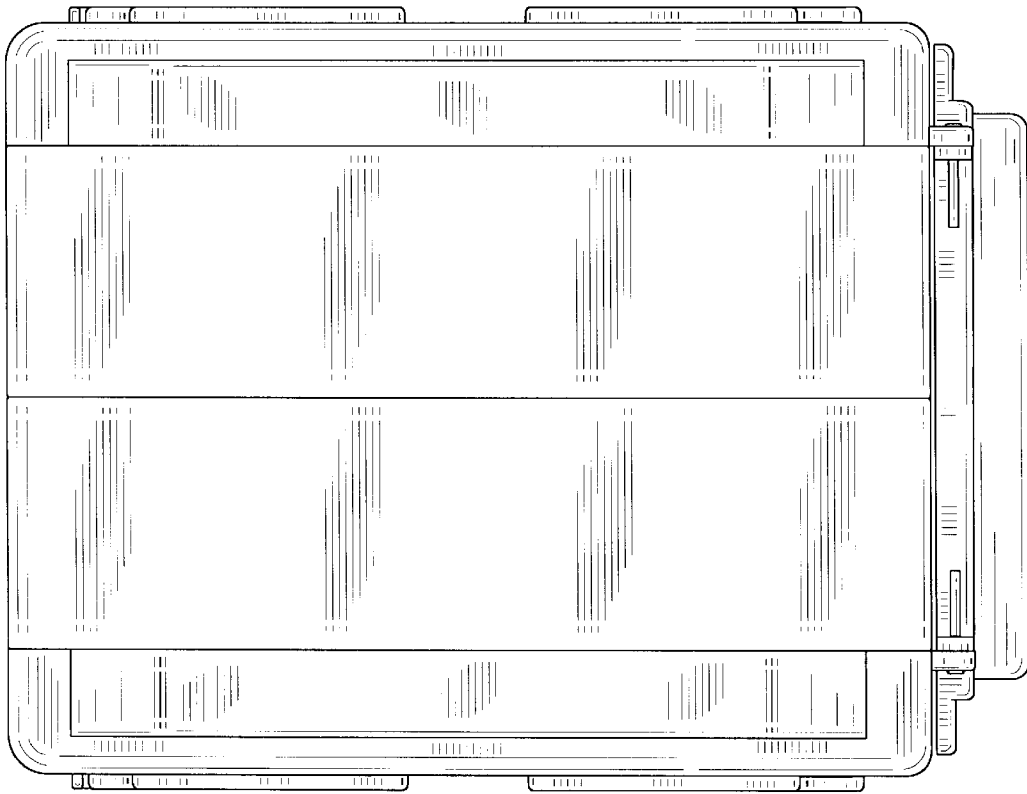

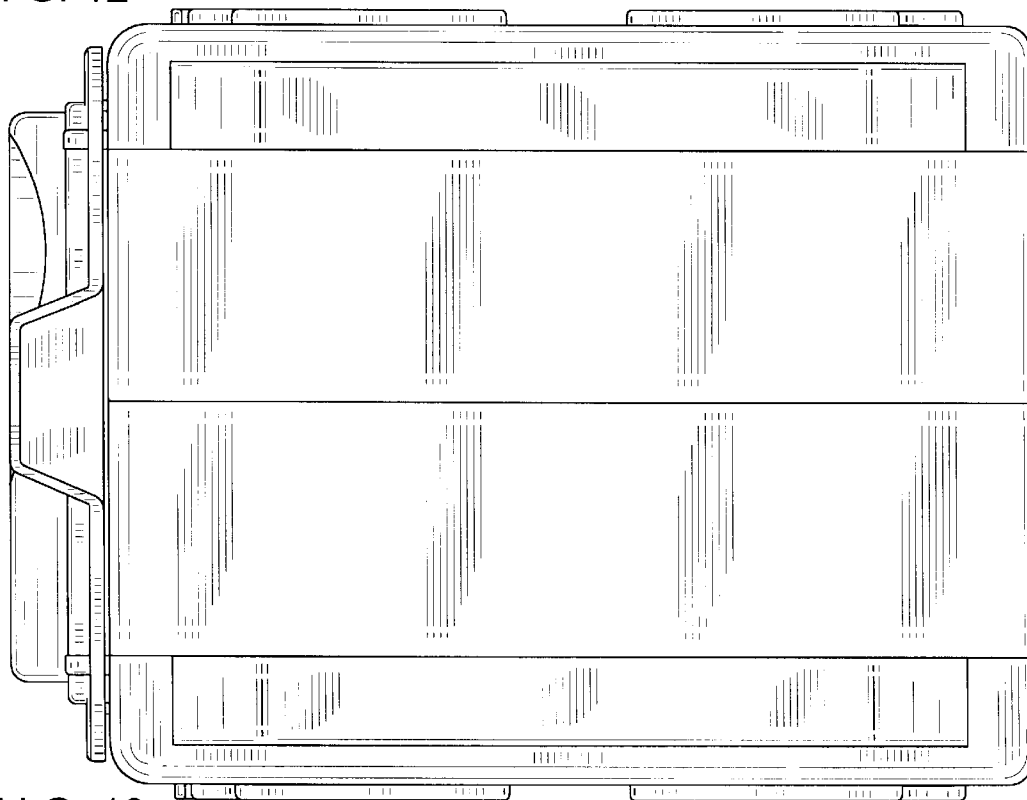

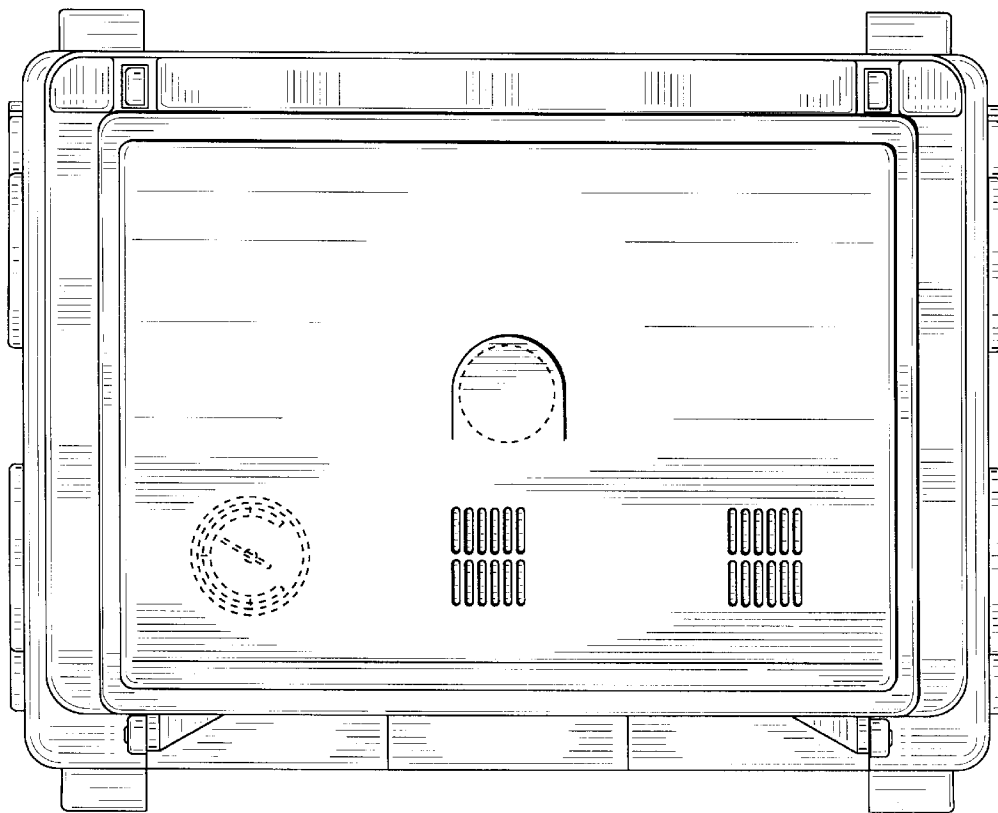

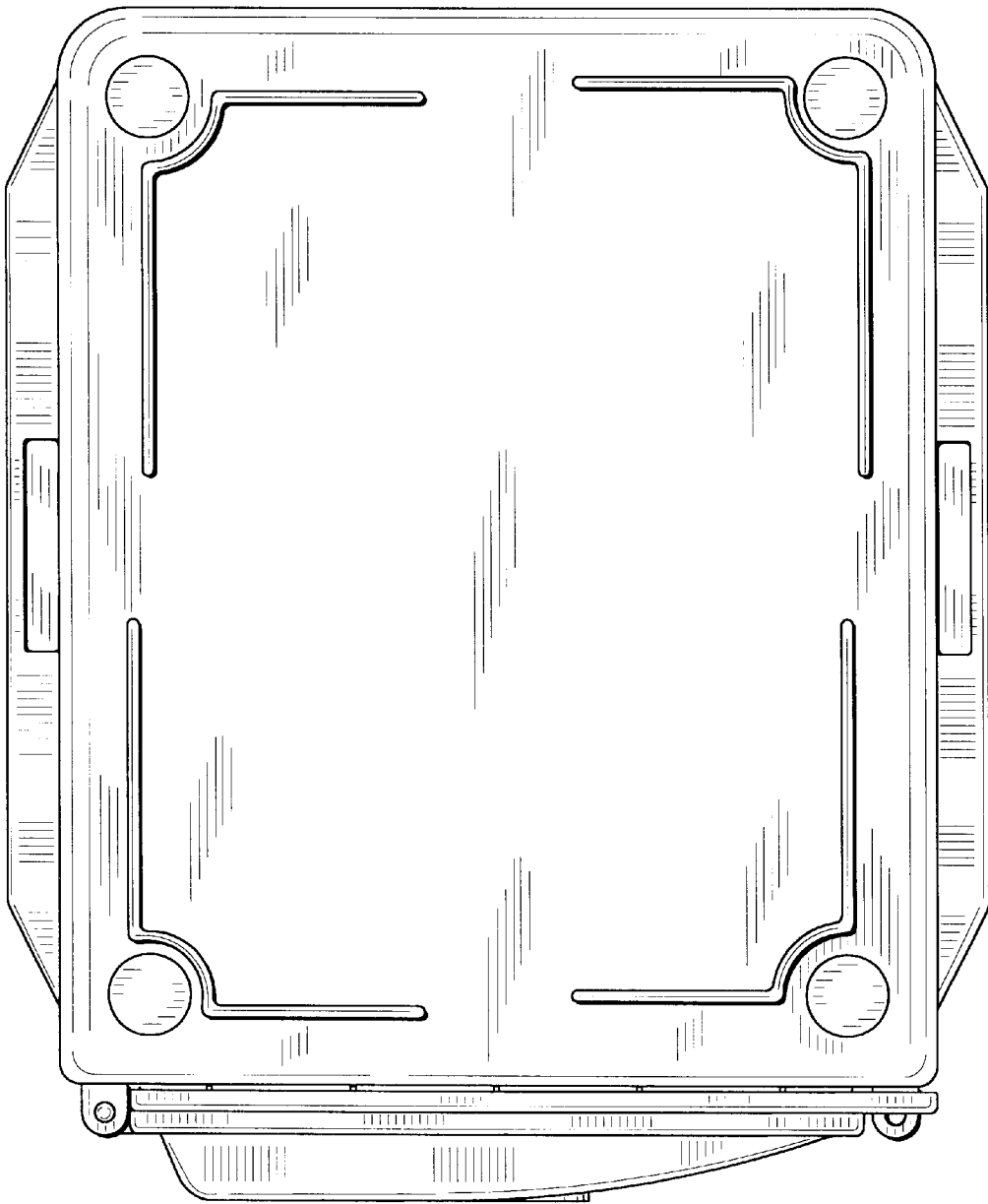

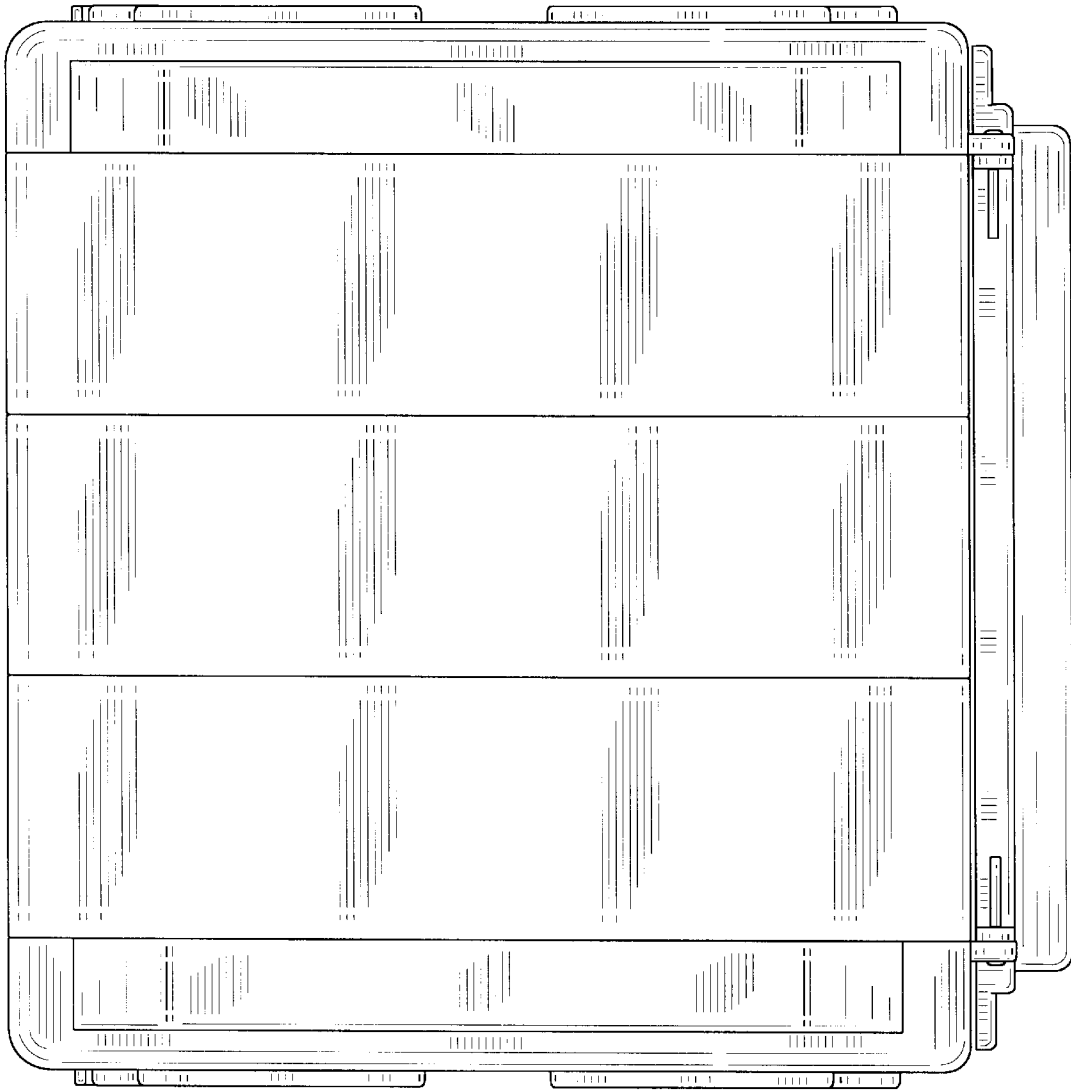

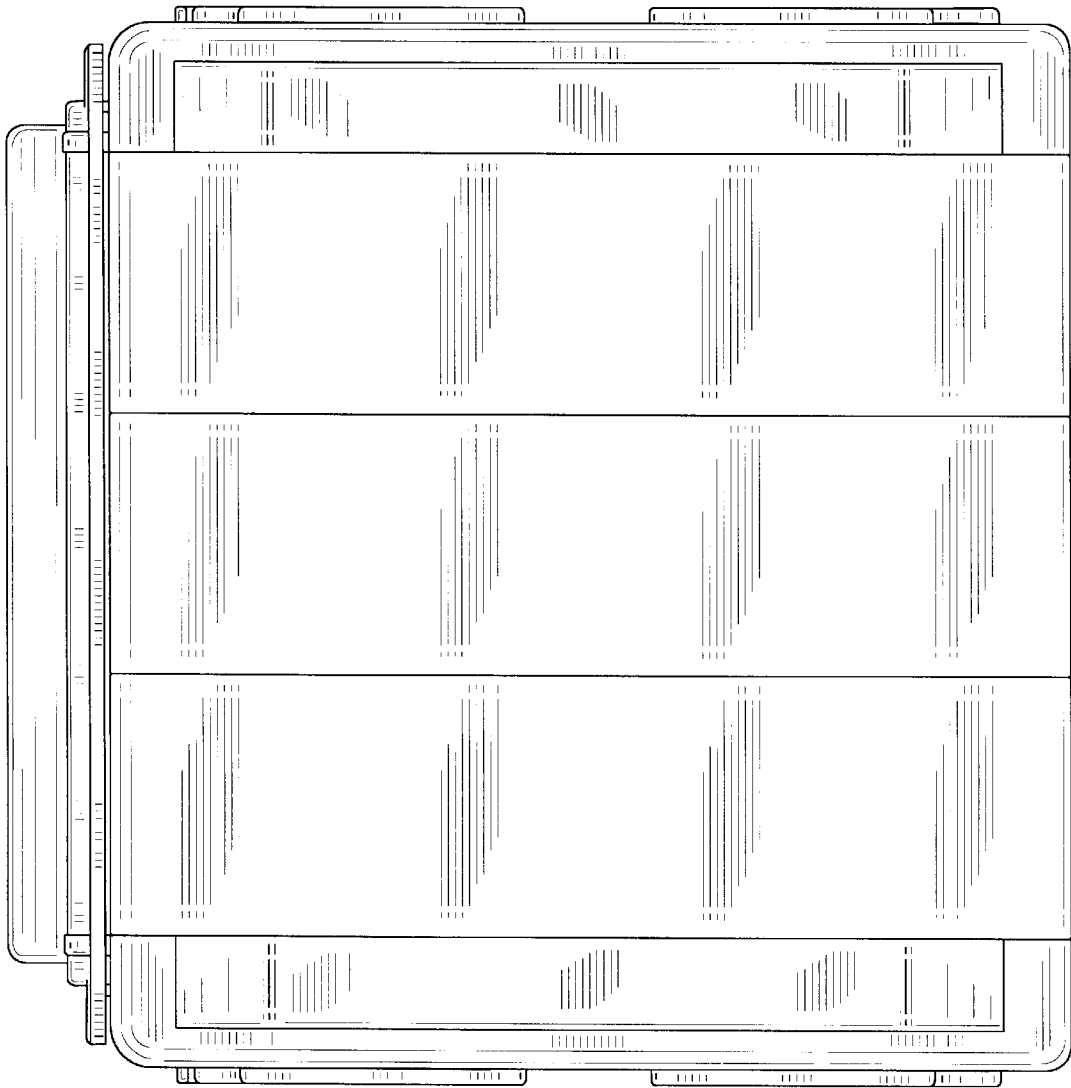

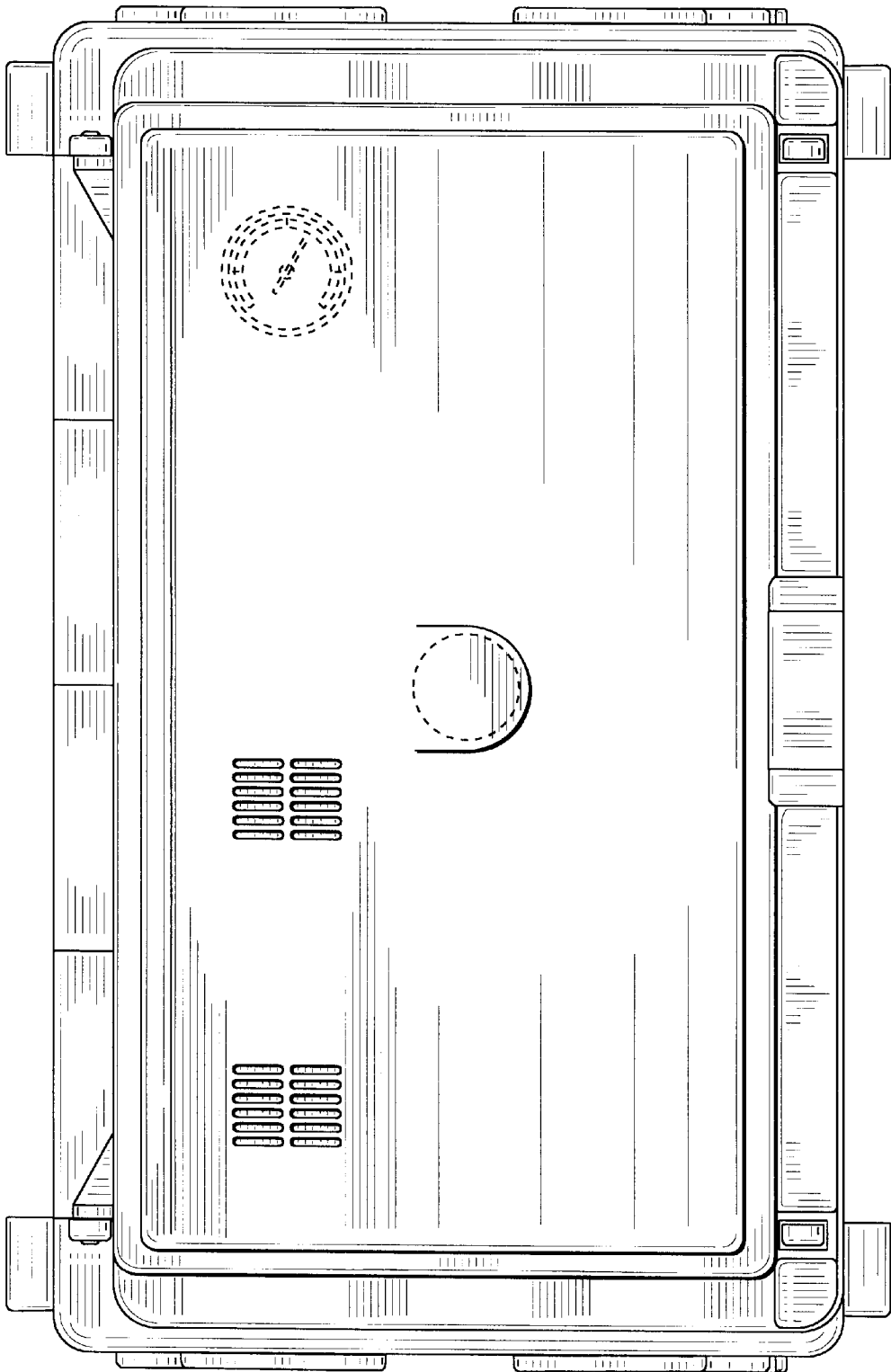

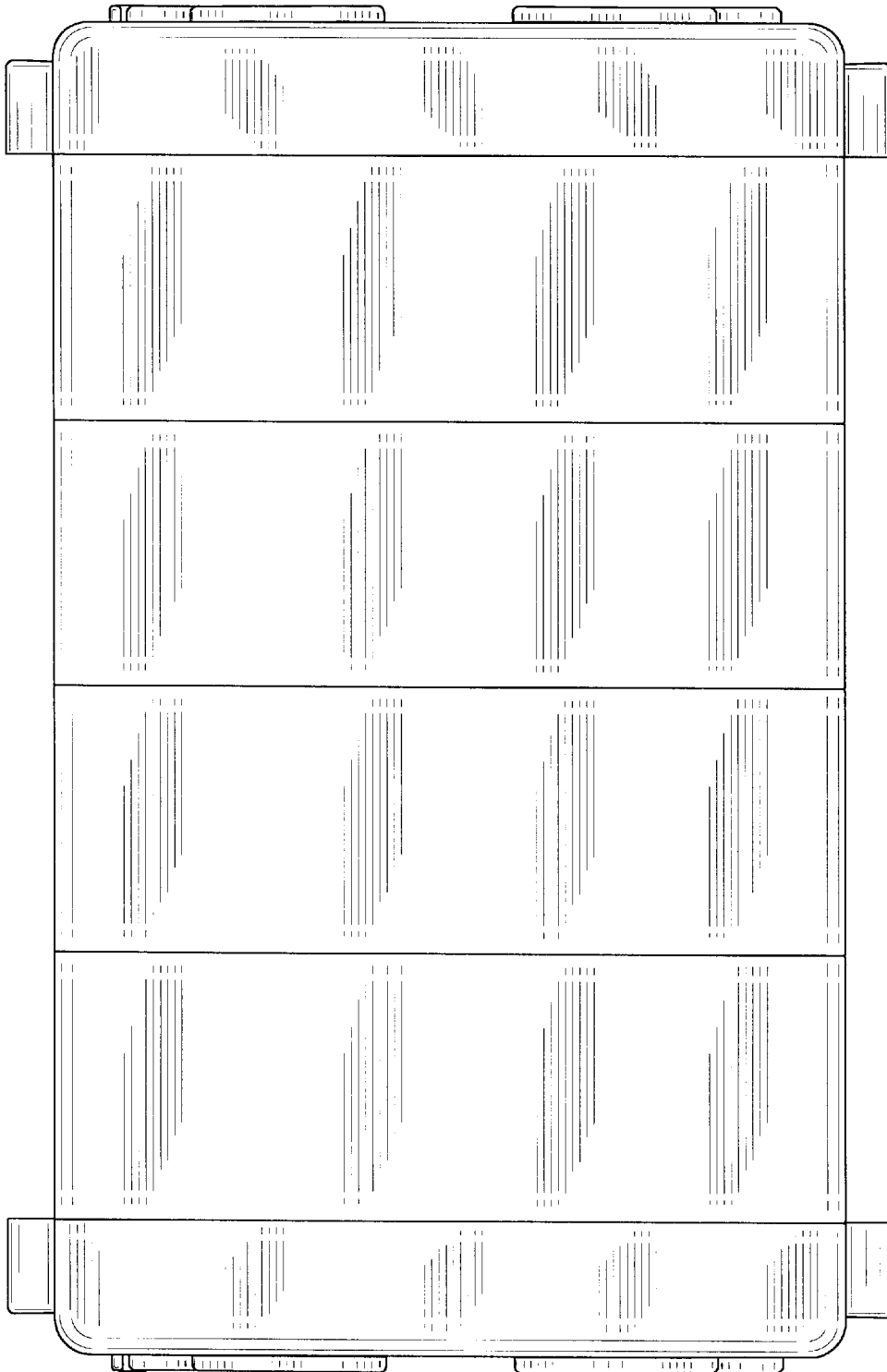

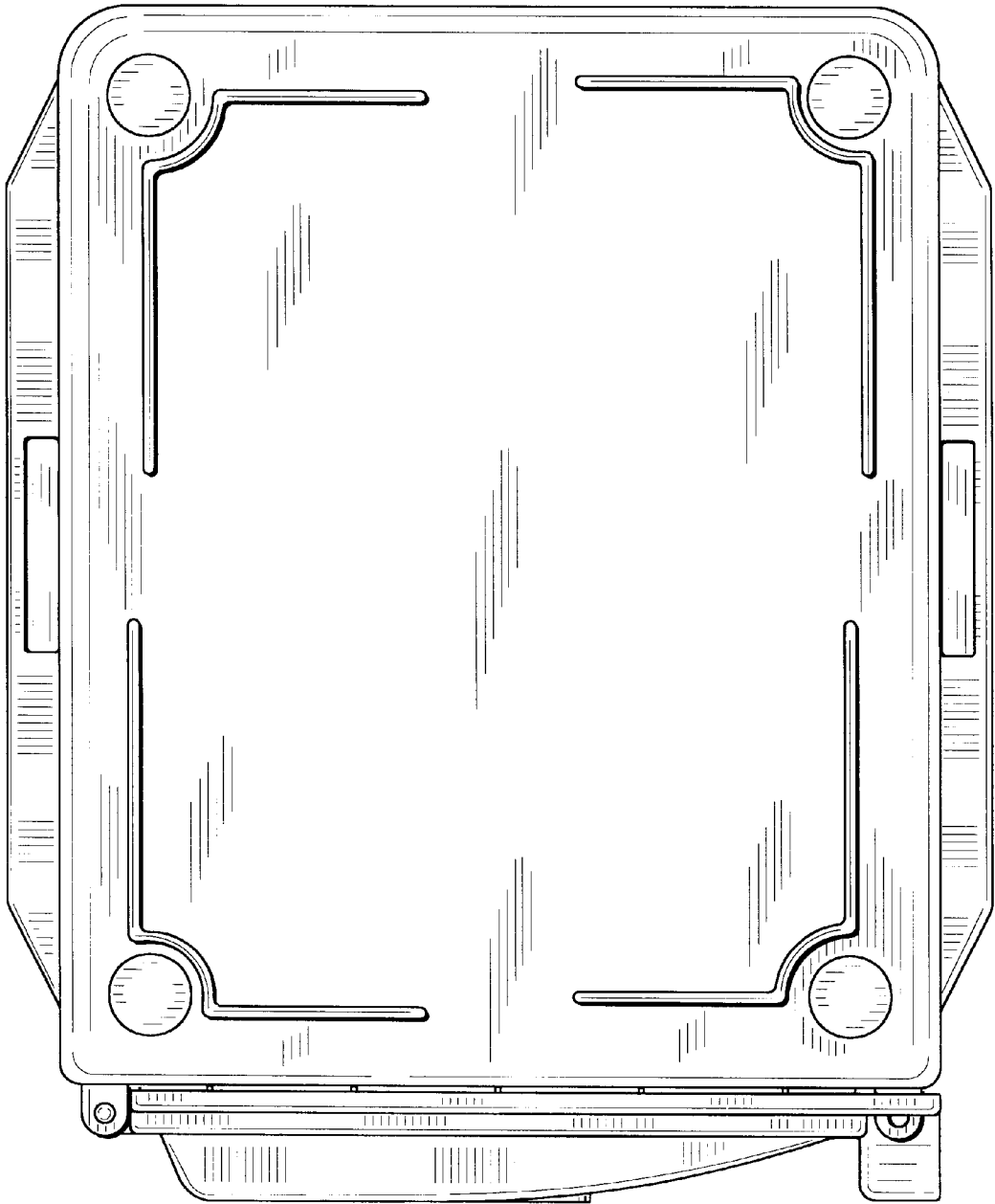

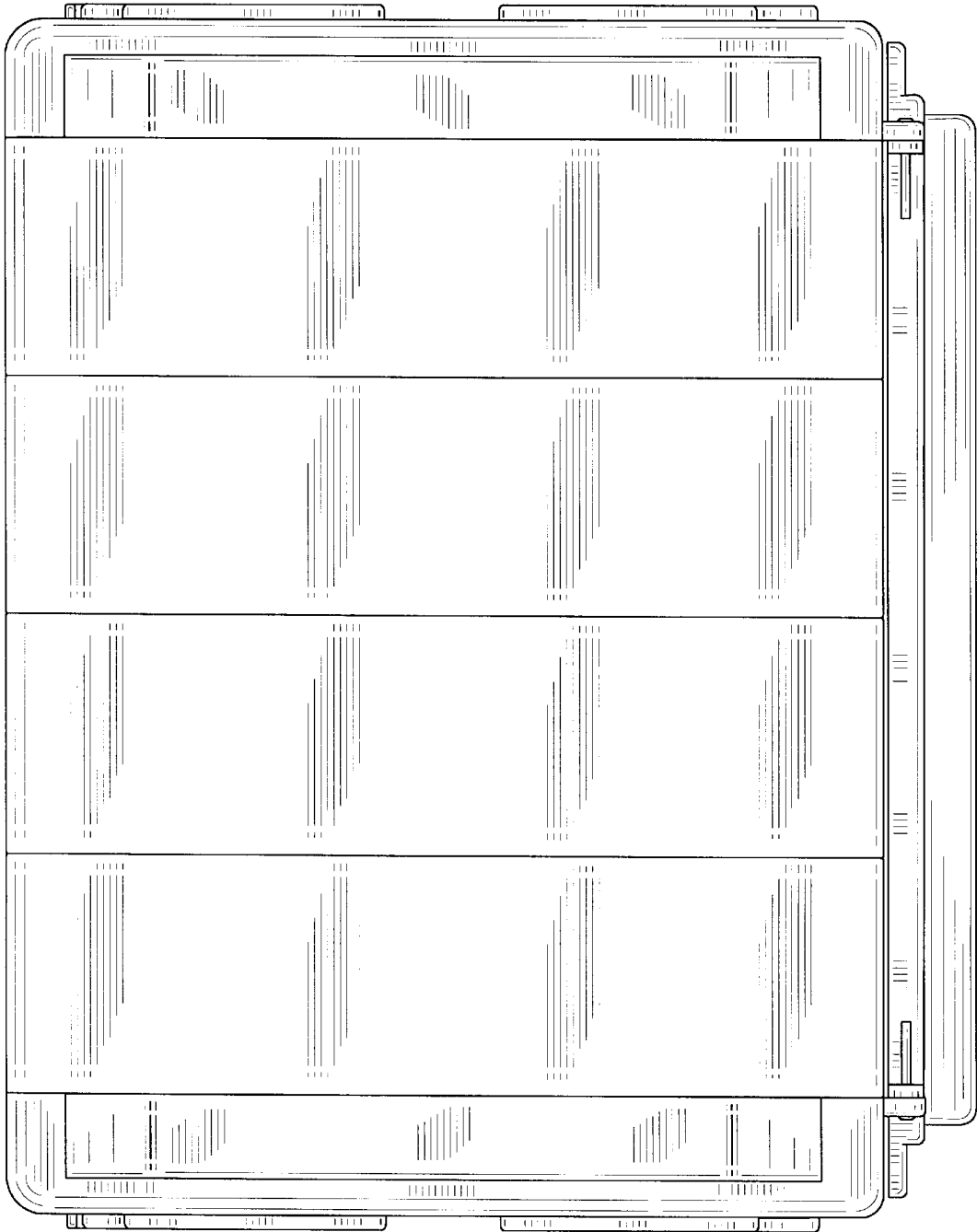

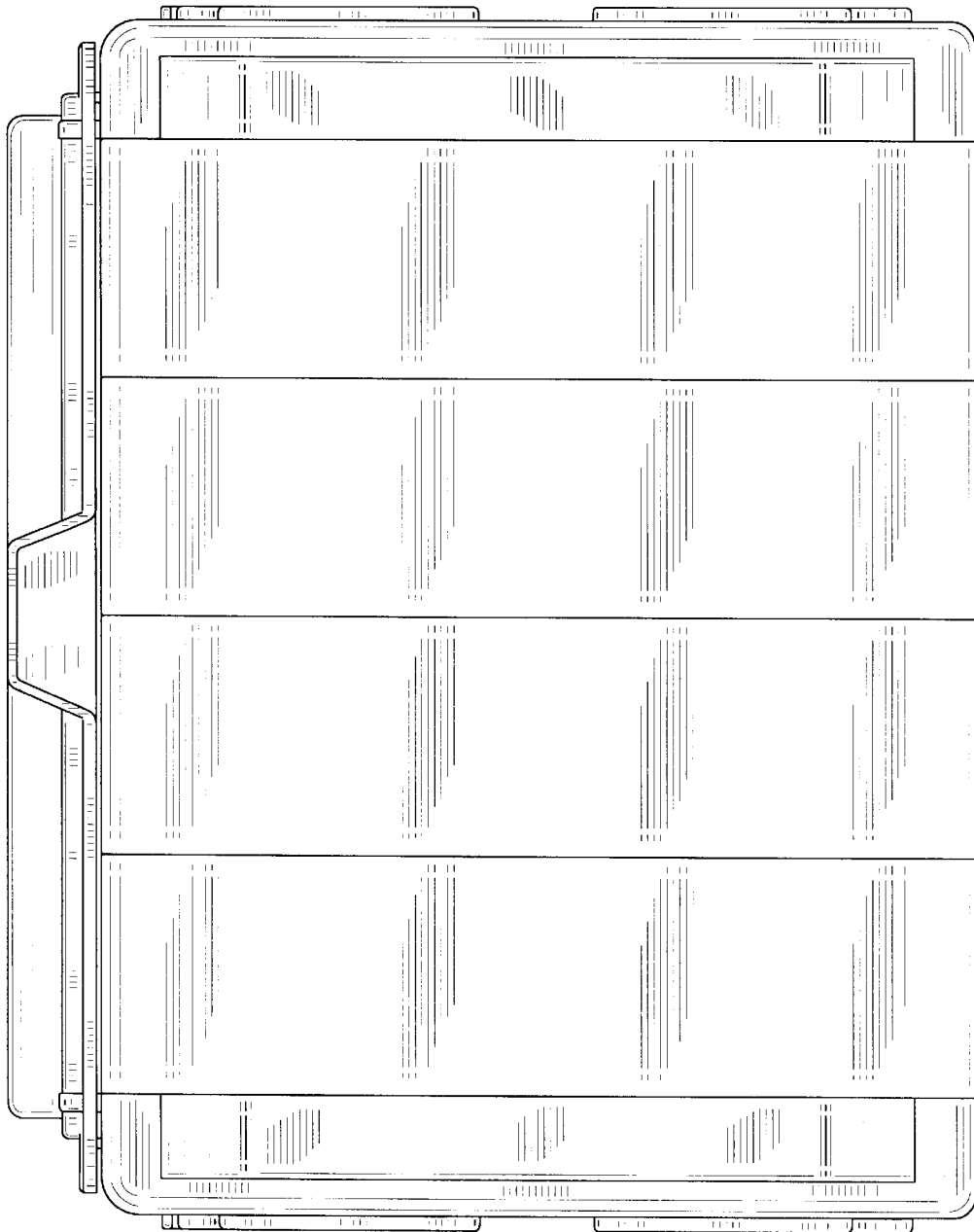
