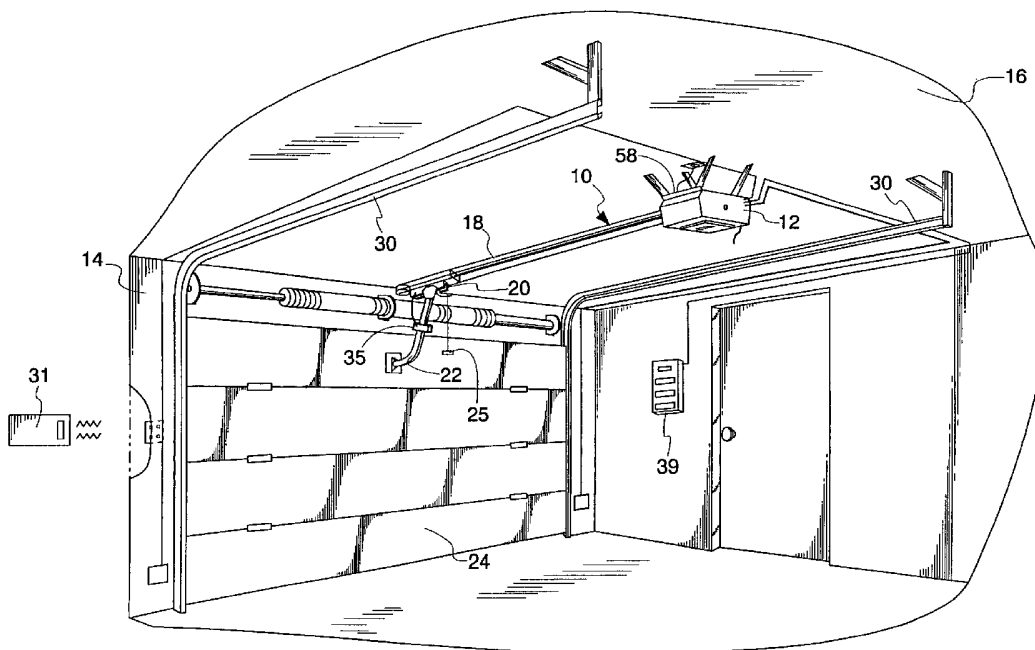

(57) Abstract: A system for decoupling a barrier (24) from a barrier movement apparatus for the manual operation of the barrier (24). Advantageously, the decoupling is performed in response to a wireless signal (61) and may be done only when the barrier (24) is determined to be in a safe position.
