

(57) **CLAIM**

What is claimed is the ornamental design for an eraser, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side perspective view of an eraser showing our new design;  
FIG. 2 is a side view thereof, all sides being identical;








