
CLAIM

(57) The ornamental design for a seismic separation clip for suspended ceiling grid systems, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seismic separation clip for suspended ceiling grid systems showing our new design; FIG. 2 is a front view of the seismic separation clip of FIG. 1; FIG. 3 is a rear view of the seismic separation clip of FIG. 1; FIG. 4 is a right side view of the seismic separation clip of FIG. 2; FIG. 5 is a left side view of the seismic separation clip of FIG. 2; FIG. 6 is a top view of the seismic separation clip of FIG. 1; and, FIG. 7 is a bottom view of the seismic separation clip of FIG. 1.














