The ornamental design for a digital camera, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a digital camera showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view of the encircled portion as shown in FIG. 1;
FIG. 9 is an enlarged view of the encircled portion as shown in FIG. 2;
FIG. 10 is an enlarged view of the encircled portion as shown in FIG. 3; and,
FIG. 11 is an enlarged view of the encircled portion as shown in FIG. 7.






















