CLAIM

(57) I claim the ornamental design for a turntable, as shown and described.

DESCRIPTION

FIG. 1 is a front/right/top perspective view of a turntable (a front/left/top perspective view would be a mirror image thereof);
 FIG. 2 is a rear/left/bottom perspective view thereof (a rear/right/bottom perspective view would be a mirror image thereof);
 FIG. 3 is a left side elevational view thereof; and,
 FIG. 4 is a top plan view thereof.
 The broken lines depict portions of the turntable that form no part of the claimed design.








