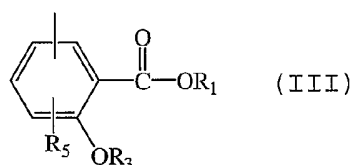
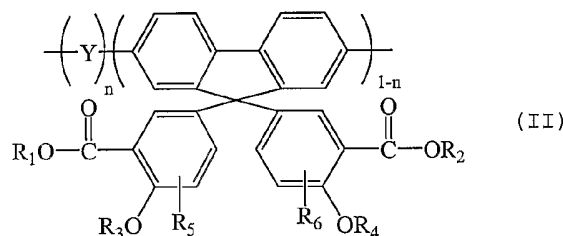
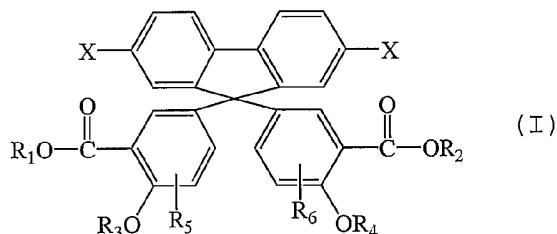

Continuation of Box II Reason 2:

In these claims, the numerous variables (e.g. R^1 , R^2 , R^3 , substituted heteroaryl, etc.), their voluminous complex meanings, and their seemingly endless permutations and combinations make it virtually impossible to determine the full scope and complete meaning of the claimed subject matter. As presented, the claimed subject matter cannot be regarded as being a clear and concise description for which protection is sought and as such the listed claims do not comply with the requirements of PCT Article 6. Thus it is impossible to carry out a meaningful search on the same. A search will be made on the first discernable invention in the disclosure, which is Example 1, compound 1 on page 16 of the disclosure.
