

The uniform and unvarying thickness of the claimed design's surface is not appreciable. Furthermore, other elevation or orthographic views of the claimed design are not disclosed as they form no part therein. The broken lines represent portions of the breath alcohol content analyzer that form no part of the claimed design.
















