
(57) **CLAIM**

The ornamental design for a combined locating system holder and battery charger, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined locating system holder and battery charger showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;










