
(57) **CLAIM**

The ornamental design for a fuel nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of an embodiment of a fuel nozzle;
 FIG. 2 is a right side view of the fuel nozzle of FIG. 1;
 FIG. 3 is a left side view of the fuel nozzle of FIG. 1;




















