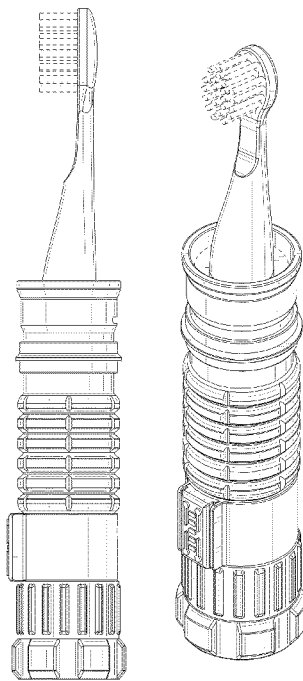
(57) **CLAIM**

We claim the ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the toothbrush showing our new design; FIG. 2 is a right side view of the toothbrush; FIG. 3 is a left side view of the toothbrush; FIG. 4 is a top view of the toothbrush; FIG. 5 is a bottom view of the toothbrush; FIG. 6 is a rear view of the toothbrush; and, FIG. 7 is a front perspective view of the toothbrush. The broken lines shown in the figures represent portions of the toothbrush that form no part of the claimed design.

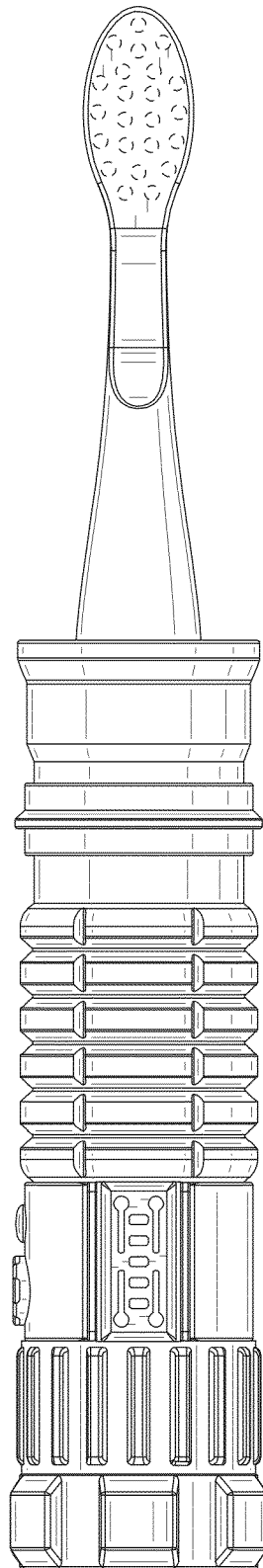

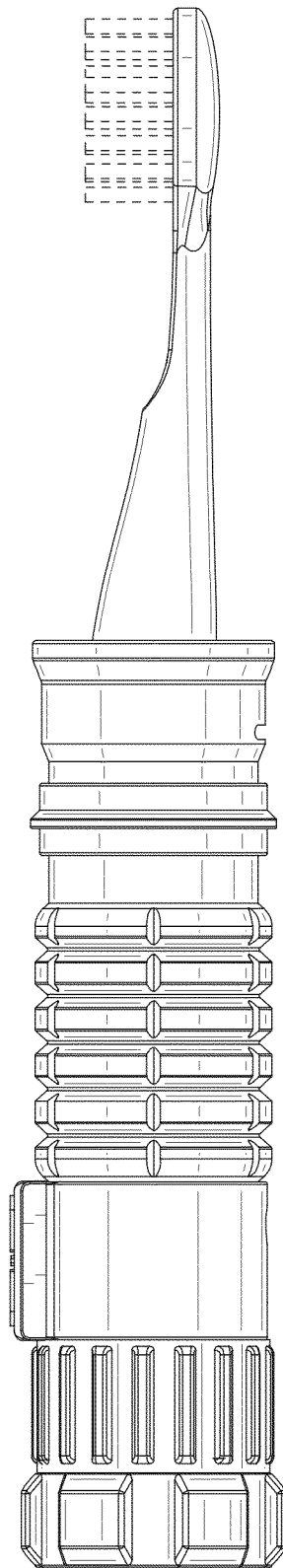

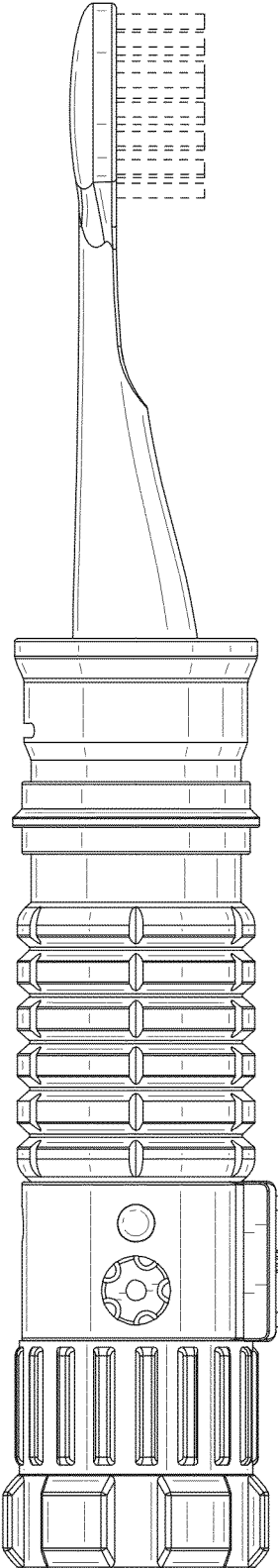

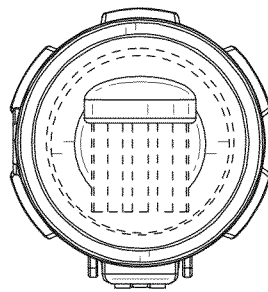

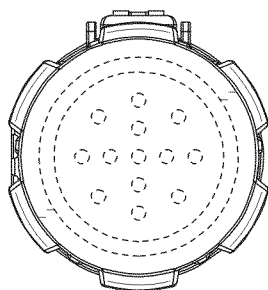

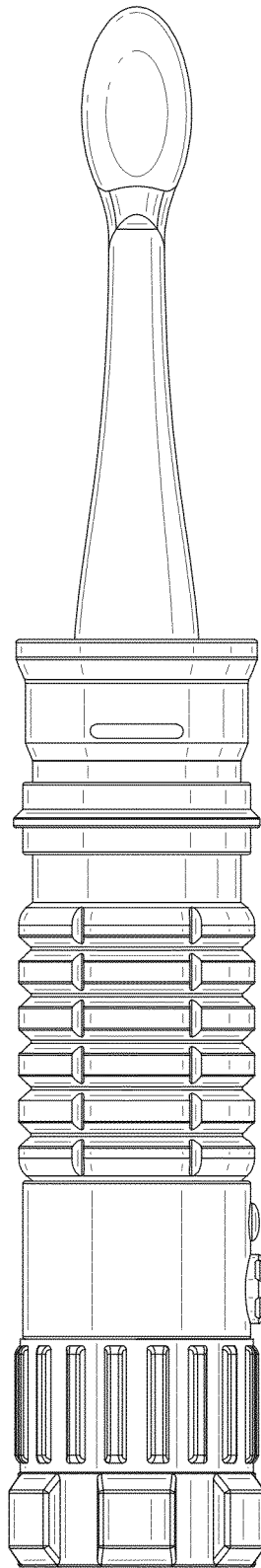

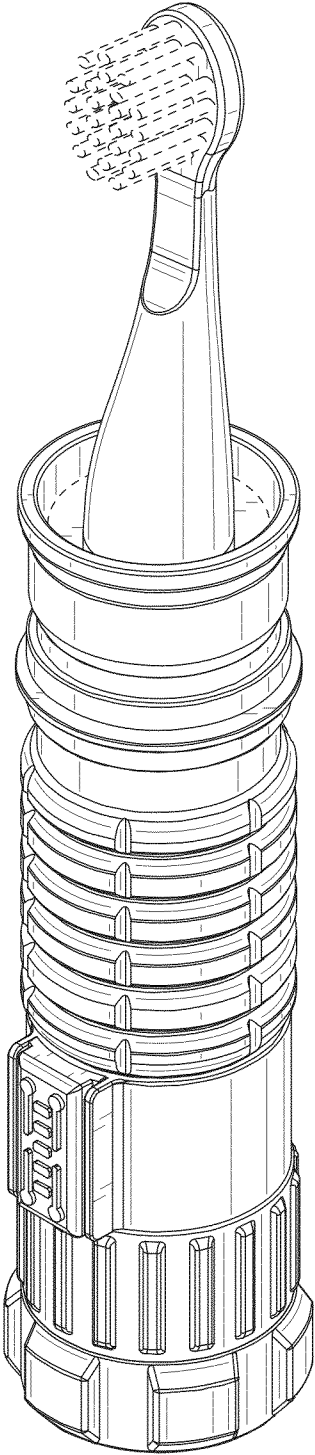
