(57) **CLAIM**

The ornamental design of a vehicle system with exchangeably arrangeable operator controls, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a vehicle system with exchangeably arrangeable operator controls showing my new design;

FIG. 2 is a top plan view thereof which is also a mirror image of the bottom view thereof;

FIG. 17 is a front view of a fourth alternate embodiment of my new design;

FIG. 18 is a top plan view thereof which is also a mirror image of the bottom view thereof;

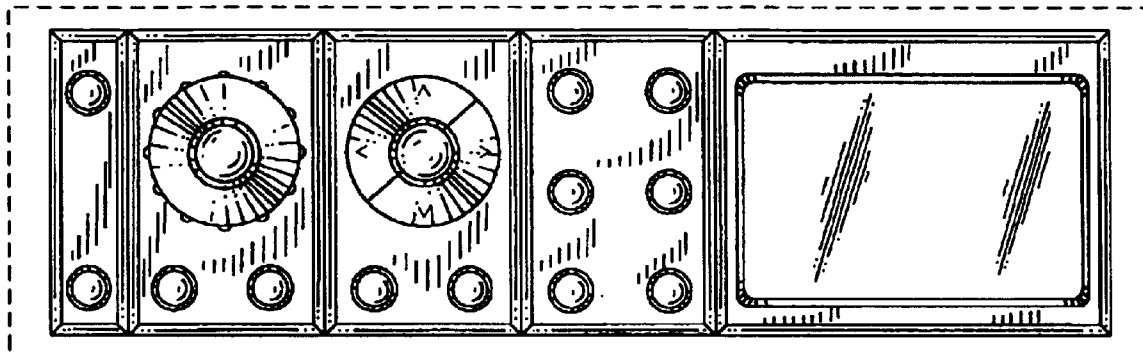

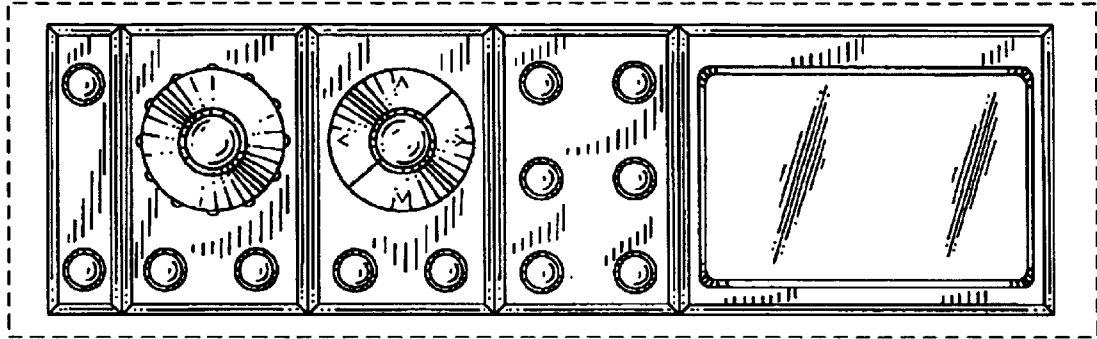

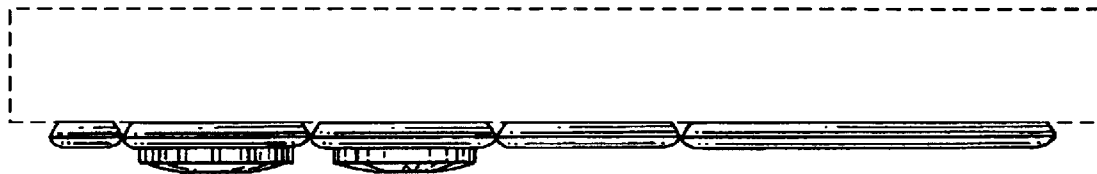

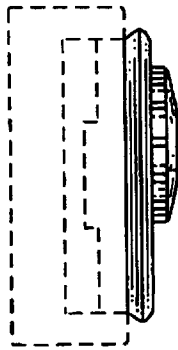

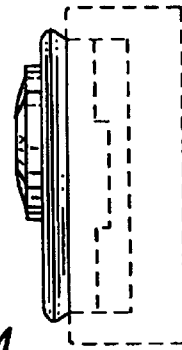

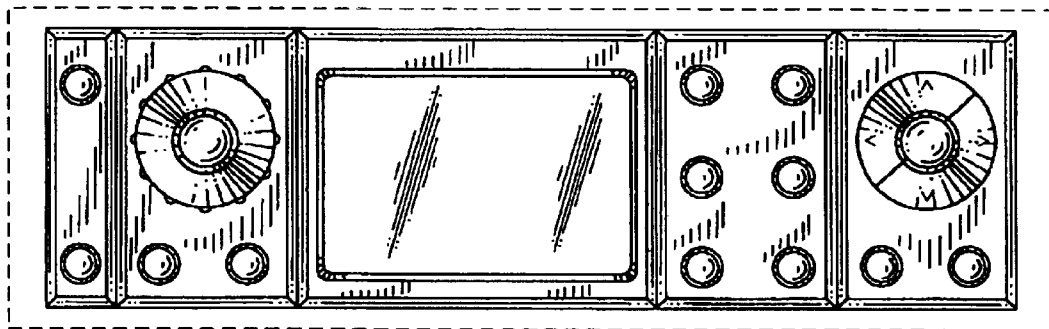

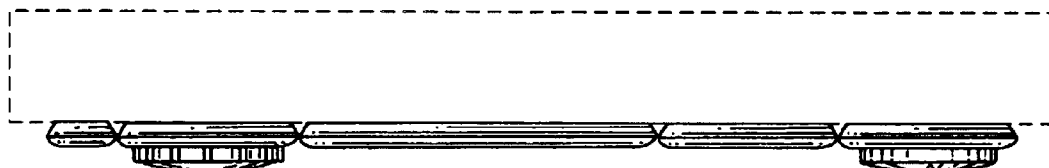

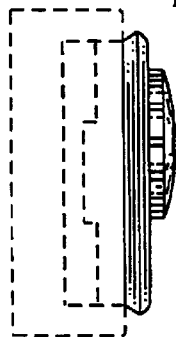

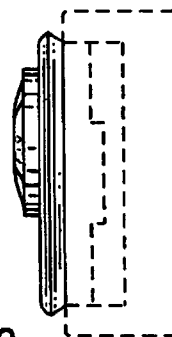

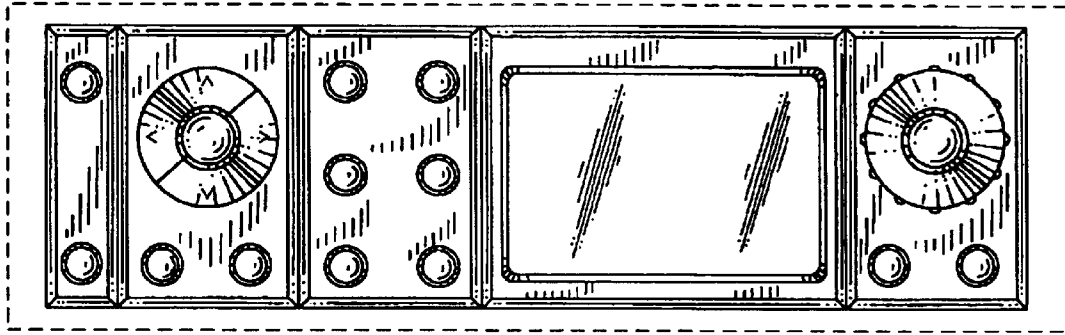

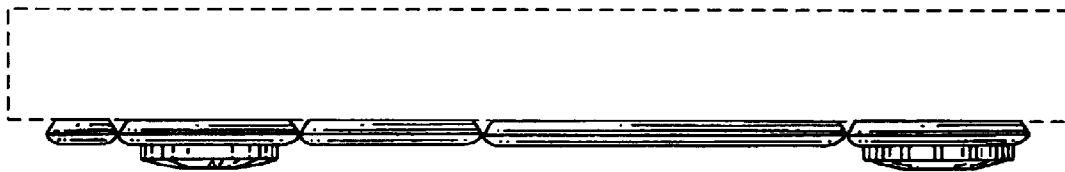

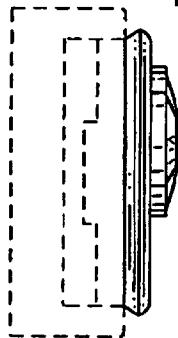

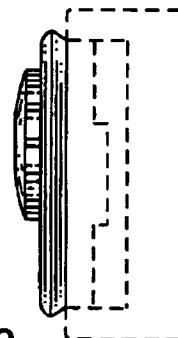

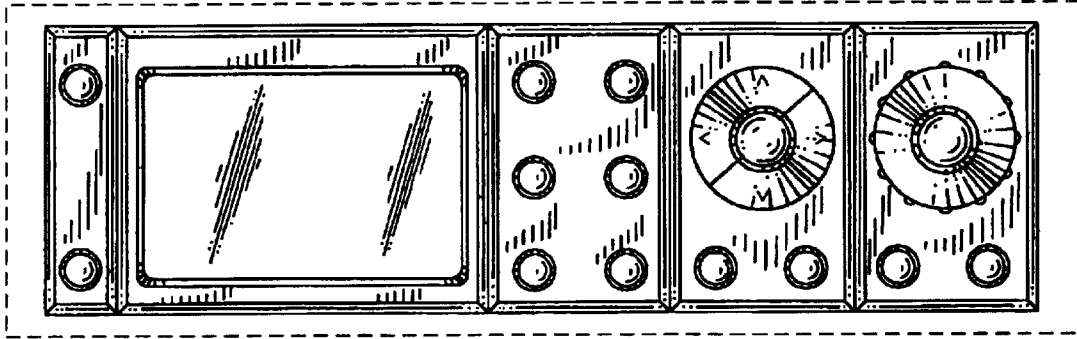

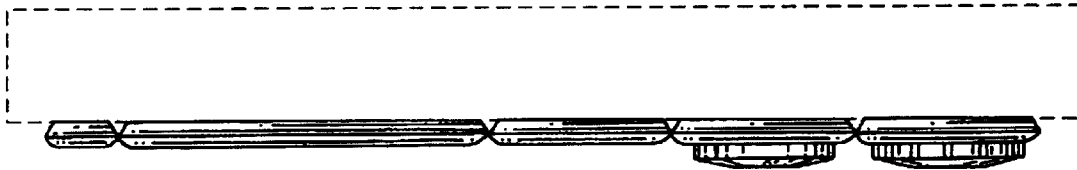

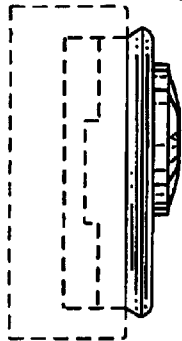

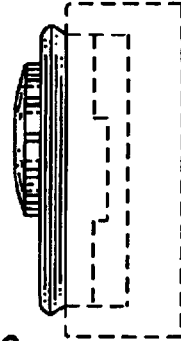

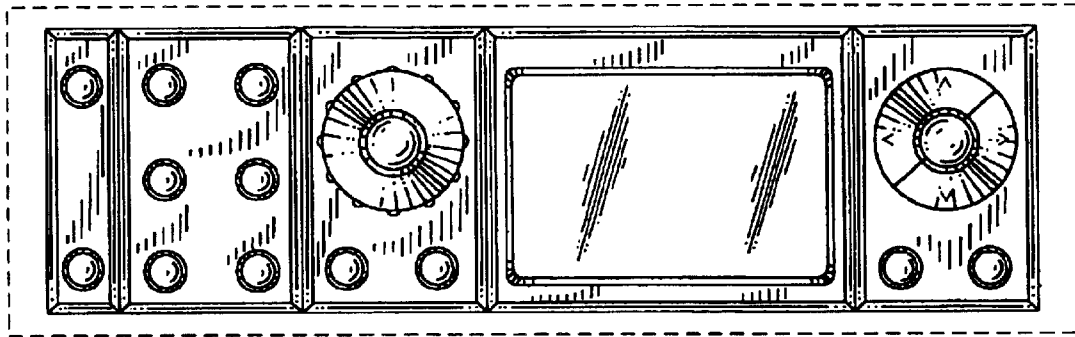

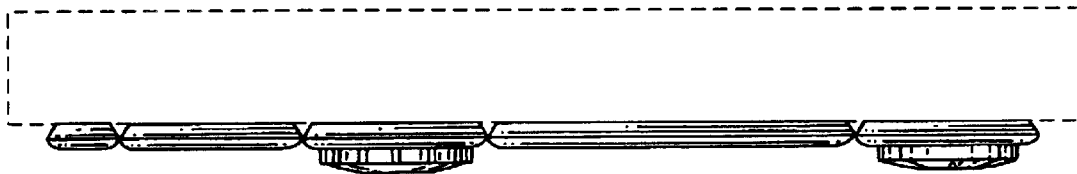

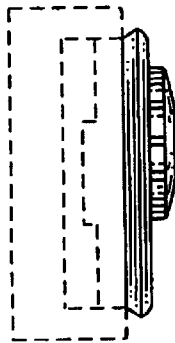
