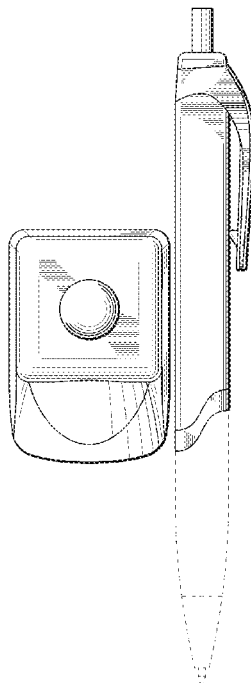

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of the pen; FIG. 2 is a top plan view thereof, shown at an enlarged scale; FIG. 3 is a bottom plan view thereof, shown at an enlarged scale; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a left side elevation view thereof, the right side elevation view being a mirror image.

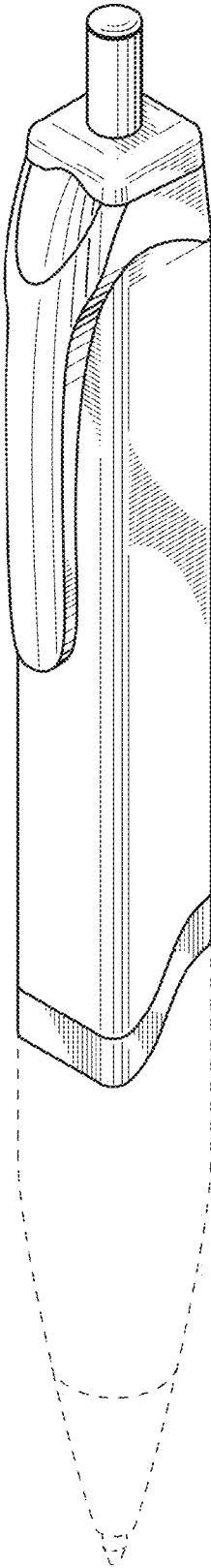

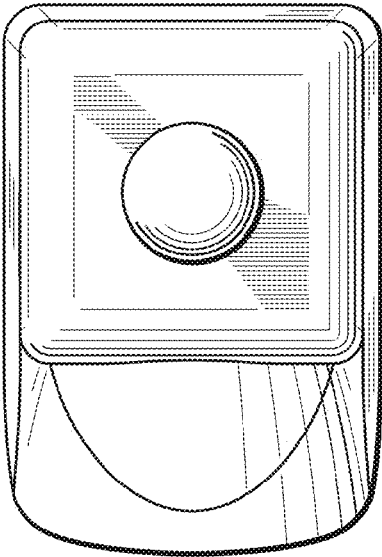

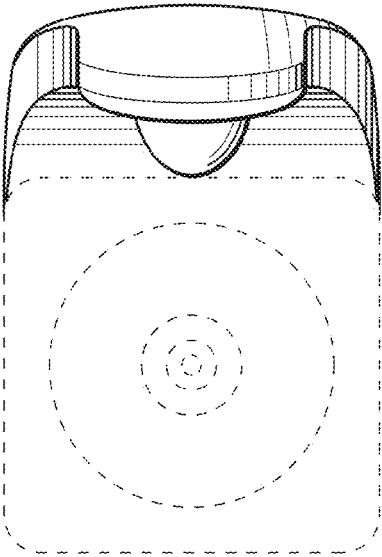

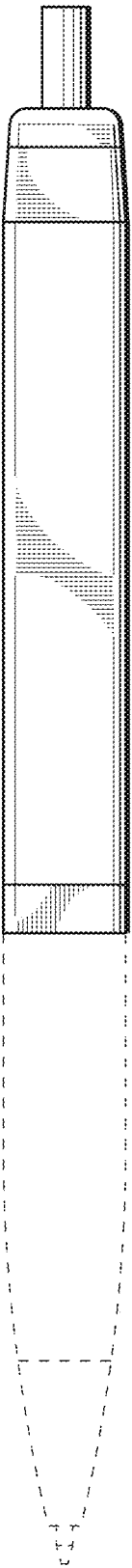

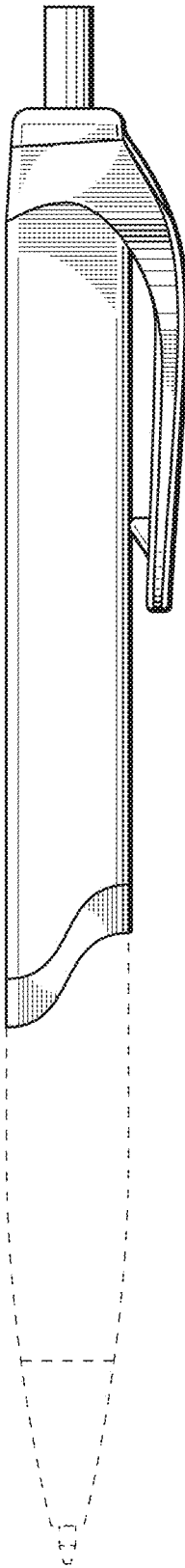
