
(57) **CLAIM**

What is claimed is the ornamental design for a shoe midsole and insert, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe midsole and insert showing the new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a front side view thereof; and,
FIG. 6 is a rear side view thereof.
Any elements shown in dotted lines are provided for purposes of illustrating portions of the shoe midsole and insert that form no part of the design claimed.












