(57) **CLAIM**

The ornamental design for a beverage dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the beverage dispenser of the present design;

FIG. 2 is a front elevational view of the beverage dispenser; FIG. 3 is a right side elevational view of the beverage dispenser; the left side elevational view of the beverage dispenser being a mirror image thereof;

FIG. 4 is a rear elevational view of the beverage dispenser; and,

FIG. 5 is a top plan view of the beverage dispenser.











