The ornamental design for an inkjet printer, substantially as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an inkjet printer, in accordance with the present invention;  
FIG. 2 is a front view thereof;  
FIG. 3 is a right side view thereof, the left side is a mirror image;  
FIG. 4 is a top view thereof;  
FIG. 5 is a rear view thereof; and,  
FIG. 6 is a bottom view thereof.













