(54) Title: METHOD FOR REDUCING PISTILLATE FLOWER ABORTION IN PLANTS

(57) Abstract: The present invention relates to a method for reducing pistillate flower abortion in plants, comprising treating the plant, plant parts, the locus where the plant is growing or is intended to grow and/or the seeds from which the plant grows with at least one strobilurin (compound A). In addition, the invention relates to the use of at least one strobilurin for reducing pistillate flower abortion in plants.
