The ornamental design for a paper binder.

DESCRIPTION

FIG. 1 is a front perspective view of a paper binder positioned along the end of a stack of paper.

FIG. 2 is a perspective view of the paper binder.

FIG. 3 is a top plan view of the paper binder.

FIG. 4 is a front elevational view of the paper binder.

FIG. 5 is a left side elevational view of the paper binder.



FIG. 6 is a right side elevational view of the paper binder.
















