(57) **CLAIM**

The ornamental design for a food container with a holder, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a food container with holder of our new design with the top and bottom portions shown in a separated condition;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a top plan view of FIG. 1 showing the top and bottom portions side by side thereof;

FIG. 4 is a bottom plan view of FIG. 3;

FIG. 5 is a front view showing the top and bottom portions vertically stacked;

FIG. 6 is a rear view of FIG. 5;

FIG. 7 is a first side view of FIG. 5;



FIG. 8 is a second side view of FIG. 5;




















