(57) **CLAIM**

We claim, the ornamental design for a monitor, as shown and described.

DESCRIPTION

FIG. 1 is the front/right-side/top perspective view of a monitor showing our new design;

FIG. 2 is the front elevation view thereof;

FIG. 3 is the rear elevation view thereof;

FIG. 4 is the left-side elevation view thereof;

FIG. 5 is the right-side elevation view thereof;

FIG. 6 is the top-side plan view thereof;

FIG. 7 is the bottom-side plan view thereof; and,

FIG. 8 is the rear perspective view thereof.

The surface treatment of the monitor shown in the figures forms no part of the claimed design, a monitor according to the claimed design may have any surface treatment.

The relatively solid black appearance shown in portions of FIGS. 4-6 represent the curved features shown in FIG. 3.

The dashed broken lines illustrating portions of the monitor are for environmental purposes only and form no part of the claimed design.

















