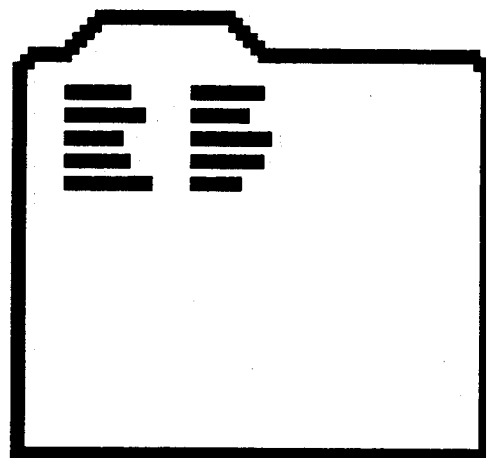
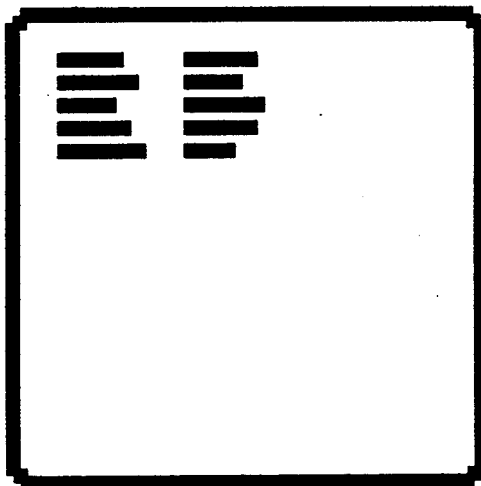

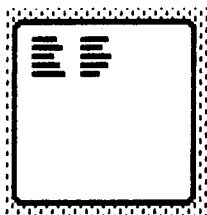

 The broken line showing of a partial half tone di screen in FIGS. 1 and 7 is for illustrative purposes and forms no part of the claimed design.



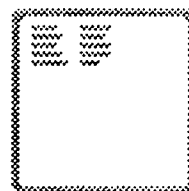

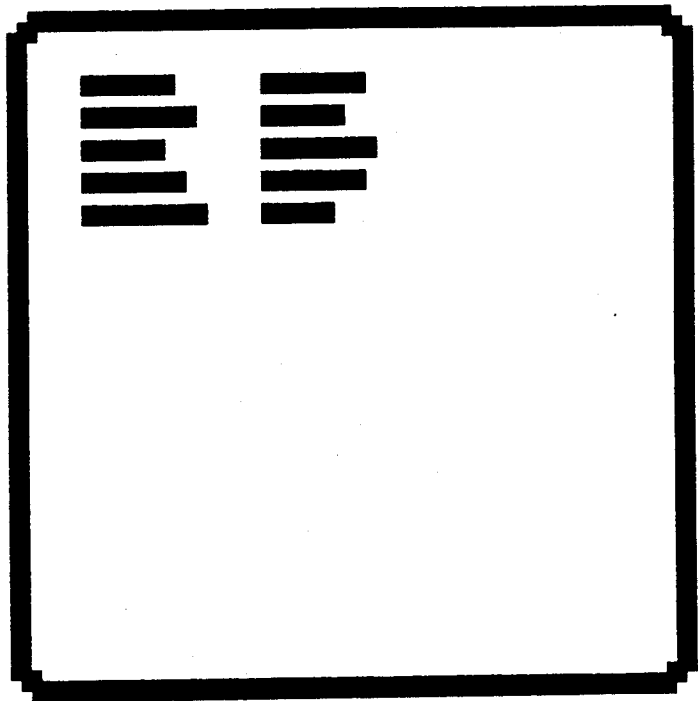

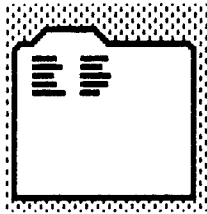

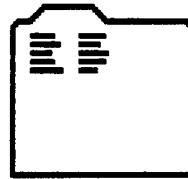

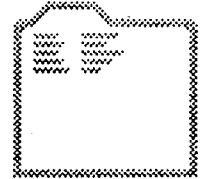
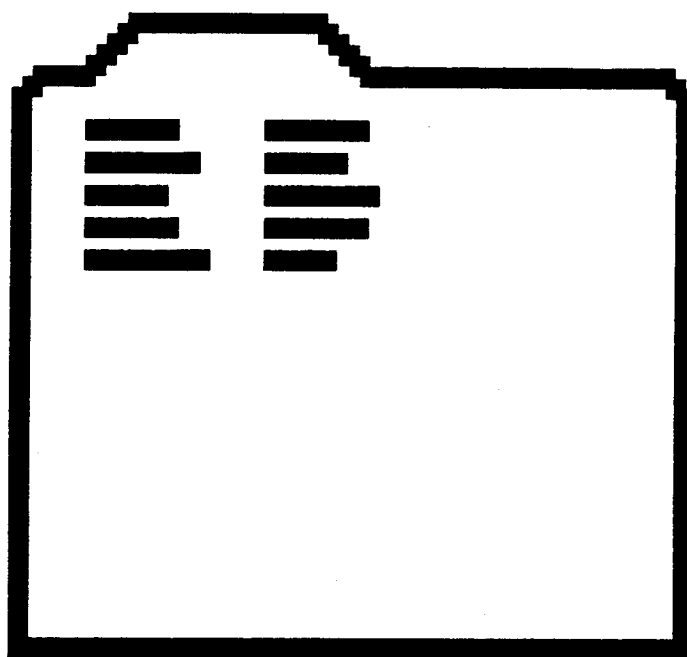
