(57) **CLAIM**

The ornamental design for a suspended light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a suspended light fixture showing our new design.

FIG. 2 is a front elevation view of the suspended light fixture of FIG. 1.

FIG. 3 is a rear elevation plan view of the suspended light fixture of FIG. 1.

FIG. 4 is a right elevation view of the suspended light fixture of FIG. 1.

FIG. 5 is a left elevation view of the suspended light fixture of FIG. 1.


FIG. 6 is a top plan view of the suspended light fixture of FIG. 1; and,

FIG. 7 is a bottom plan view of the suspended light fixture of FIG. 1.

The fixture is shown broken away in FIGS. 1-7 to represent a continuation of the design uniformly along a non-specific length.

The broken lines depict portions of the suspended light fixture that form no part of the claimed design.






