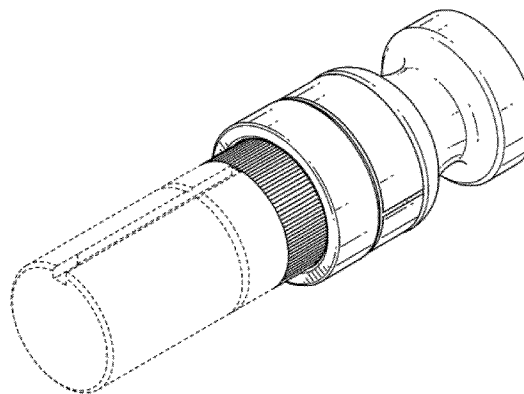
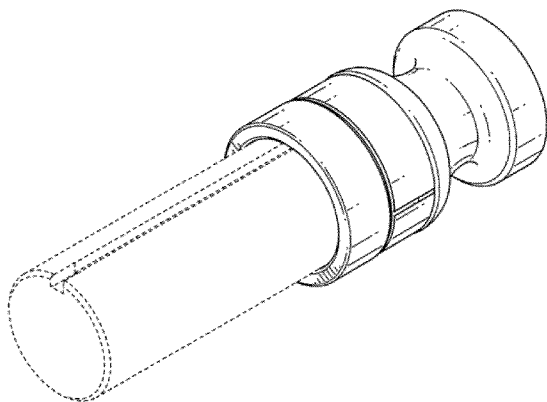
(57) **CLAIM**

We claim the ornamental design for a punch holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of our new design for a punch holder; FIG. 2 is front view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a rear side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective of a second embodiment of our new design for a punch holder; FIG. 9 is front view thereof; FIG. 10 is a left side view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a rear side view thereof; FIG. 13 is a top view thereof; and, FIG. 14 is a bottom view thereof. The broken lines showing the bottom portion of the punch holder form no part of the claimed design.

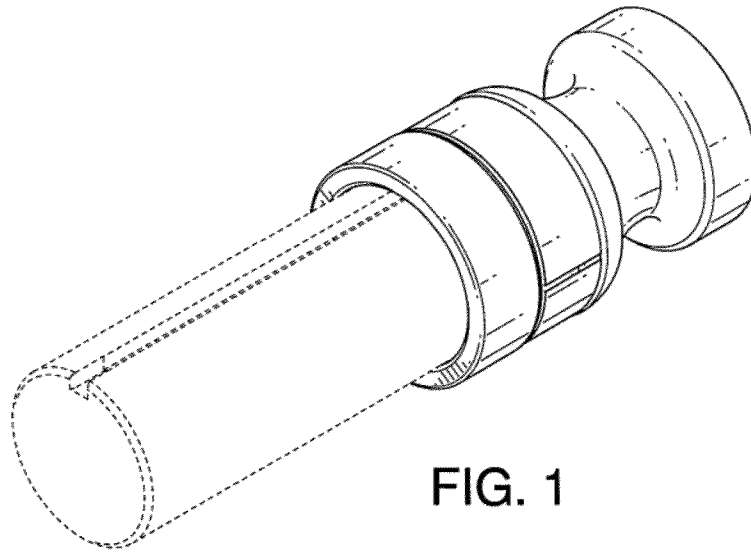

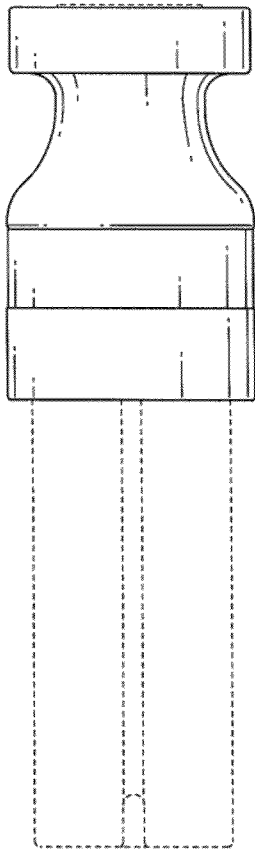

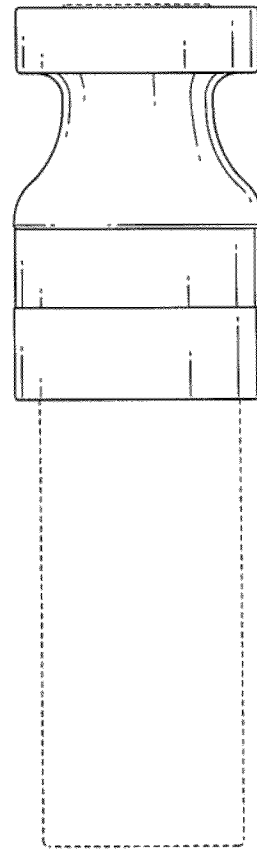

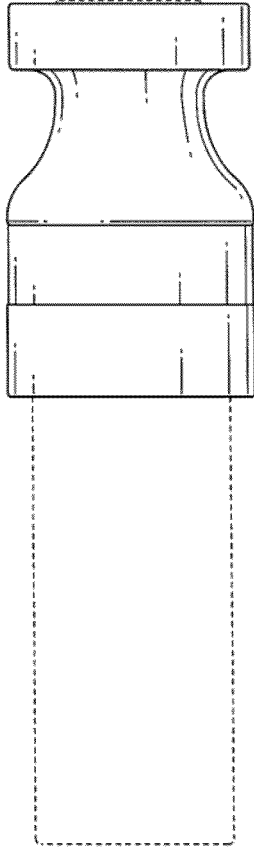

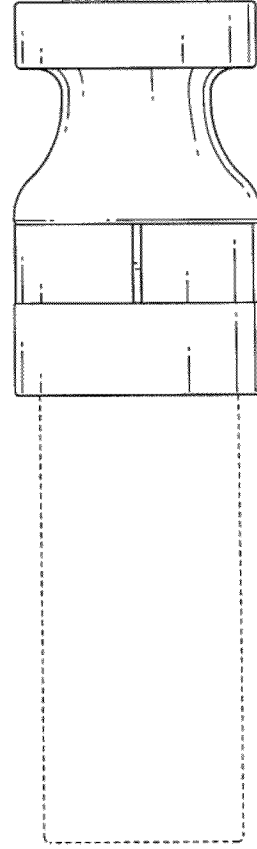

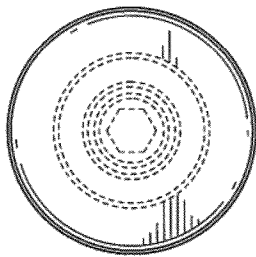

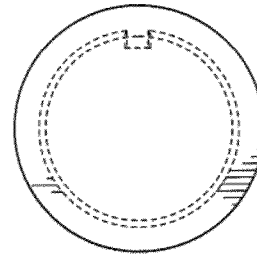

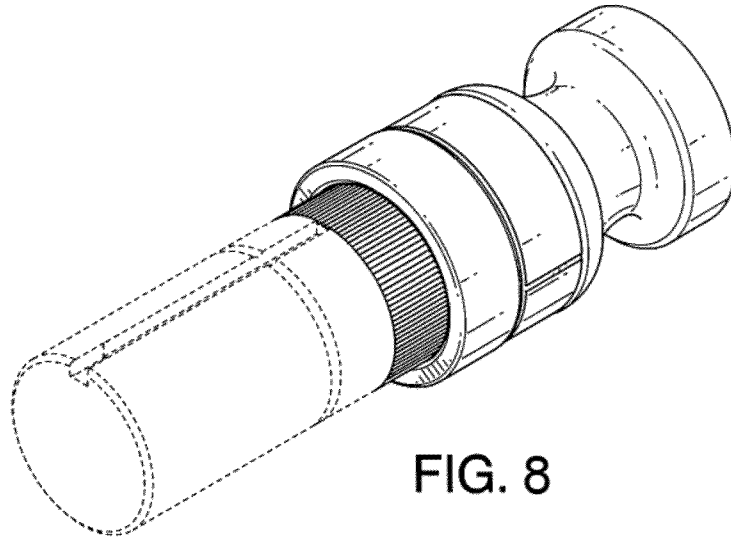

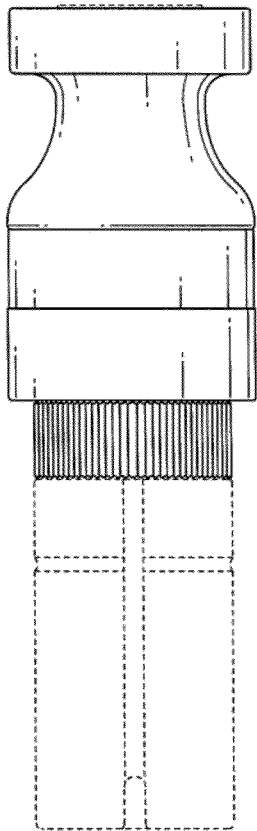

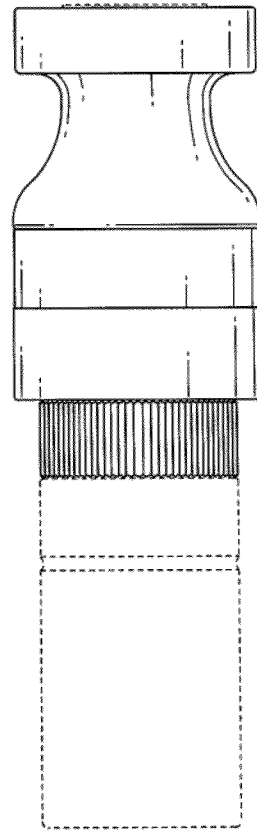

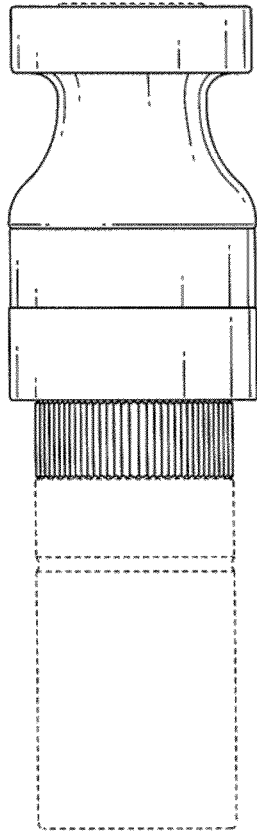

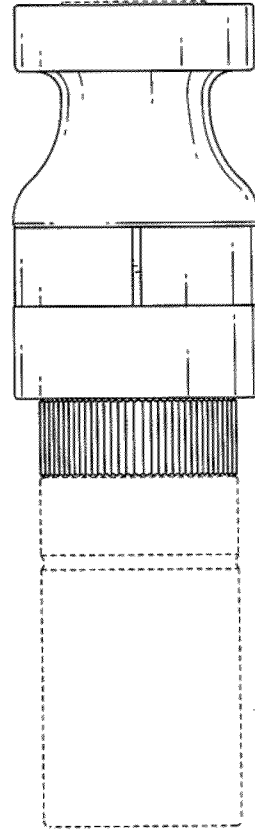

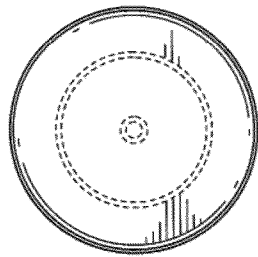

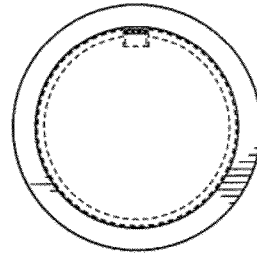
