

FINGERPRINT SECURITY THROUGH A HEADSET IN A HEAD COVERING

(57) Abstract: The mobile communication device is for use as a cell phone, as a wireless identity authentication device with other electronic devices, and as a headset in the form of an earphone, an eye-covering, or a head covering for audio communication with a central processor, another mobile terminal a cell phone, or a pda. The mobile communication device is hands-free being worn on or near the face, and only requires a finger touching for bimodal identity authentication. An audio receiver is compatible with the ear of the user and a microphone transmits words spoken by the user, electronically there through. A fingerprint sensor is mounted and positioned within th device. When user authentication is required, the user is prompted to touch the fingerprint sensor, and said fingerprint data is compare with fingerprint images of authorized users.
