(57) **CLAIM**

I claim the ornamental design for a multi-media DVD recording and/or reproducing device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of multi-media DVD recording and/or reproducing device showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is an inverted rear view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in FIGS. 3–7 form no part of the claimed design.














