(57) **CLAIM**

The ornamental design for the lamp support arm, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the lamp support arm in accordance with my design, illustrating the environment of the support arm;

FIG. 2 is a front elevation view of the lamp support arm in accordance with my design;

FIG. 3 is a side elevation view of the lamp support arm in accordance with my design;

FIG. 4 illustrates the rear elevation view of the lamp support arm in accordance with my design;

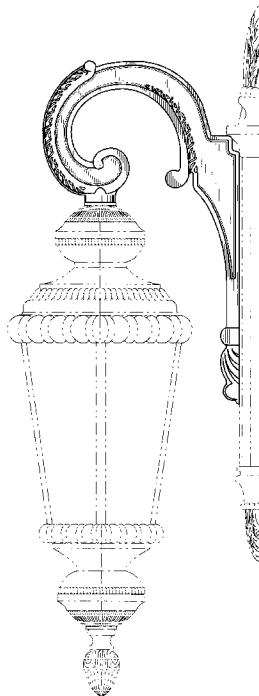
FIG. 5 illustrates the top view of the lamp support arm in accordance with my design; and,

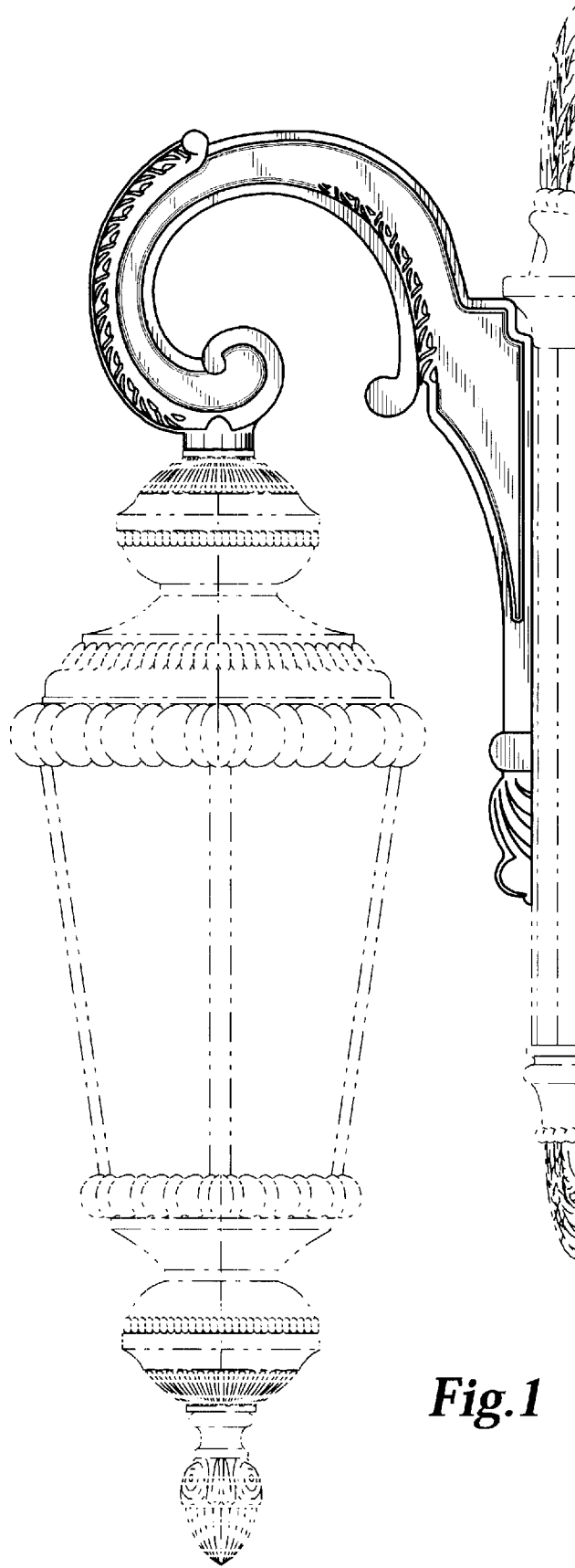

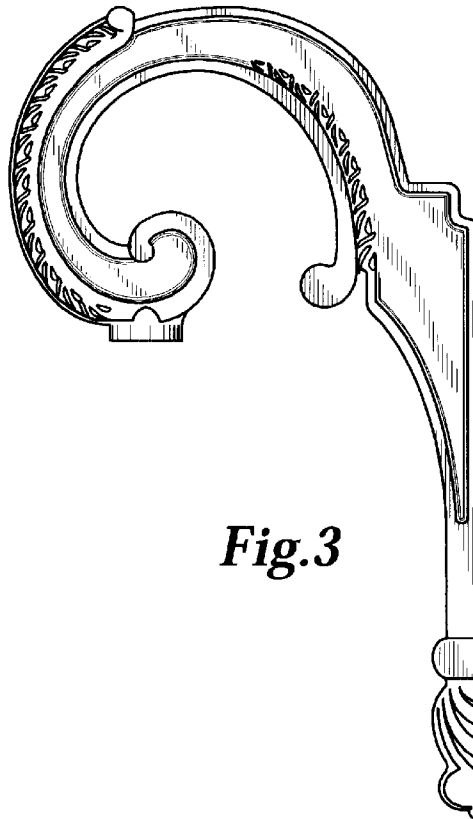

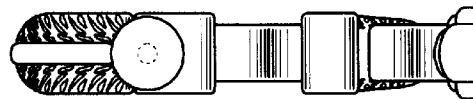
